An Act to attach the Local Municipality of *Notre Dame du Portage* to the Municipality of the County of Temiscouata.

WHEREAS the Local Municipality of *Notre Dame du Portage* is situated partly in the County of Kamouraska and partly in the County of Temiscouata; And whereas it is expedient to decide to which County Municipality it shall belong, for Municipal purposes only: Therefore Her Majesty, &c., enacts as follows: Preamble.

I. From and after the the Local Municipality
of *Notre Dame du Portage* shall form part of the County Municipality of Temiscouata, for Municipal purposes. Municipality
Notre Dame
du P. added to
Temiscouata.

II. That portion of the said Local Municipality of *Notre Dame du Portage* which is situated within the County of Kamouraska, shall continue hereafter to form part of the said County, as regards the election of a member of the Legislative Council to represent the electoral division of which the said portion of the said Local Municipality forms a part, and also as regards the election of a member of the Legislative Assembly for the electoral county, of which the said portion of the said local Municipality forms a part. But the part in
Kamouraska
to belong to
said County
for electoral
purposes.

III. Until an assessment roll and alphabetical list of persons who shall appear by the said roll to be qualified, under the Act 22 Vict., chap 82, to vote at the election of members of the Legislative Council and Legislative Assembly, shall have been made in conformity with the said Act, for the said Local Municipality of *Notre Dame du Portage*, that portion of the said Local Municipality which is situated within the County of Kamouraska shall continue to be entered on the assessment roll and alphabetical list of the Local Municipality of St. André, of which it formed a part previous to the passing of this Act. As to the
Voters' Lists
under 22nd
Vict., cap. 82.

IV. The electors of that portion of the said Local Municipality which is situated within the County of Kamouraska, shall continue to vote at elections for members of the Legislative Council and Legislative Assembly, at the poll of the Parish of St. André. Where votes
to be given.

V. This Act shall be deemed a public Act.
