The Canada Temperance Act.

The citizens of Charlottetown will shortly be called upon to declare whether they desire a continuance of the provisions of the Canada Temperance Act, which, for the past three years, has regulated the sale of intoxicating liquors among them.

It is not necessary that, in referring to this matter, we should dilate upon the evils of intemperance—we presume that all good citizens are fully impressed with the terrible consequences which follow an unrestrained indulgence in spirituous liquors.

We have had three years' experience of the working of the Scott Act—which, for convenience, we shall call it—let us enquire how far it has come up to the expectations of its friends.

Our readers do not require to ask the question, for well they know to the contrary, and that the very name of Scott Act, instead of commanding respect, and infusing terror into its transgressors, is everywhere among us a by-word and a reproach.

We state, without fear of contradiction, that there are more places to-day in Charlottetown where liquor is sold than there were four or five years ago under our License system.

We say, moreover, that there is as much liquor drunk as there was then; and worse than all, the most of it is of a quality so vile that it is little better than poison.
