COUNCIL CHAMBER, Tuesday, 29th January, 1833.

THE General Assembly having been, by Three Proclamations, prorogued to this day, the Council met—

The President acquainted the Council that by a Commission bearing date the twenty

twenty fifth instant, under the Great Seal of the Province, William Tyng Peters, Esquire, is appointed Clerk of the Council in General Assembly.

Read the said Commission.

ORDERED, That Mr. Peters taken his seat as Clerk accordingly.

The Council was adjourned during pleasure.

After some time the Council was resumed.

His Excellency Major General Sir Archibald Campbell, Baronet, Knight Grand Cross of the Most Honorable Military Order of the Bath, Lieutenant Governor and Commander in Chief of the Province, came to the Council Chamber, and, by Message, commanded the attendance of the House of Assembly.

The House of Assembly attended accordingly, and His Excellency opened the Session by a Speech.

The House of Assembly withdrew, and His Excellency retired.

The President reported a copy of His Excellency's Speech, which he read as follows:—

"Mr. President, and Honorable Gentlemen of His Majesty's Council, "Mr. Speaker, and Gentlemen of the House of Assembly,

"IT gives me much satisfaction to meet you again in General Assembly, and I rejoice that press of business has not obliged me to call you together before the period which I was led to suppose, on a former occasion, would be the best suited to the convenience of the Members of both Houses.

"In thus meeting you for the second time, it was my wish to have avoided a repetition of any of the subjects adverted to in my address at the opening of the last Session; but I feel myself most reluctantly called upon again to draw your attention to the state of the Great Roads throughout the Province, the unfinished and ruinous condition of many of the lines so termed, evinces, after the liberal appropriations made from time to time for the attainment of an object of such paramount importance to the settlement and prosperity of the Province, (amounting to no less a sum than one hundred thousand pounds since the year eighteen hundred and fifteen,) that some radical defect exists in the system, the remedying of which, will, I confidently trust, be deemed of sufficient moment to merit your most serious consideration: It is to be feared that the same remark may be found applicable to the Bye Roads, notwithstanding the expenditure, within the same period, of the sum of about fifty thousand pounds.

"The Act for regulating the Statute labour expiring this Session, I am convinced that it is quite unnecessary for me, in a matter of such importance to the Country, to call, in its renewal, your most mature and deliberate attention to the different interests of the public.

"I regret to state that that important source of our Commerce, as well as of our domestic comfort, the Fisheries, has of late become nearly a failure, particularly,

on

on the rivers—owing either to the insufficiency of the existing Laws for their protection, or the impunity with which those Laws are permitted to be transgressed. It is therefore desirable that measures should be adopted for the correction of this evil from whatever cause it may proceed.

Mr. Speaker, and Gentlemen of the House of Assembly,

"I have directed the Treasurer's Accounts and all the documents connected therewith to be immediately laid before you, from which it is gratifying to find that there is a considerable improvement in the last year's Revenue compared with that of the former; yet it is to be regretted that those of both years leave a heavy deficiency to meet your appropriations for the same period, which has already given rise to much inconvenience and obstruction to the public service, as well as loss to individuals, and must, I fear, for a time, lead to still further evils. I therefore feel it my duty to call your most serious attention thereto, relying upon your wisdom to provide such means for their removal, as your experience may suggest.

"Since the close of the last Session, expenses to some small extent have been incurred in various parts of the Province, by the Commissioners of the Boards of Health and other Authorities, in the establishment of sanitary precautions against the introduction of Cholera. Those outlays for a purpose so incalculably important

to the community at large, will, I am convinced, be cheerfully provided for.

"Mr. President, and Honorable Gentlemen of His Majesty's Council, "Mr. Speaker, and Gentlemen of the House of Assembly,

"That we have hitherto remained untouched by that awful visitation, by which so many other lands have been filled with mourning and distress, ought, indeed, to awaken in our hearts, feelings of the deepest and most fervent gratitude towards that gracious Providence which has so mercifully spared us; but it ought not to be forgotten that the day of our visitation may yet come. The disease still lurks in our neighbourhood, and although we must be sensible that we cannot depend upon any merely human means for our continued preservation from this dreadful malady, or for arresting its march, should it unfortunately break out, yet it would be presumptuous in us to neglect those precautions, and that preparation which wisdom and experience recommend, and which, if they cannot avail to prevent its introduction, or its spread among us, may at least do much to mitigate its horrors.

"I appeal with confidence to the humane feelings of this Legislature, in behalf of the poor and needy portion of the community, who are ever the greatest sufferers on such occasions. I am persuaded that you will see how necessary it is, on their account, that effective Boards of Health should be established in every populous neighbourhood, and enabled to meet with promptitude the first inroad of the disease.

"The whole Country will doubtless regard it as one of the chief duties of the Legislature, at this time to provide, so far as they are able, against the danger which threatens all alike, and I rely upon your making such wise and cautious enactments as will oblige all to acknowledge that your duty has been done, whatever it may please Divine Providence to order for us.

"I have it in command to acquaint you that His Majesty has been graciously pleased,

pleased, on account of the late much encreased, and still encreasing Judicial Duties of the Province, to relieve, at their own request, the Puisne Judges from their Seats in the Executive and Legislative Councils, and at the same time to express to those honorable and distinguished Individuals His Majesty's thanks and approbation, for the uniform and highly important services hitherto rendered by them, as Members of those bodies. And it is His Majesty's further pleasure to direct, that the present Judges do retain the rank and privileges appertaining to Members of Council.

"In compliance with an Address of the House of Assembly, made last Session, I caused the appointment of a Commission to be issued, for investigating the Forms and Proceedings of the Common and Civil Law Courts, and other Judicial Institu-

tions of the Province: its Report I shall direct to be laid before you."

ORDERED, That an humble Address be presented to His Excellency the Lieutenant Governor, in answer to his Speech; and that Mr. Shore and Mr. Baillie be a Committee to prepare the same.

The said Address being read at the Clerk's Table, paragraph by paragraph, was approved of, ordered to be engrossed and is as follows:—

"To His Excellency Major General Sir Archibald Campbell, Baronet, Knight Grand Cross of the Most Honorable Military Order of the Bath, Lieutenant Governor and Commander in Chief of the Province of New Brunswick, &c. &c. &c.

"THE HUMBLE ADDRESS OF HIS MAJESTY'S COUNCIL IN GENERAL ASSEMBLY,

"MAY IT PLEASE YOUR EXCELLENCY,

"WE thank Your Excellency for your Speech at the opening of the present Session.

"Aware of the importance of Great Roads throughout the Province, without which

the vast resources of the Country cannot be developed, we shall feel it our duty to give such attention to the subject, and to concur in such alterations in the present laws, as we trust will insure the judicious outlay of any future appropriations for that service.

"The state and condition of the Bye Roads will also receive our due consideration.

"Fully impressed as we are with the necessity of such legal provision regulating the statute labour, as will bear with equity and justice upon the different classes of society, and tend to a judicious and proper application of labour, under an improved system, we shall be ready to give such mature consideration to the subject as its importance demands.

"The decay of the Fisheries is a subject which shall receive such attention as upon proper investigation it shall be found to require, and we will concur in such regulations as will tend to promote and secure that important source of our commerce and

of our domestic comfort.

"We join with Your Excellency in fervent gratitude to that beneficent Providence which has, up to the present moment, so mercifully spared us from the baneful effects of that dreadful disease which has spread its terrors over so large a portion of the earth; and while we are sensible of the inefficacy of all human efforts unaided by the Divine Will, yet we are fully aware of the obligation upon us not to neglect such means as have elsewhere proved beneficial, either in arresting or mitigating so dreadful a scourge; and we shall therefore feel it our duty to make such regulations of a sanitary character as experience has pointed out.

"Your Excellency having informed us, that on account of the increasing duties of the Puisne Judges, they had, at their own request, been permitted by His Majesty to withdraw from the Executive and Legislative Councils, we cannot but acknowledge to Your Excellency, the able assistance this Board has invariably received from their extensive knowledge of the Country and their eminent abilities; and we cannot permit so important a measure to be communicated to us, without expressing the regret we feel at losing the assistance of men so well qualified to render important

services to the Country.

"We thank your Excellency for directing to be laid before us the Report of the Law Commission, and we anticipate much good to the Public from so wise and necessary a measure."

Ordered, That Mr. Baillie, as a Committee of this House, do wait upon His Excellency, to know when His Excellency will be pleased to receive the Address.

Mr. Simonds presented a Petition from Ralph M. Jarvis, Esquire, and others, Merchants in the City of Saint John, praying for an Act of Incorporation for the establishment of another Bank in the said City.

"William the Fourth, by the Grace of God, of the United Kingdom of Great Britain and Ireland, King, Defender of the Faith.

"To our Right Trusty and Well-beloved, MATTHEW LORD AYLMER, Knight, Commander of the Most Honorable Military Order of the Bath, Lieutenant-General of Our Forces, GREETING:-

"WHEREAS by Letters Patent bearing date at Westminster, on the Sixth Day of July One thousand eight hundred and thirty one, in the Second Year of Our Reign,

We did constitute and appoint you to be Our Captain-General and Governor-in-Chief, in and over Our Province of New-Brunswick, and did, by Our said Letters Patent, give, grant and commit to you certain powers and authorities to be by you exercised in manner therein mentioned, with the advice and consent of OurCouncil of Our said Province, as by reference to the said Letters Patent will more fully and at large appear: And Whereas We have deemed it expedient that there should henceforward be two distinct Councils in Our said Province for the purposes hereinafter mentioned; Now, therefore, Know Ye, that We of Our special Grace, certain Knowledge, and mere Motion, have thought proper to grant, provide and declare, and do hereby grant, provide and declare that there shall henceforward be within Our said Province of New-Brunswick two distinct and separate Councils, to be respectively called the Legislative Council and the Executive Council of Our said Province; and We do hereby further direct, and declare Our pleasure to be, that all and every the powers and authorities in the Letters Patent aforesaid contained. and thereby conferred on and vested in Our Council therein mentioned, so far as respects the enactment of any Laws to be made within Our said Province, shall henceforth be and the same are hereby vested in the said Legislative Council, and that all other powers and authorities whatsoever in the Letters Patent aforesaid contained, and thereby conferred on and vested in Our Council therein mentioned, shall henceforth be and the same are hereby vested in the said Executive Council: And We do further direct, and declare Our pleasure to be, that all and every the provisions, clauses, matters and things in the said Letters Patent contained, or which are or shall be contained in the general or other Instructions therein referred to, with reference to the constitution of the Council therein mentioned, and to the number of the members thereof, and to the nomination, appointment, suspension, or removal of such members, shall be and the same are hereby made applicable to the said Legislative Council as fully as if the same and every of them were here repeated: And We do further declare that the said Executive Council shall consist of five members and no more, and that three of such members shall constitute and be a quorum of Our said Executive Council; and that such persons shall be the members of the said Executive Council as are for that purpose nominated and appointed by the additional Instructions under Our Signet and Sign Manual accompanying these Presents, and bearing even date herewith, or as shall be so nominated and appointed by any further Instructions to be by Us for that purpose addressed to you under Our Signet and Sign Manual, or by order in Our Privy Council, or through one of Our principal Secretaries of State: And We do further direct and require that every member of Our said Executive Council of Our said Province shall take and subscribe such and the same Oaths, to be by you for that purpose administered, as by the said recited Letters Patent are required to be taken by the members of Our Council therein mentioned: And We do hereby authorize you, subject nevertheless to the rules and regulations in that behalf contained in the Instructions aforesaid. to suspend any member of the said Executive Council from his place therein until Our pleasure shall be known: And We do hereby declare that the respective members of the Executive Council shall respectively hold their places therein during Our pleasure. In Witness whereof, We have caused these Our Letters to be made Patent.

"MEMORANDUM submitted by the Provincial Secretary for the consideration

of His Excellency the Lieutenant Governor.

- "By the provisions of the several Acts of Assembly that appropriate public money, the money is to be paid by the Governor's Warrant, to be issued by and with the advice and consent of the Council. Hence it becomes necessary to submit to the Council applications for Warrants, and, of course, to record the orders made thereon.
- "The Warrant is then prepared for the Governor's signature, and a docket entered in a book kept for that purpose; which docket contains the substance of the Warrant.

"The Warrant is then transmitted to the Treasurer.

"By the Ordinance of Fees the Secretary is authorized to charge a fee of five shillings 'for all Warrants for temporary services,' of which nature Warrants for payment of money are considered; but as it would bear hard on many persons who have demands on the Treasury, to pay for their Warrants, this fee has never been charged to individuals.

"An Account was for several years submitted to the Assembly, who admitted the

right to the Fce and paid the Account; but latterly they have declined making any allowance for this service.

"Between the 1st January 1832 and the 2d of February 1833, there were issued 1193 Warrants, which occupied a very large portion of the time of one Clerk, for which no compensation has been received, and no allowance is made to the Office for Clerks' wages."

They hold 426 Shares of the Stock, which amount to £21,300, upwards of forty two per cent. of the Capital, while their liabilities as promissors, are not eleven per cent. of the debts due the Bank.

It will therefore be observed that the Directors have not availed themselves of the accommodation to which they were justly entitled; and from a general inspection of the Discount Sheets, and the Books for the last few years, your Committee are of opinion, that the Institution has been conducted in a sound, discreet and impartial manner, and that every convenience has been afforded to the Public, consistently with the means in their power, and a due regard to the interests of the Stockholders.

The average amount discounted per week has been about £10,000, and the

semi-annual dividend five per cent.

The money in the Vaults has not varied much for the last two or three years, and great difficulties have been experienced, to keep a supply equal to the demand, owing to the constant drain to the United States.

They hold 83 Shares of the Stock, which amount to £4,150, nearly twenty eight per cent of the Capital; and their liabilities as Promissors are about twenty per cent. of the debts due the Bank.

The Weekly discounts average £2,000, and the semi-annual dividend from three to four per cent.

The institution appears to have been managed with good judgment, and a proper regard to the interests of the Stockholders and the Public, and your Committee are of opinion, that their proceedings have been conducted with impartiality.

"To the King's Most Excellent Anglesty.

"The Humble and Dutiful Address of His Majesty's Legislative Council of the Province of New Brunswick, in General Assembly convened.

"MAY IT PLEASE YOUR MAJESTY,

"AT Your Majesty by Your Royal Commission under the Signet and Sign Manual, bearing date the 3d day of December 1832, was pleased to declare that there should be two distinct and separate Councils in this Province, to be respectively called the Legislative Council and the Executive Council; and did further direct and declare that all the powers and authorities, so far as respects the enactment of laws, should be vested in the said Legislative Council, and that all other powers and authorities whatsoever, should be vested in the said Executive Council; but as Your Majesty was not pleased to signify your pleasure as to the rank which the Members of those Councils should respectively bear to each other; and as doubts have arisen upon that subject, as also upon the right of succeeding to the administration of the Government, in case of a vacancy; and as we must necessarily be materially affected thereby; and as we, Your Majesty's most loyal and faithful subjects, the Members of the Legislative Council, are, from our great distance from England, induced to believe that Your Majesty could not have been fully informed of the local interests and duties of the respective Councils, and the political situation in which they stand towards Your Majesty's other subjects in this Province, Wetherefore most humbly pray leave to approach Your Majesty, and to offer for Your most gracious and benevolent consideration, the following brief statement of facts and observations in elucidation and support of the prayer of this Address. Acknowledging that Your Majesty has the sole power of conferring honors and dignities, but as we know that Your Majesty is also the fountain of Justice, we rely, with the most unbounded confidence, that Your Majesty will not bestow them, when fully informed, upon any but such as deserve them, always weighing the respective merits of Your subjects, in the even scales of impartiality.

"We therefore most respectfully proceed to state, that upon the erection of this Province by Your Majesty's Royal Father of glorious memory, He was graciously pleased

pleased to appoint a Council consisting of twelve Members, as had been accustomed upon similar occasions from a remote period, investing them with the powers, and enjoining upon them the performance of the Executive and Legislative duties, both of which we can confidently, but in the most respectful manner, declare to Your Majesty, have been constantly and faithfully performed by the different persons who have been successively Members of that Council, with zeal and fidelity, from its first crection to the time when Your Majesty's said Commission and Instructions were promulgated, (for the truth of this declaration we are conscious that we could safely appeal to all those honorable personages who have successively administered the Government of this Province); till which period, except in time of War, it was clearly and distinctly understood that the Members ranked according to the dates of their respective appointments, and that the administering of the Government, in case of a vacancy, devolved, except in the case of one of the Judges, as matter of course, upon the senior Member of the Council. But as Your Majesty has been pleased by the said commission to divest the old Council of some of its powers and duties. and to invest them in the new or Executive Council, thereby materially changing the political constitution of the Province, we humbly hope that we shall be excused in . making a few observations as to how this change will affect us, particularly upon the two points before mentioned.

And first, as to rank: If the Legislative Council is, as we conceive it is intended to be, analogous to the House of Lords in the United Kingdom, or if perhaps to speak more correctly, we are considered as the miniature or representation of that august body in this Province, the importance and usefulness of our duties must necessarily raise us to a corresponding dignity and rank, and consequently give us similar precedence here, as is established by the table of precedence in England.

As to the rank of the Executive Council, we have carefully looked into the table of precedence as established in England, and also into that as settled for and acted upon in Your Majesty's American Colonies, but do not find that the Members of an Executive Council, as such, are in any way recognised in either of them. Morcover if the duties of the Members of this Council be considered relatively to Your Majesty's Cabinet Council in England, they will be found to be of so subordinate and limited a nature, that they can bear a very slight resemblance to the duties of that most dignified and important Council, the Members of which Your Majesty is pleased to invest with adequate authority and powers to conduct the Executive duties of Your Majesty's Government, but who must possess sufficient power and influence to enable them to perform the important duties of the Government, both in its domestic arrangements and foreign relations. As this cannot be the case with any Executive Council in Your Majesty's American Provinces, we therefore humbly conceive that the Members of such Councils are not entitled to corresponding rank.

"We beg leave further to observe, that it has been doubted whether the expression used in the additional Instruction, 'That the Member of Our said Council whose name shall be first placed on the list shall preside in Our said Council,' can imply that the person so presiding would be entitled in such an event to administer the Government, as we assimilate the duty of such person, upon such an event,

to

to that of the President of Your Majesty's Privy Council in England, who, we may conclude from the precedent recorded in the case of King James the Second, when he had withdrawn from the Kingdom, would not succeed to the Government.

"As the Member now placed at the head of the Executive Council is junior to two of the Legislative Council, and as a collision might take place if he should claim to administer the Government in case of a vacancy, notwithstanding the seniority of those two Gentlemen, who have faithfully served Your Majesty both as Legislative and Privy Councillors, one of whom has also heretofore so conducted himself in the administration of this Government as to induce Your Majesty to convey to him Your Majesty's entire approbation of the manner in which he administered the same; We, therefore, the Members of Your Majesty's Legislative Council, most humbly pray that Your Majesty will, in Your wonted goodness, be graciously pleased to take into Your benevolent consideration, and to view with favor the merits and services of those two Gentlemen and of other Members of the same Council, and to order that the rank between the Members of the two Councils should be determined by the seniority of their respective appointments; and that the administering the Government, in case of a vacancy, should, as heretofore for a long time accustomed, devolve upon the senior Member of either Council, according to the date of their respective appointments, which we most humbly conceive would be attended with the most happy results, by preserving harmony between the two Councils, and thereby essentially promoting Your Majesty's interests, and insuring the quiet administration of Your Majesty's Government in this Province. And as in duty bound will ever pray."

And on the question whether the said Address be agreed to, the House divided.

"To the Bing's Mosi Excellent Majesty.

"The Humble Petition of Your Majesty's Legislative Council and Assembly of the Province of New Brunswick, in General Assembly convened:

" MAY IT PLEASE YOUR MAJESTY,

"WE, Your Majesty's faithful Subjects, the Council and Assembly of New Brunswick,

" Under

Brunswick, being apprehensive that the question of altering the wood duties, would again come under the consideration of Your Majesty and the Imperial Parliament, conceive it to be our duty, most humbly to call Your Majesty's attention to our Ad-

dress of February, in the year 1831, on this subject.

"Deeming it unnecessary to repeat the arguments which have again and again been reiterated, showing the effect that would be produced on the trade of this country and the British Empire in general, by any alterations in the scale of duties on Timber and Deals, we have little else to add, than to give it as our deliberate opinion, that the adoption of such a scale as was proposed in Parliament, in the year 1831, would nearly, if not entirely, annihilate the trade of this Province in these articles, and would inevitably lead to all the evil consequences detailed in the Address annex-

ed, and to which we beg leave most humbly to refer.

"If by the adoption of the proposed alteration of duties, the trade should be destroyed or rendered altogether unprofitable, the lumberers would be driven to seek out other avocations, and perhaps other countries; the establishments for carrying on the Timber and Deal trade would be broken up; and in the event of the ports of the Baltic being again shut against British commerce, and the requisite supplies of wood being then obtainable only from the British North American Colonies, a long time must clapse before a sufficient number of workmen skilled in the manufacture of timber, could be collected to furnish that supply; and it hardly could be expected that the lumberers would return to an employment, or that merchants would reinvest capital in a trade so uncertain in its duration, as was that out of which they had been thrown by an act that had ruined or deeply injured them, and increased the profits of Foreigners.

"We earnestly implore Your Majesty to take this our Petition into Your most gracious consideration, assuring Your Majesty, that it is only by a rigid adherence to the present protective policy in favor of the North American Colonies, a great portion of Your Majesty's subjects resident therein, will be preserved from inevita-

ble ruin.

"And as in duty bound will ever pray &c. &c."

"To the King's Most Breellent Majesty.

"The Humble Petition of Your Majesty's Council and House of Assembly of the Province of New Brunswick, in General Assembly convened.

" MAY IT PLEASE YOUR MAJESTY,

GUR Majesty's most faithful subjects, the Council and Assembly of New Brunswick, being greatly alarmed at a report which has reached this country, of an intention entertained by Your Majesty's Ministers, so to alter the duties upon wood imported into the United Kingdom, as to destroy the protection afforded to colonial over foreign wood by the existing system of duties—a measure (if carried into operation) fraught with consequences ruinous to all Your Majesty's North American Colonies, and to New Brunswick more extensively than to any other, beg leave to lay at the foot of the Throne, this our humble representation.

"Under this protecting system, originally adopted for the purpose of rendering the Mother Country independent of foreign nations for a supply of wood, a trade of vast magnitude has grown up, in which British Capital alone is engaged, and British

interests alone are promoted.

"We have not at command the documents from which we can accurately ascertain the actual extent of this trade, but from the information we possess we are induced to believe, that the number of vessels employed in the whole trade with the Canadas and these lower Provinces, does not fall short of two thousand annually, and that the number of sailors required for navigating them amounts to twenty five thousand.

"This is the staple trade of New Brunswick. In its two branches of Ton Timber and Deals, nearly the whole commercial industry of the country is interested, while the commercial establishments and outlay of capital are altogether arranged with a view to its prosecution.

"We have as yet no articles of export which would find a market in the United Kingdom but the produce of the forests; and if our means of paying for British manufactures cease, the importation of these manufactures must cease also.

"With a sinking commerce, our credit with the British merchant must wear away—the revenues of the country must dwindle—internal improvements be stopped—and the settlement of the wilderness lands in a great measure suspended.

"That the commercial intercourse between the United Kingdom and these Northern Colonies, especially this Province of New Brunswick, would be very greatly reduced, if not altogether annihilated, by withdrawing the protecting duties on our wood, and the consequent increase of supply of this article to the Mother Country from the Northern Powers of Europe, we fear, is too evident to need any proof; and we therefore contemplate the disastrous consequences of such a measure, with no

small degree of discouragement and dismay.

"But the commercial evils which would ensue to these Colonies, are not the only ones which we apprehend; we very much fear that the ruin of the wood trade with the United Kingdom, following so soon after the opening of the West India Colonies to the United States, would be viewed, by all the North American Colonists, as such an abandonment of their interests in Your Majesty's Councils, as could not fail to excite discontent, and have a strong tendency to shake the loyal affection which they have hitherto cherished with such honest zeal towards the Parent State; and there is no political evil which the inhabitants of this Province would more scriously deprecate than a weakening of their ties to that country, which they, and their fathers before them, have so steadfastly adhered to, throughout every change of fortune, prosperous or adverse.

"We forbear to enlarge upon the effects which a change of the existing policy with regard to the Colonial wood trade would have upon the general interests of the Empire, in its bearing upon the shipping interests, and as a nursery for British scamen; these are topics upon which Your Majesty's Ministers must have far more extended means of information, than are within our reach. But there is one most important consideration connected with this trade, which we cannot refrain from distinctly bringing to notice, and that is, the facility which it affords for the emigration to

lhese

these Colonies of the surplus population of the United Kingdom, and the means of employment which it lays open to the emigrant after his arrival in the Colony; circumstances which we do not hesitate to declare are both of them absolutely essential to the continuance of that tide of emigration, which now so fortunately both for the Mother Country and the Colonies, is directing its course to these British American shores. If the Colonial wood trade cease, there will be neither ships to bring out the emigrants, nor business in the Colonies to give them wages for their labour, until they can clear and cultivate their lands, nor a market for the produce of the soil, after their cultivation of it has rendered it productive.

"The Council and Assembly, therefore, most humbly implore Your Majesty to take the foregoing circumstances into Your most gracious consideration, and earnestly pray, that Your Majesty's Government may not be induced to alter the present system of protection to the Colonial wood trade, which is so vitally important to the interests of these North American Provinces, as constituent parts of the Bri-

tish Empire.
