OBJECTS:

I. To unite Young Churchmen in love for their Church and for each other, by means of an Organization, entitled, The Men's Guild of S. Alban the Martyr.

II. To utilize to the best advantage whatever time, talents or attainments, each one may have at his disposal to promote GOD'S Glory and the well-being of the Church, under the direction of the Clergy of S. Albans.

III. To encourage the study of GOD'S Inspired Word, the Liturgy and Principles of the Church of England, and to foster a taste for the various branches of Science and General Literature.

MEMBERS.

4

1. Men in full Communion with the Church of England, who have been Confirmed and are habitual Communicants, and who having signed the Constitution and Rules of the Guild, declare their desire to assist in carrying out its objects. These shall be styled Ordinary Members.

2. Men who habitually attend the Services of the Church of England, and who having signed the Constitution and Rules, make the same deelaration. These shall be styled Associate Members.

3. Men of age and good repute in the Church, who signify their desire to forward the interests of the Guild, and who shall be elected by a unanimous vote of the Subscribing Members, to an Honorary Membership, without the privilege of holding office or of voting at Guild Meetings. These shall be styled *Patrons*.

4. Ordinary Members, who have served the Guild well and faithfully for three consecutive years, and are recommended as such by the Council at a General Guild Meeting. These shall be styled *Fellows*, and be entitled to certain special privileges.

THE OFFICERS.

The Officers of the Guild shall consist of a Warden and Vice-Wardens, a Master and three De all *Gu* for

st of a l three Deputy Masters, three Secretaries and a Treasurer, all of whom shall constitute the *Council of the Guild*: And of this Council five members shall form a quorum for the transaction of business.

THE WARDEN.—The Rector of S. Albans, for the time being, shall be *ex-officio* WARDEN of the Guild, and the Assistant Clergy *ex-officio* VICE-WARDENS. Any other Clergymen of the city of Ottawa and neighbourhood, being in Priests Orders, may be elected as Vice-Wardens at a General Guild Meeting. The WARDEN, or in his absence, one of the VICE-WARDENS, shall open and close the Guild Meetings, with the office authorized, and they shall be *ex-officio* members of all Committees.

THE MASTER.—The presiding officer of the Guild, styled a Master, shall be a Layman chosen from the Ordinary Members, ard—after the third year from the date of foundation—from one of the Fellows. He shall take the Chair at all General Guild Meetings, summon and preside at Council meetings, and be *ex-officio* member of all Committees.

DEPUTY MASTERS.—There shall be *Three Sections* of the Guild, over each of which a Deputy Master shall preside. These Sections shall be styled the Sections of Theology, of Science, and Literature. The Deputy Masters shall be chosen from the Fellows or from the Ordinary Members.

- THE SECRETARIES.—There shall be a Secretary for each Section of the Guild, the Secretary of the Theological Section taking precedence, and undertaking the duties of secretaryship for the Guild generally. They shall record in a book the names of all who attend each meeting and the minutes of the business transacted, issue notices of meetings when required, and see that all the members sign the Constitution and Rules of the Guild.
- THE TREASURER.—There shall be one Treasurer, who shall keep an account of all moneys received from Entrance Fees and Subscriptions, Donations, or any other source, for the benefit of the Guild; also of payments made, which shall be only such as have been ordered by the Council. He shall also present an Annual Account of Receipts and Disbursements at the last general meeting in the month of June.

RULES.

1. There shall be an Annual Meeting of all the Members of the Guild on S. Alban's Day (June 17) in each year, at which a Statement of the and sha atte a se of t

of all Day ent of the Receipts and Disbursements shall be presented, and at which all the Officers for the ensuing year shall be elected. On that day the members shall attend Divine Service in S. Alban's Church, and a sermon shall be preached by the Warden or one of the Vice-Wardens.

2. There shall be a General Guild Meeting on the first Tuesday evening of each month from October to June (inclusive), at the hour of 8 p.m., when Reports from each of the Sections shall be presented, and general business shall be transacted.

3. There shall be a Weekly Meeting of the members of each Section during the same period, or oftener if necessary.

4. Each Section may make its own Rules or By-Laws, to be in force when approved by a general monthly meeting.

5. Each Ordinary Member or Associate shall, at least one week before admission, be proposed by one of the Ordinary Members or Associates and seconded by another, in writing, to the Secretary, and no objection having been raised, he shall be considered elected, and be received in due form; and in case any objection be raised by a member, he shall state the same to the Warden in confidence, then the Warden shall decide whether the objection le such as shall exclude the member proposed.

6. There shall be an Entrance Fee of One Dollar, to be paid on Admission by each Ordinary Member and Associate, and a Monthly Subscription of Ten Cents, to be paid on the first Tuesday Evening of each month, from October to June, and the balance due for the romaining Summer Months on the first ensuing General Meeting in October, or the whole Yearly Subscription may be paid in advance at a General Guild Meeting.

7. No Rule or Regulation of this Constitution, shall be altered unless after notice of one month and with the consent of two-thirds of the members present at a General Monthly Meeting of the Guild. ti

Master.—Has any objection been offered to his election?

Secretary .- No, sir.

Master.—Direct him to signify his assent to the Constitution and Rules, and to deposit his Entrance Fee.

(Here the new member shall sign the Roll, &c., and this done, the Secretary shall say:)

Secretary.—Sir, Mr. —— has signed the Roll, and his Entrance Fee is paid. The Master shall then conduct the new member to the Warden and say :

Master.—Reverend Sir, I hereby present to you Mr. ——, who has been duly proposed and seconded as Ordinary (or Associate) Member of our Guild, and has signed the Constitution and Rules, and I pray you to receive and introduce him accordingly.

The Warden shall then affix the Badge of the Guild, and taking the new member by his right hand, shall address him thus;—all the members present standing up:—

Brother —, I bid you welcome to the Guild of S. Alban the Martyr, and I give you the right hand of fellowship, trusting that henceforth we may be a blessing to you and that you may be a blessing to us: in the Name of the Father, and of the Son, and of the Holy Ghost. (All the members shall respond) AMEN.

Then the WARDEN, addressing the members present, shall say :---

Brethren of the Guild, I now introduce to you all Brother ———, who has been duly elected and received as an Ordinary (or Associate) Member, and I ask you to join with me in invoking the Blessing of God. ber
