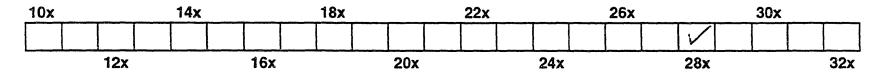

An Act to incorporate the Iberville Academy.

WHEREAS several of the inhabitants of the Parish of St. Preamble. Athanase, in the County of Iberville, have, by their Petition, prayed that with the view of promoting education in their locality, they may be incorporated under the name of the Iberville Academy, 5 and it is expedient to grant their prayer: Therefore Her Majesty, &c., enacts as follows:

Aubertin, Pierre Requier, and all and corporate name and gen-other persons who may by virtue of this Act replace or be united with eral powers. 10 them, shall be and they are hereby constituted a body politic and cor-porate, under the name of the "Iberville Academy," and under the said name shall have power to acquire for themselves and their successors, under any legal title whatever, and for the uses and purposes of said Academy, immoveable property or rentes constituées in money in 15 this Province, and not exceeding the net annual value of £600 cur- Property linrency, and may sell and alienate the same, and acquire others in ited. their stead for the purposes of this Act: For the administration and Powertomake government of the Academy they shall make such by-laws not con- By-laws. trary to law as they shall deem expedient, providing at the same time 20 for their amendment or repeal; and generally shall have all necessary

corporate powers for the purposes of this Act.

II. All the revenues of the said Corporation, from whatever source Purposes to they may be derived, shall be devoted exclusively to the maintenance which the of the Academy and to the furtherance of education, and to no other be applied. 25 purpose.

III. The members of the said Corporation shall have power, in ac- Power to apcordance with the provisions of their by-laws, to appoint one or more and instructpersons as attorneys, or preposés, for the affairs of the Corporation, and ors. for the administration of the property thereof, and to grant them 30 remuneration as such: They shall also have power to select and remunerate certain persons as instructors, and may confide the duty of instruction to them, subject to such conditions and in such manner as they may deem expedient.

The members of the said Corporation shall have power to enter Academy may 35 into an agreement with the School Commissioners of their School the elementary Municipality for the union of the elementary school with the Academy, school. and the Commissioners are authorized to that effect by this Act.
