An Act further to secure the Independence of Parliament.

WHEREAS it is expedient to repeal the Act passed in the twentieth Preamble. ho twith standar year of Her Majesty's Reign, intitled, "An Act further to 20 V. c. 22. These free auble, there secure the Independence of Parliament," with a view to amend its provisions: Therefore Her Majesty, by and with the advice and 5 consent of the Legislative Council and Legislative Assembly, enacts as follows: follows :

The 201. c. 22.

I. From and after the passing of this Act, it shall not be lawful for Office holders any person holding any office, place, commission, or appointment from not to vote at Elections. the Crown, or from or in any public department, or from the Legislative 10 Council or Legislative Assembly or any officer thereof, to vote at any election of a member of the Legislative Council or of the Legislative Assembly: Provided that nothing in this section shall prevent any officer Exception.

of the army, or navy, or any officer of the militia, or any Justice of the Peace, or any <u>Postmaster</u> whose salary or income as such does not exceed \$ per annum, from voting at such election, if not otherwise incapacitated. 15 exceed 3

II. The vote of every person rendered incapable of voting by section Votes of such one, shall be null and void; and for giving the same, he shall incur a persons to be null if given. 
