An Act to separate the Township of Georgina from the County of Ontario, and annex it to the County of York.

**W**HEREAS the inhabitants of the Township of Georgina, in Preamble.  
 the County of Ontario, have by their petition and by the  
 petition of their Municipality, prayed that the said Township may  
 be disunited from the said County, and may be annexed to the  
 5 County of York, and it is right and expedient to grant the prayer  
 of said petition; Therefore be it enacted, &c.,

That from and after the passing of this Act, the Township of Township of  
 Georgina, in the County of Ontario, shall be disunited from the Georgina  
 said County, and shall be annexed to and form part of the County annexed to  
 10 of York, for all purposes whatsoever. County of  
York.

II. And whereas the Provisional Municipal Council of the said Recital.  
 County of Ontario, has, for the erection of County buildings,  
 contracted a debt the greater part of which is yet unpaid; And  
 whereas the said Township of Georgina has not been, and will  
 15 not in anywise be benefitted by the erection of the said County  
 buildings, Be it therefore enacted, That no part of the said  
 debt shall be charged upon the said Township of Georgina, nor  
 on the said County of York, but shall be wholly borne by the said A certain debt  
 County of Ontario, any law to the contrary notwithstanding. to be borne by
