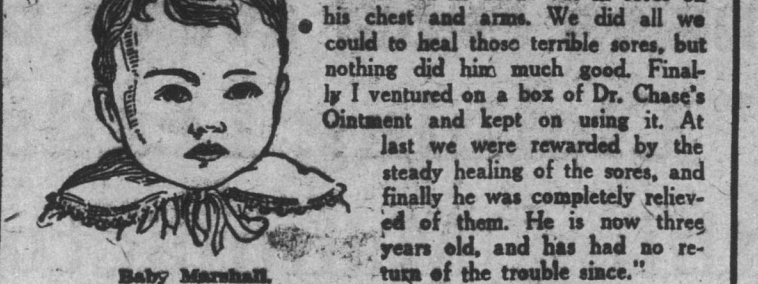

Nothing Doing for Squires-Coaker Party.

Why was the House of Assembly dissolved? Why did the Government appeal to the country for a general election? Why did not the Government remain in their offices for a full term? Wesley Church.

MISSIONARY SERVICES LARGELY ATTENDED.

Wesley Church can look back with pride on many successful Missionary anniversaries, but that of yesterday eclipses all previous occasions of the same class.

The morning preacher, Rev. Hammond Johnson, delivered a very eloquent sermon from John 3, 16, "God so loved the world that He gave His only begotten son," etc. He referred to the one hundred million heathens that is estimated that have not yet heard the Gospel. The magnitude of the task is appalling, but a promise of the Divine Lord comes, "I am with you" and we think of that incomprehensible "so," which we cannot analyze and few comment upon, we are left to understand that He loved so much that He gave His son. How God does love is inexpressible. The Church is not falling. When Carey went out in 1792 the offering to send out the pioneer was sixty-five dollars. Last year the Methodist Church of Canada alone raised one million, five hundred thousand dollars. But it is saddening to read that the people of Canada will spend \$350,000,000 for movies and chewing gum and tobacco, and give only ten million to extend the Kingdom of God. The last point was "our personal responsibility and all was just thrilling, as he spoke of all doing their duty like Nelson on the deck of the Victory. When a shot from the enemy splintered the mast and took a button off Nelson's shoe he said, "what would Hardy give to be here."

At night the church was thronged, over a thousand people being present. Rev. Dr. Fenwick led the congregation in prayer, and followed with a scriptural reading. His Excellency Sir Wm. Allard, who presided, delivered an excellent address on the work of the Wesleyan Missionaries in Fiji Islands during his residence of over twenty years in those Islands of the Southern Pacific.

Rev. J. G. Joyce gave an interesting report of operations of the Missionary Society to which Wesley Church has given over \$1,000 a year for the past seven years, reaching to \$1,254 in 1921, but dropping forty-six dollars the past year.

Rev. R. J. Power, M.A., followed with a magnificent address. He referred to a speech made by Sherwood Eddy in Massey Hall, Toronto, after his return from a tour in the East which he had the privilege of hearing, and held the closest attention of the large congregation. The speaker said we are only playing at Missions, juggling with the commission of Jesus Christ, spending millions on luxuries and even the most liberal denominations giving about six cents a head for Christian Missions. What is the root of the trouble? Mr. Power said my answer is want of vital faith in Jesus Christ. His message and His mission. Let us go over the fundamentals. Do we believe that Christ is the world's Saviour, and the sole Saviour? If we doubt that we are wasting time, money and effort, if we don't believe that He is the only way to the Father and the only mediator, the missionary enterprise is unnecessary. When Duff fainted while pleading for more men for India he was carried into the vestry. When someone who recovered he begged to be allowed to go out again and speak saying that if no young man would volunteer to go, although over seventy years of age, he would go out himself. We are responsible. Christ has committed to us the Gospel of reconciliation. Is your brother in India, China or Korea to be lost? What are you going to do about it?

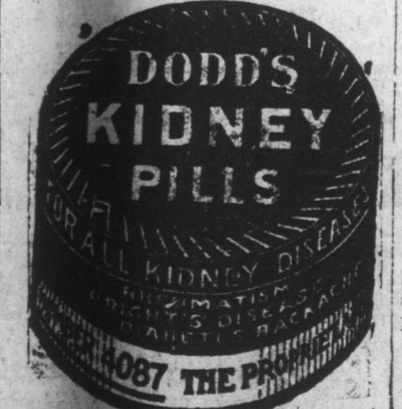

The "Slacker" Party.

PREMIER SQUIRES AND THE SOLDIERS.

He Appoints "Slacker" Member to a Fat Job on the Pension Board.

During the last General Election, Sir Richard Squires sought the aid of the returned soldiers and no words were too flowery to paint their "exquisite self-sacrifice," and no promises too great to make "the boys who by their sacrifice, their achievements and death have made the name of Newfoundland famous and won for us a place of honor in the world's record." But that was when Mr. Squires wanted their votes. Then he petted them, said nice things about them and made them all kinds of pledges—but it was only words. He was as sincere in his compliments as he was in his promises; and the proof of this is found in his insulting remark to a widow of a gallant captain of the Royal Newfoundland Regiment who laid down his life on July 1st, 1916, that "the soldiers did not go across to fight because they were inspired by any sense of chivalry or patriotism but for the money that was in it." The story of this callous insult was told by ex-President Harold Mitchell at the G.W.V.A. meeting on June 18th 1920, and that it raised a storm of indignation is not surprising. Newfoundland has been and is justly proud of the achievements of her soldier and sailor sons, but it has remained for one who occupies the position which he debases and disgraces, to insult those who have won the laurels of the war, and the memory of the splendid lads who so nobly gave their lives for their country in the struggle. Such reflections on the patriotism of our soldiers calls for the strongest condemnation and every man who donned a uniform in the time of crisis should know what to do with Squires and his candidates on Polling Day. The spirit which animated Premier Squires in this insult to the memory of the brave men who fought and died for Newfoundland in the war is still strong within him. He seems to have gathered to him every slacker in the country. In any other country the knowledge that a leader, himself within military age at the time of the War but who did nothing all through the years of the struggle, had gathered about him a party of slackers, would mean that an indignant public would rise en masse and hurl him and his slacker followers into oblivion, and we hope that in Newfoundland the electorate will do the same on May 3rd. But the list of slackers is not complete until we take in his two slacker editors, Mosdell, of the "Daily Mail," and Cloutier of the "Advocate." Cloutier has felt it necessary to minimize public contempt for the slacker class by pleading that he volunteered but, being a teacher, was given leave of absence; but Mosdell cares for nothing except place and pay. During the years of war he gave no service whatever and now Squires' reward to him is to put him in on the Pension Board at a huge salary. As for Cloutier, his pitiful excuse should not weigh a minute. Why should a teacher get leave of absence any more than any other class, and what sort of a spirit did the young man have who volunteered and then was willing to accept leave of absence because he was a teacher?

We call upon the returned soldiers and sailors and their relatives and those of the men who gave their lives overseas, to do their part on Polling Day by voting against the "Slacker Party."

BY THE GRACE OF SQUIRES

The Reids Cash In On the Humber.

In saying that "Armstrong ownership has succeeded Reid ownership in the Humber Valley," the Mail is neither critically correct nor spiritually true. Critically speaking, the Humber project provides for ownership by the Newfoundland Power and Pulp Company, in the directorship of which, at the outset, the Armstrong interests will predominate, but the Reid interests will be important, and the Armstrong interests may be sold or otherwise disposed of at any time, and the Reids come into actual control. We challenge disproof of this by a publication of the Humber Contract. The statement of the Mail that "the Reids will be out of control. The Armstrongs will buy them out," is grossly untrue, a falsehood deliberately told!

When the Mail says that the Reids were placed in possession of the Humber properties by Morine and Cashin, by "the Railway Contract of 1898" it "lies in its beard." Not an inch of Humber land or a quart of Humber water was given to the Reids by the 1898 Contract. Is the Mail ignorant, only, or intentionally untruthful, when making such an assertion? The Humber properties were given to the Reids by the Whiteway-Bond Operating Contract, 1893, which Morine opposed, and when Cashin was not in the Assembly.

"Not a dollar of money raised under the guarantee from the Government of Newfoundland will be paid to the Reids for the properties," says the Mail, and thereby asserts what it cannot in the very nature of things know to be true, and is not true in spirit. It may be that the agreement with the Newfoundland Power and Pulp Company stipulates the purposes for which the money raised under the guarantee may be directly used, but what about indirect uses? The price to be paid by Sir William Armstrong to the Reids, for the Humber properties, is the result of the guarantee given by the Newfoundland Government. Without that guarantee there could, apparently, be no Humber project, and hence Sir William Armstrong would not buy the properties, or pay the Reids, and therefore all the Reids are to get is the consequence of the Newfoundland Government's guarantee.

The Mail says: "The Reids could not arrange with the British Government because they could not show that the Newfoundland Government would guarantee. The Reids could not pledge support of the scheme to the Armstrongs of the Newfoundland Government. Only Sir Richard Squires could do that." We admit the truth of both assertions, and say, well, then, Squires made possible the fulfilment of the Reid scheme for the sale of the Humber properties! All that the Reids are to get from it, they get by the grace of Squires! If this be true, then, what nonsense it is to say the Reids get nothing from the guarantee. They get all by the guarantee.

Squires and Confederation.

The present Government has been accused of favouring Confederation with Canada, and colour has been lent this accusation by the statement made by Mr. W. F. Coaker, who said that negotiations are in progress for the sale of Labrador to our neighbouring dominion. The Canada-West India Magazine, published in Montreal, throws further light upon the Confederation question, when it publishes interviews with one Harry J. Crowe upon the subject of commercial and political union of the British West Indies and Newfoundland with Canada.

The name of Harry J. Crowe is well known here as that of a man whose interests are inseparably bound up with those of the Reids. In putting through the Humber Deal and taking over the Street Railway, the Government are associating themselves to a very large extent with the Reids. Possibly, then, it would not be too much to suggest that Mr. Crowe is the instigator of the Confederation idea in the minds of Messrs. Coaker and Squires.

In the interview mentioned above, Mr. Crowe quotes as follows from a letter received by him from Rt. Hon. Neville Chamberlain, Minister of Health in the British Cabinet: "I am wholeheartedly with you in believing that the entry of the British West Indies and Newfoundland into a political confederation with the Dominion of Canada would be of the greatest value to all three of the partners and to the Empire at large, and I believe success for this Imperial scheme will ultimately be achieved."

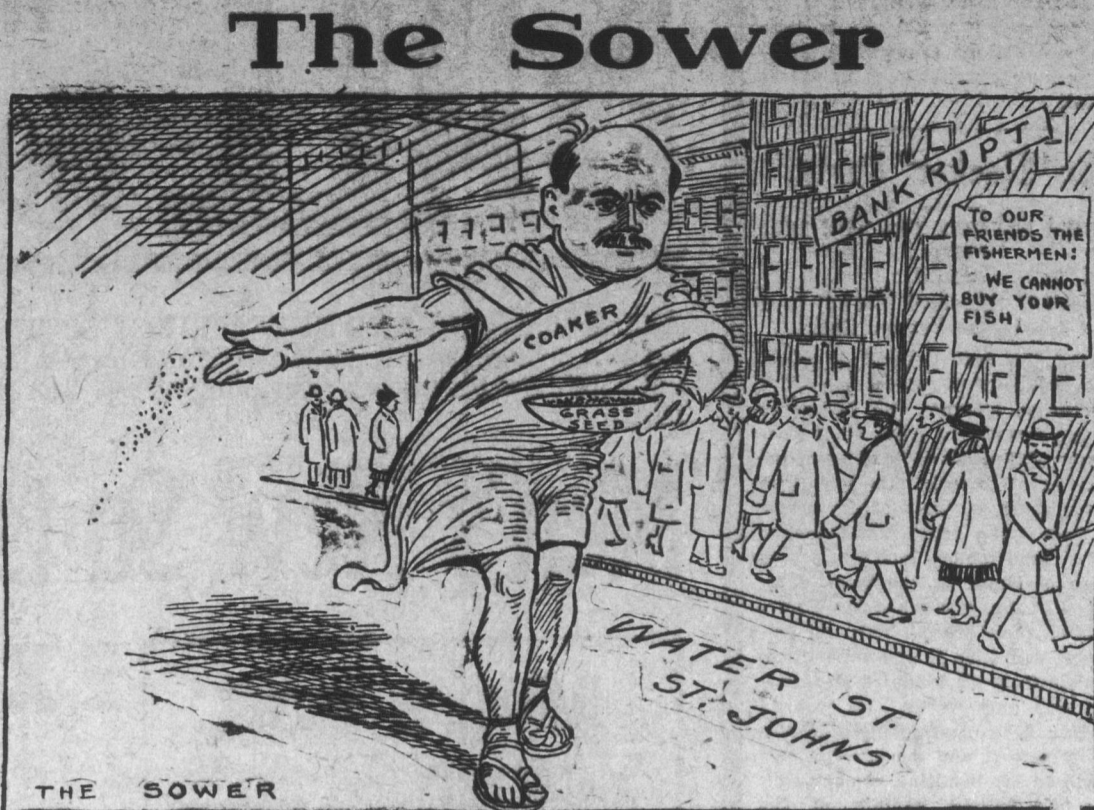
The letter proves beyond all shadow of doubt that the question of the confederation of Newfoundland with Canada has been removed from the remote, and is occupying the attention of British statesmen. Furthermore, it has been considered by our own pseudo-statesmen, Coaker and Squires, who have decided that the sale of our great dependency of Labrador will be a very good first move, and that this accomplished, the sale of the island of Newfoundland would soon follow.

EARLY CABLES.

BONAR LAW WILL NOT RESIGN.

LONDON, April 15. The Prime Minister has no intention whatever of resigning, said a statement issued to-night from No. 10 Downing Street, the official residence of Andrew Bonar Law. This constituted the Government's reply to statements in several morning papers which the Government could not allow to pass unchallenged. The official denial, however, it is generally agreed does not affect the situation previously indicated that Bonar Law's retention of office depended upon his health.

UNITED STATES SHIP PROBLEM.

WASHINGTON, April 15. A decision was reached by President Harding and members of the United States Shipping Board at a two hour conference yesterday to proceed at once to consolidation of foreign trade lines, and then offer these liners and ships for sale under authorization of the Merchant Marine Act of 1920, conditions on suitable guarantee of maintained service. The programme further provides that if the Government finds itself unable to sell the ships and line without "unjustifiable sacrifice," the policy will then be to proceed to direct Government operation as the last resort.

A MYSTERY OF THE SEA.

NEW YORK, April 15. A mystery of the sea involving a possible pitched battle between rum runners and pirates developed to-day, when the coastguard cutter Manhattan found abandoned the two masted schooner Patricia M. Behan, with her sails set and anchor dragging, at the entrance to Great South Bay. The deck was strewn with empty cartridge shells and there was signs of a struggle. The schooner was formerly the Edith Helen Vergo. The vessel probably carried a crew of ten men. Lashed to the deck of the schooner, which is finely built and of the Nova Scotia trading type, was a staunch twenty-five foot motor boat with the name "Maid of Canada, LaHave," painted on the stern. The Patricia M. Behan was formerly the Edith Helen Vergo, built at Sheet Harbor, Halifax County, in 1920, and believed sold to United States parties last fall, when the name was changed. She registered eighty-nine tons and sailed from here last November for Nassau, commanded by a Captain Thor.

L. G. TO CROSS OCEAN.

LONDON, April 15. According to the News of the World, former Premier Lloyd George will visit the United States and Canada in September.

AUSTRALIA AND IMMIGRATION.

LONDON, April 15. Ten thousand British emigrants will be sailing for Australia in the next five years, according to the scheme of the Empire Settlement Act, signed here yesterday. A novel feature of the scheme is that each immigrant must possess three hundred pounds on landing.

AUSTIN SLACK CAPTURED.

DUBLIN, April 15. The Irish Free State troops on Saturday captured Austin Slack, former Republican Minister for Home Affairs. According to the Exchange Telegraph, he was hiding in a ditch in the mountains near Clonmel.

INDUSTRIAL DEMOCRACIES.

CHICAGO, April 14. The wages of approximately two hundred thousand workers in the packing industry throughout the United States were increased an average of ten per cent. on Friday. Decision on the pay increase was reached by representatives of the management and workers, functioning through employees representatives. The plans which are in vogue at the Armour, Swift and Wilson plants, and which are known as "Industrial Democracies," system of employee representation, as an alternative for trade unionism, received their first trial in November, when the plant assemblies voted a wage reduction of ten per cent. The plan was assailed at that time as a device for reducing wages.

DRIVE TO THE RIGHT.

HALIFAX, April 15. "Drive to the Right," went into effect in Nova Scotia to-day.

DIED IN NORTH SYDNEY.

NORTH SYDNEY, April 14. Benjamin Calpin, 77, ship's carpenter, dropped dead at the marine slip here this morning. He was a native of Newfoundland and twice married. A wife and nine children survive.

On October 22nd, 1919 Squires' or the Daily Star edited by Dr. Mosely told at length what Squires was doing to do if he got in to make the Bell Island companies pay a large sum every year in the way of taxes. Today as we know Squires has been in service and for four years in service and has collected a dollar each year from the tax because they did not work the mines unless he did.

Even under

normal circumstances the real benefits of this ore are conferred on the Sydneys, which have developed into great industrial centres, manufacturing a Newfoundland product.

"The crumbs of the mineral wealth of Bell Island fall to Newfoundlanders. The substantial benefits go to Canadian shareholders and Canadian workmen.

"This unfair situation must be rectified. Newfoundland must be given possession of her rightful share of the benefits of the exploitation of her mines and of her minerals. This is one means whereby Hon. R. A. Squires proposes to increase our revenue without increasing the burden of taxation already borne by the people. Indeed, this is one way in which it is possible for him to lighten that grinding load now carried by Newfoundlanders.

"The second aim of Hon. R. A. Squires in connection with these Bell Island corporations is to ensure their payment of better wages to their workmen. 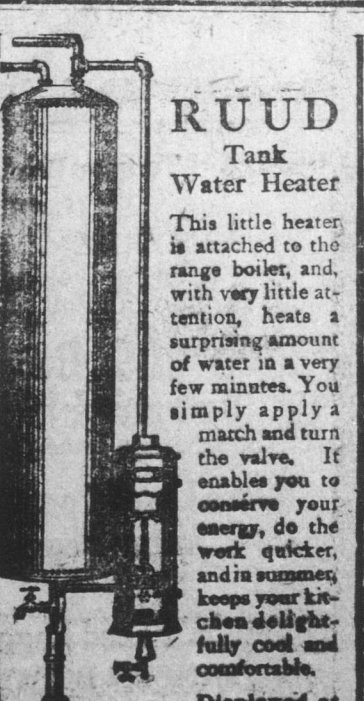

Young Mr. Winter, who came in from Port-de-Grave Saturday evening last, was a picture of dejection that indicated all too plainly that he has no hope of being elected there.

The reception given to John R. Bennett and A. E. Hickman at the Railway Station when they arrived from Harbor Grace Saturday night last is another confirmation of what St. John's will do on Polling Day.

ful days pay on the Kumber working in the woods.

Bennett's promise of a bounty on fish is what interests the fishermen. His promise to do away with useless offices, reduced expenditure and then taxation so that they can get their fishing outfit at a price that will make the fishery pay is what interests the fishermen just now and not the "Humber Deal!" If it is a good deal Bennett will carry it on better than the "Incompetents" and the young men will go there to work after the fishing is over.

The money thrown away on crazy undertakings the past year would give the fishermen a bounty of \$2 a quintal on fish not to speak of one dollar.

The worst of it is there is nothing to show for it, and it has doubled the per capita permanent taxation that every man in Newfoundland will have to pay as long as he is above ground.

We suggest in all sincerity that the best thing Squires, Coaker and Campbell could do when the expenditure of the past year is tabled by the Bennett Government would be to hide themselves.

It was only by an accident that such men could get control of the destinies of their country for three and a half years, now that one comes to look back on the period. It has been a fatal accident for poor old Terra Nova and will be the blackest page in our history.

If Squires has not wisdom he is endowed with a quality that often poses as wisdom namely "cunning." He succeeded for three years in bluffing a large per centage of the people of Newfoundland but his bluff will be called on polling day and he will be put in a position where he can do no more harm to this unfortunate country.

The Prime Minister has so far issued no Manifesto. In view of people's memory of the last one, he probably is quite enough not to do so as the public would take it as a "joke." It is useless to make any promises because the people would not believe him. When people are tricked once it is not easy even for Sir Richard Squires to trick them the second time.

We see no circulars now from Coaker about "White Nape" fish split to the "crux of the tail." How he fooled the people to be sure in the days of his impudent power and prosperity. The fishermen as well as every other class are only waiting for the day now to politically split him and his tyrants to the "crux of the tail." They will be genuine "White Napes" after May the 3rd.

What madness it is for the Government organs to be abusing the merchants at this particular time when the fishing is about to begin and so few are in a position to give out supplies.

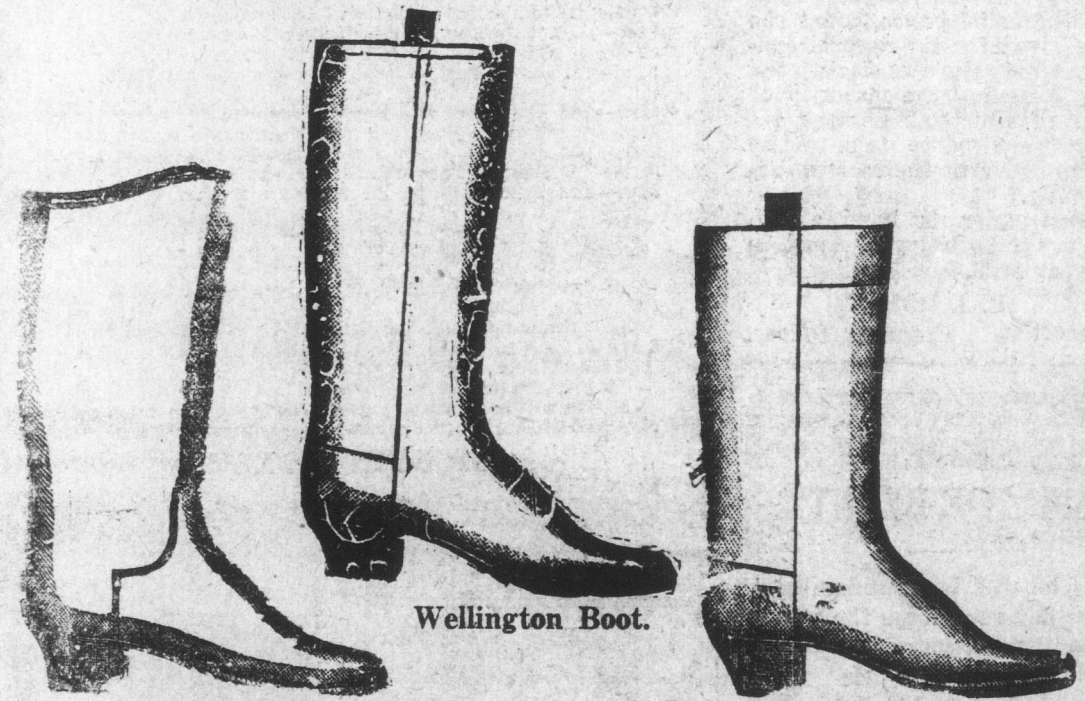

line. They are out for jobs, and government patronage. In Bennett's Party we have Monroe, Hickman, Crosbie, Cashin, Long, P. J. Moore, Ayre, Winsor, Harris, and are all suppliers for the fishery.

If the Government is turned out, these men will take new heart and no doubt give out supplies for the fishery because they realize that they will be helping to save the country from utter ruin. If the fishery is not carried on ruin will surely come and the Humber Deal with all its boasted potentiality will not prevent it. These merchants see the change and have come forward to avert it. They want to live themselves and to do so they know they must help the fishermen to live. Coaker's "no credit" stores will not help the fishermen. One Walter Monroe is as good as a dozen Coakers.

Fishermen who have money invested in the Union can hardly be blamed for following that money and trying to get it. There is another side to it, however. An Agricultural Meadow

A GOVERNMENT PROMISE UNFULFILLED.

In no part of their programme has the Government made such a dismal failure as that of agriculture. How have the wonderful promises of 1919 been fulfilled? Let us proceed to stock taking. We need not concern ourselves with scandals for the present. Turn back to the spring of 1920 just a few months after the Government came into power and you will find Dr. Campbell, Minister of Agriculture, addressing a meeting of farmers in the British Hall. There the Doctor in his breezy style denounces the manner in which the defeated administration has neglected agriculture. He grows livid as he recalls the thousands of dollars squandered in importing scrub stock. He contrasts things as they appeared to him and paints a picture of a land flowing with milk and honey. A place where a scrub animal could not be found and where every second farmer would be a Burbank. Four years was the limit allowed when every milkman would own a herd of thoroughbred cattle. Milk production would be doubled, and in addition, the disgrace of having to import meat and vegetables to supply home needs would cease forever. How was the miracle to take place? Let us quote the Doctor as he addresses the meeting: "We are going to start a model farm that will

be run on a paying basis. We are going to import pedigree stock which we will sell to farmers at auction. If you can't afford it we will start you off with some of the young stock which we will have on the model farm. Our stock there will increase so rapidly that we will, in a short while, be able to make the distribution to everyone in the country. The station will be St. John's and when our plans are developed St. John's will become the Agricultural Island." (How prophetic). Many who were present will remember the address. Look at conditions as they are to-day and then consider the Coaker-Squires' promises of 1919. They were going to make Newfoundland a place fit to live in. A. B. C.

Four Years in the Service of the Public—The Evening Telegram.

West St Barbe.

Where Glaring Electoral Anomalies are Freely Discussed and Condemned.

(Final Article.)

Port Saunders.—(By Aerial Mail, Delayed.)—A well known Newfoundland timber and mining pioneer recently landed at St. John's from the Rosalind and gave the Evening Telegram a brief interview in which he suggested a miscarriage of Hawkes Bay discovery and development honours. What alone is of public interest, if only for humane reasons, is that Port Saunders and Hawkes Bay have this winter saved north-west St. Barbe from starvation. This is an undeniable fact. Without the work provided, the wages paid and the food landed and stored at great risk and expense at Hawkes Bay the people of this coast would now be engaged in their first real life-and-death struggle with the wolf of poverty.

NEW TIMES STARTED A YEAR AGO

The earlier Newfoundland histories do not mention this shore. The first discoveries on the east coast, and wherever mention is made of the growth of the fishery and the possibilities of industrial and agriculture development nothing further north of the Humber valley was taken into account by early travellers and writers. Hawkes Bay, called Hawke Harbour on the Admiralty charts, was terra incognita until less than two years ago. The real credit for its discovery as a natural town site and shipping port must be given to the Aerial Survey Company—Messrs. Butler, Cotton and Bennett—working through the Hawkes Bay Trading Company. It is a discovery of the aeroplane, which brought these three young pioneers to the scene of their present business activity, and it now enjoys the distinction of being the first aeroplane centre on the west coast. It is linked by aeroplane with St. John's via Botwood and is the halfway stopping place on the aerial route to Labrador. The bay has now postal and telegraph facilities and its first claim to be considered a port of the Colony is based on the fact that the coastal steamer makes regular calls and also that the English steamer Penare took away the first cargo last year and that four or five vessels are expected this summer. Mining claims have also been taken up and the bay is now boldly on the map with a bright future for its new activities.

SINGLE MEMBER REPRESENTATION A FARCE.

I have woven into these travel articles the distressful story of the chief needs of the coast. These make a catalogue of troubles and grievances which are a standing condemnation of St. Barbe's faithless and useless representation and a strong argument in favour of a redistribution scheme which will terminate the divisions single member farce so frequently referred to in the newspapers. The coast is full of trouble, ashore and afloat, and it was the Government's mismanagement of shipping on this coast in the late fall which led Capt. James Barry, of Bay of Islands, to sarcastically declare in the Western Star that the West Coast has ceased to be a part of Newfoundland, while the same paper, supporting the Government, but sane on this redistribution question, has published several extremely informative and statistical articles showing the proportional anomalies of the electoral system, the injustice in the cases of St. George's and St. Barbe being most glaring when comparisons are made between them and the over-represented districts of Conception Bay.

On this coast we badly want all-the-year-round industries, and as we have so many signs that these are coming along we require, for this and many other reasons, better representation in the House of Assembly than we have had, or can ever hope to have, with a single member. This is a freak division. Two of the well known reasons why the west is neglected are St. John's indifference towards western aspirations and business progress and the failure of the west to wish and work sufficiently hard for a fuller representation in the House of Assembly. So long as the miserable political life of St. John's remains what it is—the forcing house for the keeping of political appetites at white heat—so long will the West Coast be neglected and the prosperity of the people be checked. It is a mistake to think the people of the west—St. George's as well as St. Barbe—are careless about political representation. In St. Barbe it is certainly not so. There may have been no sustained public agitation, even at Bonne Bay, the most important business centre of the division, but there is a strong undercurrent of feeling that the people have too long suffered a gross franchise injustice, that in fact while other places are constantly in the public eye and successfully clamour for Government benefits St. Barbe is still the Cinderella

POLITICAL ATTENTION AND ASSISTANCE. DIVIDE BOTH ST. GEORGE'S AND ST. BARBE.

Both divisions ought to be divided at once. The outgoing Government ought to have done the work. It was their obvious duty—an act of common fairness, a business of the heart, seeing that the whole country knows that St. Barbe in particular has been the plaything of St. John's party politicians for a full generation. St. George's has an admittedly powerful case for increased representation, but the one for St. Barbe appears to me to be even stronger. St. George's is unbroken territory with every settlement linked up by the railway, and it has the advantage of accessibility. Its claim is greatly strengthened by the proposed Humber Valley industry and the inevitable increase of population. But it is the great length of the coast line and the absence of travel facilities which make St. Barbe such an anomalous electoral division and an absolutely impossible proposition when it has to be canvassed by candidates and represented by a single member.

New members will find the burdens of responsible and active representation incomparably greater than they have been in the past. Not only has the fishery been temporarily lost to the coast but St. George's and St. Barbe are on the threshold of an era of immense industrial development, and it is therefore the duty of every man who has a vote to see that candidates pledge themselves to work and fight for the introduction of a redistribution bill in the first session of the new House. It is also the business of the people and the duty of candidates to see the party leaders are asked to give written opinions on the subject of a full and adequate enfranchisement of these two western divisions directly to the House meek. Election manifestoes and platform promises count for little in these days; written ones are preferable in a case like this. Things as they are cannot go on for another four years. Therefore, amend the Election Act this spring and either split the division in two (with a member for each side) or give the division as it now exists two seats. In this way will the politicians be doing something to help west coast industry in these new times. As it is now, the people of St. Barbe have practically no representation and their franchise privileges and rights are a farce.

WHAT THE POLLS PROVE.
It is because the men of St. Barbe know and condemn these things that they take such a small interest in the elections. Take the evidence of the polls. In October, 1913 election Clapp vs. Mott, St. Barbe had 2674 voters and the votes polled, 2124 showed 550 absentees. In November, 1919, Scammell vs. Keen, there were 3179 voters on the list but only 2167 voted. This failure of more than 1,000 voters to go to the polls is a significant expression of the contempt which the men of St. Barbe

felt for the iniquitous system of representation and a doubtful compliment to the men who asked for their votes. When only two-thirds of an electorate go to the polls it shows that something is wrong and in the case of the 1919 election the votes were cast by men who were sick and without hope. The case of St. Barbe is unique; of all the parliamentary divisions it has been the victim of the most flagrant neglect by the House of Assembly and the greatest sufferer from faithless and useless representation.
