

An Act to change the name of the College of Bytown, and to amend the Act incorporating the same.

WHEREAS the Roman Catholic Bishop of Ottawa, President of Preamble, the said College; the Superior of the said College; the Curé of the parish of Ottawa; the Director of the said College; the Professors of Philosophy and Belles Lettres, and the Bursar of the said College, con-5 stituted a body corporate, under the name of "The College of Bytown," have petitioned that the corporate name of the said corporation may be changed, and that the Act incorporating it may be amended, in manner hereinafter mentioned, and it is expedient to grant the prayer of the said petition; Therefore Her Majesty, by and with the advice and con-10 sent of the Legislative Council, and Assembly of Canada, enacts as follows:

Act relating to the said corporation, or of any instrument or proceeding to or in which the said Corporation by its former name may be, or may have been a party, or in anywise concerned or interested, but the same shall have full force and effect, and shall apply to and be continued with respect to the said corporation, by the name and style hereby assigned to it.
