A BILL for the encouragement of Education in this Colony.

[Words in Italics, and Sums in Figures, to be filled up in Committee.]

HEREAS, for the encouragement of Education, it is expedient that several sums of Moncy should be granted for the establishment and support of Elementary Schools throughout this Island, and that Regulations should be made for the proper expenditure of such Monies, and the management of the said Schools.

I .- Be it therefore enacted, by the Governor and Assembly, in General Assembly conve- £4985 annually ned, that from and out of such Monies as shall from time to time remain in the hands of the Colonial Treasurer, unappropriated, there be granted to Her Majesty, her heirs and succes-Years, from and after the passing of this sors, annually, for the period of

Act, the sum of £4985; which said sum of money shall be annually distributed, one part in the support of Schools appropriated to the instruction of the children of Members of the several Reformed Churches, and the remaining part in the support of Schools appropriated to the instruction of the children of Members of the Roman Catholic Church.

To be divided between Protestants and Catholics.

Il .-- And be it further enacted, that the said sum of £4985 shall be applied and Appropriation of expended under the superintendence of Boards of Education, to be appointed as hereinafter prescribed, in the several Educational Districts hereinafter named, in the proportions following, that is to say :- In the District of St. John's, £1250,- of which £320 shall be at the - disposal of the Protestant Board, and £930 at the disposal of the Roman Catholic Board ;-In the District of Brigue, the sum of £375, - of which £155 shall be at the disposal of the Protestant Board, and £220 at the disposal of the Roman Catholic Board ;- In the District (20) of Harbor Grece, the sum of £560, - of which £360 shall be at the disposal of the Protestant Board, and £200 at the disposal of the Roman Catholic Board; -- In the District of Carbonear, the sum of £600, -of which £350 shall be at the disposal of the Protestant Board, -and £250 at the disposal of the Roman Catholic Board ;-- In the District of Trinity Bay,

And be it further enacted, that immediately after the passing of this Act it shall and Boards of Educa- may be lawful for the Governor or administrator of the Government for the time being, by warrant under his hand and seal, to nominate and appoint, in each of the Educational Dietricts aforesaid, except as is hereinafter otherwise provided, Seven Persons to form and be a Protestant Board of Education for such District, in which Board shall be included the Senior or Superior Clergyman or Missionary actually resident or officiating within such District, of every religious denomination of Protestants therein, and the remainder of the said Board shall consist of Protestants of whom a majority shall be of the same religious persuasion as the majority of Protestants resident within the said District : Provided that it shall not be necessary to appoint a Protestant Board in any District where the amount hereinbefore appropriated to the Protestant part of such District shall be less than £40; but that in every such case it shall be lawful for the Governor or administrator of the Government for the time being, to authorize the Protestant Board most contiguous to such District to (50) expend the sum appropriated for such District, in such Educational purposes as shall be most for the advantage of the same.

V .- And be it further enacted, that immediately after the passing of this Act it shall and Catholic Boards. may be lawful for the Governor or Person administering the Government for the time being, of Education to by warrant under his hand and seal, to nominate and appoint, in each of the Educational Districts aforesaid, except as is hereinafter otherwise provided, Seven Persons, of the Roman Catholic Church, to form and be a Catholic Board of Education for such District; in which Board shall be included the Senior or Superior Clergyman of the said Church, actually resident or officiating within such District. Provided, that it shall not be necessary to appoint a Provise. X .- And be it further enacted, that no Book or Books shall be used in any School or Schools established, or to be established, supported or to be supported, by any Board or Boards of Education appointed, or to be appointed, under this Act, but such as shall be chosen (10) and selected by the Board or Boards of Education as aforesaid having the superintendance or management of the said School or Schools; Provided always, that no Board or Boards of Education constituted or appointed as aforesaid, shall, on any pretence, choose or select, for the use of such School or Schools, any Book or Books of a character or having a tendency to teach or inculcate the doctrines or peculiar tenets of any particular or exclusive Church or Religious Society whatever.

Old Boards to transfer property, &c. to schools under this Act.

XI.—And be it further enacted, that as soon as the said Boards of Education in the aforesaid Districts shall have been respectively constituted as hereinbefore provided, the several Boards of Education acting under any previous Acts for the encouragement of Educa- (20) tion, shall respectively transfer and pay over to the several Boards of Education to be appointed under this Act, all School-houses, Lands, Chattels, and Monies, obtained and held by them by virtue of any such previous Acts as aforesaid, remaining in their power or under their control respectively, first deducting thereout sufficient to defray any amount for which the said Boards respectively may, in the discharge of their functions, have become liable; and the said School-houses, Lands, Chattels, and Monies, shall be held by the Boards to be appointed as hereinbefore provided, to be by them applied for the purposes of this Act.

Appropriation of school houses to Protestant Boards.

XII .-- And be it further enacted, that the following School-houses, built by Boards of Education appointed under such previous Acts as aforesaid, shall be under the management of the several Protestant Boards of Education to be appointed under this Act,-that is to say,- (30) in the District of St. John's two Schools, one at Broad Cove and one at Quidi Vidi; in the District of Conception Bay, one School at each of the following places, that is to say Lower Island Cove, Western Bay, Crocker's Cove, Bay Roberts, and Brigus; In the District of Trinity, one School at each of the following places, that is to say, the North Side of Trinity Harbour, Catalina, New Harbour, Hants Harbour, and Old Perlican; And that in all other Districts where the majority of the Inhabitants shall be of the Protestant denomination, all Schools erected therein under the provisions of such previous Acts as aforesaid, shall be under the management of the Protestant Boards for such Districts respectively.

Appropriation of Catholic Boards.

XIII .- And be it further enacted, that the following School Houses, built as aforesaid, school houses to shall be under the management of the several Roman Catholic Boards of Education to be (40) appointed under this Act, -- that is to say, -- in the District of St. John's, Four Schools, -viz. One at Brookfield, One at Outer Cove, One at Logy Bay, and One at Windsor Lake: In Conception Bay, Four Schools,—that is to say,—One at Harbour Main, One at Musquito, One at Holyrood, and One at Harbour Grace: And that in all other Districts where the majority of the inhabitants shall be of the Roman Catholic denomination, all Schools erec-

ted thorein under the provisions of such previous Acts as aforesaid, shall be under the management of the Roman Catholic Boards for such Districts respectively.

XIV .- And be it further enacted, that the following Rates of I'ces shall be paid by Fees to be paid Pupils attending the several Schools to be established under the provisions of this. Act, to be appropriated towards the Salaries of the Masters of such Schools—that is to say,—the Sum of 5s, annualty for every Pupil learning Reading and Writing only, and the Sum of 7s. 6d. annually for each Pupil instructed in Reading, Writing, and Arithmetic: Provided Provise. that nothing therein contained shall be construed to prevent the Children of such persons who are unable, from poverty, to pay such Fees as aforesaid, from being instructed gratui-(10) tously in the said Schools.
