An Act respecting the admission into this Province of Foreign re-prints of British Copy-right Books.

BILL.

An Act respecting the admission into this Province of Foreign re-prints of British Copy-right Books.

WHÈREAS it would be of great advantage that Preamble,
 2 Foreign re-prints of British Copy-right Books
 should be allowed to be imported into this Province on
 4 payment of a fair duty thereon, the proceeds whereof
 should be appropriated as equity may require: Be it
 6 therefore enacted, &c.

and it is hereby enacted by the authority of the same, that whenever the Act or Acts of the Parliament of the United Kingdom now in force in that behalf, shall be so amended as to permit the importation into this Province of Books wherein the copy-right shall be subsisting, first composed or written or printed in the United Kingdom, and printed or re-printed in any other Country, and with regard to which the notice to the Commissioners of Customs required by such Act or Acts shall have been given, then it shall be lawful for the Governor in Council to impose an *ad valorem* duty not exceeding twenty *per centum*, on any such Books as aforesaid imported into this Province, and from time to time to alter the same (not exceeding in any case the rate aforesaid) and from time to time to establish such regulations and conditions as may be consistent with any Act of the Parliament of the United Kingdom then in force, and as he may deem requisite and equitable, with regard to the admission of such Books and to the distribution of the proceeds of such duty to or among the party or parties beneficially interested in the copy-right; Provided always, that no such order in Council shall impose a duty on the importatation of any Book which may now be imported free from duty.

II. And be it enacted, That the word "Book" in this Act shall include every Volume, part or division of a Volume, Pamphlet, Sheet of Letter Press, Sheet of Music, Map, Chart, or Plan separately published.
