### SPEAKERS' PROGRAMME - 1979/80

Each year, the Department of External Affairs, under its Academic Relations Programme, draws up a list of officers who are prepared to give talks or participate in seminars at the invitation of universities, community groups, clubs, associations and organizations interested in international affairs. We therefore encourage you to think of "External Affairs" when you require an expert in the areas of departmental activity outlined in this booklet. Since speakers talk best about topics with which they have worked for years, the booklet is arranged by subject, to help you select the most appropriate speaker.


Not all major themes of foreign policy appear on the following list and it need not be regarded as exclusive in terms of topics or individuals. Special requests are always welcome.

While the formal type of lecture is not excluded, a preference is expressed for the informal type of gathering, such as the seminar or working group. Such gatherings are generally found to be more satisfying to the participants and to yield better results. Although our speakers are not expected to perform as spokesmen in the official sense, they will refer to government policies, comment on subjects of Canadian interest and analyse world affairs drawing on their professional backgrounds. The speakers would be prepared to answer questions during ensuing discussions. Unless prior consent from the Department has been obtained, these talks are not to be reported or attributed in the media. In this way, it is hoped that a more frank and effective dialogue can be developed.

Requests for speakers should be directed to the Academic Relations Division; if possible, several weeks in advance. Travelling expenses required to implement the program are normally met by the Department. Every effort will be made to fill requests for speakers; however, the Department's ability to respond to invitations is subject to the availability of travel funds, pressure of work in Ottawa, and prior commitments by speakers. In most cases it would be desirable to make arrangements for the speaker to visit several centres or universities on a circuit, as this would represent a more economical use of resources and might help to meet requests more equitably.



We would also like to draw your attention to the services provided by the Department's Domestic Information Programs Division. This Division has, as one of its prime functions, the fostering of a greater awareness of foreign policy matters among the Canadian public. In this regard, the Division is prepared to provide written and other information material on Canada's external relations to members of the public, on request.

### PROGRAMME DE CONFÉRENCIERS 1979/1980

Dans le cadre de son programme de relations avec les universités, le ministère des Affaires extérieures dresse, chaque année, une liste de ses fonctionnaires disposés à donner des causeries ou à participer à des séminaires sur invitation des universités, des groupes communautaires, de clubs, d'associations et d'organisations intéressés aux affaires internationales. C'est pourquoi nous vous encourageons à penser aux "Affaires extérieures" si vous avez besoin d'un expert dans les domaines d'activité décrits ci-après. 

Nos conférenciers n'agissent pas à titre de porte-parole officiel; il va de soi cependant qu'ils parlent des politiques du Gouvernement, commentent des sujets d'intérêt pour le Canada et analysent les affaires mondiales, à la lumière de leur expérience professionnelle. Les conférenciers répondront également aux questions qui leur seront posées à la suite de leur exposé. A moins d'autorisation préalable du Ministère, il ne doit pas être fait état de ces exposés dans les médias. Nous espérons susciter ainsi un dialogue plus franc et plus fécond.

Les demandes doivent être adressées à la Direction des relations avec les universités, dans la mesure du possible plusieurs semaines à l'avance. Le Ministère s'efforce d'acquiescer à toutes les demandes, mais comme il assume normalement les frais de déplacement, il doit tenir compte des fonds disponibles, des besoins du service à Ottawa et des engagements antérieurs des conférenciers. Dans la plupart des cas, il est préférable qu'un conférencier visite plusieurs centres ou universités lors d'une même tournée, ce qui permet d'utiliser les ressources d'une façon plus économique et de répondre aux demandes d'une manière plus équitable.



Nous attirons également votre attention sur les services rendus par la Direction des programmes d'information au Canada, dont l'un des principaux rôles consiste à sensibiliser le public canadien aux questions de politique étrangère.
