THE VOTERS LIST.

How the Electoral Franchise Act works.

At last session of the Dominion Parliament amendments were made to the Franchise Act which make quite a change in the mode of applying the various provisions of the act.

The preliminary review for this city and county will be made by taking the list of electors of three years ago, the one on which the last general election was run, as a basis, and comparing it with the assessment rolls for the city, and the County Municipality rolls. One supplementary list will be made up of the new names to be added and corrections to be made, and another supplementary list showing the names to be struck off. A notice is given or will be given regarding this proceeding, as the law is about on that point. Any person whose name was not on the list three years ago, or who is entitled to have his name put on the list now, can have it done by making a declaration giving his name, residence and the kind of qualification in his own handwriting, and the declaration to be delivered to the Registrar.

Any owner of real estate in the city assessed last year, and whose name is on the assessment list will be placed on the supplementary list of new electors, unless (if his name was not in the list three years ago, so it will be unnecessary to send in any declaration regarding himself.

Any tenant should send in a declaration showing his qualification. Sons of owners, 21 years old, and living home, if the property is assessed sufficient to give them the vote, should send in their declaration.

THE FRAUDS. There will be a final revision of the list at a later period (in October probably) and the names on the list will be printed and will be open for inspection at three places in this city.

There must be 21, a British subject, and the name under one or other of the following classes:

1. OWNERS OF REAL ESTATE. Any owner of real estate, or his "tenant" or "agent" who, however, have been in possession for a year.

2. PAYING TAXES. Any person who has paid or is paying taxes on real estate for a year.

3. HAVE AN INCOME. Of \$500 a year in money or money and kind, provided he has been in possession of the property for a year.
