An Act to amend the Act intituled, "An Act respecting the Assessment of Property in Upper Canada."

WHEREAS certain Manses, Parsonages, Deaneries and residences of Ministers of Religion, attached to places of worship, or appendant thereto, as and being the property of the congregation attendant at such places of worship, or the Trustees, Incumbent and Wardens or Elders thereof, or the Synod, Presbytery or Conference of the religious body to which such congregations belong, and being the residence of the Minister of religion, officiating in such place of worship, should under certain circumstances be exempt from taxation; Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

- 10 **1.** All such Manses, Parsonages, Deaneries, and the buildings thereto appertaining in Upper Canada, and all lands comprised therewith, and on which the same are erected, when not including more than one acre, shall be and the same are hereby exempted from taxation.
