An Act to divide the Township of Windsor, County of Richmond, into two distinct Municipalities, one of which to be designated as the Township of St. George de Windsor, and the other to remain designated, as at present, the Township of Windsor.

An Act to divide the Township of Windsor, in the County of Richmond, into two distinct Municipalities.

WHEREAS it is expedient to separate the Township of Windsor in the County of Richmond, into two distinct Municipalities, inasmuch as such division of the said Township will greatly promote the welfare and convenience of its inhabitants: Therefore Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:—

Preamble.

I. Upon, from, and after the first day of January one thousand eight hundred and sixty-one, the first, second, third, fourth, fifth, and sixth Ranges of the said Township of Windsor shall constitute a separate Township or Municipality, by the name of the Township of St. George, de Windsor, and the said Township of St. George de Windsor shall hereafter be deemed to be such separate Municipality for all Municipal, School, Judicial and other purposes whatsoever, in the same manner and to all intents and purposes as though the said Township had always been distinct from, and had never formed part of said Township of Windsor, and shall enjoy all the rights and privileges appertaining to other Townships in Lower Canada; and the remainder of said Township shall remain as at present, and form the Municipality and Township of Windsor.

New Township constituted out part of Windsor.

Remainder to be a Township by itself.

II. All, and every, the debts of the present Municipality of Windsor shall be divided between the respective Municipalities of Windsor and St. George de Windsor, by a Bye Law to be passed by the County Council to that effect, and as soon as said debts shall have been divided as aforesaid, each of said Municipalities shall be bound to the payment of the share of the said debts which shall have been so assigned to it as aforesaid, as though such share of the said debts had been incurred by such Municipalities respectively.

Division of the debts of the old Township.

III. This Act shall be deemed a Public Act.
