AMERICAN AGRICULTURIST.—We have received a copy of this lively and instructive journal from John Anderson.

MR. FRASER'S SON.—We regret to hear that the doctors have been unable so far to extract the bullet from the head of little Fred. Fraser. The bullet travelled along the bone, cutting a groove as it went, and getting gradually deeper until it wedged itself firmly in the bone, at the same time flattening and spreading out. A fresh orifice had to be cut in the scalp to reach the ball, but it was so tightly wedged in that extraction could not be accomplished. It is hoped, however, that by keeping the wound open for a time a sloughing and suppurating action will be set up that will loosen the bullet. Chloroform was used in the unsuccessful operation, we believe.

North Wellington Local Election.

The Globe, referring to the meeting of the Reform Convention on Saturday, says:—

There is no doubt that if Mr. McKim be the nominee of the Convention, he will be returned by an overwhelming vote. Wellington was one of the counties gerrymandered in so unscrupulous a fashion by Sir John A. Macdonald, and the result is seen in the small majority commanded in the North Riding by Col. Higinbotham, the member for the County of Wellington, and the loss of the Centre by the Liberal party in the late contest. But in the contest for the representation of the North Riding in the Local House Mr. McKim can defy all enemies, and will make short work of the man who, a Reformer to-day and a Tory to-morrow, has taken the field as the candidate of the Opposition.

Mr. McKim has been a most painstaking and faithful representative of the North Riding, and in personal devotion to the interests of his constituents, both individually and collectively, has been beyond all praise. We hope to see him in a very few weeks once more in his place in the assembly, doing as in the past good service to his party and his constituency.

A GOOD TRICK.—A good story comes from an 'S. Eastern college. The students in divinity were compelled, at stated seasons, to write a prayer for the critical eye of the professor. This professor was of the crankiest nature possible, and the unledged Bechers could never manage to blend, in any harmonious whole, adoration, application, thanksgiving and confession, so as to suit his taste. One morning one of the students, being proficient in stenography, was moved to take down the professor's own opening prayer verbatim, and having written it out, he handed it in for criticism. Wellington County Council.

February 4th.

The Council met at ten o'clock, the Warden in the chair; present all the members, except Messrs. Broadfoot, Dalby, and Meiklejohn.

Mr. Mair brought up the report of the special committee appointed to strike the standing committees for 1874, as follows:—

FINANCE.—Messrs. Leslie, Mitchell, Ogden, Darby, Teeter, Raymond, Kilgour, Leeson.

ASSESSMENT.—Messrs. Mair, Howard, Henderson, Dawson, Robb, Frain, Stevenson, Gibson, Roberts, Rea, McKim, Nichol, McMillan, Hollinger, Dalby, Golden, Anderson.

ROADS AND BRIDGES.—Messrs. Dalby, Jelly, Swan, Duffield, McManus, Hamilton, Miller, Mitchell, Hanson, Broadfoot, O'Donnell, Teeter, Leeson.

The report was adopted, on motion of Messrs. Mair and Frain.

Mr. Darby brought up the report of the Commissioners of the Guelph and Fergus Road. Read, and referred to the Committee on county roads.

The Warden read a petition from Messrs. Cyrus Sargent and John Hill, trustees of school section No. 7, Garafaxa. It stated that at a meeting of the Township Council of West Garafaxa on 21st June last, a resolution was passed to dissolve the union existing with school section No. 7 and East Garafaxa. Against this decision the trustees appealed and were granted an arbitration to take place on the matter, in accordance with the School Act. A petition from 44 inhabitants of the section, to the same effect, was also read.

Some conversation took place on the matter, and Mr. Black, of Douglas, was allowed to address the Council on the question. He said that the movement for division originated with some persons who were dissatisfied with an addition proposed to be made to the school house, which was, and who said that if the trustees went on they would endeavor to leave the section of the Centre. There were 110 scholars, however, and the Inspector compelled the trustees to provide the additional accommodation. As these dissatisfied persons could not get out without dissolving the union, they got the Township Council to pass this resolution. The trustees only fourteen remained in the section who wished to leave the union, and only seven of these sent children to the school, to the number of fourteen. They petitioned the Township Council because they wanted to reduce the section to one teacher only. He asked that the matter should be fully investigated.

Mr. Gibson moved, seconded by Mr. Teeter, that Mr. Darby, the County Judge, and Mr. Fordyce be a special committee to decide the appeal of the trustees of Union School Section, No. 7, East and West Garafaxa.—Carried.

A petition from J. Morrison Dunn, Elora, to be appointed a member of the Board of Examiners of Public School Trustees.

The foregoing were referred to the proper committees, together with several accounts.

The Warden read a statement from the Treasurer, in reference to the County Finances, dated Jan. 27. He stated that the public accounts were ready for audit. \$9,000 borrowed from the Ontario Bank had been paid back with interest. He had received \$8,236 of the county rate during December, and \$25,473 in January, \$20,473 still due. Part of this had since been paid. For the year 1873, the gross receipts were \$96,474, and the expenditure \$88,873, leaving a balance of \$7,601 carried forward to the general fund. To meet county liabilities between now and July 1, there was \$39,906 of assets—uncollected rates, &c.—the whole of which was required to meet the grants made by the Council. Eighteen January debentures, or \$7,791, had been redeemed; and \$5,922 was provided to retire debentures maturing on July 1. The county debt would then be \$95,408. A statement of the non-resident land fund for 1873 was also read.

Referred to the Finance Committee.

Moved by Mr. Leslie, seconded by Mr. Nicoll, that the Reeve of each municipality in this county do at their first meeting in each year give the name and P. O. address of their respective Treasurers and Clerks to the Clerk of the Council in order that they may be published in the minutes.—Carried.

A by-law was brought in by Mr. Leslie and Mr. McMillan to postpone the sale of lands for taxes until further directed by the Council.

Mr. Dawson said that there were 40,000 acres of non-resident lands in his township, and it was an injustice not to have a sale every year.

Mr. Leslie said the only object of the by-law was to comply with the statute. A sale had been held last October in the county, and there could not therefore be another sale until next October.

The by-law was then read a first and second time, and the Council adjourned.

Mr. Baird of Kincardine has been re-elected Warden of Bruce.

Prof. Anderson, the well-known conjurer, is dead.

Social and Presentation.

On Wednesday evening a social was held in the basement of the Wesleyan Church, and was very numerously attended. There must have been nearly 400 persons present, and \$43 was taken at the doors. This sum will be a "substantial brick in the new church," to which object it is to be devoted. The operation of tea-taking was a long one, and only concluded at half-past nine. This necessitated the omission of the greater part of the programme. The choir gave the "Hallelujah" choruses from the Messiah; a little girl named Nellie Foster sang a solo very prettily; and the Misses Stevenson played and sang a good duet.

The most interesting part of the evening's proceedings, and one of the reasons for holding the social, was a presentation to Mr. Hough, who has been for so long the teacher of the Bible Class in connection with the Wesleyan Sunday-school. It was a large framed picture, comprising fifty-seven separate photographs. Mr. Hough's own portrait is in the centre, and around him are ranged portraits of the members of his class. The likenesses are good and well taken, and the whole work is very creditably done.

Mr. Gilbert Maddock read the following address:—

To JAMES HOUGH, Esq.,

Honored and Dear Sir,—We, the members of your Bible Class, have for some time felt a desire to express to you the sincere regard which we feel for your personal character, and also our high appreciation of the valuable instruction which you impart to us from Sabbath to Sabbath.

Your able expositions of the Scriptures have, we trust, led us to a better understanding and a higher appreciation of the Sacred Volume; whilst your uniform kindness, and your manifest anxiety for our spiritual welfare, have greatly endeared you to us; and we sincerely hope and pray that the valuable course which we have so often received from you may have a lasting and salutary effect upon our minds, and hearts, and lives.

Your consistent and useful life we see exemplified in the inspired aphorism, "The hoary head is a crown of glory if it be found in the way of righteousness"—and we do sincerely pray that you may still be spared for many years to benefit and bless the church of which you have been so long an honored, active, and useful member.

Please accept this picture as a small but sincere expression of our gratitude and esteem; and when you look upon these likenesses which surround your own, we ask you to pray for us, that our future lives may be lives of honor, and piety, and usefulness.

I have been endeavoring to cultivate an acquaintance with him these many years, have been his companion at home and abroad, and watched his conduct, scrutinized his actions, and pryed into his motives, and although I do not always feel on the best of terms with him, yet I disclose more to him than to any other person my private concerns. I may be mistaken in him, but he means to be as good as I do. One thing I know, he has a special regard for young men; but having frequently detected his liability to err, I dare not place implicit confidence in him. However, as he is a personal friend of mine, I will pardon him. I leave him for you to form your own estimate of his character.

I sincerely thank you for your handsome present. You may rest assured I will treasure it as a memorial of your kind regards so long as I live, and leave it for future generations to see and to say, "Behold how they loved him."

YOUR TEACHER.

London, Feb. 4.—Late advices from the Gold Coast report that the Ashantees have released the German missionary whom they held in captivity, and sent him to Sir Garnet Wolsley with proposals for a treaty of peace. Twelve hundred British troops have advanced to within a day's march of Coomassie, the Ashantee capital. As yet there has been no opposition to their advance. The troops were healthy. The Fantee carriers have deserted the British army. Up to Wednesday 108 Liberals and 141 Conservatives had been returned to the new Parliament. The balance of parties in 208 other places remains unchanged. The Conservatives have gained 30 seats previously held by Liberals; and the Liberals have ousted nine Conservatives. The Conservative journals are jubilant over the results of the elections.

London, Feb. 4.—Additional returns give the Liberals a gain of six, and the Conservatives twelve.

Additional returns show that the Conservatives have gained one seat each at Buckingham, Canterbury, Christ Church, Marylebone, Newcastle-on-Tyne, Salisbury, and St. Ives; and the Liberals have gained one each at Abington, Harlepool, Mounthorn, and Stockport. Liberal members of the old Parliament re-elected from Darlington, Huddersfield, Hull, Leicester, and Perth by large majorities. Mundella and Roebuck are elected from Sheffield; Roebuck headed the poll by 1,300 votes. Forsyth (Conservative) at Marylebone had a majority of 1,500. Sir Joseph Colvin (Radical) was returned from Newcastle-on-Tyne by 2,000 majority. Home Rule candidates are elected in the Irish constituencies of Mallow and Yonghul County.

New York, Feb. 5.—Weather clear and cool.

The Bluff City Oil Works at Memphis were burned last night. Loss \$150,000.

It now transpires that the recent dissolution of the heavy cotton firm of Thos. Perkins & Co. was owing to the fact that all of the five clerks had been speculating for two years, and making good their losses out of the firm's funds.

Work on the Colossal Railroad Tunnel through Bergen Hill, N.J., begins to-day. Five hundred men will be employed night and day for two and a half years, and seven shafts to be sunk.

It is apprehended that the general cigar-makers' strike in Havana will materially enhance prices here.

New York, Feb. 4.—Havana advices to the 28th report that a serious mutiny has broken out among the Spanish troops in Trinidad, owing to their receiving no pay for six months. Five officers have been killed.

Board of School Trustees.

On motion Dr. Keating was called to the chair, pro tem., when Mr. Newton moved, seconded by Mr. Knowles, that the thanks of this board be due and are hereby tendered to H. W. Peterson, Esq., for the kind and courteous manner in which he has presided over the deliberations of the Board during the past year.—Carried unanimously.

Moved by Mr. Newton, seconded by Mr. Inglis, that H. W. Peterson, Esq., be chairman of this Board for the ensuing year.—Carried.

Mr. Peterson returned his cordial thanks to the Board for again appointing him chairman. He had always endeavored to do his best, and was happy to say that the deliberations of the Board had always been of the most pleasant character. He referred to the bright prospects before the Board in the expected early completion of the Central School. Notwithstanding that the expenditure on it will be large, the ratepayers had liberally seconded their efforts. He hoped to retain his connection with the Board till that building was completed, and their school system put on a proper and satisfactory basis, and then he would gladly retire with the feeling that he had done all he could for the interests of education in the town.

Mr. Raymond moved, seconded by Mr. Stevenson, that the Rev. Robt. Torrance be Secretary of the Board for the year. Carried.

Moved by Mr. Newton, seconded by Knowles, that G. A. Sandilands, Esq., be Treasurer of the High School for the current year.—Carried.

Moved by Mr. Raymond, seconded by Mr. Kennedy, that the following be a committee to draft standing committees for the year: Messrs. Kennedy, Knowles, Inglis, Stevenson, Peterson, and Dr. Keating and the mover.—Carried.

The Board adjourned for ten minutes to allow the Committee to meet and bring in their report.

The Rival Clansmen

A Scottish Vendetta.

CHAPTER XVII. AN IMPORTANT CONVERSATION, WHICH INDICATES THE RESULTS LIKELY TO ARISE FROM IT—NEW DANGERS AHEAD.

Helping himself to another draught of the mountain dew, which was already deepening the red on the point of his nose, Gregor cleared his throat and commenced—
