An Act to amend chapter 85 of the Consolidated Statutes for Lower Canada, respecting Seizures and Sales by authority of justice.

HER MAJESTY, &c., enacts as follows:

Preamble:

I. Notwithstanding anything to the contrary, in the third section of chapter 85, of the Consolidated Statutes for Lower Canada, "intituled *An Act respecting Seizures and Sales by authority of justice;*" or in the Act passed in the 23rd year of Her Majesty's reign, and intituled *An Act to exempt certain articles from seizure in satisfaction of debts."*

In all cases wherein a writ of execution issues upon any judgment of any court in Lower Canada, obtained before the nineteenth day of May, 1860, (the day of the passing of the above cited act,) the goods and chattels exempt from seizure under such writ, shall only be those which were exempt from seizure in virtue of the ordinance 2 Vic, cap. 28, subject always to the provisoes and restrictions therein contained; And thesaid ordinance shall, as regards the judgments above referred to, be revived and have force and effect, and the said Act 23 Victoria, and the third section of chapter 85 of the Consolidated Statutes of Lower Canada, shall not apply to or affect the said judgments.

Certain exemptions from seizure, not to apply to judgments obtained before 19th May, 1860.
