DOMINION DASHES.

Applications for liquor licenses in Montreal within the past few days number 650. The Quebec and Lewis Electric Light company has been started with \$50,000 capital.

The 3-year old daughter of David Babcock, Belleville, was burned to death Tuesday and died Friday from her injuries.

There is trouble in the St. Jean Baptiste society in Montreal, owing to the purchase of a \$20,000 monument, of which only \$2000 has so far been subscribed.

There was a strong rumor in Montreal on Saturday that a syndicate of contractors had guaranteed the construction of the Pacific railway bridge at Lachine, which is to cost \$3,000,000.

The only child, a 2-year old boy, of Mrs. E. Galbraith, Fort Hope, was burned to death last week. She left him alone in the house and he got some matches to play with. Thirty hours of terrible agony resulted in death.

General Freight Agents to Meet. The General Freight Agents association will hold their annual general meeting at Hamilton, commencing on Wednesday next. A discussion will come up on the question of the transportation of crosses and long cars, and the transportation of live stock; transportation of government stores; the declaration to be required from shippers; the quantities of bulk freight which shall be considered a car load. A lively time is expected, more especially as the Canadian Pacific is opposed to all rules which will make the time of the live stock in short cars as cheap as in long cars, of which their entire equipment is made up.

RIPE FOR A RIOT.

Anarchists at Industrial Centres Preparing for a Revolution. PITTSBURGH, Feb. 8.—An official says the story that a socialist revolution was being prepared for has some foundation. Dynamite is being stored and ten groups, comprising 4000 men are drilling nightly. Foreigners are mainly concerned in the movement.

CLEVELAND, Feb. 8.—F. K. Gogger, a former agent of the international workingmen's association (anarchists), says there are four groups of the order here with two hundred members and many supporters. Two are Bohemian and two German. A fifth, American, will be organized to-morrow. Gogger says the workmen here are ripe for a riot, and that unless times improve a great revolution will be inaugurated. The socialists are increasing rapidly.

St. Louis, Feb. 8.—Socialists this afternoon discussed the labor question. A banner bordered circular was freely distributed containing a bitter trade against Germany for the execution of anarchists and other labor agitators. The speaker, a Canadian, urged a revolt against priestcraft, monarchs and monopoly.

CRIMINAL NEIGHBORS. Serious Charges Against the Crews of the Hi-fived Iceboats. CHARLOTTETOWN, P.E.I., Feb. 7.—The Charlottetown Examiner demands a royal commission to investigate the conduct of the crews of the iceboats under oath. It alleges that the crews neglected their duty and were guilty of gross cowardice and inhumanity, that they started in the teeth of a storm entirely unprovided with food, fuel, oil, light or compass, and that they monopolized the fire to themselves and excluded the frost-bitten passengers; also, that they had determined, in case of necessity, to leave the passengers to their fate and save themselves at all hazards.

The Socialists Denounce the Mail. C. B. Reynolds lectured last evening in Albert Hall on "Salvation." He described the Christian doctrine on this point and said that socialists do not accept, but urge upon all men to work out their own salvation here and now, by leading good and useful lives, and using their utmost endeavor for the benefit of their fellow-men, physically, morally and intellectually. Socialism teaches that there is no other salvation but this. At the close of the meeting the following resolutions were passed by acclamation:
