PENDENT OPERA INTERRUPTA.—FIN.

UPWARDS of twelve years have now elapsed since Colonel Bouchette's Maps and Topography of the Canadas first became the topic of conversation and discussion, and to this day, his claims on the Province, arising from the publication of his work, occupy the attention of the public, and remain undetermined, though recognized by the Colonial Legislature, or rather, I should say, by the House of Assembly. That a measure of such palpable and undeniable justice to the individual should have been suffered to linger in the Honorable House and its Committees for so long a series of years, is a natural cause of surprise, and awakens curiosity. I have, therefore, taken some trouble in referring to the Journals as far back as 1814, and have collected the material Legislative proceedings connected with this matter, to which I am induced to give publicity, in the full conviction that many of the Honorable Members, and the inhabitants of the Province generally, are not aware of the successive measures of the House of Assembly, from their origin, on Colonel Bouchette's application; the former having no doubt a variety of other objects to attend to, which they conceived of more general interest and im-

port ; the latter from not having free access to the Journals of the Honourable House. The motive, therefore—and I am sure it will be deemed a laudable one—is merely to exhibit, collectively, the petitions submitted and the *resolves, &c.*, of the House, at its several sessions since 1814, on the subject of the publication of Bouchette's work ; convinced, at the same time, that from the evidence of these documents, the House will act up to the spirit of its judicious resolutions with despatch and unanimity, and not allow so much of their precious deliberative time to be engrossed, without any result, by a measure which all the friends and well-wishers of arts, science, and literature would rejoice to see liberally disposed of.

Previous to undertaking the publication of the Maps of Canada, the author petitioned the Legislature for aid and encouragement in the performance of the onerous task of publishing ; and, thereupon, in February, 1814, the Special Committee, to which the petition was referred, reported, recommending a grant of £1500, and subsequently the whole House resolved as follows :—(a)

(a) The extracts are given in one language only, reference to the Journals (where the proceedings are entered in French and English) being facilitated by the statement of dates.

“ HOUSE OF ASSEMBLY, “ WEDNESDAY, 23d February, 1814.

“ In Committee of the whole House, on the report of the Special Committee, to which was referred the petition of Joseph Bouchette, Esquire, Surveyor-General :

“ Mr. DENECHAU called to the Chair,



" 1st.—On motion of Mr. Taschereau, seconded by Mr. Lee,

" **R E S O L V E D**—That it is the opinion of this Committee, that a sum
 " of *Fifteen hundred pounds*, currency, be employed, under
 " the direction of Commissioners, to encourage and aid
 " Joseph Bouchette, Esquire, to publish the Topographical
 " and Geographical Maps of the Province."

We have here a beacon held out to the petitioner, who, satisfied with this pledge of the whole House to receive its support to the extent of £1500, crosses the Atlantic, proud of the patronage of his country's Legislature, and commences the publication of his work.


In March, 1815, whilst Colonel Bouchette was laboriously engaged in England, superintending the engraving of his Maps, the Provincial Legislature grant him an aid of £500 currency.

Upon his return to Canada, having wholly completed his publication, and that in a manner highly honorable to his country and creditable to himself, and for which he received the commendation of the British Society of Arts, and had the honor of being introduced as one of its Members, Colonel Bouchette finds himself exceedingly embarrassed, owing to the original intentions of the House of Assembly not having been carried into effect; and he naturally looks up to the Legislature for relief. He petitions the House circumstantially, and after stating that the work, as produced, exceeded the plan of the Prospectus, (which every one must admit,) he

" respectfully submits to their consideration the extent and importance of the work, which is the fruit of many years labour and application, and which, from the very great expense attending it, instead of yielding him profit, has involved him very considerably, and from which he sees no means of extricating himself but through the liberality of Parliament."

He then prays for the difference between the original vote of £1500 and the grant of £500, " to enable him to surmount those difficulties in which the publication of his work had involved him."

On the 4th of March, 1817, the Committee to which this petition was referred, reported as follows :—

" Mr. Bouchette was examined, and informed your Committee " that he caused to be engraved one thousand copies of the Maps " of the Province ; that these Maps cost him, according to the " Account hereunto annexed, marked A, which he produces,

(a) Desirous of rendering his work as generally useful to his countrymen as possible, Col. B. published his Topography in both languages, and thereby considerably increased the expense of his publication. Zeal is seldom adequately rewarded.

" The petitioner does not expect to raise more by the sale of his Maps : that assuming that he may sell for £700 more, he will remain in arrear £1701 18 2, whereby his credit would sustain great injury, and he would also be disabled from improving the Maps of the Province.

" Your Committee observes that Mr. Bouchette executed these Maps under the patronage of the Provincial Legislature, and that he has thereupon sustained a loss of £1701 18 2, and is there-

" fore of opinion that it is just to reimburse him a part of his loss, and
 " that it is even expedient so to do for the encouragement of the
 " Arts and of the persons who may apply themselves thereto in
 " this Province."

The measure recommended by this Report, which is obviously dictated by a generous public spirit and feeling honorable to the Members of the Committee, was not proceeded upon by reason of the prorogation that ensued shortly after.

At the ensuing Session, the author of the Maps of Canada appears again before the Provincial Parliament as an humble petitioner. He alleges that the sequestration of his work, after its publication for the security of the debts contracted in its production, had checked its sale, and that he had in consequence suffered a loss exceeding £2000 instead of £1701 18 2. He goes on to state that he is encouraged to bring forth his claims again,


" under the sanction of the favorable testimonials contained in the proceedings of the Honorable House in this behalf, and he ventures to add, by the patriotism by which he has been guided, and the disinterestedness with which he has undertaken and completed a work that can but lead to give to his Sovereign, his fellow citizens and to the whole world, some more accurate information on, and of course enable them to appreciate more adequately the physical and moral resources of this part of the British Dominions, as well as the loyal and patriotic devotion of its inhabitants. Such was the principal end of 14 years incessant labour, happy if he has attained the whole or even a part of that end; but his happiness would have reached its height if it had only cost his labour and time, and if his fortune had allowed him to attain it without his being reduced to the necessity of soliciting public assistance: it is therefore the most impious necessity that alone can induce him to come again forward before the House as a petitioner."

This petition, which must be si-

lowed to contain strong and equitable claims on the House of Assembly, was referred to a Special Committee, which, on the 16th January, 1818, reported to the House, substantially to the same effect as the Committee to which the same matter had been referred during the preceding Session, with this additional clause :—

“ That these Maps have been seized by the persons who assisted him in the publication : the pecuniary means of the petitioner being inadequate to the advances necessary to the undertaking he relied much on the liberality of the Legislature, the House having in a Committee of the whole, so early as the 24th February 1814, resolved that he should be aided with the sum of £1500, to encourage the publication ; ”

And after reporting their examination of John McNider, Esq., whose evidence was strongly corroborative of the facts uttered in the petition, the Committee concluded by stating it to be their opinion, that it were just to reimburse the losses suffered by Mr. Bouchette, to the amount of one thousand pounds.

On the 25th March, the House went into a Committee, to consider this report; but several Members having retired, the House was adjourned for want of a Quorum.

On the 27th the House again resolved itself into a Committee, but Mr. Viger having shortly after put in a motion for adjournment, the measure was lost for that Session.

Two successive failures, from such causes, to bring the subject under the consideration of the House, might give rise to animadversion; but let us proceed to facts.

The following Session, Colonel Bouchette once more petitioned the House, to the same purport and with the same views he had previously

done, with the addition of a tender to the Province, of the copper Plates of his Maps.

The Special Committee to which the latter petition was referred, on the 15th March, 1819, reported as follows :

" Your Committee have attentively examined the allegations of the said petition and find them generally supported by the evidence on the Journals of the House, and the examination of witnesses, reported by Special Committees on the 4th March, 1817 and 16th January, 1818.

" Your Committee is of opinion that although the resolution of the Committee of the whole House of the 23d February, 1814, was not acted upon during that Session, which terminated on the 17th March following; yet the said resolution may have induced Mr. Bouchette to expect assistance from the Legislature to that amount, for the publication of his Maps, and contributed to his proceeding personally to England in the ensuing summer, for the purpose of superintending a work honored with such distinguished patronage.

" Notwithstanding the grant of £500, which was made to Mr. Bouchette, during the ensuing Session of the Assembly—Your Committee finds, by the aforementioned evidence, that he has actually been a loser by the publication of his Maps and Topographical account of Canada.—Your Committee, however, will not take upon itself to pronounce that any further pecuniary compensation ought to be made to Mr. Bouchette, out of the public money; it is however of opinion, that it would be an act of justice to that gentleman, now that a work which the Legislature has unequivocally patronized, is completed, should that work be found worthy of such patronage, to afford the author some public mark of approbation.

" Mr. Bouchette has submitted to your Committee, original documents of which the papers annexed, letter A, 1 to 6 inclusive, are true copies. These documents, in the opinion of your Committee, shew, that his Maps and Topographical account of Canada have been judged favorably of, by some of the most distinguished and most competent authorities in Great Britain, and in this point of view, they must have contributed to establish abroad a favorable opinion of the talents of the native of Canada, while they also disseminated in the mother country, additional information on the resources and importance of the Colony.

Le Comité Spécial auquel cette dernière Pétition fut référée, fit son rapport le 15 Mars 1819, en les termes suivant :



" Your Committee is of opinion, considering the premises, the nomination of Mr. Bouchette as Surveyor General, and the probable advantages which must result to the Crown as well as to this Province, from the attention which Mr. Bouchette's work will naturally draw to the vast extent of waste lands therein, that it would be expedient to address His Grace the Governor-in-Chief, praying that he would be pleased to recommend Mr. Bouchette for a grant of the Waste Lands of the Crown."

It is foreign to the object of this paper, to comment at length any of the proceedings of the House of Assembly, upon the matter in question; but I cannot refrain noticing *in transitu*, this first effort to transfer, from the House of Assembly to the Crown, the *onus* of remunerating and indemnifying the Author of the Maps of Canada for his losses. I feel intimately convinced, however, that the friends of that Gentleman on the Committee resorted to this measure, of commuting the proposed indemnity from £ s. d. to acres, from a conviction that it would, as it really was readily acceded to by the House;—for, on the 17th April, 1819, in a Committee of the whole House, it was


" Resolved, That an humble Address be presented to His Grace the Governor-in-Chief, representing the *importance* of the Geographical and Topographical Maps of Joseph Bouchette, Esquire, Surveyor General, and the *losses* he has sustained in publishing them, representing also the *importance* of those Maps, both to His Majesty's Government and to the Province at large, and praying His Grace would be pleased to take the whole into consideration, and would also be pleased to *indemnify* him for his *services* and *losses*, by such grant of the Lands of the Crown, as His Grace in his wisdom may think fit;"
in which resolution the House *unanimously concurred*, but owing to the unfortunate and lamented death of the Duke of Richmond, the Address was not acted upon.

Two years after, His Excellency the Earl of Dalhousie sent down to the House the following Message:—

Deux ans après, Son Excellence le Comte Dalhousie, soumit à la Chambre le Message suivant.



" Dalhousie, Governor,
 " The Governor-in-Chief calls the attention of the House of
 " Assembly to the importance of the Geographical and Topogra-
 " phical Maps, made by Joseph Bouchette, Esq. Surveyor General,
 " who states to have sustained a considerable loss in publishing
 " them.

" The Governor-in-Chief is of opinion, Mr. Bouchette's claim
 " to remuneration is *just* and *reasonable*, but does not approve of
 " the mode of remunerating him by a grant of land as was pro-
 " posed by the Address of the Assembly of the 17th April, 1819.

On the 7th March, the Special Committee, to which was referred the foregoing Message, reported as follows :—

" Your Committee, after full consideration of the matters referred, are of opinion on the former, that Joseph Bouchette, Esq. Surveyor General, hath made and published Geographical Maps of the Province, which are of *important utility* to His Majesty's Government and to the Province, and that in the publication of those Maps, he hath *incurred and sustained considerable losses*, and taking into consideration the recommendation made by the House of Assembly of this Province, to His Grace the Duke of Richmond, Governor-in-Chief, in 1819, and the sentiments expressed at the time by the House, relative to the services and losses of the said Joseph Bouchette. Your Committee are of opinion, that *there ought to be granted unto him a sum of £1000*, as well to indemnify him for the losses he hath sustained by the publication of his Maps, as to encourage talent and useful undertaking in this Province."


It does not appear by the Journals that the House ever took this Report into consideration during that Session.

On the 7th Feb. 1822, the consideration of the Report on the Governor-in-Chief's Message was moved, and the House accordingly resolved itself into a Committee,—but several members having retired, the names of those present were

taken down,"—“and at half-past 8 o'clock at night Mr. Speaker adjourned the House *for want of a quorum.*”

On the 9th Feb., two days afterwards, the order of the day for the General Committee of the House being read, “On motion of Mr. Lagueux, the order of the day was postponed,” and the House, at 7 o'clock at night, was again “adjourned *for want of a quorum.*”

In the ensuing Session, on the 28th Feb., the consideration of the Governor-in-Chief's Message was revived, and the Report thereon referred to a Committee of the whole House on the following Monday. The order of the day was suffered to lapse, and, in consequence, on the 18th March, Mr. Stuart, seconded by Mr. Oldham, moved its revival—but—“A member having retired,” “at 8 o'clock at night Mr. Speaker adjourned the House *for want of a quorum!*”

Session after Session the consideration of Colonel Bouchette's well-grounded claims on the House having been in this manner shuffled off, his credit suffered, his difficulties daily increased, and he found himself urged to tender his plates more formally to the Province, and would, I believe, have been satisfied with a moderate compensation for them, owing to the awkward dilemma in which he was placed by this aggravating disappointment.

On the 24th Feb. 1824, His Excellency the Governor-in-Chief, who certainly seems to have been prompted to this step and the former by a



dangerous desire of acknowledging and rewarding the merits of that Gentleman, sent down to the House the following Message and Letter :—

On the 5th March, 1824, the Committee on the Settlement of the Crown Lands, to which this Message and Tender were referred, as in some measure connected with the subject already before it, caused to be laid before them the Map as improved by Lieut.-Col. Bouchette, and the original documents referred to in his examination, and then proceeded to report as follows :—

“ Your Committee satisfied, that the improvements already made, and those contemplated by Lt. Col. Bouchette, would be of great utility, deliberated upon his proposal to assign over to the Province the original Plates, as well of his large Map of Lower-Canada, as of his general Maps of Lower and Upper-Canada, and the neighbouring Countries, for the price which the same cost him, and to complete in the course of the next



The Committee recommended the adoption of neither of these alternatives, as attended with inconvenience in the execution, and by their desire, another project was submitted, by which Col. Bouchette undertook to republish his Topographical Map, and furnish each branch of the Legislature with two copies thereof, upon his receiving £450 Sterling, as a remuneration for his labour and research in the improvement of this part of his work, and an equal sum to meet the expenses of publishing the same.


Upon this latter proposition the Committee is silent, and proceeds to report on the chief object of its nomination, and—with the lecture of the Report this branch of its subject-matter dropped for that Session.

This long-winded procrastination strengthened Col. Bouchette's claims in the same ratio that it diminished his prospects of an eventual success. He took, I believe, occasional opportunities of intimating his fears to several of the Members of the House, one of whom, apparently roused to a proper sense of the irresistible force and justice of his claims upon the Assembly, on the 10th March, 1824, *suo motu*, moved the lecture of entries on the Journals of the House of the 15th March, 1819, and 24th Feb. 1824, and on this occasion some de-

Le Comité ne recommande aucune des alternatives proposées, comme étant toutes deux sujettes à plusieurs inconveniens dans leur exécution, et à sa réquisition, un autre projet lui fut soumis, par lequel le Colonel Bouchette entreprenoit de perfectionner, et publier de nouveau, sa Carte Topographique, donnant à chacune des Branches de la Législature, deux copies de la Carte, le tout moyennant la recette de £450 Sterling, comme une rémunération pour ses travaux et recherches dans l'amélioration de son ouvrage, et une semblable somme pour défrayer les dépenses d'une telle publication.

bate took place, which it is painful to recollect and unnecessary to recall. After obtaining a reference of the Message and Report, read from the Journals to a Committee of the whole House, this evanescent measure was again made mysteriously to elude a final investigation and decision.

Here the matter rests, no steps having been subsequently taken to bring it again under the consideration of the Assembly.

The facts to be collected and inference to be drawn from the resolve of the whole House on the 23d Feb. 1814; the Reports of the Special Committee, in constant unison with the spirit thereof; the Address of the House to the late Duke of Richmond; the Governor in Chief's Message; and the ulterior proceedings adopted thereon, must be obvious to every person who will take the trouble to peruse them; and it would, indeed, be an offensive reproach to the justice and liberality of such of the Representatives of the people of this Province, as have hitherto treated this subject with neglect & indifference, or something worse, to suppose, for one instant, that had they been fully conversant with the steps successively taken by the Honourable House relative to this matter, they would not zealously and promptly have come forward to support the *spéciale honneur* and dignity of the House, by seeing that its engagements be sacredly and scrupulously kept.


Since the period of passing the first resolution three or four different Parliaments have been called together, and although each succeeded to the obligations of the other, yet

private questions, however intimately connected with public justice, must necessarily have suffered from the changes; and by such reasons, might probably be explained the peculiar situation of this case. I have, therefore, in order to obviate the difficulties presenting themselves from such a cause, thus thrown the proceedings *en masse*, more than ever convinced, from the evidence of the whole, that the Assembly will, upon further consideration, make ample amends for long delays, and not give genius in its birth "a knock on the head," and banish it from the Colony to climes where it is *fostered and encouraged*; but that on the contrary the Assembly of Lower-Canada, will stamp with their *effectual countenance* and support, and in conjunction with the world at large their approbation, a work of acknowledged elegance, utility and importance, and which every Canadian must feel proud of, as springing from his native soil.
