

The request from Leray Monthly Meeting to become a component part of West Lake Quarterly Meeting, being brought before this Meeting for our consideration and concurrence therein, and men friends having informed us they have united with the request, we are also united therein, and from this time forth they will report to West Lake four Months' Meeting, and thereby become members thereof.

The Queries, with their answers, have been read at this

time as far as the fourth Query.

The meeting adjourns to meet to-morrow morning at 11 o'clock.

Seventh Day Morning, 6th Mo., 20th, 1885.

Friends met near the hour adjourned to.

Matilda Branscombe, on behalf of the Representatives, report they have conferred together and are united in proposing Eliza H. Varney for Clerk; and Margaret Jane Jones for Assistant; with which this meeting unites, and they are appointed to that service for one year.

Finished reading the Queries, with their answers, as they came up from the different Quarterly Meetings, a summary

whereof is as follows :-

SUMMARY ANSWERS.

1st Ans.—Most Friends are careful to attend all our Meetings for religious Worship and Discipline. One report from one small meeting says two First Day Meetings not attended on account of sickness and death. The hour is nearly observed; no unbecoming behavior to remark.

2nd Ans.—We believe Friends are preserved in love one towards another. No differences known amongst us. Talebearing and detraction discouraged and mostly avoided.

3rd Ans.—Most Friends do endeavor to train up their children in the principles of the Christian religion as pro-

fessed by us in the plainness and simplicity of dress and deportment it enjoins, the igh deviations are apparent. Friends are mostly good examples in these respects themselves.

We believe they do endeavor to guard their children and others, under their care against corrupt conversation and the

reading of pernicious books.

4th Ans.—We believe most Friends are diligent in reading the Holy Scriptures in their families, collectively.

5th Ans.-Friends do avoid the use of all intoxicating drinks, except for purposes strictly medicinal, and are clear of attending places of diversion as far as we know.

6th Ans.—The circumstances of the poor have been inspect-

ed and relief seasonably afforded them.

We believe all children under our care are in a way to be properly educated for the ordinary duties of life.

7th Ans.—All our meetings are reported clear of complying with Military requisitions or of paying any fine or tax instead thereof.

8th Ans.—We trust Friends are just in their dealings and punctual in fulfilling their engagements, and we believe they are careful to conduct their business as becomes our religious profession. We know of none who have given fear on these accounts.

9th Ans. -- Care is mostly taken to deal with offenders in the spirit of meekness, and agreeably to our discipline.

During the reading and answering of the queries much excellent counsel was handed forth, and Mothers were encouraged to greater faithfulness, and daughters counselled to yield to God's grace in the heart so that they might be enabled to say with the Apostle Paul, "By the grace of God I am what I am." They were also advised to hold these things in an even balance, and not lay too much stress on any one thing, and not enough on another or even to the exclusion of another, but to be watchful over our own spirits, and to be ensamples to the flock, watching unto prayer, that our children may see we are following the meek and lowly Jesus, and and that we see to it that we discharge every duty in the fear of the Lord, leaving all in the hands of Him "who doeth all things well." Setting a watch over our lips that our words

may be seasoned with grace, remembering that "the tongue can no man tame, that it is an unruly evil, full of deadly poisons." It is written, "He that keepeth his mouth keepeth his life."

Mothers were counselled to bear the cross before their children, and by watchfulness unto prayer receive strength from our Heavenly Father, who will hear and answer their petitions, and children will be brought into the fold of Christ.

Friends are admonished to read the Holy Scriptures in a prayerful manner, and have the mind gathered inward to the Light of Christ in the soul, and be faithful to the intimations of duty made manifest by the Holy Spirit in the heart .-There are a diversity of gifts and a diversity of administra-May each one abide faithful to their gift, and let obedience keep pace with knowledge.

The younger listers were admonished to cherish the precious feeling that at times cover them, and to come out and follow Him who endured the Cross and despised the Shame that they may be partakers of that "River, the streams whereof shall make glad the City of God-the holy place of

the tabernacle of the Most High."

We appoint Lydia M. Haight, Matilda Branscombe and Sarah Leavens to audit the Treasurer's Accounts and report to our next meeting.

We appoint Margaret Jane Jones and Jane Cronk to see to the printing of 600 copies of Women's Minutes, and forward to their respective meetings, and report next year.

We feel to acknowledge that a precious covering has rested over this meeting, and that we have been owned by the Master, and unto Him would we ascribe all the praise.

who are to report at a future sitting.

This meeting being brought under exercise, as to whether our First-day Schools come under the care of the Yearly Meeting, which being prayerfully considered this meeting has decided for each Monthly Meeting to appoint some Friends to have the oversight thereof and see that they are conducted in an orderly manner, and report to the Quarterly Meetings and through them to this meeting: Number of scholars? How many are members that attend them? How far they are conducted strictly according to Friends' Principles? Which Men Friends have united with the meetings are directed to act in accordance therewith.

This Meeting adjourns to meet at 10 o'clock to-morrow
