LET THE BRIDGE BE FREE.
We learn that the question of the advisability of memorializing the Dominion government in regard to making the railway bridge free has been before the Council of the Board of Trade, and although no decision was arrived at, it is generally understood that several members of the council are opposed to the bridge being made free until terminal facilities for the shipment of grain and heavy freight in transit, have been provided on the West side. They argue that if the bridge is made free before this is done the freight business will go to Halifax and St. John will derive no advantage from the building of the Short Line. Our reason for referring to this matter at this time is that it will come up at the next meeting of the Board of Trade, and it is highly desirable not only that there should be a large attendance of the members of the Board to discuss it, but that they should come to the meeting with correct views in regard to the question to be debated.

THE EXHIBITION.
The proposed St. John Exhibition next year is already exciting favorable notice in the other provinces. The Montreal Star has an editorial on the subject in which it especially commends the features of the exhibition which makes it open to all. Our contemporary says:—
There cannot be a doubt of the wisdom of the proposition at which the St. John Association arrived, as will be fully demonstrated when the Exhibition comes to be held. The broad lines of action will not only attract many exhibitors but many visitors from the Upper Provinces, which is especially desirable in view of the people of the Maritime Provinces themselves, and drawing out the manufacturers of the latter provinces than has yet been done. The decision of the association is also indicative of the steady development of the Maritime Provinces, of that self-reliance which is everywhere manifest in the Maritime Provinces, and which is especially noticeable in Canada and which would be for the country's future prosperity and well-being. It is a blow to sectional feeling, and another proof of the prevalence of that sense of sentiment and interest which is gradually knitting Canadians together into a united people.

MARRIED DAUGHTERS AND SONS.

His four daughters, born under such peculiar circumstances, are still living. The first three are not only stepmothers but also consorts. The fourth, the daughter of the mother-in-law, is not only a cousin and stepmother, but the aunt, while the grandmother is the stepmother to her own grand-children.
