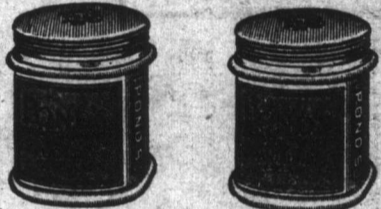

Clynes Introduces the Labour Amendment of Want of Confidence.

Liberals Advised by Asquith to Support Amendment—Five Deaths in New York Caused by the Storm—Shenandoah will Undertake the Polar Trip.

CLYNES INTRODUCES WANT OF CONFIDENCE MOTION.

LONDON, Jan. 17.—Former Premier Asquith, leader of the Reunited Liberal Party, announced in the House of Commons to-day that he would vote in favor of the Labour amendment expressing no confidence in the Baldwin Government, and would advise all his friends to do the same. The Labour amendment was introduced by John R. Clynes, Deputy leader of the Parliamentary Labour Party, at the resumption of the debate on the Speech from the Throne.

CLYNES DECIDES TO SUPPORT LABOUR AMENDMENT.

LONDON, Jan. 17.—Premier Baldwin's Conservative Government received its death warrant this evening at the hands of the opposition in the Commons, when former Premier Asquith arose, and addressed his followers on the Liberal benches, announced he would vote for the Labour motion of no confidence, and that he would advise his followers to do likewise. Nothing short of a political upheaval involving the election of large numbers to the Conservative flag can now save the Government which will go to its doom according to the present programme. Asquith, introducing the no confidence motion in the form of an amendment to the Address in reply to the King's Speech, John Robert Clynes scored a Tory regime both for what it had done and what it did not do during the last twelve months. The Speech, he declared, was inaccurate in stating that Great Britain's relations with other powers remained friendly. If relations with Russia had been friendly, he asked, then why had not Russia recognized? If it was because Russia had not undertaken to pay her debts, then how was it France had a representative in London? The position abroad is weaker than ever before, he asserted.

Mr. Asquith, summarizing the position of himself and the Liberal party, declared that the Labourites were the natural inheritors of power, when the Baldwin Government was defeated. It was the duty of every patriotic man and woman to do their duty without sacrificing principle or to facilitate labor's task. In those constituted like the present Labour Government it was wrong to talk of the danger of a Socialistic regime. Labor possessed no freedom of what they liked. They were not to own masters, but like other parties in the House were bound by circumstances. Sir William Joynson-Hicks, President of the Ministry of Health, followed Asquith and made an effective onslaught against the Labourites. He was emphatic in denying there ever had been formal overtures of Conservatives to Liberals for the support of Labor. He predicted that while the Liberals would do no more by their action, they would create an impression as would keep the party out of power for the next few years. The general belief is Clynes' amendment will be carried by a majority of about seventy.

LABOUR OFFICIALS RECEIVE DRASTIC TREATMENT.

MADRID, Jan. 17.—A government examination of the accounts kept by provincial authorities has disclosed that in at least five provinces accounts are 29 years old. In several cases they are more than a score of years in arrears. Many provincial officials have been imprisoned by order of the Military Director for alleged malfeasance in office.

THREE MONTHS TO CONSIDER.

LONDON, Jan. 17.—The miners' federation headquarters made public to-day figures on the

vicinity in many years has subsided to-day, after causing indirectly five deaths, considerable property loss and damage to small shipping in the harbor and along the New Jersey Coast. Four of the deaths, attributed to the storm, occurred in New York City; three were due to traffic accidents resulting from the driving rain that combined with high wind and almost halted traffic; the fifth resulted from a traffic accident in Jersey City, 23 persons suffered slight injury.

QUAKE IN ALASKA.

STEAMSHIP LATOUCHE (Via St. Paul Island, Alaska), Jan. 17.—Inhabitants of Belkofsky and vicinity report that a severe earthquake occurred at ten-fifty Tuesday morning. The southern edge of the Pavlov volcano blew off. Belkofsky is on the Alaska Peninsula. The people of Belkofsky left their homes for safety.

ARGENTINE'S CROPS.

BUENOS AIRES, Jan. 17.—Argentine crops for 1923-24 will be the largest and most valuable ever harvested, according to the Minister of Agriculture, who announces that the estimated production of six principal cereals, excepting maize, will amount to 10,240,000 tons valued at \$1,160,820,000.

WILL UNDERTAKE POLAR TRIP.

WASHINGTON, Jan. 17.—United States naval officers who had doubts about using the dirigible Shenandoah for a projected Polar flight, appeared converted to-day by the performance of the big ship in riding out last night's gale, after being torn from her mooring mast at Lakehurst. Secretary Denby sent congratulations to the crew and disclosed the determination of the department to get the Shenandoah ready promptly for the polar flight this summer.

TRYING TO SAVE OIL FIELDS.

EL PASO, Texas, Jan. 17.—President Obregon has ordered every available soldier not needed on other fronts to proceed to Tampico in an effort to wrest the oil fields control from the rebels.

BANK OF FRANCE RATE RAISED.

PARIS, Jan. 17.—The Bank of France raised its discount rate to six per cent. The rate was raised a week ago to five and a half per cent, which it had been since March 11, 1922.

TACOMA IN IMMINENT PERIL.

GALVESTON, Texas, Jan. 17.—While U.S.S. Pensacola was en route to aid the United States cruiser Tacoma against distress on Blanco Island, 16 miles from Vera Cruz, heavy seas were preventing the tug from drawing alongside the cruiser, according to naval wireless messages received here last night. A wireless received by the hydrographic office here yesterday said the Tacoma was sending out distress calls and had appealed to the United States Consul for help, and unless assistance arrived within two hours, according to the intercepted message's time 6:30 a.m., it might be too late to drag the warship off the reef.

Mr. G. Whiteley called attention to the need of having a light placed in Factory Lane off Forest Road, as this thoroughfare was used very much by pedestrians in going to and from the Curling and Prince's Rinks.

The matter was left in the hands of the Lighting Committee.

J. D. Andrews applied for position on Council Staff.

There being no vacancies at the present time, the application was ordered filed for future reference.

Several tenders were received for repairs to Motor Trucks, but no decision was made. It was decided amended specifications be prepared, and new tenders asked for.

The Medical Health Officer reported 24 new cases Scarlet Fever during the week.

City Engineer and Sanitary Supervisor tabled their annual reports, which will be given consideration at a special meeting.

With the reading of reports of other officers, and granting of requisitions for the several departments, the meeting adjourned.

The Enquiry Conducted by T. Hollis Walker, K.C.

JANUARY 15th.
COMMISSIONER—Will you let me see your pass book?
WITNESS—Yes. I have it here.
COMMISSIONER—What was the date of the July 27th, 1922, I think.
WITNESS—I left St. John's on June 4, 1922.
COMMISSIONER—I am not interested in that. I am interested in the state of the account at that time.
WITNESS—One June 30th.
COMMISSIONER—I am not interested in that. Can't you answer the question?
WITNESS—I can't answer the question, because the book is not balanced at that date.
COMMISSIONER—Can you not by your pass book find the state of your account? If you want to see a cheque, is there nothing in your pass book to show whether you are in funds or not?
WITNESS—No. You would find out from the Bank, but not from books.
COMMISSIONER—So that you did not know whether you had to meet the cheque or not?
WITNESS—You would know that from your own records.
COMMISSIONER—When you keep records. So that this book did not show whether you were in funds or not?
WITNESS—I say that from the fact it is not possible to tell whether any particular day, in any particular month, your account stands in any particular way.
COMMISSIONER—If you could not tell from the books could you tell any other source?
WITNESS—You could tell by entering the Bank.
COMMISSIONER—Have you entered from the Bank whether or not your account was overdrawn at this time?
WITNESS—Then why were you so sure you were not overdrawn?
WITNESS—Because the account was with a credit balance of over \$500.00 on the 25th July.
COMMISSIONER—But how did you know to tell me just now that you were overdrawn at that date?
WITNESS—I did not believe that I was out of town from the 23rd to the 25th, and on the last day of July I had a credit balance of some \$2,000.
COMMISSIONER—A great deal here upon contradiction between you and Miss Miller. She says on July 27th, 1922, your account was overdrawn. Does that account

claim from Meaney. Can you say if she ever received anything political for you?
A—I believe she did from her brother. I am of opinion that that \$2,000.00 was not money received from Meaney. That is my own personal view of the matter, but I can't prove it.
Q—Then you say that she did receive money from political sources?
A—Yes.
MR. HOWLEY—I have here, sir, copies obtained from the Bank of the actual deposit slips under which this \$500.00 and this \$3,000.00 were deposited.
COMMISSIONER—For the \$500.00 we have a document, and I suppose this is a duplicate. I suppose that document is a counterfeit?
MR. HOWLEY—We have no counterfoils here.
COMMISSIONER—In our payments in we have a slip like a cheque. The slip is perforated, and you tear off one side and get the bank to initial it, and give the other side to the bank, and keep the initialled or the stamped side for the purposes of keeping the books.
MR. HOWLEY—We do not have those here.
COMMISSIONER—You just make out one of those slips and they do not give anything in return?
MR. HOWLEY—If you ask for it they do.
COMMISSIONER—Under these circumstances the originals would be kept by the Bank, and they have given you copies?
MR. HOWLEY—Yes.
COMMISSIONER—I do not see that there is any reason for doubting that these are fair copies. I shall let you use them.
WITNESS—The practice in my office up to the time that I retired from business was to have duplicates. The practice was that the clerk made up a slip and a duplicate and had the bank stamp the duplicate.
MR. HOWLEY—Are these copies which you received from the bank of those two deposit slips?
A—Yes. These are copies given by me by one of the officials of the Canadian Bank of Commerce.
COMMISSIONER—In the absence of any suggestion to the contrary I shall assume that these are accurate.
MR. HOWLEY—I shall put these in. (Put in marked R. A. S. 1 and 2.)
Q—In my cross-examination of Mr. Meaney I asked him "why did you not want an audit" and he replied "it does not refer to this particular one but I will tell you. Some time in 1922 I ascertained that the Auditor General intended making a check up of the stock. The amount then outstanding was represented by those L.O.'s, and I sent word to the Premier, not myself, that if the audit of the Department was intended I would have to be reimbursed for the Department for the whole amount which was then outstanding before it was done, and I understood from the Auditor General that Squires said to desist." Now was any word brought to you by anyone with regard to reimbursement on that occasion?
A—No.
COMMISSIONER—I assume that you mean that Miss Miller was a go-between, and Sir Richard Squires has already said that Miss Miller did not mention any of these matters to him.
MR. HOWLEY—I understand he says he learned from the Auditor General that Squires said to desist?
WITNESS—I did not make any such statement.
MR. HOWLEY—What the Auditor General says is that you said "let it stand over." Later on in the examination he was asked if the Auditor General told him that, and he answers "a clerk of the Auditor General."
COMMISSIONER—Does it make any difference who told him? Somebody in connection with the Auditor General's office told him that Sir Richard Squires had stopped it, whereas he says that all he had done was to say "let it stand over."
MR. HOWLEY—I further cross-examination I asked Mr. Meaney when did the breach that is between you and himself become serious, and he answered in March, 1922, speaking from memory. Do you remember anything happening in March, 1922, that would justify that statement?
COMMISSIONER—You must remember all that Mr. Meaney said. He said that he had been suspicious for some time, and he had made up his mind that Sir Richard Squires was not going to fulfill what he thought he had promised him—the appointment to full Controller.
WITNESS—There is no particular incident. But in the summer of 1922 Mr. Meaney was wanting the appointment, and I was not giving him satisfaction.
COMMISSIONER—He was clamorous and resentful?
WITNESS—Yes. But that had been going on for nearly two years. He thought that if I was there he might not get it.
COMMISSIONER—He seems to have thought that you had promised it, and that you were not fulfilling your promise, and as a result he was getting sore.
COMMISSIONER—You are going back to an alleged interview, Sir Richard denies that it ever took place.
MR. HOWLEY—Coming to these statements of Mrs. Harsant. In her examination, when she was asked as to when her employment ceased, she did not seem to be able to fix any definite date. Are you able to say when her employment ceased?
A—Her connection with my law office terminated at the end of July. I understand her keys were delivered up at that time. I have no personal knowledge, the information was given me by one of the clerks.
COMMISSIONER—But she went on doing personal matters for you. Those of the staff who have been here agreed that she went on doing insurance matters, and she also went on doing financial matters for you?
A—Not to my knowledge, except in that she assisted in the circle in which she moved to raise what money she could for the political campaign.
COMMISSIONER—I think that is different from what she meant by "financing."
WITNESS—She was then entitled to \$40.00 per month up to the time that the insurance which she represented and controlled was cancelled.
MR. HOWLEY—Miss Miller has told us specifically that her first dealing with Mr. Meaney was because you had suggested to her to go to Mr. Meaney. Is that so?
A—That is not true.
COMMISSIONER—She has already denied that.
MR. HOWLEY—She has told us that prior to your departure for England in 1920, you instructed her to go first to her brother for financial assistance, and when her brother's resources in that direction were exhausted to call on Mr. Meaney. Is that correct?
A—That is not correct.
COMMISSIONER—You denied that yesterday. I assume that you would deny to-day what you denied yesterday. You gave a detailed account yesterday on your notes and the rest of it.
MR. HOWLEY—By the way, you told us yesterday that prior to your going away in 1920, you left some notes?
A—Yes. I said I left some notes, either signed or endorsed, or both, with my secretary, Miss Saunders, to whom I also dictated a letter of which no information was given.
COMMISSIONER—I shall want the letter if it exists. I thought it was a letter to Miss Miller?
A—So it was.
COMMISSIONER—Presently she will be recalled, and we shall find out what has become of the original.
MR. HOWLEY—You left some notes signed or endorsed?
A—Probably both.
Q—Do you remember what forms what bank they were on?
A—My judgment would be that they would be on the Bank of Nova Scotia.
COMMISSIONER—Your judgment would be of no use to us. We should like to see the notes.
MR. HOWLEY—You signed those notes you say, and gave them to Miss Saunders?
A—Yes, my Secretary, the same person to whom I dictated the letter.
Q—Did you give Miss Saunders any instructions as to the disposition of the notes?
A—I gave her verbal instructions; she was to deliver one and all of them to Miss Miller as circumstances might require, that is should such circumstances arise.
Q—And I think you also wrote a letter addressed to Miss Miller on the same subject?
A—Yes.
Q—Mrs. Harsant told you she asked her not to fill out the counterfoils of the cheques?
A—No. I did not.
COMMISSIONER—That was denied yesterday.
MR. HOWLEY—She also stated that Mr. Meaney had asked for payment, and that she had brought the matter to your attention?
COMMISSIONER—That has already been denied by him.
MR. HOWLEY—She also stated that the money which she received from Mr. Meaney, the first cheque of \$500.00—that of December 12th—that she accounted for to Sir Richard. Did she do so?
A—She may have some office records. There was no personal accounting with me.
COMMISSIONER—I understood you to state yesterday that she, from time to time, received money for you, but you had no idea it came from any public department?
A—No. Of what advantage would it be to me to get campaign funds that would have to be refunded. I could do borrowing myself.
MR. HOWLEY—Now then, Sir Richard, do you know what the conditions in your office were during the

When Labour Rules.

The whole world awaits with intense interest the outcome of the present political situation in Great Britain, and the result of the want of confidence vote which will be taken on Monday night will be but a preliminary to the more important events which will follow.

In the event, and from the appearance of things at present it seems to be a foregone conclusion, of the vote being carried, Ramsay MacDonald the Labour Leader will assume the reins of Government. His remarks so far have indicated that he has no intention, whatever his inclinations may be, to introduce a policy of a revolutionary nature. They have been temperate in tone, decisive, and if anything discouraging to those of his adherents who would hoist the red flag over Westminster and tear the constitution to shreds.

It is difficult to see how MacDonald could hope to retain the leadership of the House for a moment if he attempted to introduce extreme Radical ideas, for it is evident that any such measures would be as strongly opposed by Liberal as by Conservative. A united vote of these two parties is capable of blocking any legislation that Labour may introduce, and it is certain that if a policy were brought forward which in their opinion would tend to be detrimental either to the economical or to the constitutional safety of the country or the Empire, their action would be united and immediate.

The Labour Party contains many level headed men among its leaders; the great majority of the rank and file are certainly possessed of sound common sense, and it is safe to predict that they are unlikely to destroy the existing institutions or carry out any plans which would endanger their means of livelihood for the sake of gratifying the desires of the advocates of anarchy.

We are prone to give more attention to those who make the greatest amount of noise, but it does not follow that they dominate the situation, or even command a following of any great political weight.

The attitude of Mr. Asquith as expressed in this morning's despatch must be taken to mean that he has confidence in the Labour party to carry through a sane programme. If his utterances were given any other meaning than that, it would be equivalent to accusing him of being willing to sacrifice the cause of his country and the Empire for the sake of obtaining a political triumph at a later date. It is inconceivable that a man in his position could be capable of any such premeditated plan however great his personal ambition might be, and it is certain that if such a motive prompted his actions, he would be repudiated by the great majority of his followers.

Circumstances Leading to Sir Richard Squires Resignation Investigated Examination Continued This Morning

The enquiry yesterday afternoon for the most part had reference to the political matters which immediately preceded the resignation of Sir R. A. Squires in the Spring of 1923. It was admitted by Sir Richard that he had discussed the terms of his resignation and that they were suggested by Sir W. F. Coaker, Sir Richard charged that his resignation was brought about by political intrigue. The interest was that the Attorney General was a party to it and then arose the question of his resignation. When the Attorney General announced that he would vindicate himself the spectators applauded, and he and the Commissioner were compelled to demand silence. The Commissioner cautioned those present that should other such demonstrations take place, the public would be excluded for the remainder of the investigation. When the Attorney General announced his intention of going into the details of his part in bringing about the resignation of Sir Richard, the Commissioner objected, but the Commissioner ruled that his client had brought the matter up and the Attorney General was justified in attempting to find out what was implied by political intrigue and who the instigators were.

When Sir Richard was called to the stand the Attorney General read a letter sent by him to the witness on Sept. 10th, 1922. Asked if he had answered the letter, Sir Richard said he did not but sent a copy of it at once to his solicitor, Mr. Howley after which he left for England. He said he did not regard the letter as a rumour. The witness previously explained that the public who had learned by rumor of the misappropriation of the funds of the Controller's Department made an attack on him. He did not take steps to vindicate himself with his party nor the public, nor did he bring the matter up on the floor of the Assembly although it would have been in order.

COMMISSIONER—Did this widespread attack go on uncontradicted?

A—As far as I am concerned I never contradicted the rumor.

Sir Richard explaining said the attack was made by the public who were under the impression that he had misappropriated funds of the Department according to the rumors he had heard. There was not a day passed that there was not some reference to it. He followed the course he thought best under the circumstances.

COMMISSIONER—That is a political aspect, there is a personal. I can't understand how you did not deny the accusations to the Attorney General. Was not that the object of his visit?

THE ATTORNEY GENERAL elicited the fact that besides himself Sir Wm Coaker had brought the matter up but to neither did the witness deny the accusation. To the COMMISSIONER the witness said he regarded the affair as a political intrigue with a view to the reconstruction of the administration by the exclusion of himself and the inclusion of others. After putting several questions about the charges against Dr. Campbell, the Attorney General asked the witness if he remembered having a party meeting and the attitude of the party towards the matter. After an explanation of how the demand for the resignation of Dr. Campbell arose the witness said he regarded it not as a part of one scheme of the political intrigue but as a combination. A discussion as to the exact meaning of the word intrigue was followed by Sir Richard suggesting to have the word manipulated.

ATTORNEY GENERAL—I put it to you that Dr. Barnes was the man who demanded Campbell's resignation. Do you mean he was one of the manipulators or was guilty of political intrigue?

A—No.

ATTORNEY GENERAL—Do you connect me with that political intrigue?

A—I have no proof.

Q—Then who was guilty of the intrigue?

A—I am not prepared to answer.

ATTORNEY GENERAL—I want to find out who were the members of the Government party who drew your attention to the story of Mr. Meany prior to your resignation?

A—The only ones I remember was yourself and Sir W. F. Coaker.

Asked if Dr. Campbell called his attention to the matter, the witness replied, "Not in detail." He mentioned that Meany had been spreading rumors that he had the goods on him.

COMMISSIONER—Did you enquire what that meant?

A—I merely laughed at the idea.

ATTORNEY GENERAL—Why did you not tell your party there was nothing in the rumor?

A—Because at the time the situation arose I took the view in which I still concur.

ATTORNEY GENERAL—Q—But by the statements you make, I take it it was Mr. Higgins, or Mr. Meany or myself who were actuated in bringing those charges to your attention for political motives?

A—It was my opinion by the action of Mr. Meany certainly.

COMMISSIONER—It is true that Mr. Higgins had waited upon him and told him he was solicitor for Mr. Meany and that Mr. Meany contemplated, if it was true that Mr. Higgins told that to Mr. Warren was it intrigue for him to call on you?

A—No, I had not said so. The call I presume resulted from Mr. Higgins' interview with him as solicitor for Mr. Meany.

COMMISSIONER—And his interview was only proper and right?

A—Yes.

Asked by the Attorney General if any conversation about the cheques and I.O.U.'s took place when the (Attorney General) and Sir Wm Coaker were present, the witness replied Yes, and to further questions he said he neither confirmed nor denied the charge.

ATTORNEY GENERAL—You have stated what took place between us in the interview. Do you remember discussing with me and Sir Wm Coaker the question of your resignation?

The witness replied Yes, but he did not try to make terms nor at any time authorize their discussion with the Opposition.

ATTORNEY GENERAL—What were the terms?

A—I outlined to you important public matters to which it was necessary for me to give special attention; I pointed out some four or five of them, if I remember rightly, and said if you wanted to be Prime Minister, which you said you did not want to be, I had no objections whatever to handing over the administration to you for one or two years while I look to clearing up certain vital matters which were outstanding.

The witness said it was correct that he was prepared to resign on Jan. 1st, 1924; that he wanted to go to the Imperial Conference to represent the Colony; that he wanted to be given the Labrador Boundary to handle, and also given charge of our portion of the British Empire Exhibition.

ATTORNEY GENERAL—Is it correct or not that you told me you would resign and you had to be looked after financially for a couple of years?

A—No, I will not say in that respect, but the fact that I insisted upon handling these matters, the fees for these services would suggest I was not prepared to work for nothing.

Asked if the terms had been mentioned to Sir Michael Cashin or Mr. Higgins, the witness stated that he did not authorize it.

ATTORNEY GENERAL—Did I not tell you it was necessary to consult Higgins, because he knew the facts and had the making of a charge against you?

A—Whatever you said I was prepared to hand over the office of Prime Minister.

COMMISSIONER—Your retirement with preference for Mr. Warren was suggested to you by Sir William Coaker or his associates.

A—The regular suggestion of my retirement was suggested to me in that way.

ATTORNEY GENERAL—Did I ever make the suggestion to you to retire?

A—No.

Q—Did I ever offer terms?

A—No.

Q—Did I ever suggest to you that any of the things you asked for would come your way?

A—No.

Witness agreed that the Attorney General had informed him that unless the resignation of witness was in by ten o'clock on Monday that his would be in by eleven. Asked if there were any other reasons than those referred to for his (Attorney General's) resignation, witness replied no, except for the Meany charges.

This closed Mr. Warren's cross-examination.

(Mr. Howley re-examines Sir Richard Squires).

In commencing his re-examination of witness, Mr. Howley, K.C., referred to the interview which took place between witness and Sir W. Coaker and Mr. Warren, and asked if the stories of the irregularities in the Department referred to were in the hands of the authorities at that time.

Witness said yes, and that the conversation which took place had to do with the retirement of witness from political activities temporarily. Mr. Howley informed the Commissioner that his questions were intended to

have reference to the suggested political intrigue and prefaced the questions by referring to the political conditions in Newfoundland regarding the methods of raising political funds and the way in which they were handled. It was pointed out that many subscribers preferred to maintain secrecy in the matter. Mr. Meany remained unknown even to the leader of the party. The Commissioner stated that circumstances here were apparently similar to those elsewhere. The campaign fund, it was shown, had to be kept going after the 1919 election to meet expenses of bye-elections. Such moneys obtained by the campaign committee were handed over to witness. Asked by the Commissioner if the committee was formally constituted one, witness said that that was not the custom here. The Bank of Commerce account was mainly political funds. The total deposits there up to July, 1923, were between \$95,000 and \$100,000, the greater part of which was the political fund. Asked if anyone else had made deposits while he was out of the country, witness said no, with the exception of those referred to. Witness said he had no knowledge of entries in the books during 1922, 21 and the first part of 1922 of receipts or payments with the exception of some particular matters that had already been mentioned. Asked if all irregularities took place during Miss Miller's time, witness replied that he could not say yes or no.

Adjournment was then taken until eleven this morning.

COMMISSIONER concludes cross-examination of Sir Richard Squires. Re-examination by Howley, K.C.

THE MORNING'S PROCEEDINGS.

Sir Richard Squires was recalled to the witness stand when the enquiry resumed this morning and examined by Mr. Howley. The original letter from the Attorney General in reference to his resignation and dated Sunday, July 22nd, 1922 was put in by the witness and read by the Commissioner. Following the witness stated that there had been a meeting of Committee of Council, on the Friday preceding the date of the letter, at which the Attorney General, Capt. Bona and Mr. Fooks were present. It was at this meeting, he said, he informed the Council that he was considering the matter of his resignation.

Asked by Mr. Howley if he had discovered that there was communication by Miss Miller during his visit to Montreal, the witness said he had found amongst his papers a copy of two messages which were apparently drafted by Miss Miller for transmission to the Colony; that he wanted to be given the Labrador Boundary to handle, and also given charge of our portion of the British Empire Exhibition.

ATTORNEY GENERAL—Is it correct or not that you told me you would resign and you had to be looked after financially for a couple of years?

A—I did not enquire as to the date the account was opened or closed.

Asked if he drew cheques on the account, the witness could not remember specifically, but he observed "probably nobody but himself had power to draw on it." If Mrs. Harsant had anything to do with the account, it would appear on the records of the bank. To the Attorney General who asked was there an understanding that she was to finance that account, the witness replied that he had no recollection of having a conversation with her, but if there was a conversation he would get the particulars.

ATTORNEY GENERAL—When can you get the particulars of a conversation, the Commissioner records of a conversation won't help.

COMMISSIONER—The Attorney General asked for what purpose was the account opened, to which the witness replied if there were a letter of credit account that he should have something to draw on whilst out of the colony.

He said, in answer to further question, that it was not improbable that it was opened by himself or Miss Saunders, and he was not impossible that some one could make deposits to his credit. He did not know if the account was increased between the years 1921 and 1922. He did not remember if the Bank had any authority to deal with Miss Miller in the matter of the account.

Asked if it would be a surprise to him to know that she had, the witness replied she would not be particularly surprised at anything.

ATTORNEY GENERAL—In 1923?

A—No.

To a further question, the witness said he had no recollection that Miss Miller made any deposits to the credit of the account, but it is possible that she would deposit political funds to credit, although it was a private account. He did not know if the amounts deposited were from private or political funds, it was a matter of record.

THE ATTORNEY GENERAL asked what would happen if there was an overdraft. To this the witness replied the Bank would telephone himself or Miss Saunders.

COMMISSIONER—Supposing Miss Saunders could not find the money to meet the overdraft, would she ask Miss Miller?

A—I do not think so.

Asked by the Attorney General if

The account in 1922 was overdrawn, would Miss Miller have authority to make deposits, the witness replied no, she would have no specific authority. To the question did the Bank appeal to Miss Miller, the witness replied he did not know.

The Attorney General next made an application under Statute to have an inspection of the account made and to have Mr. Archibald of the Bank of Commerce, subpoenaed to which the Commissioner acquiesced, referring to Mr. Howley right to object to his giving the particular evidence.

The Commissioner referring to the period in 1921 when the witness was abroad, asked if the account was overdrawn then; to this the witness replied yes, during August to the extent of about \$5,000.

COMMISSIONER—And that is the only account from which funds could be obtained during your absence. You were leaving an overdrawn account and notes coming due, and you left signed notes with Miss Saunders. Where they secured?

A—No.

COMMISSIONER—Were they to be discounted?

A—The Bank was prepared to carry a certain amount of accommodation. There would be a substantial office receipt, but none sufficient to meet the notes.

COMMISSIONER—Then they had to raise money somehow. Were the notes ever put in circulation?

A—As far as I know they never left Miss Saunders' possession. They were destroyed.

COMMISSIONER—Are you quite sure you did not tell Miss Miller, or get money from her husband. Her story is, she approached him and raised \$47,000. The witness said he was quite sure he had no conversation with her regarding the matter.

COMMISSIONER—When was the \$4,000 paid back to Meany, the date has an important bearing. Would it be within five days after you got back?

To this Sir Richard replied that he could give no definite idea.

The Commissioner was told that witness had made it clear to Miss Miller that he did not wish to be under any obligation to Mr. Meany.

COMMISSIONER—Why should she go immediately in defiance of your wishes, and obtain further money from Meany?

WITNESS—I can give no explanation whatsoever.

COMMISSIONER—Do you swear she never told you of the later transactions—that is those that she said followed the cheques which were redeemed?

WITNESS—I do. I had no knowledge of any payments made to Miss Miller by Mr. Meany. I have received no application for re-payment of monies which may have been advanced by Mr. James Miller.

COMMISSIONER—What reason did you give Miss Miller for reaching her power of attorney?

WITNESS—I have no recollection. COMMISSIONER—Did you ever accuse her of any improper conduct or in any way being the cause of friction in the office?

WITNESS—Not that I am aware. I think her interest in my party did not abate on the cancellation of her power of attorney.

COMMISSIONER—Is this then a wicked conspiracy between Miss Miller and Mr. Meany to plant these I.O.U.'s on you. Is there any alternative to this. It sounds a most faithless thing.

WITNESS—I can give you no explanation.

To further questions he said, "I do not recollect her retaining money for expenses. I know she made trips to Bell Island on my affairs and I would expect her to make memoranda of her expenses."

THE COMMISSIONER referred to Mr. Howley's statement at the open part of the enquiry that he had not been instructed that Sir Richard Squires was implicated in the first paragraph.

WITNESS replied that Mr. Howley had said "no official information."

"Did you discuss the second paragraph with Mr. Howley," asked the Commissioner.

WITNESS—I did.

COMMISSIONER—Then why didn't you discuss the first paragraph with him? This is a matter impugning your personal honour and it is a curious

matter that you did not instruct your counsel as to your defence before the this Enquiry opened.

WITNESS said he had discussed matters with Mr. Howley.

COMMISSIONER—Did you tell Mr. Howley about your interviews with the Attorney General in time to prepare his case?

WITNESS—I think Mr. Howley knew these things. He was the counsel with whom I discussed my case. Sir Richard was permitted to leave the box after an examination lasting four days.

MISS SAUNDERS CALLED.

MISS LOUISE SAUNDERS was then called. Examined by Mr. Howley, witness stated she had been Privy Secretary to Sir Richard Squires for some years. She remembered Sir Richard's departure for England in 1920. He had given her financial instructions prior to leaving, but he left her some signed notes with the amounts omitted. There were four of these, and they were on the Bank of Nova Scotia. He had told her to give them to Miss Miller if she asked for them. Witness put them in the safe. She thought she had not given one to Miss Miller. She had not given any of them to anybody else, nor had she used any of them herself. She tore them up after Sir Richard came back. The one she had given Miss Miller had not been returned to her.

MR. HOWLEY—How did you come to give that note to Miss Miller?

WITNESS—I don't remember.

Continuing, witness said she remembered when Squires was in Montreal in January 1922. She thought Miss Miller had brought her some messages to be sent to Squires. They were probably brought to her (Witness) to be coded. There was a code in use between Squires and her. The originals brought to her were not in existence so far as she knew.

(Copies of the messages were put in and identified by Miss Saunders.)

Witness said she had not sent the messages because they were political and she did not want to bother him with them. Sir Richard had told her to use her own judgment, but she had asked Dr. Campbell's advice and he had advised her not to send them.

MR. HOWLEY—Did you inform Miss Miller as to whether you had sent these messages or not?

WITNESS—No.

COMMISSIONER—Why did you not tell her when she brought the second message that you had not sent the first?

WITNESS—She did not ask me. The messages were read out and proved to be purely political.

MR. HOWLEY—Were you guided in your decision not to send the message by any opinion expressed by Dr. Campbell?

WITNESS—He advised me not to send them.

Continuing, witness said she remembered no other messages than those read out.

COMMISSIONER—Can you give any information about that note you did give out?

WITNESS—I don't know anything about it. I had to go to the head office to get the note as it was in the safe there.

Cross-examined by Mr. Hunt, witness said she had been told to give the notes to Miss Miller when asked for them. She herself had nothing to do with the finances of the office. She knew practically nothing about the affairs of the Law Office.

To the Attorney General, witness said she had deposited amounts to Sir Richard's account at the Bank of Commerce. She did not know of a letter of credit when he went away. She had never received money from Miss Miller to deposit. She did not know why Miss Miller brought her these messages. Apart from the fact that they had to be coded, she had acted on her own responsibility in submitting the messages to Dr. Campbell.

ATTORNEY GENERAL—Why did you put both messages on the one sheet of paper?

WITNESS—I copied them both at the one time. I did see Dr. Campbell on Jan. 2nd, the day I got the first message. I showed him the original because I had several small pieces of paper which made it inconvenient to file.

ATTORNEY GENERAL—Did you understand the second message?

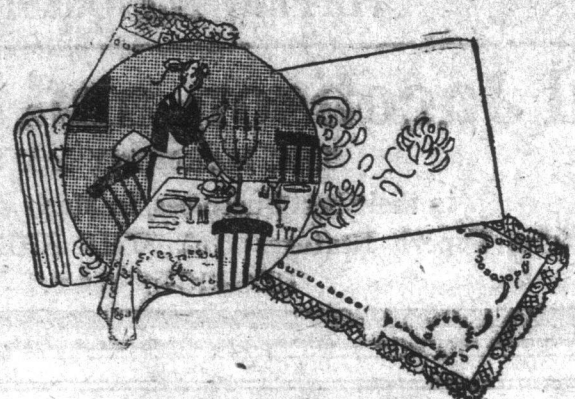

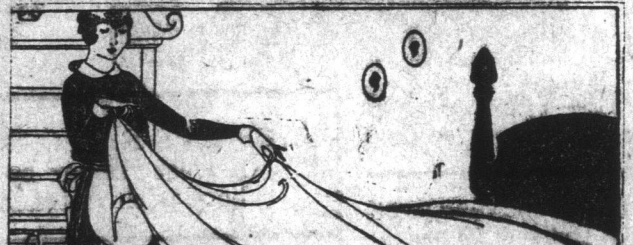

period of 1920 and 1921, that Miss Miller was in charge there?

A.—I have a vivid impression of what they are like now by the evidence before this Commission. I knew there was a general mess over there, and I secured the services of an expert, Mr. Fraser.

COMMISSIONER—That was Mr. Curtis's doing.

A.—He consulted me. I authorized the message to him, and arranged his salary.

COMMISSIONER—Mr. Curtis would hardly take it on himself to do it without consulting his senior partner. Did he discuss the matter with you before he did so?

A.—Yes. He came to me and I authorized the message. The question of salary and everything like that was arranged between us.

Sir Richard Squires—(Cross-examined by Mr. Warren.)

MR. WARREN—Sir Richard, I take it that generally your evidence amounts to this—correct me if I am wrong—that payments may have been made to you at your office, but that you had no knowledge of them at all?

COMMISSIONER—As to their source.

A.—I am not denying that she brought the whole or any portion of this money.

COMMISSIONER—Neither denying or affirming?

A.—No.

MR. WARREN—At no time, I take it, did Miss Miller hand you any money and say where it came from?

A.—At no time did she hand me any money and suggest that it came from Meaney, the Liquor Controller.

Q.—Did she at any time hand you any money and tell you where it came from?

A.—I said in my evidence I think that I had recollection of Miss Miller on several occasions handing me money, which came to a total of \$2,000.00, and I understand the money came from Mr. Miller, her brother, who offered me his services as Treasurer of my campaign. He was a strong political supporter of mine. I understand the money came from her brother; I also understand that some of it came from other sources.

Q.—Now when Mr. J. T. Miller offered his services as your campaign treasurer, you declined?

A.—Yes.

Q.—When did he offer to be your campaign treasurer?

A.—I think the first suggestion of assistance from Mr. Miller was in the autumn of 1919. Mr. Miller is a very active, capable man.

Q.—But when did Mr. Miller offer to be your campaign man?

A.—He made that offer on several occasions. I could not identify the first.

COMMISSIONER—You think it was 1919?

A.—Yes.

MR. WARREN—You declined his services?

A.—I did not accept his services. I did not make him campaign treasurer.

Q.—I understand you to say just now that you declined his services?

A.—I did not decline in the sense of saying I would have nothing to do with him. I did not accept them. There is a difference in telling a man you won't have his services.

COMMISSIONER—You would never tell a man that in politics, would you?

MR. WARREN—You could not accept his services.

A.—I was myself campaign treasurer.

A.—After June, 1921, she ceased?

A.—I think in June, 1921, Mr. Fraser issued cheques on his own account. My own account was in the Canadian Bank of Commerce.

Q.—Did anyone keep that for you?

A.—I kept that myself.

Q.—You knew the state of that account from time to time?

A.—Yes, I inquired at the bank and they would tell me how it stood.

Q.—You never heard of \$30,000.00 being put to that account?

A.—I heard of various amounts, \$1,000.00, \$2,000.00 and \$4,000.00 moneys that came in from various people for my political account. That was largely a political account.

Q.—Were amounts ever placed to the credit of that account without your knowing about it?

A.—Amounts going to that account would be known by me as to the amount. They would often be known by me as to the source, but not always as to the source.

Q.—You regarded that account as purely a political account?

A.—I so used it.

Q.—Now in 1920, before you went away, you say there were two notes outstanding one account Daily Star, and one personal account.

Q.—Was this note payable to you? How did this \$14,000.00 note arise?

A.—It was a Daily Star accommodation note.

Q.—Have you the note?

A.—I looked up the records at the Bank as to whether I was promisor or endorser.

Q.—Have you the note now?

A.—I have never seen the note since. It would be in the custody of the bank, or sent up to my office.

COMMISSIONER—If it was paid?

A.—Then it would probably be in the possession of Mr. Fraser at my law office.

Q.—Then is it in the papers now?

A.—Yes.

Q.—Could you get it from your office?

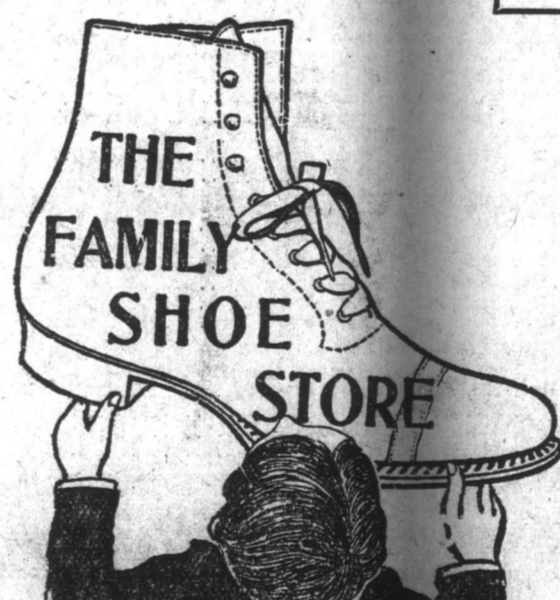

Miss Miller gave them money, she would not be acting contrary to your instructions?

A.—No.

Q.—And if there was no money in the Bank, she would not be doing wrong if she raised it?

A.—No. She would be in a difficult position. She could say to Mr. Goodland to get his books in order and collect the money himself.

Q.—If the money was not in the bank she could get it on your behalf?

A.—Yes.

Q.—She would not be committing any breach of instructions from you?

A.—No.

MR. WARREN—You knew the Daily

Star was hard up?

A.—The Daily Star was a political and not a business organization.

COMMISSIONER—That means the same thing—"hard up."

MR. WARREN—You had the financing of it to the extent of \$124,000.00?

A.—Or more.

Q.—Does that represent what you were out?

A.—Before I can answer that question, I would have to go through the books, and go through the records. I have not seen that account. My judgment is that I am out more than that.

Q.—Well, at least \$124,000.00, and since Miss Miller did not finance to your knowledge, how did you finance

the Daily Star to the extent of \$124,000.00?

A.—You mean from 1917 to 1919, how was I able to make a political investment of \$124,000.00.

Q.—Miss Miller says that she financed it by going to Mr. Meaney and getting money from him. You say she may or may not have done that, but if so without your knowledge. Your books show \$124,000.00 paid the Star. How did you manage to do that?

A.—I got that \$124,000.00 as a result of fifteen years of practice. I took no evenings off, did not play golf, spent my holidays at work.

COMMISSIONER—You got it out of your professional income?

A.—My professional earnings and commercial ventures in business, and I am happy to say I got more than that during all these years of slavery, when I was working, before undertaking political organization.

MR. WARREN—Now then, in August, 1920, this note was outstanding. In fact the two notes. And, at that time, Miss Miller had your confidence?

A.—Yes. When I went away in August, she had my absolute confidence. Q.—And power of attorney to sign cheques, notes and all the rest of it? A.—Yes. Q.—You say you did not have any

particular conversation with her before you went?
 A.—Yes, others than as I have referred to.
 Q.—You had no discussion with her about the signed notes?
 A.—Yes.
 Q.—Did you tell her you had left the signed notes with Miss Saunders?
 A.—I told her I intended to leave the notes with Miss Saunders, I signed the notes and handed them to Miss Saunders, and also the letter to which I referred.
 Q.—And why to Miss Saunders?
 A.—Miss Saunders was my secretary. I told her to give them to Miss Saunders if necessary. Ordinarily she would not need the signed notes. She had power of attorney. General bank power of attorney.
 Q.—I cannot understand why you went to the trouble of signing notes when she had full power of attorney?

A.—The Star note was outstanding, \$14,000.00, and I judged it would be renewed. That is a pretty large amount for any one individual note. I thought that my personal signature, rather than the signature of a clerk who had power of attorney, would make it look a better transaction.
 COMMISSIONER—Why was it necessary to leave the notes behind you, when she had power of attorney?
 A.—There was a \$14,000.00 note outstanding, which I judge would be renewed. Under these circumstances, I thought the bank management might possibly require my personal signature.
 COMMISSIONER—Will you return to the witness box please Sir Richard?
 A.—Yes.
 MR. HOWLEY—Before resuming the cross examination I may say that Sir Richard now has from the Bank of Commerce a statement as to his

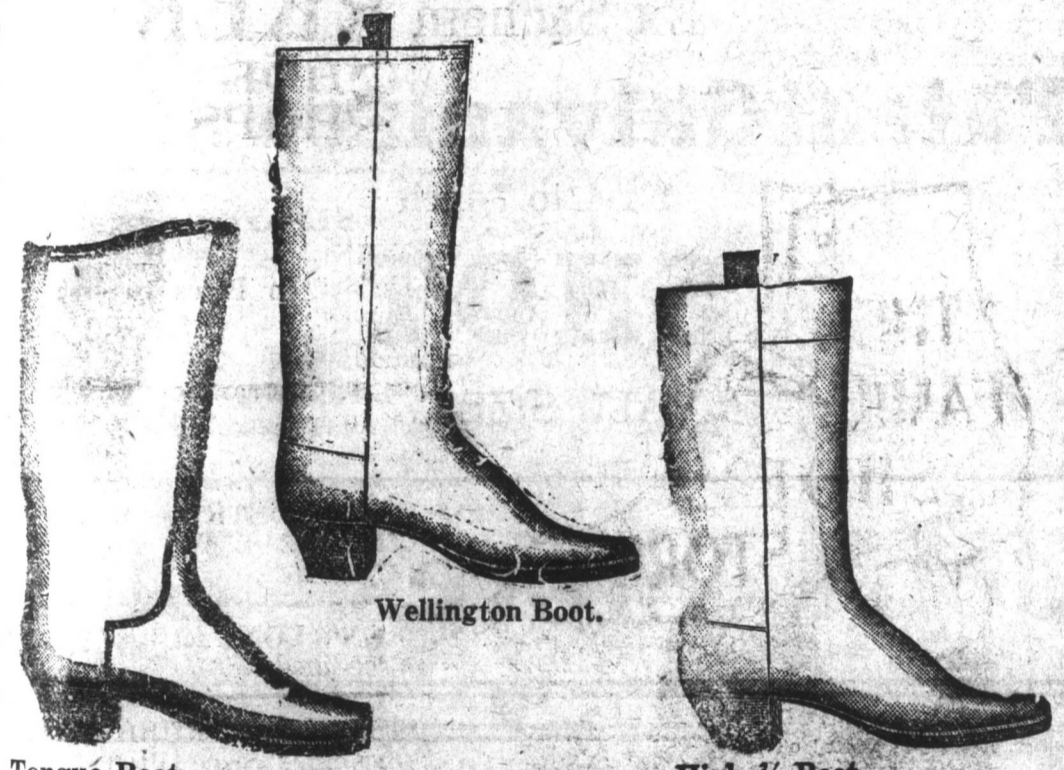
balance on July 31st which I would like to put in.
 COMMISSIONER—I will ask for it myself. Have you got it there Sir Richard?
 A.—Yes.
 Q.—It is simply a statement or a copy of the account?
 A.—Just a statement.
 (Statement handed to Commissioner.)
 COMMISSIONER—On the 24th of July there was a balance apparently of \$500. July 25th there was a balance of \$68.45; July 27th, \$108.45 and then a deposit of \$500, making in all a credit balance of \$117.71? Would you like to see this, Mr. Warren?
 ATTORNEY GENERAL—Yes.
 COMMISSIONER—You may like to go a step further in it.
 ATTORNEY GENERAL—The only thing in reference to this statement is, were there any demand notes against this?
 A.—I have no recollection at all that was on the 27th of July and I went away on the 23rd of June.
 Q.—And do you know whether there was a demand note or not?
 A.—All I know is that when the information was asked for this morning I got this.
 Q.—I am asking a straight question. Do you know whether or not

there was a demand note outstanding at this time?
 A.—I can give you no information, but I can get the information if you require in the same way as I got that.
 Q.—Before receding I think you misunderstood a question I asked and which I would like to clear up. I asked you where the \$124,000 came from and you said it was the savings of your own private work, etc.
 A.—Yes, that is what I mean.
 ATTORNEY GENERAL—That \$124,000 that you paid the "Star" from time to time extended over a period from 1916 to 1921. How did you keep that going from time to time. I do not mean to enquire into your private affairs, but as you were paying out of either Squires and Curtis or R. A. Squires account from time to time, where did the money come from?
 A.—The money came from my own various investments.
 COMMISSIONER—Did you sell investments?
 A.—No, the total was accumulated during the period of 1915 to 1921, and covering a long period of time.
 Q.—But that is only six years. Would you call that a long period of time?
 A.—That is a long period of time.
 COMMISSIONER—It may be so to some people.
 ATTORNEY GENERAL—The "Daily Star" was applying to you from time to time for money and according to that account, which I have not seen and which I have no desire to see, you paid them money through these years from time to time when you were suddenly called upon to pay certain amounts. I admit I am handicapped because I do not know the largest amount you paid them, but where did you get the money to pay these certain amounts?
 A.—It would come out of my account at the Bank of Nova Scotia or if I did not have the money I would float accommodation.
 COMMISSIONER—You would never ask Miss Miller to go and procure it for you, would you?
 A.—No.
 COMMISSIONER—The \$124,000 is all debited to the "Daily Star" in your business books is it?
 A.—In my office ledger there was an account for the St. John's Daily Star.
 Q.—That is your business book?
 A.—Yes.
 Q.—If one saw that book occasionally one would assume that the \$124,000 had been in some way paid out of the business to which those books related?
 A.—The money would be paid out of my private account, which was kept separate.
 COMMISSIONER—Always had been.
 A.—I divided the books into two sections; one section for business accounts strictly and the remaining section consisted of accounts of my own.
 COMMISSIONER—Is it in the books now?
 A.—No.
 COMMISSIONER—We could have seen it if it had been left there.
 ATTORNEY GENERAL—Then you say that you financed the "Star" by accommodation from time to time?
 A.—To the extent of \$20,000 and \$14,000 of which was outstanding when I left the country in 1920.
 Q.—Do you swear that Miss Miller had nothing whatever to do with financing the "Star" at any time?
 A.—She might have been paying out money to the "Star" and handling "Star" transactions all the time.
 Q.—Upon whose authority was she paying money to the "Star"?
 A.—Upon my authority.
 Q.—How was that authority conveyed to Miss Miller?
 A.—She knew that the "Daily Star" could not exist if it was not financed from time to time and when weekly wage bills would have to be paid they would come to the office and when I deserted my office, unfortunately, in 1919 she did the best she could to carry the "Star" along.
 Q.—But how was that authority conveyed to Miss Miller?
 A.—She had no express authority.
 Q.—Do you mean that she took it upon herself and without any authority from you to finance the "Star"?
 A.—No, she did the same as I did when I was there.
 Q.—Then Miss Miller took it upon herself without any authority to finance the "Star"?
 A.—She had the knowledge that it was my business.
 COMMISSIONER—A sort of general authority to do what she thought was right in your business?

 A.—She had the implied knowledge that it had to be done.
 Q.—You swear now that that is the only reason why Miss Miller financed the "Star" namely, because it had to be kept going?
 A.—She did do it in my interests.
 Q.—Had she any instructions whatever from you?
 A.—She had general instructions but no specific instructions.
 COMMISSIONER—She had rather more than most clerks had. She had a very wide general authority in your interests while you were away?
 ATTORNEY GENERAL—You admit as a matter of fact that she had to finance the "Star"?

soon after you left for England in 1920. Did not that note cause you some concern?

A.—No, it was a note that had been put in the Bank of Nova Scotia as accommodation. It had been renewed a number of times and the thought that it would not be renewed again never occurred to me.

COMMISSIONER—Was Mr. Glennie Manager of the Bank of Nova Scotia at the time?

A.—Yes, I think it was. In accordance with your suggestion this morning, Mr. Commissioner, I had my account go through the files in the short time at his disposal and he has found a series of notes in connection with this \$14,000.

COMMISSIONER—The \$14,000 had been renewed many times before?

A.—Yes.

Q.—And renewed without any reduction and no interest paid?

A.—I could not say.

Q.—Can you get your notes renewed as often as you like without paying for the accommodation?

A.—I presume the interest was charged.

Q.—You presume the interest was charged somewhere. That is the series of the \$14,000 renewals and I take it that the \$14,000 note had been renewed before several times.

MR. HOWLEY—It is not the entire series, the last one is not there.

COMMISSIONER—But these documents confirm it. I suppose at last these notes will have to be paid. Did you ever hear that Mr. Glennie would not renew this note any more?

A.—Not until I heard the statement made that he desired his payment.

ATTORNEY GENERAL—Apparently the note for \$14,000 came due from time to time. They are all in the handwriting of Miss Miller are they not?

A.—Yes.

Q.—Endorsed not by you but by Miss Miller, per R. A. Squires and Squires and Winter, per J. G. Miller, and suddenly although she had been endorsing these notes month after month in August, 1920, you decided that you would leave blank notes and endorsed by yourself personally?

A.—I decided to have them signed by myself personally and I decided to leave them with Miss Saunders.

COMMISSIONER—I thought this morning you said that \$14,000 was too big a sum to be carried over Miss Miller's signature?

A.—Absolutely, but while these notes were running I was in town always, then going away for a lengthy trip I did not know whether the Bank would accept her signature for this large amount or not.

COMMISSIONER—That is rather different from what you told this morning. It was not the amount; it was really because of your absence?

ATTORNEY GENERAL—And although Miss Miller had been in the habit of endorsing all these cheques

actions which are not associated with the matter now before the court.

ATTORNEY GENERAL—This note was due in August 1920 was it not?

A.—Yes.

Q.—You went away and left this note outstanding?

A.—Yes.

Q.—Was it a thirty days' note?

A.—For two reasons; one so that she could sign herself and secondly to have blank notes available.

Q.—After you went did you make any enquiries as to how she got on about this note?

A.—I have no recollection of having made any enquiries.

Q.—Did you communicate with her and ask her what happened to the notes generally?

A.—I have no recollection whatever concerning the note.

ATTORNEY GENERAL—Do you remember sending her a wireless message from the "Digby"?

A.—In her evidence I think she said she received one.

Q.—I ask you again do you remember sending her a wireless message from the "Digby"?

A.—I have no definite remembrance.

COMMISSIONER—Is that the ship you left on in August?

A.—I travelled on the "Digby."

Q.—Did you send Miss Miller a wireless message?

A.—I do not recollect exactly. I may have sent a wireless to her.

ATTORNEY GENERAL—So that anything Miss Miller did was done gratuitously and under implied authority from you?

A.—Anything she did was in the interest of the "Daily Star" and for the general benefit of all concerned.

Q.—Anything she did for the "Daily Star" was done gratuitously and from a sense of duty, is that it?

A.—I have no recollection of giving her any instructions in connection with the "Daily Star" after I left town.

ATTORNEY GENERAL—Just look at that! (Produces wireless message and hands it to witness.)

A.—Yes.

Q.—Does that refresh your memory?

A.—It gives me an idea of what probably happened.

Q.—I thought you had an idea of what probably happened before this?

A.—I resent that discourteous remark.

Q.—It is not a discourteous remark. Will you just read out that message?

COMMISSIONER—Is the telegram produced the one that you sent to Miss Miller?

A.—Probably.

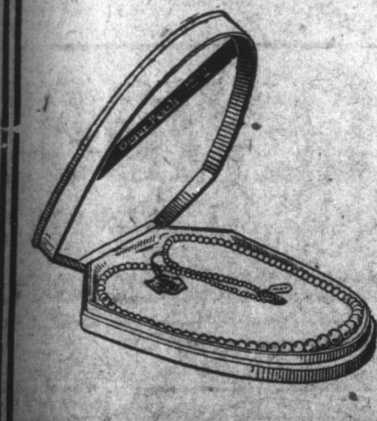

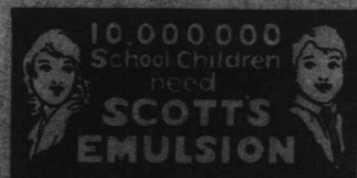

NOTICE!

The attention of those engaged in the packing or in the selling of Herring of "Scotch and or Norwegian Cure Method" of pack is drawn to the following sections of the Rules and Regulations respecting the Herring Fisheries of Newfoundland, which the Department of Marine and Fisheries is determined to enforce:

"SCOTCH CURE AND OR NORWEGIAN METHOD" OF PACK.

No person shall engage in the business of curing and packing herrings under the "Scotch and or Norwegian Cure Method" at any place in the Island of Newfoundland without having previously taken out an annual License. And the owner or manager of every plant cause to be branded upon the head of every barrel or half barrel, the number corresponding to the number of the License of said curing or packer. For this purpose he shall obtain through "The Fisheries Board" a suitable branding iron, the cost of the same to be fixed by said Board and defrayed by the Licensee. No branding irons other than those obtained from the Fisheries Board shall be used. And any person or persons in the Colony selling, purchasing or exporting, or being in any way a party to any transaction in the nature of a sale, purchase or export of a package containing any herrings put up under the "Scotch Cure and or Norwegian Method" without any brand as aforesaid, shall be deemed guilty of an offence against these Rules and Regulations.

Inspectors shall have the right to visit all Plants putting up Scotch and or Norwegian Pack, at all reasonable hours, and shall not be obstructed in any way from carrying out their duties. Any curing or packer in any way hindering or obstructing such officer in the discharge of his duty, shall be deemed guilty of a breach of these Regulations. The license of such packer may at the discretion of the Minister be cancelled without further notice.

PENALTY CLAUSE.

Contained in Chapter 11 of the Consolidated Statutes (Third Series) entitled "Of the Department of Marine and Fisheries."

Every one who violates any provisions of this Act, or of the Regulations under it, shall be liable to a penalty not exceeding one hundred dollars and costs, and in default of payment, to imprisonment for a term not exceeding two months. All materials, implements or appliances used and all fish caught, taken or killed in violation of this Act, or any regulations under it, shall be confiscated to His Majesty and may be seized on view by any Fishing Officer, or taken or removed by any person for delivery to any Justice of the Peace.
