EXPLANATORY NOTES.

BILLS OF SALE—The first name and address is that of the party who gives the Bill of sale, and whose occupation or business is given at the end of the line.

CHATTEL MORTGAGES—The first name and address in this list is that of the Mortgagor; the second that of the Mortgagee. When the letter R. is placed after the second name it signifies Renewal; P. N. means Promissory Note, and Coll., Collateral.

WRITS—The first name is that of the person against whom the Writ is issued. The letters at the end of the line indicate the courts in which the suits are entered, as: C. C. County Court; Q. B. Queen's Bench; C. P. Common Pleas; Chy, Chancery; H. C. High Court.

JUDGMENTS—The first name of each line is that of the judgment debtor.

The figures at the beginning of the lines are the dates of the various items during the week or so previous to date given at the head of the list.
