The Grand Worthy Patriarch read his report, as follows:

To the Grand Division of the Sons of Temperance, of Nova-Scotia.

Officers and Representatives.

WORTHY BRETHREN,-Having met again in Annual Session, permit me in submitting my last report to greet you in the name and spirit of our three cardinal principles.

It is with sincere satisfaction I have to state that the divisional year now closing has been one of cheering progress.

When you listen to the carefully prepared statistical tables presented in the Grand Scribe's report, you will ascertain for yourselves the pleasing fact, that since the year 1854 the Order in this Province has not been in a more healthy and prosperous condition. With but few exceptions the Subordinate Divisions are either steadily maintaining their ground or prosecuting the cause with vigor and success, weekly adding to their numbers. It may not seem invidious if honorable mention be made of some of these last.

From Yarmouth—the birthplace of the Order in this Province—Deputy Pinkney reports that the "prospects seem brightening" in some of the Divisions under his charge, while one, Milton No. 4, "is going at locomotive speed."

From North Sydney—the other extreme of our jurisdiction —Deputy Bown reports that the Divisions under his charge "never were in better working order, or showing more zeal."

In the same quarter of the moral sky "Star in the East" Division is in the ascendant.

Chester Division "is in a most healthy condition." "Never since its formation did it present a more flattering appearance." The Quarterly Session of the Grand Division held in Chester last summer created new life and vigor in their ranks. An Episcopal clergyman has joined this Division during the last guarter, who brings with him considerable influence. "The enemy has hardly been seen within the bounds of Wellington Division, Sherbrooke, this summer." The Captain of the packet to that port steadily refuses to carry the accursed thing in his vessel. All hail! to the Captain of the Sherbrool.e packet and to Wellington Division. Long may they prove worthy the name they have as invincible soldiers of temperance, and long may they be a flame of fire and a sword of terror in the eyes of their enemies.

"The Divisions at Wallace and Pugwash are in a healthy state. The Pugwash Division, which twelve months ago was in a very feeble condition, is advancing beyond all expectations."

The "June Rose" Division, Hammond's Plains, is in a more healthy state than formerly. The last quarter has been one of great activity and prosperity. They have a Hall in course of erection. The principles of the Order are loved and cherished. Their motto is "onward." May the "June Rose" long bloom and continue to "shed a more cheering fragrance," and may it never, like "the last rose of summer," be "left blooming alone."

Deputy Shean informs me that "in the city of Halifax, taking all things into consideration—the Order is progressing." This officer deserves special thanks for the able manner in which he has discharged his duties during the term.

The above extracts are presented as specimens of the letter and spirit of not a few of the reports that have come into my bands.

It gives me pleasure to state that nearly all the Deputies have made their reports for this quarter.

But though the picture has a *bright*, it has also a *dark* side. Notwithstanding that—with here and there a painful exception—the Subordinate Divisions are in good working order and increasing in numbers. I regret to be compelled to confess that intemperance is not correspondingly diminished, but rather on the increase. The existence of our Order, without doubt, prevents the evil from spreading more rapidly than it otherwise would; but it is melancholy to reflect that, after having expended large sums of money and years of laborious effort, we have been instrumental mainly in hindering the more rapid development of intemperance, when its utter extirpation might have been expected. The amount of good accomplished does not appear commensurate with the amount of labor expended.

Much positive good doubtless has been done; but in a neg-

Our progress has been up-hill, with many a slide tive form. backward. Some have grown weary of the incessant and seemingly never-to-be-ended contest with hoary evil. Others have given it up in despair. Such have miscalculated the nature of human depravity, and of the vice against which we are waging war. This moral demon-this Nena Sahib-this destroyer of men, women, and children-has a thousand lives and will die hard. Do you ask, "When is this moral warfare to end?" If any imagine, that, after fighting a few years, with various turns of fortune, they are going to retire with laurels and rest upon their trophies, they have mistaken the calibre of their enemy. With such a foe it is a wearisome battle. Intemperance and its occasions form a moral Delhi, not easily subdued. We will have to await many an assault in the trenches, and repel many a sortie before we are able to storm the well fortified citadel. It may require a generation or two to accomplish its subjugation. Shall we therefore relinquish the contest?—Never:—we fight for posterity as well as for ourselves.

A hundred years ago the Dutch built their ramparts—mud walls—to resist the effects of the ocean upon the soil they had redeemed from its grasp. Does the Hollander trust these walls? No. Day by day he steals an hour from toil to fill the breach made by the ocean. The willows are constantly decaying and must be replaced to keep out the wild waters that roar bove his head, that he may retain the heritage left him by his ather. We, also, have redeemed some ground—

> "Yet much remains To conquer still; peace hath her victories Not less renowned than war."

We have shut out the angry floods of appetite, custom and necess, that are raging around us. It may take a long time o convert the remaining water into land. But will we not ght to retain the land we *have* redeemed at so much labor and spense? We will,—if it should cost us a life-time spent in is effort alone.

In the name of hundreds saved, and millions exposed to the stroyer, I charge you not to peril by indifference what so uch toil and self-devotion have purchased for us. Our fathers e growing gray in this service; shall we not transmit the orks of their hands with unimpared efficiency to posterity, and put those who come after us in a position to finish that which we have begun.

But have we put forth efforts in keeping with the magnitude of our undertaking? We have not.—What have we done in our own Province? nay, rather, what have we left undone? Our duty clearly is to extend our principles to the utmost of our power. We have pledged ourselves not to cease working until every brother in the great brotherhood of humanity stands embraced within our circle of safety and honor. How does this comport with the fact that our ably conducted journal, so full of interesting and convincing argument, has the meagree circulation of nineteen hundred numbers? Is this a proper response to the labours of the devoted and learned brother who conducts it? Is this a' proper expression of our interest in the prosperity of our Order and in the cause of temperance?

Do we expect the public mind will be illuminated by such a circulation as this? We should not rest contented until the *Abstainer* is in the hands of every man, woman and child that can read, in the Province. If we are to rely upon the instrumentality of the press as a means of the conversion of the entire **Province** to temperance and prohibition, we must circulate the *Abstainer* by thousands. I once more, and for the last time, earnestly urge this matter upon your serious consideration.

It gives me pleasure to inform the Grand Division that the measure proposed at the last Quarterly Session—that of getting up a Bazaar for the purpose of raising funds to promote the work of temperance—is being carried into effect. The Committee to whom this matter is entrusted will report progress. I will not anticipate what they have to state; be simply say that Divisions in the capital are making commenable efforts in assisting the Committee to carry out the objec in view, the Chebucto and Athenaeum Divisions having issue circulars to their friends soliciting co-operation in the goo cause.

In presenting my official report I cannot overlook the fact known to you all, that a Temperance Convention met yesterda —the 27th—in the city of Halifax. The deliberations of the Convention were of the most interesting character. I commend its action to your attentive consideration. It would the to promote concert of effort among the friends of temperan in the country, if the Grand Division would re-affirm—as to as they wisely can—what was said and done on that occasion is With regard to the question of prohibition, which has been so often before the Grand Division and to which we have so unequivocally given in our adherence, I have simply to say that while considered as a principle there is little difference of opinion among the Sons of Temperance. Some are beginning to question the wisdom of pressing it upon the consideration of the Provincial Parliament until the public mind is more thoroughly indoctrinated therewith.

Our efforts with the Legislature must have their basis upon enlightened public sentiment ; otherwise they will prove abor-Both the Legislative and judicial branches of the , tive. Government are against prohibition, and must be made to feel the pressure of this question as a Provincial demaind. The battle must be fought at the hustings and at the polls-the constituencies must be converted before prohibition can become the law of the land.-The measure is not regarded, even by the Sons of Temperance themselves, as a matter of supreme political importance; and until they and the people generally so regard it politicians will continue to burke it in Parliament, and judges scout the principle on the Bench. I have no hope, until the issue is thus presented, that the Province ever will be redeemed from the ruinous, intemperance-producing traffic in intoxicating drink.

A few hours hence I shall be called upon to lay down the evolution of my authority, and retire from the chair. I embrace it is opportunity to express to the Grand Division my deep inse of obligation for their courtesy and confidence. I came among you a stranger and you were pleased to confer upon me be highest office in your gift. It has been my endeavour to show you that your confidence was not misplaced; but I retire from office under the painful conviction that my efforts, though qual to my ability, have not been commensurate with the obliations of the chair.

Permit me again to revert with sincere satisfaction to the act that, during my administration, the members and interest f the Order have not diminished, but increased. Much of this resperity is due to the efficiency of your G. S., with whom my numacy has been of the most pleasing character, and to whom am indebted in being able with any degree of ability to meet be duties of my office.—To the other officers of the Division return my sincere thanks for the manner in which they have ischarged their respective duties, and the respect and courtesy with which they have treated the chair, as well as for personal favours.

Leaving the interests of the Order in the hands of the thoughtful and benevolent men around me, who are looking and labouring with unwavering faith for the day of social redemption, I respectfully submit this, my last report, in Love, Purity and Fidelity.

Referred to Committee on State of the Order.

The Grand Scribe read his report, as follows:

### To the Grand Division of the Sons of Temperance of the Province of Nova-Scotia :

Grand Worthy Patriarch, Officers and Brethren :

We are again permitted — by the goodness of the Almighty — to meet in annual session, to deliberate on the best means of sustaining and advancing the Order under this jurisdiction. I trust we shall begin and end our work with a right spirit, and during the session adopt such measures as may be practically carried into effect.

Several subjects will be presented for your consideration, which, I feel assured, will receive that attention at your hand which their importance demands.

The first great subject that will engage your attention is the steps that ought to be taken with reference to a Prohibitory Liquor Law. A great diversity of opinion exists at present as to the propriety of again seeking that measure at the hand of our present legislators. A few years ago a vast majority the temperance people of Nova-Scotia gave a decided opinion (through petition, &c.) in favor of it. The bill which was prepared and presented a few years ago, being politically hocus-pocussed out of the legislature so often, the ardor a some of its warmest friends has cooled, and they do not not feel inclined to appear, through their petitions, before the assembled wisdom of the land; others are desirous of only petitioning for a partial law; while a large number have se z. their minds on seeking for the separation of the liquor traff 'n from all other traffic. I presume, however, that the measure that may be agreed upon by you, in unison with those adopte he

by the Provincial Convention, will be accepted by those who are represented in both bodies. It is my opinion that the petitioning for the whole measure should not be abandoned, notwithstanding the representations made as to the failure of the law in some of the neighboring States. I have no doubt that every brother present is already aware of the triumph recently gained by the "Maine Law" party in the Pioneer State, and which, no doubt, will result in the spreading of the Law once more on its Statute Books; this shows, brethren, that the people of Maine would rather have a Prohibitory Law than a host of rum shops; they have set an example which should be copied by every Kingdom, State and Province. Let Nova-Scotia follow in the wake of the "Down Easters," and beneficial results will soon be apparent.

In reference to the remarks made as to the reverse of the law in some places, I will here give you the report of the Special Committee on Prohibition, as presented to the National Division at its fourteenth Annual Session, held at Providence, in June last:

"The Committee to whom was referred the subject of Prohibition, beg leave to report that they fully echo the sentiment of our M. W. P., regarding prohibition as a "fixed necessity," the establishment of which, in every State and Province of our jurisdiction, is a matter devoutly wished and sincerely to be labored for; nor can we be content until we hail its accomplishment. The reverses which may have attended the merations and existence of the law in some parts of our jurisliction, were not at all owing to its weakness or inadaptedless to effect all that its most sanguine supporters expected, but owing entirely to the ceaseless activity and agitation of ndividuals financially interested in the traffic in intoxicating iquors-representing the law as unjust and tyrannical, withut a corresponding effort on the part of its promoters to how the falsity of such a cry-together with the negligence nd partiality of those officers who were charged with the duty f carrying out the provisions of the law. No law is so instinct ith life as to march forth in the struggle of manhood to exeute its own requirements, but needs on the part of the secutor a watchful eye, and unwavering hand, an impartial ad fearless judgment—and on the part of the public, a symathy and countenance of such officers as will execute honestly e requirements of the law. To say, therefore, that because

executive officers have neglected *their* duty, and communities *their* privilege in the use of the franchise, the law is a failure, is as unreasonable as it is unphilosophical.

Where the law found conscientious officers doing their duty and communities availing themselves of their privilege, it has answered to the fullest extent the desired and expected endmaking prisons and poor houses tenantless, and tottering inebriates in the street a sight very rarely seen; while many family circles rejoiced in the happiness it extended to them.

We look with deep solicitude and interest on the first battle field of this question-Maine; for a repeal of the law in this State paralyzed to a great extent the efforts of its friends in other jurisdictions. The fact is understood by the well informed, that its repeal in Maine was not from any want of efficiency, but from a variety of extraneous causes. Yet the effect has been disastrous. If, however, this jurisdiction shall restore to her statute book her prohibitory law. a new and more powerful era will be inaugurated; and we . rejoice to learn that they are now exerting themselves to occupy the honorable position they once did, and towards the accomplishment of this every assistance should be rendered them by this body. With feelings of honest pride we have learned the enthusiastic reception given to our much esteemed and distinguished Brother, Past Most Worthy Associate Dow, in Great Britain, and feel sanguine that his candid and matter of fact statements of the working of the prohibitory law in the State of Maine particularly, and other States generally, will be attended with the most satisfactory results.

The foregoing report was adopted by the National Division, thus showing that Prohibition has now become one of the principles of our Order.

The next subject of importance is the Agency question and it, brethren, will require your most serious considertion, as a Lecturer and Agent to visit Subordinate Division is now more requisite than ever. While nothing can be dom as regards the employment of Lecturers, until funds are obtained for that purpose, the question might be discussed at the present Session, in order that full information and instruction may be given the Agency Committee, so as that arrangements can be entered into at the commencement of next year, by which time the proceeds of the contemplated Bazaar may be counted upon.

The Abstainer newspaper also requires your attention. I regret to say that while the circulation of the first volume was 1868 copies, the second volume commenced with an issue of only 1723; since the commencement of the second volume 31 additional copies have been ordered, which makes a nett decrease of 114 copies. No cause has been assigned for the diminution. It is hoped that increased exertion will be made to extend the circulation of the paper. I would refer you for further information, to the report of the Publication Committee. I have ordered a copy of the paper on file for the use of the G. D.

The Bazaar Committee appointed at the July Session, held at Chester, have attended to the dutics imposed upon them, as far as it was practicable or prudent for them to proceed. Their report will be duly presented.

The Committee appointed at the same Session to make arrangements for a Provincial Temperance Convention, have also attended to their duties, and their report will also be duly presented.

Respecting the state of the Order,—while some of the Divisions have had declensions, and others nobly hold their ground, some of them have had large accessions, and from the information conveyed to me, I am happy to state that, upon the whole, the Order under this jurisdiction is in a very good condition, and Total Abstinence principles advancing in many places throughout the Province. This is the result of efforts made by a few of the Divisions, aided by 'Temperance Socieics, and very commendably seconded by clergymen of sevenal religious denominations. In some of the Eastern Counics the 'Temperance Watchmen Clubs appear to be doing a good business in their way. More detailed information respecting the cause in the several districts, I persume will be armished by the G. W. P., who no doubt has been put in possession of many facts by the Deputies.

There are 73 Divisions on the Roll, 66 of whom are sup-

posed to be in working order. I have received returns from 49 Divisions, of which the following is a summary ;---

Returns for quarter ending 30th September, have not ye been received from Acadia, Union, Victoria, Walton, Roseway, Olive Branch, Lunenburgh, Lake, Iron Age, Father Mathew, Clements Arch, Kellogg, Chedabucto, Evening Star, Invincible, Parrsborough, Railway, Exeter, Flowing Fountain, Diligent River, Alma.

I have received no intelligence from the Divisions at Digb and Londonderry for twelve months, and from the Division: Parsborough I have received no account since my appointment to this office. The only way, in my opinion, that these annoyances can or will be rectified, is by the regular visits of an energetic Agent; one who is well versed in the rules, &c., of the Order, and capable of explaining them to the Division.

I herewith submit papers received from the Secretary of the Provincial Temperance Convention, which met yesterday; they contain various resolutions approved of by that body, and are referred to the Grand Division for its approval.

Fighty-nine copies of the Journal of Proceedings at the Fourteenth Annual Session of the National Division, have been received from the office of the Most Worthy Scribe, and one copy sent to each Division.

A Circular Letter addressed to the Subordinate Divisions of the Order, has been issued by a Committee of the National Division, in accordance with a resolution passed by that body at its late Session. An official copy has not yet been received.

The amount appropriated by the Subordinate Divisions towards the expenses of the Representatives to the National Division, was £28 18s. 3d.; of that sum, £26 18s. 3d., have been paid. The expenses of the Representatives who attended amounted to £30, leaving a deficiency of only £1 1s. 8d., to be made up from the funds of the G. D. That immediately subsequent to the session referred to, your Committee met, and, after much consideration, resolved to issue a Circular, addressed to the subordinate Divisions, setting forth the objects for which it was intended to hold the Bazaar, requesting their co-operation in the matter, and offering several suggestions for their guidance. Two hundred copies of the Circular were mailed to the Divisions and to a number of temperance friends throughout the Province, withineighteen days after the session of G. D., at Chester.

At a subsequent meeting of your Committee — but few replies to their Circular having been received, and after consulting with the Committees appointed by the city Divisions, as also with a number of gentlemen who have had experience, from time to time, in getting up Bazaars — we felt that it would be imprudent, (probably result in a failure, and perhaps involve the Grand Division in debt), if the Bazaar was to be held at the time originally named, viz., during the Annual Session Your Committee, therefore, came to the unanimous conclusies of postponing the holding of the Bazaar to Thursday, 17d day of December next, as the most suitable time, although later period was urged. Two hundred other Circulars were then issued, announcing the postponement and causes there for, to the subordinate Divisions.

Both Circulars were published in the *Abstainer*, and a com of each is herewith submitted.

Your Committee have held ten meetings for consultation among themselves and with others, as to the best course to pursued. The subject has been constantly kept before the city Divisions, and has also been brought to the notice of the Deputies and others throughout the Province, by the Grand Scribe.

From replies received, your Committee would present the following as the result:

Committees have been appointed in accordance with suggestions contained in first Circular, by the following Divisions: Chebucto, Micmac, Mayflower, Howard, Chester (with Committee of ladies), Royal (do.), Star, Star in the East, Athenæum, and Rechab (with Committee of ladies).

Committee to prepare those Addresses: J. S. Thompson Dr. Cramp, and W. M. Brown, and both to be signed by the Officers, and the P. G. W. P.'s and P. G. W. A.'so the Grand Division. 4. "That a Petition be prepared, and be signed by the Officers of this Grand Division, to be presented to the Legislature at its next session, setting forth the advantages of prohibition, and praying for the enactment of a Prohibitory Liquor Law."

Committee to prepare the Petition : Wm. Howe, S. Selden, W. M. Brown.

5. "That the friends of the Temperance Cause in the Legislature be requested to advocate all the rights and claims of the cause, but to accept such ameliorations of the present system as may appear obtainable."

The last mentioned committee to take charge of this resolution.

6. "That pending the application to the Legislature for Prohibition, efforts be made for the legal separation of the sale of Liquor from all other sales; for some more efficient right of search in reference to places supposed to be engaged in illicit sale of liquors; and for more easy conviction for such offences,—so as to prevent evasions of justice, and vexatious delays."

Committee to take charge of this resolution : R. Motton, W. Howe, and A. James.

7. "That Moral Suasion should be a prevailing object of our organizations,—and that it should be conducted by regular and occasional lectures; by addresses from the pulpit, where practicable; and by the publication of tracts prepared in the Province, and the circulation of other tracts; and that a permanent Committee be appointed, whose duty shall be the consideration of ways and means for those purposes."

The Agency Committee to take charge of this resolution.

While it is the conviction of your Committee that a very considerable proportion of the inhabitants of this Province would hail, with no small degree of pleasure, the enactment of a Prohibitory Liquor Law, — are anticipating, with much interest, the arrival of the period when our Province will no longer be cursed with a traffic fraught with so much evil, under the high sanction of law, — yet your Committee feel persuaded that much effort is still needed for the diffusion of our principles by means of lectures and the press.

The valuable services of the esteemed and talented brother who has the editorial management of *The Abstainer*—our official organ—merit much larger encouragement than they have yet received, and we doubt not but that, by more general and zealous attempts to introduce that valuable auxiliary to our cause to the notice of temperance friends, its sphere of usefulness may be very greatly widened. We commend this matter to the very earnest attention of the Divisions, and of all the temperance Orders and Societies in the several localities.

Whatever differences of opinion may be entertained as to he desirablencess of pressing the immediate enactment of a Prohibitory Liquor Law upon our present House of Assembly, our Committee regard it as of high importance that the subect should be continuously brought before the Legislature, hat thereby our testimony may be distinctly borne, as to the aiquity of legalizing the traffic in strong drink, and that the iends of the measure may be encouraged not to relax their florts until the object so dear to their hearts is gained.

Your Committee earnestly hope that the services of one or nore efficient Agents and Lecturers may shortly be secured, s being necessary in order to the more complete enlightennent of public opinion on the temperance question, and for he further preparation of the constituency of the Province to est that question at the hustings.

The Committee recommend that the Grand Scribe be structed to take measures for the introduction of the new itual in all the Divisions within our jurisdiction, at as early period as practicable.
