AN ACT TO INCORPORATE THE ALUMNI
OF KING'S COLLEGE, WINDSOR.

Passed the 30th day of March, 1847:

WHEREAS, a number of persons have associated themselves under the name of The Alumni of King's College, Windsor, for the promotion of Education, and have raised by private contribution sums of money which they are desirous to expend in aid of the funds of the said College, and the Collegiate School, at Windsor, connected therewith, in or towards the maintenance and support of the teachers therein, or in such other way as may best conduce to the end which they have in view, and they are desirous of obtaining assistance from the Legislature, by the passing of An Act of Incorporation for enabling them to hold property, and to manage their affairs with greater ease and convenience.

I. Be it therefore enacted by the Lieutenant-Governor, Council and Assembly: That John T. Twining, James B. Uniacke, Henry Pryor, Hugh Hartshorne, and all and every such other person and persons as now are members of, or in the said Society, and their successors, shall be and are hereby appointed a body, politic and corporate, in deed and in name, by the name of "The Alumni of King's College, Windsor," and by that name have succession and a common Seal, and by that name shall sue and be sued, plead and be impleaded, at law and in equity, and in all Courts and places, and be able and capable in law to have, hold, purchase, get, receive, take, possess and enjoy, lands, tenements, hereditaments and rents, in fee simple or otherwise, and also goods and chattels, and all other things real, personal and mixed, and also to give, grant, sell, let, assign or convey the same or any part thereof, and to do and execute all other things in and about the same, as shall or may be thought necessary or proper; and also shall have, from time to time and at all times, full power, authority and license to

constitute, make and establish such Bye-laws, Rules and Ordinances, as may be thought necessary for the rule and good management of said Society, the establishing of Officers proper for the management of its affairs, and declaring the extent, duration, and authority of the Offices and Officers of the Society, and their mode of appointment, and generally for promoting the objects of the Society, provided such Bye-laws, Rules and Ordinances be not contrary and repugnant to the Laws and Statutes of this Province, or those in force within the same, or to the Laws and Statutes of King's College, Windsor, respectively, at the time such Bye-Laws, Rules and Ordinances may be constituted and established, or to the provisions of this Act: and provided, also, that the said Society shall not hold at any time lands, tenements, hereditaments, goods, chattels, property or effects, of greater value than ten thousand pounds.

II. And be it enacted, that all persons paying an Annual Subscription of twenty shillings or upwards, or making at one time a donation of twenty pounds or upwards, shall be entitled to be members of the said Society, having been duly admitted, pursuant to the Bye-Laws thereof, provided that such annual subscription or donation be actually paid into the funds of the Society, and provided that no person now a member of the said Society, or who, hereafter, may become a member of the same, shall, at any time hereafter, continue a member of the same, unless he shall have heretofore paid, or shall hereafter pay at one time into the funds of the said Society a donation of at least twenty pounds, or shall hereafter annually, and from year to year, pay into the said funds the sum of twenty shillings or upwards; and if such Annual Subscription, or payment of any such Annual Member, shall not be paid on the first day of May in each year, such Member shall, thereupon, cease to be a member of the said Society, until such Annual Subscription or payment shall be actually paid, or until such person shall otherwise become a member of the said Society, under some Bye-Law or Rule thereof.

III. And be it enacted that the said Society shall be governed, and its affairs managed, by a Committee of nine, comprising a President, Vice-President, and seven other members, a Secretary and Treasurer; the said Committee to be henceforth called the Executive Committee, and such other Officers as the said Society, from time to time, may think proper.

IV. And provided and be it enacted, that John T. Twining, D. D., now the President of the said Society, shall, after the passing of this

said Act, be the President of the said Society; that the Hon. Henry Hezekiah Cogswell, now the Vice-President of the said Society, be the Vice-President of the said Society after the passing of this Act; that Samuel L. Shannon, Esquire, now the Secretary and Treasurer of the said Society, be the Secretary and Treasurer thereof, after the passing of this Act; and Samuel P. Fairbanks, Henry Pryor, James B. Uniacke, William J. Almon, Robert Fitzgerald Uniacke, Mather B. Almon and Charles Twining, now the Managing Committee of the said Society, shall, after the passing of this Act, be the Executive Committee of the said Incorporated Society, until an Executive Committee be elected under this Act.

V. And be it enacted that all persons, without regard to religious denomination or difference of religious sentiments, may be, and at any time hereafter, become members of the said Incorporated Society, being in all other respects entitled to be and become members of the said Society, and now, and at any time hereafter, may hold any of the said appointments, or any other offices and appointments in the said Incorporated Society, being duly elected and appointed thereto, pursuant to the Bye-Laws thereof, any thing contained herein, or in any Rules, Regulations, or Bye-Laws of the said Society, to the contrary notwithstanding

VI. And be it enacted that the said Society, incorporated as aforesaid, shall have power from time to time hereafter, to appoint the President, Vice-President, and Executive Committee, at some General Meeting of the said Society, by a majority of the members of the Society present, the whole number present being not less than twenty members, according to such regulations concerning such appointments as may hereafter be made by any Bye-Laws of the said Society, to be made by virtue hereof.

VII. And be it enacted that the Secretary and Treasurer of the said Society, and such other officers as may hereafter be required for the management of its affairs, shall be appointed in such manner as shall be declared by the Bye-Laws and Rules of the said Society, to be passed by virtue hereof.

VIII. And be it enacted that all donations to the said incorporated Society, to constitute Life Members or otherwise, of not less than twenty pounds, shall be invested under the direction of the Executive Committee as a permanent fund for the benefit of the said Society, and that the funds of the said incorporated Society shall from time to

time, be laid out and applied by the Executive Committee in such way and for such purpose only as any General Meeting of the said Society may direct or appoint, and that the Executive Committee shall be bound, and are hereby required annually to account to the Society for all their acts, receipts, expenditures and doings whatsoever, in the said office, and to make a report annually to the said Society at its General Meeting, of the progress and state of the said Society, and of its affairs generally.

IX. And be it enacted that a General Meeting of the said Society shall be held once, that is to say sometime within the last ten days of the month of June, in each year, and as much oftener as may be directed by any Rule or Bye-Law of said Society.

X. And be it enacted, that the Executive Committee of the said Society shall meet and assemble as often as there may be occasion, and any three members shall form a quorum.



VI. That the funds of the Association will be appropriated for the payment of one or more Professors or Lecturers and one or more Bachelors at the University of King's College or one or more Teachers or Exhibitors in the College School at Windsor, to be determined by the Annual Professors and Bachelors respectively.

VII. That the Association will occasionally apply such donations as may be made to the University of King's College or to the Bachelors of the University of King's College.

BYE-LAWS

VIII. That the Association shall be an Incorporated Society and shall be known as the Alumni of King's College, Windsor.

The Alumni of King's College, Windsor.

IX. That the Association shall be incorporated in the Province of Ontario and shall have perpetual succession and shall be a body corporate.

PASSED AT A GENERAL MEETING HELD AT THE HALIFAX HOTEL, JUNE 27, 1948.

I. Besides the Annual General Meeting of the Incorporated Society, it shall be competent for the Committee at any time, either of their own accord, or upon a requisition signed by at least ten of the members of the Association, upon giving seven days notice in the public papers, to call a Special General Meeting of the Association, specifying the purposes for which it is called, and in which meeting it shall be competent for the Association to transact any such business as may be required. Ten members shall be deemed a quorum for the transaction of business.

II. That the Books, Accounts and Papers of the Association shall be open at all times to the inspection of all the members, and the Secretary shall furnish an account of the affairs of the Association, whenever required by the Committee.

III. That the Treasurer and Secretary, and such officers as shall be requisite for the Incorporated Society, shall be annually appointed by the Executive Committee.

IV. That at the Annual Meeting of the Association, the President and Vice-President shall alternately go out of office, accompanied by the first three of the Committee, and that all or any of them having a majority of votes, shall be eligible to be re-elected.

V. That at any meeting, members not present may vote by proxy, in writing to be held by any other member; provided that no member shall be entitled to vote either personally or by proxy, whose dues are not all paid up for the preceding year.

VI. That the funds of the Association will be appropriated for the payment of one or more Professors or Lecturers, and one or more Scholarships at the University of King's College, or one or more Teachers or Exhibitions in the Collegiate School at Windsor, to be denominated the Alumni Professorships and Scholarships respectively.

VII. That the Association will scrupulously apply such donations as may be made to them, to such specific objects in aid of King's College, as may be directed by the donors respectively.

VIII. That all meetings of the Incorporated Society shall be opened with prayer.

IX. (Passed at General Meeting of June 21st, 1849.) That the elections for members of the Incorporation shall be by ballot.

RULES AND REGULATIONS

PASSED AT DIFFERENT TIMES, AND NOW DIRECTED TO BE PUBLISHED.

THAT no resolution or proceeding inconsistent with or modifying any resolution or proceeding adopted by a general meeting, be entertained by the executive committee in Halifax, except upon a month's notice to the committee being given by the person proposing the same, and that no such resolution or proceeding be carried into effect until the same shall have been confirmed by a general meeting to be summoned for the consideration thereof, if necessary to be arranged before the annual general meeting.

That a corresponding committee of three residents in Windsor, or its neighborhood, the chairman whereof shall be, if possible, a member of the executive committee, be appointed to meet on the second Wednesday in every month, and at such other times as may be expedient, upon summons of the chairman, to confer with the officers of the College or Collegiate School upon any subject to be submitted to them either by such officers, or by the executive committee in Halifax, in reference to the College or School, and to report thereon to the executive committee.

A month's notice shall be given of all resolutions affecting the rights of members, or creating new officers or salaries

No individual shall be entitled to vote under a parochial certificate, unless he be authorised by a parish meeting.

All annual general meetings of this association shall be holden at Windsor.

That the treasurer make up his annual account to the 30th of April, in each and every year.

All undergraduates, resident at College, shall be competent to compete for the prize or certificate for modern languages.

At a general meeting held June 27th, 1855, it was moved by Hon. M. B. Almon: "That at this and all future elections of Governors the ballot shall be taken separately for each vacancy," which being seconded passed in the affirmative.

At the general meeting October 17th, 1856, it was resolved, "That the right of voting by proxy be in no way interfered with."

The following resolution was passed at the general meeting 24th June, 1857:

Resolved, That the ballot be not sent round for any officer of this association, or of the Board of Governors, whose name has not been previously proposed and seconded by some member of the association; and that the ballot be not taken until all the names of the persons intended to be proposed for any office be given.

REPORT.

THE Executive Committee have to present to the members of the Incorporation, their report for the past year, as required by the Act of Incorporation.

The several matters entrusted to them at the last annual meeting have been carried out by the committee.

The sum of £25, voted on that occasion to procure books for the library, has been paid to the committee specially charged with that duty, and the books have been procured, and doubtless will prove a valuable addition to the library. Your committee would recommend that a grant of similar amount should be made to be expended in the same manner for the present year. By continuing this grant annually the library will gradually become enriched, while the expenditure is not burdensome to the society.

The funds of the society have received the attention of the committee during the past year. The sum of £85 10s. 8d. is now deposited in the Savings Bank at 4 per cent. interest. This sum has arisen from the sale of the lands conveyed to the Incorporation by Charles Merritt, Esquire, of St. John, N. B. These lands were subject to the agreement for sale when Mr. Merritt presented them, and the payments have been made in pursuance of that agreement.

There is a balance of £76 6s. 7d. to the credit of the society on the general account, as shown by the treasurer's account; which, however, is subject to the payment of £20 for the prizes for the past year, and £12 10s. a half year's payment to the Principal of the Collegiate School, which will be due in October. By the terms of the resolution granting the sum of £25 per annum to the school, the payment ceases in October next.

Your committee would earnestly call the attention of the Association to the importance of increasing their funds; if the Association are de-

sirous of effecting much good, their expenditures must be largely increased. It is obvious, however, that to do this, the income must be augmented in a corresponding degree. The list of annual subscribers is very small, and, as no less than nine life members have died since the year 1856, the members of the Incorporation (by whom also the governors are elected) will gradually become reduced to the comparatively few individuals who form the list of annual subscribers. The committee would therefore, on these grounds, call upon all who are interested in the College to come forward and join this Association; the expense to the individual subscriber is not great, being £1 per annum, while the aggregate may be of the utmost importance to the College.

The committee have the pleasure of reporting that they waited on His Excellency the Earl of Mulgrave and requested his acceptance of the office of Patron, which had been held by his predecessors, Sir John Harvey and Sir Gaspard LeMarchant. To this request His Excellency was pleased to accede, and to express his interest in the cause of education generally, and particularly in the institution of King's College, of the education obtained at which His Excellency stated that he had heard very favorably in England.

The report of a committee appointed on motion of the Rev. E. B. Nichols, at the last annual meeting, has not yet been received by the executive committee, and therefore they are unable to report thereon.

The business to be transacted at the present meeting, is the election of two governors in the place of James C. Cogswell and John W. Ritchie, Esquires, who retire by rotation, but who are eligible for re-election, and one governor in the place of the Hon. James B. Uniacke, deceased.

The Vice-President, Dr. Almon, and three members of the executive committee, Nepean Clarke, Esq., Rev. Dr. Shreve, and Rev. E. Gilpin, jr., also retire by rotation, but are eligible for re-election.

THE following EXTRACTS from the Minutes of the Annual Meeting, held at Windsor, on the 24th June last, were ordered to be printed :

"The President announced having received donations from Edward Binney, Esq., of £25, and also from Henry Boggs, Esq., (special) of £25."

"Rev. Dr. Twining gave notice that at the next general or special meeting he should move that the present mode of voting for each individual separately, and in alphabetical order, be discontinued; and that the usual mode of putting all the names proposed on the same ballot, and of whom those having the highest number shall be declared elected, should be adopted."

"Mr. Pryor gave notice that at the next general, annual or special meeting, he would move the following resolution :

Resolved, That no member of this Association, holding the office of Governor of King's College, shall be eligible to be elected to the office of President or Vice-President of the Associated Alumni."

"Rev. Dr. Gray, after stating that, although the number of new students had not been so great as might be wished, yet from his own knowledge he was convinced that an increased feeling of interest in the College was felt in his own Province and locality, went on to state the necessity for providing better accommodation for the Library,—a Chapel, and a room for holding the Encœnia, &c.; and moved the following resolution, which was seconded by the Hon. M. B. Almon, and passed :

Whereas it is highly desirable that there should be a building erected for the purpose of furnishing rooms for a Chapel, a Library, a College Hall, and Museum, under the same roof; and that such building should be constructed of stone or brick.

Therefore resolved, That it be deemed a primary object of this Corporation to collect funds for this purpose; that a committee be appointed to devise means for carrying this design into effect; and that this Corporation do respectfully express their wish to the Governors that some portion of the General Fund should be appropriated to this desirable object."

"It was moved by Mr. Hill, and seconded by Hon. Mr. Almon, that the sum of £85 10s. 8d., now in the Savings Bank, arising from the sale of Mr. Merritt's land, be appropriated to the object of Dr. Gray's resolution for building a Hall, which passed unanimously."

"It was moved that £10 be granted, to be competed for as a scholarship in the same manner as the former foundation scholarships, which was seconded and passed."

"On motion, the following votes were passed:—£5 for a prize in Classics; £5 for a prize in Mathematics; £5 in Modern Languages, and £5 in Natural Science. The prize in Modern Languages and Natural Science to be divided as the Professors of the respective branches shall deem best."

THE course of instruction comprises all studies necessary for matriculation at King's College, or requisite for a thorough practical education. The Principal has engaged the services of an assistant in the English departments, while the modern languages—French, German, Spanish and Italian—are faithfully taught by a competent foreign teacher. Every attention is given to diet and exercise, and the boys are subjected to a thorough military drill. The grounds are ample;—no boy is permitted to leave them unless by direction of the Principal, or some one acting under his authority.

TERMS.—Boarders under fourteen years, £25; if over that age at the time of admission, £40 per annum, payable quarterly in advance; this includes tuition, board, washing, and ordinary mending. Day scholars, £8. Modern languages, one or more, £3. Library, 5s. Seat in church, 2s. 6d. There will also be charged a sum not exceeding 6s. 3d. quarterly for the services of drill master; and £1, on admission, for the use of the gymnasium. Each pupil is required to furnish two pairs of sheets, pillow cases, and towels.

PRIZES.—The two Alumni prizes of £8 and £4 are annually competed for at the Encenia. The £5 prize for book-keeping, established by the Hon. Judge Stewart, C.B., will be awarded at the same time, and others in various departments at the semi-annual examinations.
