An Act to authorize the Court of Chancery and the Courts of Queen's Bench and Common Pleas in Upper Canada, to admit John Symons to practise as a Solicitor and Attorney therein respectively.

WHEREAS John Symons of the City of Toronto, Gentleman, hath by **Preamble.**
 his Petition set forth, that having served under Articles of Clerkship
 for the period of five years, and having taken the oaths of allegiance and
 supremacy, he was duly admitted and is now an Attorney of Her Majesty's
 5 Courts of Queen's Bench, Common Pleas and Exchequer, and also a Solicitor
 of Her Majesty's High Court of Chancery, in England; that he hath
 resided in this Province for upwards of five years, and that during nearly
 twelve months of that time he hath been a student in the office of an
 eminent legal firm in the City of Toronto; And whereas the said John
 10 Symons is now desirous of being admitted to practise in the several Courts
 of law and equity in Upper Canada, but is advised that he cannot be so
 admitted without a special Act of the Legislature, enabling him in that
 behalf, and which he hath prayed may be passed; And whereas it is expedient
 to grant the prayer of his petition; Therefore Her Majesty, &c.,
 15 enacts as follows :

I. It shall and may be lawful for the Court of Queen's Bench, the Court **The said**
