

CIRCULAR TO BE ISSUED.

By Dawson Board of Trade, Dealing With the Treadgold and Other Concessions --- To be Widely Distributed Throughout Canada. Full Text of Circular as Prepared for Publication.

TCIRCULAR has been prepared by the board of trade of Dawson bear a semblance of being a quid pro quo for the immense properties and which is to be issued in pamphlet form and distributed widely throughout Canada. s follows in the latter part of the year 1896 the famous discoveries of placer and were made on the creeks in the basin of the Klondike river. These set followed in the years of 1897 and 1898 by the scarcely less famous nor gold discoveries in the basin of the Indian river, and on the hills a benches adjoining all the creeks on which discoveries had previously as made. During the past two or three years rich placer ground has en found in the basin of the Stewart river, notably on e ment, Clear, stmile and Henderson creeks. The more famous creeks in the Klondike un are Eldorado, Bonanza, Hunker, Last Chance and Bear, while in a Indian river basin, Dominion, Sulphur, Gold Run and Quartz are the st noted. Not only in the beds of the creeks in both-Klondike and Inm river basins but also on the adjacent hills and benches the wealth of her gold discovered has been enormous.

The proper protection and development of all these discoveries would in ensured to the Yukon territory a population of at least one hundred meand souls. This population, being dependent almost wholly for food a supplies on the sources outside the Yukon territory, would have afred a large and unexcelled market to the rest of Canada for farm prohes and manufactured goods. The possibilities of this market have, we ent, not yet been understood or appreciated by the government, the instries or trades of the rest of Canada.

In the whole of the Yukon territory, except around the town of Whiteme, the prosperity of the whole population depends entirely upon the martion of gold by the individual placer miner. A very large part of people are engaged directly in this pursuit and the remainder are enand in supplying the wants of those so employed. Anything which stimhis or retards this one industry equally stimulates or retards the prosminy of the whole community. The cessation of placer mining would reat in the abandonment of the territory for the present by almost the size population. Many of the rich early discovered claims have already resteful and rough methods been worked over, leaving a large part of rold behind, and are now being re-worked by our present - improved mining methods, which are obviously capable of immeasurably improvements, as the methods used by a few of our best operators But the greater part of the placer areas have to the present remined unworked, in some cases through lack of water, but generally bene it requires a long time and much labor to prospect thoroughly so ing a country, and because it was desirable in regard to low grade mund in the earlier years, to wait for, (a) the reduction of royalty, (b) a meaning of labor, and (c) the introduction of improved machinery. The work done thus far has taught our miners to work ground at a mill fraction of the former-cost, and more thoroughly, and has located mul beds of great extent over the whole Klondike and Indian river bass hat can profitably be worked by present placer methods. 
