Town and County News

RE-OPENED—The public schools were opened yesterday, after the Easter holidays.

REMEMBER the social in the Primitive Methodist Church to-night. Tea will be served from 7 to 8 o'clock. Admission 12½ cents.

WESTERN FAIR—The Directors of the Western Fair Association met at London on Wednesday, and decided to hold the annual fair during the week commencing 29th Sept., and to offer prizes amounting in all to \$11,000.

MORE AID TO THE T. G. & B. RAILWAY.—At a public meeting held in Toronto on Wednesday night, a resolution in favor of granting an additional bonus of \$100,000 to aid in building an independent line from Weston to Toronto, was carried by a large majority.

SOCIAL THIS EVENING—We beg to remind our readers of the social to be given in the rooms of the Y. M. C. A. this evening. The programme will comprise readings, recitations, music, and an excellent essay. Those who wish to enjoy a pleasant evening's entertainment should make it a point to attend this social.

HARD ON WHEAT AND CLOVER—The past winter has been a mild one in some respects, but it has been very severe on wheat and clover on clayland. Wheat is badly frozen, and clover is almost entirely destroyed in many fields. Pasture will be greatly shortened in consequence, as much land will have to be plowed up and sowed over.

RAILWAY ACCIDENTS—A man named John Graham, residing in Caradoc, was killed by the last train going east on Tuesday, about a mile from Strathroy. Graham was walking along the track in the same direction as the train, and evidently failed to perceive its approach. The train was delayed some time near Wyoming on the same night, having there run over and killed a colored woman.

FIRE NEAR MINOSA—On Sabbath last, 5th inst., during church service, the house belonging to widow Jessop, near Minosa, was discovered to be on fire. The two sons of the widow were the first to notice the flames, and in a short time the whole congregation were on their feet. Many rushed to the scene, but arrived too late to save much of the furniture. It was with great difficulty that the flames were kept from the barns, which were but a short distance off. The fire is supposed to have originated in the chimney. There was no insurance on the property.

THE HERNDON COMPANY—There was again a full house last night when "Bertha or Death at the Wheel" was produced in good style and took well, as was evidenced by the frequent hearty applause of the audience. The characters were well sustained by the different artists, and the interest in the fate of Bertha—the victim of so many plots—was kept up till she was righted and wedded to her first and true lover. In the after piece Mr. Ward had a fine chance for displaying his peculiar talents as an Irish comedian, and kept the audience in roars of laughter. The members of the company deserve every credit for their excellent acting, and the large attendance every night show that their efforts are fully appreciated. We must not forget to mention with praise the admirable music furnished by the orchestra. To-night Rip Van Winkle will be produced, and Mr. Herndon, who has won great fame for his rendition of Rip takes that character. The play is a most attractive one and will draw a full house.

ASYLUM FOR THE INSANE, TORONTO—The report of this institution for the year ending 20th September, 1873, has been kindly sent us by Dr. Workman, Medical Superintendent. Besides a large amount of information that is interesting, the report contains much that is contrary to popular ideas in regard to the disease of insanity. The average number of patients resident has been 600, the greater number of whom are Canadians, England taking the lead in the foreign element, whereas, in years past, the population of the house was notably Irish. Dr. Workman attaches no importance to the figures representing the religions of the patients, which, by the way, show adherents of the English Church in largest numbers, while those of the Methodist Church are in the smallest, since the establishment of the asylum thirty-three years ago. Married men and single women seem to enjoy comparative immunity from this disease, as their number is much smaller than that of single men and married women. Of 131 patients, 108 were temperate, and the other 23 either intemperate or of doubtful habits. Seven patients who remained over six years were entirely recovered. This County sent 5 patients during the year.

The British Board of Trade returns for February are of the same general character as those for January, a decrease in exports as compared with the corresponding month in 1873, but not as a rule when compared with the previous year. Coal still shows an increase, and iron and steel a large decrease.

Violent Boiler Explosion.

Munich, April 8.—William Konbauch, the painter, whose dangerous illness from cholera was reported yesterday, died last night.

London, April 8.—The sovereignty of the Fiji Islands has been formally tendered to Great Britain.

The steamship Greece has not yet arrived, and there are no further particulars of the loss of the Europe.

New York, April 9.—Rain and wind during the night, and continues this morning.

Considerable confusion resulted in a workmen's mass meeting at Dermitt Hall, last night, between the respective friends of Vannort and Green. A riot was at one time imminent, but quiet was finally restored after one of the chairmen had been ousted, and another friendly to the comptroller placed in the chair.

A Boston special says the Senatorial struggle has so interrupted the Legislative business that it will not be persisted in for more than a week longer. Special efforts to bring about an agreement among the Republicans are to be made.

During the last twelve months five ocean steamers have been lost and nearly 800 lives sacrificed.

Ex Judge Henry Howland, Republican, is now being considered, it is said, for the vacant police commission.

Repairs are going on at Creedmore, and will be completed in a few days, and extensive preparations are being made for the forthcoming international rifle match for the championship of the world.

Details of the boiler explosion at the Gutoran tunnel, Pattenburg, N. J., on Tuesday, show that four laborers were killed outright, and four adjacent boilers used for compressing air, were destroyed. Not a vestige of the wooden house in which the boilers were is left. Several persons living in shanties adjacent were hit by the flying debris, but not seriously injured.

More Great Riels. There was great excitement at the Parliament Buildings on Wednesday afternoon, in consequence of the uncertainty as to whether Riel would take his seat or not. When the doors were opened, crowds made their way to the galleries, and among them was a large number of French Canadians.

The Free Press gives currency to a rumor that in order to vitiate the ground on which Mr. Bowell proposes to found a motion of expulsion, viz., that he is a fugitive from justice, Riel has delivered himself up to the authorities of Quebec for trial. This is looked upon, however, as a ruse of his friends to throw the onus of his trial on no one but himself, and to pretend to say that the evidence of Riel being a fugitive from justice is wanting.

It is said that Mr. Onimet will move that Riel be granted one month's leave of absence, as he will give himself up to the authorities of Attorney-General Clarke was deferred till to-morrow, owing to his illness.

Presentation at Georgetown.

Mr. Matthias Kirby, who has been a Director of the Esqueping Agricultural Association since he has resided in the township, and has also been President of the Society, was on Monday evening the recipient of a handsome watch, presented to him as a token of the esteem in which he is held by his fellow Directors. A number of his friends met, unexpectedly to Mr. Kirby, at his residence, where a beautiful spread had been prepared by his neighbours, to mark their appreciation of his good qualities previous to his intended departure to within a few miles of Guelph. It was moved by Col. Clay, seconded by Mr. Dent, that Mr. Jas. Menzies take the chair. After a few appropriate remarks the chairman called upon Mr. Joseph Barber, President of the Association, to make the presentation to Mr. Kirby, which duty the President performed in a felicitous manner, eulogizing the character of Mr. Kirby, and assuring him of the regret of all his friends at his departure. Speeches were also delivered by Col. Clay, Mr. Noble, and others, all showing the esteem entertained for Mr. Kirby, and expressing hopes of his future welfare and prosperity in his new home.

Canadians will be pleased to hear of the probable appointment of Sir Garnet Wolseley to the Adjutant-Generalship of Horse Guards—a position next in official rank and importance, we believe, to the Commandership-in-Chief of the British army.

The Proposed New Hall.

To the Editor of the Mercury:—Dear Sir,—I notice with pleasure that you have devoted space in your journal to the subject of the proposed new Town Hall, and I hope that now it is before the ratifiers they will give it the consideration that a matter of its importance demands.

Although I am in favor of giving our butchers all the accommodation they require, and am fully impressed with the fact that we need a larger Hall, those who have read reports of the proceedings of the Town Council will notice that I have opposed the adoption of either of the present schemes. I have given my reasons for so doing in the Council, but it will do no harm, and may do some good, to give them more publicly, and have the subject ventilated a little.

The position I take, that it is neither necessary nor expedient to have the butcher stalls and Music Hall under the same roof. You, Mr. Editor, and others who have travelled will have noticed that in most cities they are kept separate, and very properly so, for a site that is suitable for one is sometimes unsuitable for the other, as in the present case; for while the thunder of a passing train does not seriously interfere with the business of selling meat, &c., those who sing or speak in public, or attend concerts and lectures, know what an intolerable nuisance it is to them to have the effect of a choice piece of music, or an interesting speech, spoiled by having to stop while trains are passing, and talk or mutter their wishes in regard to the G. T. R. and the city fathers who built the Hall.

Then, again, the style of architecture suitable for the one is too costly for the other. Music Halls are classed with public buildings, and are supposed to be an ornament to their location and a pride to their owners, but butcher, fish and vegetable stalls are built for business, and while they should have every necessary convenience, should be built in plain style, so that the cost would be within the reach of those who do business in them, without being let at a sacrifice.

Another, and the last argument that I will give in favor of separating the two interests, is that it is impossible to keep the streets and surroundings of market stalls in a state that would be in keeping with a Music Hall. The necessary and proper standing of horses and carts, the litter of dirt, the weighing of the weighing and storing of hides, &c., make the streets, walks, and walls look anything but what they should be of a building costing \$22,000 for the bare building and \$30,000 before it is furnished, as will be the case if the proposed scheme is carried out. Proof of this is increasing, and the nuisance is becoming so great that I believe inside of five years the Hall would have to be abandoned, or used for something else, especially as there is now being a switch laid down for loading cars, and a central depot is talked about, to be placed in the immediate vicinity.

If we need, and are going to build a Music Hall, don't let us have it in a place where we shall have to give all our songs and speeches to a railroad accompaniment.

Farwell Meeting at Orangeville

The congregation and friends of Rev. Richard Large, E. M. Minister, united in a farewell meeting to that gentleman in the Town Hall on the 3rd inst. Mr. J. W. Shaw occupied the chair. Mr. D. M. Smith, I. O. G. T. lecturer, made a few remarks on prohibition; Rev. Mr. Hill, presiding elder, gave an address on the lights and shadows of itinerancy; and Rev. Mr. Carriek, of the C. P. Church, gave expression to his feelings of respect for Mr. Large and his family, and his sorrow at his departure, after which he read an address prepared by the congregation and friends, expressive of the esteem in which the rev. gentleman was held by all classes. Mr. Large responded in a few feeling remarks. The proceeds of the meeting amounted to upwards of \$50, which were handed to the departing pastor. The exercises were enlivened by music from the P. M. Church choir, and the O. D. F. silver band, who kindly lent their services. During the evening Mr. George Runney gave one of his interesting readings, which brought down the house. Altogether the meeting was a great success.

Rockwood Items.

The quarterly examination of the Public School in Rockwood took place on Thursday last week, in presence of a large number of the inhabitants, and passed off most successfully to the great credit of the Principal, Mr. Hill, and his assistants, Misses Howell and Jackson. The Inspector, Mr. Kilgour, at the close, in expressing his satisfaction with the result of the new departure of this neighborhood in school matters, referred in highly complimentary terms to the liberality and taste of the people of the section, and efficiency of the Trustees in the discharge of the duties which have of late devolved on them in the erection and furnishing of a building which he pronounced second to none in the county. As a further evidence of this spirit, they distributed among the pupils at the close of the examination no less than \$40 worth of prize books.

We are pleased to notice that our townsman, Mr. J. W. Knowles, has received an order for five sets of harness for the Provincial Farm. We have no doubt Mr. Knowles will give a good account of himself in this matter.

Harrison Correspondence.

Everything is quiet here just now. The roads are very bad, and the farmers are anxiously waiting for the spring to open up so that they can do the necessary ploughing, and repair the fences that were blown down in the hurricane some months ago.

The Good Templars contemplate the erection of a new hall, and a good sum already appears for that object on the subscription list now going the rounds.

A petition bearing the signatures of about sixty ratepayers was presented to the Village Council at its last meeting, requesting that the Reeve call a meeting to discuss the expediency of building a Town Hall and Market. The request was complied with, and the meeting appointed for the 10th inst., at Colison's Hall. This subject is the principal topic at present.

On Monday last as Mr. David Bruce was in the act of getting off the platform at the V. G. & B. Station, he made a false step and sprained his right foot so badly that he was unable to walk.

Garafraxa Correspondence.

Mr. Smith's new saw mill at Douglas is almost finished, and will be a most complete establishment, employing about fourteen men. The single and lath machines are of the most approved pattern, and the motive power will be a Burnham turbine water-wheel. Eighteen men have been engaged in Luther Township during the past month cutting logs, which will be floated down the Grand River as soon as it is free from ice.

The spring here, as in most places, is very backward, and the ground at the present time is frozen deeper than at any part of the winter.

Mr. Peter McLaughlin has bought Mr. Sellar's fifty acres, for which he paid \$2,000.

Mr. Goodall has purchased lot 15, 10th concession of East Garafraxa, for the sum of \$3,000. There are no holdings of any account on the property.

A joint stock company is forming in Toronto to start an evening paper in the Reform interest, in opposition to the Sun.

Large parties are leaving Ottawa and the vicinity with the intention of settling at Fort Garry.

A Western Rifle Association was organized at London, Ont., on Wednesday.

Another veteran of the war of 1812, Col. D. Gregory, died in Louth on the 6th inst.

It is probable that additions will have to be made to the Parliament building at Ottawa to afford necessary accommodation for public business.

A lad employed in a saw factory at St. Catharines got entangled in the machinery, and was whirled round by a shaft, turning at the rate of 240 revolutions a minute, and was seriously though not fatally injured.

The grocery, tobacco and liquor markets in Montreal continue animated, in view of the approaching changes in the tariff.

The construction of the North Shore Railway is being pushed forward with energy. Contracts, amounting in all to a quarter of a million of dollars, for fences, bridges, &c., have been given out.

An effort is to be made to raise \$40,000 as an endowment fund for the British North American Congregational College.

Seventeen out of the hundred and twenty deaths which occurred in Montreal last week were from small-pox.

They have a "saloon license war" in Barrie. The council has decided by a vote of seven to five to comply with the petition of 430 of the inhabitants and not to license any saloons.

It was six years ago, on Tuesday last since Thomas D'Arcy was assassinated in Ottawa.

The St. Catharines News says that Mr. J. M. Currie has received instructions from the Government to pay out money for lands purchased in that neighborhood for canal purposes.

Mr. Lawrence Oliphant, as one time Secretary to the late Lord Elgin, is at present the guest of the Governor-General.

Within the last twenty years Limerick county has lost by emigration 80,000 inhabitants.

It seems to us that the doubt as to whether or not an amnesty had been promised to Riel—or any one representing him—concerning the murder of Thomas Scott, could at once be removed if Sir John Macdonald chose to tell what he knows about it. Bishop Tache has published a very long statement in the Ottawa and Montreal papers, which is to the effect that such an amnesty was promised, but he brings forward no proof to substantiate his assertion; he advances nothing to show that Riel received any distinct promise under which he can claim immunity from the consequences of the crime he committed. It is true that an amnesty was offered to the people of the Red River subsequent to the breaking out of the revolt, and before the murder of Scott; but this was promised on the express condition that the insurgents should lay down their arms, and no longer menace the authority of the Queen, or disturb the peace of a portion of Her Dominions. That promise of amnesty did not, and could not, cover acts committed subsequent to the proclamation. Moreover, that promise was made only on condition that the insurgents laid down their arms. They in effect spurned the offer made, and after the amnesty was promised continued to assume a belligerent attitude. How then could they expect to receive a free pardon for offences committed after the promise of pardon was made on condition that by the acceptance they, as it were, gave bonds to keep the peace?

We said that Sir John Macdonald could clear up the mystery at once, but he is dumb on the subject, and leaves Bishop Tache to make the best of a bad case. The only evidence which the Bishop adduces is the sworn statement of Richot, which to the effect that on the 3rd May, 1870, he and his associates from the Red River, who came to Ottawa as a delegation, were promised an amnesty by the Governor-General, and that in the 10th of the same month this promise was renewed in the presence of Sir George Cartier. He also gives a short letter from Sir Geo. Cartier, referring to that interview, but refers to no offer of amnesty or pardon, and merely speaks of the liberal policy the Government intend to pursue with regard to the parties who took part in the revolt. If Richot's statement is correct, why does not Sir John Macdonald—who must have been cognizant of all that was done—corroborate it. Why leave the whole thing to rest on the bare assertion of a man who was supposed to be the moving spirit in the insurrection, and which is not sustained by any other evidence or statement whatever? Even admitting that Richot's statement is correct, there is no distinct allusion in it to the parties charged with the greater crime of murder, nor would we be satisfied in supposing that any promise of amnesty—if such was made—was intended to apply to them.

After carefully perusing all the statements made in the case, we can find nothing in them which can be construed into a promise of official pardon to those directly implicated in the murder of Scott, and nothing which should screen Riel from arrest and trial as the chief actor in that bloody affair.

There is some fear of trouble from a class of border ruffians, who are hanging about the southern boundary of Manitoba, and it is by no means improbable we will have to provide a pretty strong force to ward our southern frontier in the western part of the continent. Thus the problem of permanent military organization is being slowly but surely forced upon the attention of those who have to provide for the welfare and security of the State.

There is a dead lock in the Quebec Election Court. Judge Mondelet refuses to act, and a writ has been issued to prohibit the other three Judges of the Supreme Court from proceeding with the Two Mountains case—the first on the list.

The Ottawa Free Press states that it is rumored that an arrangement being made between the Imperial and the Canadian Governments for R. H. the Duke of Edinburgh to succeed the Earl of Dufferin as Her Majesty's representative in Canada, and that the Dominion is to be elevated to the status of vice-royalty. G. W. RAILWAY.—The Globe is informed that the Board of Directors of the Great Western Railway have signed. The Board recently announced a half-yearly dividend of 10 per cent, and afterwards reduced to 2 1/2, which so irritated the stockholders that the Board resigned.

It turns out that Mr. Alexander Ewan, of London, England, has not failed. It is expected the Finance Minister will bring down his budget on Tuesday first.

The Government Election Bill meets with praise on all hands. Mr. J. C. Whale, a resident of Burford, and an artist whose creations can be seen in many homes, is about fitting the old world with a view to improvement in his profession.

Dominion Parliament.
Ottawa, April 8.

At the opening of the House a very large number of petitions were presented in favor of a prohibitory liquor law. Mr. Bodwell moved the appointment of a committee, of which he had given notice, to enquire into the question of prohibiting the sale and manufacture of intoxicating liquor.—Carried.

Mr. Buxton then moved for a Committee to consider the operation of the tariff in British Columbia, which was carried.

Mr. Paterson moved for a Committee to enquire into the condition of the Six Nations Indians. In a brief but comprehensive statement, he pointed out the reasons for promoting an enquiry; and, whilst assuring the House he had no desire to do the Indians the least injustice, urged that, in their own interest, as well as that of the country at large, the time had come for some change in the policy adopted towards them.

Mr. Finlay wished to know whether the Indians themselves desired any change. Mr. Mackenzie, in reply to Mr. Paterson's remarks, said the Government could take no steps affecting the rights of the Indians without their consent. No doubt the existing state of things was a source of some inconvenience to the white population in the districts contiguous to the reserves; but the Indians' rights must nevertheless be respected. He had no objection to an enquiry of the kind suggested by the resolution, but if it was intended to go into an investigation of any alleged abuses they should first have a clear understanding what the charges were. Ultimately Mr. Mackenzie advised that the motion as first suggested should pass; and if any further matters demand enquiry he suggested that papers should be moved for, and then such other steps taken as the facts disclosed might render necessary.

The orders of the day were then read for resuming the examination of Attorney-General Clarke, for the attendance of Louis Riel in his place, and for the examination of the police officer who holds the warrant for Riel's arrest.

Mr. Cauchon suggested that as Mr. Clarke was not in attendance, the whole of the orders should be enlarged till Friday.

Mr. Bowell protested against delay. After considerable discussion, a proposal of Mr. Holton to postpone the proceedings till to-day was agreed to.

The Finance Minister, as the estimates were not ready for distribution, intimated that he could not make his financial statement before Tuesday next. The House then adjourned.

CORRECTION.—In our report of Prof. McCandless' address yesterday, we make him say, "I am a firm old believer in the adage." Any one reading it will see that it should have been "I am a firm believer in the old adage."

Mr. Bodwell has given notice that on Thursday he will move the House into Committee of the whole on the following resolutions:—1st that the traffic of intoxicating liquor is an evil for which the laws of this country provide no adequate remedy. 2nd That it is desirable to prohibit the importation, manufacture, and sale of intoxicating liquors in this Dominion, except for medical and manufacturing purposes.
