

QUEBEC, 10th July 1861, 10 o'clock, A.M.

THIS day the Grand Division, S. of T., of C. E., assembled in the Division Room of the Sons of Temperance, Quebec, to hold its Semi-Annual Session.

According to usage I present you my semi-annual report. And in doing so permit me to congratulate you on the unprecedented success which has crowned our efforts since we last met together as a Grand Division. Since the introduction of the Order into Lower Canada, in the month of March 1850, we have not, until now, succeeded in organizing more than six or seven divisions in a period of six months. But, during the interval between our meetings, we have organized no less than *nine* Divisions, and revived *one*, that was for some time considered as almost defunct. Seven of these new Divisions are in the Eastern Townships and two in Montreal district. In Bedford District, E.T., we had, two years ago, but one Division, and that one in a most languishing state; now, I am happy to say, we have no less than fifteen in active operation.

The Reports of the various Deputies I have heard from, are, on the whole, encouraging. D.G.W.P. Slack, informs me, that "since his appointment for Montreal District, two new Divisions have been added to his list, thus making five under his care, and that the interest in the Temperance cause in and around Montreal is on the increase. He also notes the fact of two Lodges of Good Templars being established. The Good Templars is a similar organization to our own, and has done great good since its introduction into this Province, especially in Western Canada. Bro. Slack visits his Divisions pretty regularly, and reports them all flourishing.

In Quebec the Order is not in such a flourishing condition as might be desired. The attendance at the weekly meetings of the Gough and St. Lawrence Divisions, has of late fallen off considerably. It is to be hoped, however, that under the fostering care of D.G.W.P. Hall, a revival will speedily take place, and that Quebec will once more stand forward in the ranks, as to numbers and zeal, as it did in bygone days.

Brother Stephen Lighthall reports Bethel Division, Ormstown, getting on pretty well. He says, than during last winter there was every prospect of a new Division being started at a distance of five miles from Ormstown, but through some untoward event, the friends of the

Order were disappointed in their expectations. Let us, however, hope that the new Division will be speedily organized.

**D.G.W.P.** Wanless' gives us cheering accounts of St. Andrews Division. He says they hold regular weekly meetings, and the attendance of members is, on the whole good. The rules are strictly adhered to, and the meetings characterized by a most fraternal feeling. This Division has not yet admitted the ladies, but it intends doing so, when ever a larger room can be had wherein to hold its meetings. Yet with the strong influence of the Sons at work, the brother reports in temperanee abounding to a fearful extent in St. Andrews; so much so, that the County Council has given up all attempts to regulate the traffic, their efforts for some time back to do so having effected no good.

D.G.W.P. Stoakes, of Lacolle Division reports a state of prosperity in his district, and D.G.W.P. Macfie, who has the Clarenceville and Brockville Divisions under his charge, says both these Divisions are doing well. The Brockville, which is quite a young Division, has now over forty members. This speaks well for a place in which there is but one house and shop.

**D.G.W.P.** McKeehnie says the Bristol Division is in rather a languishing condition. I hope the brother will use his efforts to get the ladies admitted as visitors, and no doubt their presence will infuse a little more life into its members.

**D.G.W.P.** Lambly says of the Balaklava Division, that it is in a flourishing state, and that since he visited the Grand Division in Melbourne, improvements have been introduced which have quite revived the interest in it.

Lake Beauport Division is reported by D.G.W.P. Gosneld, as in a fair state of prosperity, and the brother is under the impression that there is an opening at Stoneham for another Division. I hope the brothers at Beauport will lose no time in having a new Division organized at Stoneham. Nothing like unfurling our banner at the right time.

D.G.W.P. Main complains that the Members of Richmond Division are very irregular in their attendance. I am afraid this Division has not yet admitted the ladigs. If the ladies were admitted to grace the meetings with their presence, I have no doubt the generality of the brothers would be more prompt in their attendance; I hope Bro.

Main, will do his utmost to try the experiment. D.G.W.P. Campbell, of Havelock Division says, the ladies effect much good in his Division, and that the members are very attentive.

D.G.W.P. Cole, of Granby Division, says the meetings of his Division are generally well attended, and D.G.W.P. Jordan, has the same remark with regard to the Shefford Division.

D.G.W.P. Fordyce says, of Adamsville Division, that when it was first started, a little over twelve months ago, a tavern existed in the village. The Sons, however, soon induced its best customers to join the Division, and that they have now got the tavern-keeper himself.

Trout River Division does not prosper so well as I could desire. D.G.W.P. Nisbet, says a good many members have lately left on a very poor pretence, namely, that they could not afford to pay the dues, —a very small sum indeed. I hope the brother will not get discouraged on account of this, for the man who grudges to pay the sum he mentions for the propagation of temperance principles, will never be a good Son of Temperance.

D.G.W.P. Mills, says, the best of feeling prevails in the Hungerford Division; that since the admission of the ladies they have had the most perfect order, and that the meetings are of a very interesting character.

In Bedford Division, D.G.W.P. Josleyn says, new members join every meeting night, and that the temperance cause progresses surely and steadily for miles around Bedford.

D.G.W.P. Sykes sayes, the Washingtonian Division is not only able to stand its ground, but is advancing rapidly. When this Reverend Brother took charge of the Sutton Mission there were two taverns within sight of his church. There is now, however but one. The sign post of the other was cut down lately by a Son of Temperance, who now occupies the house vacated by the tavern-keeper.

These extracts, I hope will convince you that our cause progresses; avd is doing a large amount of good There is no doubt that wherever the Sons' banner is unfurled peace and prosperity follow; and it ought to be the heart-felt duty of each and all of us to endeavor to have the banner of Temperance spread wider and wider over our country, until

Many of my Deputies have not yet forwarded me any returns, with regard to their Divisions, and I sincerely hope they will not neglect this important duty much longer. In the selection of deputies I have endeavored to obtain the most active and prompt men, and also to give satisfaction to the Subordinate Divisions. In making the selection some mistakes may have occurred, but these will be corrected at once, on application. In my opinion it is absolutely necessary that the Deputies be constantly at their post, for on them rests a great amount of responsibility. The want of active men, with hearts full of love for the drunkard, is much needed.

For statistical and financials details I refer you to the report of our worthy Grand Scribe Hall. Bro. Hall, being most attentive to the duties of his office, is always in a position to lay before you the fullest information with regard to these matters.

I regret to say the trouble in the United States of America have marred to a certain extent the harmonious working of our Order in that country. The M.W.P., on account of the unsettled state of the South was compelled to put off the meeting of the National Division for a year. This circumstance has no doubt caused many a regret, more especially to such Canadian brothers, who intended visiting Tennessee this summer. Let us hope that the existing differences in the United States may be soon adjusted, and that in future no civil war will disturb our peaceful harmony.

I would strongly urge upon the attention of the Grand Division the necessity of taking immediate action with regard to petitioning the legislature for a Prohibitory Liquor Law. As you are aware, a dissolution of Parliament has taken place since our last meeting, and there is every probability that the elections will tell in our favor. But even should but few members favorable to Probibition be returned, petitioning will have at least the effect of keeping the Legislature posted up on the enormity of the liquor traffic, and strengthen the influence of those who may perhaps be only in favor of a more stringent license system. It is evident that something must soon be done to check nore effectually the growing evil of intemperance, and it is the duty of us—Sons of Temperance—who have all, more or less, tasted of the sweet fruits

of sobriety, to be ever first in the fight for the redemption of fallen humanity.

During last session of Parliament, Mr. Clark again introduced his Prohibitory Bill. It attracted but little attention, perhaps on account of the fewness of the petitions presented in its favor. It was read but a second time, and then thrown out. I present the Grand Division with a few copies of this bill, for examination, as I conceive it to be the most complete of its kind ever introduced into any Parliament, and if passed, it would at once and forever put an end to the traffic in intoxicating liquors. By the death of Mr. Clark, (which event took place but a few weeks after his return home from Quebec,) the friends of Temperance and Prohibition have suffered a great loss. This gentleman was none of those who are inclined to weary in well doing. He, as he himself informed me, had made up his mind to carry his measure, although it would take him ten years to do so, and I am thoroughly convinced he would have succeeded, had he been spared, for he was most sincere in his determination on this point.

In conjunction with temperance friends from the Eastern Townships, while the Parliament was in session here, I conferred with several M.P.P's, and endeavoured, if possible. to get a hearing, (before a select committee,) for the Hon. N. Dow of Portland, on the subject of Prohibition. We succeeded so far as to get a motion for the appointment of the Committee put on the paper, but on account of the hurry the House was in to get through with what (by it) was considered of more importance to the country, the matter could not be pushed further. Perhaps it was as well, as it turned out afterwards, that Mr.Dow could not be in Qubec at the time agreed upon, on account of the sickness of his father, who has since died. The Rev.C.Fearl, of Waterville, and the Rev.Mr.McDonald of Stanstead, a deputation from the Eastern Townships, were however permitted to appear before a Committee sitting on a Municipal License Law, and had an opportunity granted them of urging more stringert measures.

About two months ago the G.S. transmitted me a copy of a resolution he had received from the Gough Division, Quebec. It was to the effect that in the opinion of that Division it would not be conducive to the good of the Order that the semi-annual meeting of the Grand Division should take place there at this season. Having received no

communication to the same effect from any other Division in the District of Quebec, or even in the city, I deemed it best to take no action in the matter, but let the arrangements agreed upon at the Annual Meeting be carried out

Before closing this report which I find has grown rather lengthy, permit me to urge upon your attention the necessity of an effort to get juvenile Temperance societies, under whatever name you choose, organized in our midst. The carrying out of our principles, when we are numbered with the past, will and must devolve upon the rising generation, and should we now neglect this important provision, the few who may, under God, be led to follow in our footsteps, will have the same opposition to encounter in the battle for the right as we have had.

G.W.P., OFFICERS AND BROTHERS,

" It affords me much pleasure and satisfaction in the discharge of my official duty, in laying before you this my semi-annual Report, to have it in my power to state that the progress of our order in this jurisdiction is still "onwards and upwards."

Since last session of the Grand Division, nine new divisions have been organized, viz:

So few returns having as yet been received for the quarter just closedmy statistical statement must be formed on the returns made for the previous quarter, ending 31st March, 1861, and although no returns for that quarter were due from eight out of the nine newly organized divisions, still I am enabled to report a gain in the other divisions

during the past six months of contributing members, 166, of Lady Visitors, 291.

For the quarter ending 31st March last, no return has been made from two divisions; three divisions have failed to make returns for two quarters, and three have failed to do so for three quarters.

Many enqiries have been made to this Office for Withdrawal Cards for Lady Visitors. The National Division does not issue any such Withdrawal Cards, but several of the Grand Divisions do so for their own jurisdictions. Your G. S. would therefore recommend to the Grand Division to issue such Cards for this jurisdiction, and he has prepared a draft of one which is herewith submitted for consideration.

I have to complain of the irregularity with which the returns from subordinate Divisions are made. Instead of being forwarded, at the farthest, within the first month of the quarter, in many instances they are not received by me until the end of the quarter, and in some cases not until after its expiry. A little more attention on the part of the D.G.W. P's to the duties of their office would remedy this evil.

I have also to bring under the notice of the Grand Division, the incorrectness of the returns made by subordinates. Not only in many instances do the returns of one quarter not correspond with the return of the previous quarter, but even one part of the same return is at variance with another part. Out of the whole number of returns for the quarter ending 31st March last, only three are correct in all their parts. In these circumstances full reliance cannot be placed upon the statistics furnished, and something ought to be done to remedy it. In order to enable the Grand Division to see the irregularities complained of, and to suggest a remedy for the same, I have prepared, and herewith present full abstracts of the returns for the quarters ending 31st December and 31st March last.

In consequence of the troubles in the United States, no meeting of the National Division was held this year. It has been postponed for one year or until specially called.

I have to lay before you two communications, one from the Grand Division of New Jersey, and the other from the M.W.P.

### GRAND WORTHY PATRIARCH, OFFICERS AND BRETHREN :

We, your Committee to whom were referred the reports of the G.W.P., and G. S., beg leave to report that we have given them our careful consideration. We have to congratulate this Grand Division on the present prosperous state of our Order in Canada East as made manifest by these reports, and we trust that the Divisions will continue their exertions and plant a Division in every locality where one can be sustained, and that every brother of the Order will devote himself to the good work we are engaged in by using every means in his power, to bring in new members make the meetings as entertaining and attractive as possible, and helping to promote the harmony and advancing the interests of our Order in every way. This can all easily be done by a little self-sacrifice, and a sinking of personal feelings in favor of the interest of the Division and good of the cause.

The G.W.P. strongly urges the importance of making preparations early for petitioning the new Legislature in favor of a Prohibitory Liquor Law. We hope the Grand Division of Canada East and West will combine in some united effort of this nature, and get Mr. Clarke's bill put into the hands of some thorough temperance member of Parliament who will honestly see to its being properly attended to. We also feel with the G.W.P., that the cause of Prohibition has suffered a serious loss in the death of Mr. Clarke, but we trust some member may be found that will supply this loss to us. Although we have already, on several occasions failed in getting what we want by petitions from the late legislature, we are in full expectation that there will be found many new friends among the present elected representatives. We must try and keep on trying, and never lay down our weapons until our end be accomplished. The enormous evils of intemperance, notwithstanding all our efforts through the Divisions and kindred organizations still stalk in noonday in our midst, nearly as rampant as ever, although we feel that we are gradually creating a public sentiment in our favor. It is to be regretted that a hearing could not be had for Mr. Dow, in the way the G.W.P. has alluded

to, but we trust that during next session of Parliament we may be gratified by Mr. Dow getting a chance to give his testimony in favor of Prohibition before a Select Committee of the next Parliament.

In consequence of the unfortunate troubles in the United States, the Annual Meeting of the National Division has been postponed for This is to be regretted, as it will no doubt tend in a great one year. degree to retard the progress of our Order in the United States. We find however that, from circulars received by the G. S., the representatives of the different Grand Divisions are invited to attend the meetings of the Grand Divisions of Pennsylvania and New Jersey at Atlantic City, N. J., when we trust the loss of the non-meeting of the N. D. will be made up in some measure. We understand the Grand Division of Canada West intend sending two representatives to this meeting, and if any of our members who intended going to the meeting of the National Division in Tennessee should find it convenient to attend the meeting in New Jersey, we think it will conduce to our interest for them to do so.

In reference to the Report of the G.S., we would direct the attention of Deputies to the complaint made by him in regard to irregular manner in which the statistical returns of the Divisions are made out, and would urge upon them the importance of their attending to their duty in this particular, and see that R. Scribes send in correct returns.

From the G. S's report it is gratifying to find the marked progress we are making in the number of Divisions and membership. We find that nine new Divisions have been organized since last meeting, and the latest synopsis of returns show that our total membership now amounts to 1721 males, 691 female visitors, besides, 2,908 juveniles in Ganada East, showing that we must be exerting a powerful influence on the minds of the community in our favor.

We would recommend that the Grand Scribe be instructed to procure sufficient Withdrawal Cards for lady visitors of the pattern shown by him, and supply them to the Divisions at such price as will pay the cost of them.

Your Committee will now conclude by congratulating this Grand Division on the receipt of two such excellent reports as that presented by the G.W.P. and G.S., and would recommend the ability and per-

Prince Edward Island and Newfoundland, requesting them severally to take action in the matter, so that, it possible, it may be brought before the National Division at its next session, as the sentiment of all the Grand Livisions in the British Provinces, and that the different Grand Divisions be further requested to communicate to this Grand Division such resolutions as may be passed by them respectively."



Quebec, January, 1862.

TO THE GRAND DIVISION S. OF T. CANADA EAST.

Brothers :- We have been permitted once more, through the kind providence of the Great Patriarch above, to meet together as a Grand Division, and I hope we all feel grateful to Him for sparing our lives, and blessing the efforts we have put forth during the year that is now numbered with the past, with such abundant success, in the cause we are bound together to uphold and extend. Since our last meeting many trying circumstances have occurred to our brothers in the Unived States " Rapine, War and Strife " have raged, and have no doubt been the means, to a considerable extent, of loosening the bonds that have hitherto bound the "Sons" of the North and South of that unhappy country. But let us hope and pray for the day when peace shall again resume its reign; then we hope to see another and a more holy warfare, a warfare which shall have only for its object the total extermination of the liquor traffic. So far as our own country, Canada is concerned, the utmost good feeling has prevailed amongst all ranks of temperance men. Both Eastern and Western Calada have worked well for the extension of our principles. But I am sorry to say, with all our work, a great deal remains yet to be done. The battle is not yet half won. The distilleries of our country destroy nearly as much as ever of the grain God has given us for food. The dens and sinks of iniquity, in the shape of taverns, saloons and beer shops, spread out their delusive snares nearly as flauntingly as ever in our principal streets, and near our very churches, and many of our professedly Christian churches, which should be the purest institutions on earth's surface, still recognize as their members and supporters, men who are daily engaged in the manufacture and sale of the stimulant, which has and is daily blighting and destroying the hopes and happiness of millions of men, women and children, the fairest of God's creation. With these stern facts before us, let us not sit idling when there is so much yet for us to do. Let us not wait until the Legislature passes a Prohibitory Law, but let us endeavor to enforce the present Laws, however defective they may be, and allow no opportunity to pass at home or abroad, on land or sea, without pressing upon all around us by sound reasoning, the wickedness of the prevailing drinking usages of society. Then will we be nobly fulfilling our mission and seeking to enlarge our circle, "until it shall embrace the whole brotherhood of man," and thus leave "footprints on the sands of time," which, no doubt, will be followed in by those who will come after us. Let us ever remember, as we work in this noble cause, that victory must and will crown our efforts for assuredly.

A cloud's about to vanish from the day, And a brazen wrong to crumble into clay; Lo! the nights about to conquer:

Ofear the way! Through the "Sons" shall many more Enter smiling at the door; With the giant, RUM, shall fall Other evils great and small, That for ages long have held us for their prey: Sons of Temperance, clear the way.

During the last twelve months we have done well in Canada East, as many, if not more, new Divisions have been instituted than in any one previous year in the history of the Grand Division. At the Semi-Annual Meeting I had the pleasure of reporting the establishment of nine new Divisions, and since that time, I am happy to say, two additional Charters have been grant-ed-making in sll, eleven. In addition to this, two Divisions, which had been virtually dead to us, have been restored to life, and are now standing boldly forth on the front ranks. This state of prosperity, must, Brothers, be highly gratifying to us all, and I have no donbt, if we work well together, next year we can double this number, and instead of averaging one new Division a month, we will average two. Let us, by all legitimate means, strive to do On the whole, the Deputies Reports, so far as received, are encouraging. 80. Everything appears to be going on very well. The order, I am pleased to say, in the city of Quebec, has taken a new start. At the time of our meeting there last summer, as you are aware, the Divisions were in a very languishing Now the meetings are well attended by men and women, and everystate. thing betokens healthful activity. May it long continue so. I have, person-In Sept., ally, been able to visit but few Divisions during my term of office. however, I made it my duty to pay a visit to those under the care of D.G.W. P., W. G Slack, in the Montreal District, and was highly repaid for my trouble. In fact, I was perfectly surprised to see the progress one of these Divisions had made. Five years before, when I was an humble active Member of it, we often experienced difficulty in raising a quorum-now there seemed as much difficulty to find room for its attending members. I allude to Howard Division, No. 1. May it long continue to stand at the head of our Order, not only as first in number of organization, but as A 1 in our ranks. The other Divisions, organized at a subsequent date to the Howard, progress most favorably, and exert a great influence in their various localities.

Shortly after our meeting in Quebec, the Grand Scribe transmitted to me a letter he had received from the M.W. Patriarch. This communication had been written, at a subsequent period, to the one which was submitted at the Semi-Annual Session, and on which, action was taken. It contained a most urgent request that this Grand Division send Delegates to the convocation which he had called to take place at Cape May. It appeared to me that the future prosperity of our noble Order depended so much on this meeting, and any action that might be taken at it, and hence the importance of our having a representative there, that I unhesitatingly recommended your Grand Scribe, Bro. J. S. Hall, to attend, which he accordingly did. The meeting came off, and was attended by representatives from Canada East and West, as also New York, Pennsylvania, New Jersey, &c. Several important subjects came up for discussion, such as the granting of dispensations to Sons in the American Army, to open Divisions; the granting of farther privileges to Lady Visitors, and, also, the subject of allowing youths under eighteen years of age to hold office in Subordinate Divisions. The representative from Canada, East spoke strongly in favor of the latter me asure. In regard to the first question, Grand Divisions were empowered to grant dispensations to such of their Members who desired to open Divisions in the Army. However, no definite action was taken with regard to the two latter subjects. They were left over for further discussion on a future occasion. The subject of the meeting of the National Division claimed particular attention, and after due deliberation it was agreed that there should be no Meeting held until June, 1862, and that it should then take place in the city of Montreal, provided the affairs in the United States continued as at present, but should a change take place, as to allow of a Meeting at Nashville, then it should be held there, and the advice of the Convocation to the Executive was, to call the next Meeting of the National Division at that time and place, under the above limitation. The M.W.P., however, while expressing his own concurrence, stated that before taking any definite action, he would take the opinion of the Grand Divisions who were not there represented. As far as I am aware, the M.W.P. has not, as yet, issued any definite instructions as to the Meeting in 1862; it will, therefore, be necessary for us to take immediate action in this affair, and petition for this next Session to be held in our jurisdiction. There is no reason to suppose that the Grand Divisions, which the M.W.P. will consult, will put any obstacles in the way of our having this meeting next summer. The Grand Division of Canada West has already agreed to give us their favorable support, as also that of Nova Scotia .-

Whether we succeed or not, in the undertaking, let us shew, by our prompt action, that we decree success. The chances are, that should the meeting take place in Canada, the attendance of American delegates will be small; be this as it may, let us heartily welcome those who may come, and shew them, that we, as Sons of Temperance, recognize and sympathize with both South and North, as we are a united brotherhood linked together by ties that are only separable by death.

In the month of November last, a very able Circular was issued by the M.W. Patriarch, in which, he gives a concise report of the state of the Order in the United States. As it is important that everything connected with the National Division should be known at the present moment, and as particular allusion is made to the next Annual Meeting of that body of which he is head; oar Worthy Grand Scribe will read it to you at the proper time. While on this subject, I would beg respectfully to suggest to you the propriety of passing an address to M.W.P. Condiet, expressive of our high sense of the zeal and vigilance he has displayed in watching and guarding our interests during these trying times, for assuredly, to use his own words: "the lines have fallen to us (the Executive Officers of the National Division) in troublesome times indeed. Discouragement and uncertainties have met us at almost every step, and we have groped our way thus far in darkness and gloom."

Apart from the routine business of this Session, many important subjects will come up for discussion. The fixing of a permanent place for the holding of our Annual Meeting, will necessarily occupy our attention. Next, it will be necessary to fully discuss the propriety of petitioning the Legislature for a Prohibitory Liquor Law, or a more stringent License Law. Kindred Associations to our own, are now busy preparing their petitions for presentation, and we must not be behind in wielding the powerful lever petition-to move our indifferent Legislators. We must convince them that we are in earnest in our demands, and that they may, for a time, lend a dull ear to our prayers ; yet, the day is, we hope, not far distant when they shall see it is for the interest of the country to grant all we ask. It may be also necessary to discuss the subject of petitioning the Legislature for a grant of money to endow an Asylum for the reformation of drunkards. The principle of drunkard reformation has been already tried in the neighbouring Republic ; and what has already proved a success in that country, would, no doubt, be equally successful in Canada. From a recently published statement, it appears that during the last four years, no less than one thousand confirmed inebriates were admitted into an Asylum called the "Washington House," New York, and that there is good grounds for believing that not less than four-fifths of that number were reclaimed, and returned to the world better and wiser men, and are once more filling respectable positions in society. The propriety of establishing a National Division for British North America, will next claim attention, although perhaps it will be found best to allow the question to remain as it is for the nonce.

A general desire seems to prevail amongst Subordinate Divisions that some definite action should be taken towards getting a law allowing Lady Visitors full membership. This is a matter that should claim our particular attention. We are all satisfied, no doubt, that since the introduction of the ladies into our order our principles have spread with a greater rapidity than heretofore, and the attendance of male members in the Division Room has encreased more than ten-fold. I conceive it is our duty then to do all in our power to increase the usefulness of this class, and if we think our Order will be benefited by the change, let us at once petition the National Division for the necessary powers to grant these privileges.

powers to grant these privileges. As you are no doubt aware our act of incorporation expires this year. If it is found desirable that it should be renewed, definite action must be taken in the premises, so that the matter may come before Parliament at its first Session.

In conclusion Brothers, I must now thank our Worthy Grand Scribe for the assistance he has lent me during my term of office. My opinion is that it would be a difficult matter for you to find a more efficient or devoted man to fill the office of Grand Scribe. I have always found him at his post, and always willing to do all in his power to advance our Order. And although my official connection with him now ceases, I hope we will still continue to fight side by side, as we have done for the last ten years against our common foe, intemperance. And to my deputies I also return my sincere thasks for the manner in which each and all of them have performed the duties I entrusted to their care. And to you Brothers of the Grand Division I owe a lasting debt of gratitude for having placed me in the position I have occupied for the last twelve months. The honor I will ever remember and if God spares us, I hope we will meet as heretofore for years to come, as members of the Grand Division of Canada East, and endeavour to still further our noble Order. I may not have performed the duties of the office so well as you might have wished, but this much I will say, I have done all I could to advance the interests of our Division and promote the cause of temperance.

The G. S. read his report as follows :

Office of Grand Scribe, Montreal, January 13th, 1862.

To the Grand Division S. of T. C. E.

Officers and Brothers,—Permitted by a kind providence again to assemble at this our tenth Annual Session, it becomes my duty to report the transactions of this office for the past term and the present condition of the Order in the jurisdiction. In doing so I am gratified to be enabled to say that the several Divisions are generally in a healthy condition and altho' the addition to our membership reported is not so large as I had anticipated, yet it is sufficiently so to demonstrate that we are still progressing though slowly, surely. During the six months preceding 30th September, last we have added to our numbers 184 members and 265 lady visitors, and I believe that had I received all the returns for the quarter ending 31st December last, I would have been enabled to show a still larger proportional increase.

Since last meeting two new Divisions have been instituted one located at North Stanbridge, Go of Missiaquoi, and named North Stanbridge Division, No. 66, and the other located at Roxton, Co of Shefford, and named Milton Divisio, No. 67. In the month of October, 1860, Cameron Division after having ceased its meetings for some years was again revived but only continued in operation for a few months. Again on 12th November last the Division was re-organized and I am happy to say with fair prospects of a long and successful career.

Three Divisions since my list report have ceased working, viz. Manningville Hope, No 22, located at Manningville. Perseverance, No 4, located at Huntingdon and Lochaber, No 13, located at Lochaber.

One Division has made no return for three quarters, one has failed to do so for two quarters, and two for one quarter.

At the semi-annual meeting held at Quebec I placed before the Grand Division Communications from the M. W. P. and from the Grand Scribe of New Jersey inviting the Representatives of the several Grand Divisions to meet the Grand Divisions of New Jersey and Penusylvania and also to hold an advisary meeting of the National Division. No deputation however was named by this Grand Division. Subsequently a communication was received by me from the M. W. P., (herewith laid before the meeting) urging in very strong terms a Representation from this jurisdiction. This communication I immediately laid before the G. W. P., who agreed with me in considering that it would be only paying a proper respect to the request of the M. W. P., that at least one Representative should attend the meeting from this locality, at the same time stating that he could not from his other eugagements go to the meeting but requesting I should myself go, or if I could not, I should endeavour to get some one of our Representatives to attend the convection. I consulted the Representatives residing in Montreal but found that none of them could spare the necessary time myself excepted I consented at their solicitation to be the Representative of the Grand Division. I therefore attended the meeting, which was attended by Representatives from nine Grand Divisions, which though seeningly a small representation was in reality a large one, those nine Grand Divisions comprising more than one half of the whole Order. Various matters were brought up by the M. W.P., for advice. Those more directly interesting to this locality were :-

1st. The time when, and place where, the next Session of the National Division should be held. It was the unasimous opinion of the meeting that no Session of the National Division should be held until June, 1862, and that under existing circumstances it should be held in one of the British Provinces, and after some discussion Montreal was selected as the fittest place for holding such Session. The M. W. P., however intimated that before finally deciding on the place of meeting he would take the opinion of all the Grand Divisions as to what place would be most suitable. He has accordingly done so by special circulars to Grand Divisions herewith laid before you, and it now behoves us as a Grand Division to extend a cordial invitation to the National Division to hold its next Session in the City of Montreal, I may here state that responses have already been made by several Grand Divisions. Those of the British Provinces which have responded, Prince Edward's Island and New Brunswick have recommended Halifax, Nova Scotia, whilst Nova Scotia itself has gone in favor of Montreal, stating that although they were apxious to have the meeting of the National Division held at Halifax, yet they considered that in the present circumstances of the Order it necessary that the meeting should be held in a place easy of access, they therefore recommended Montreal as the most suitable place for next meeting, hoping at some future day to have the pleasure of receiving the National Division at Hallfax, and giving them a Nova Scotia welcome. 2d. Whether it would be proper to recommend the further extension of the privileges of Lady visitors. The meeting were all but unanimous in recommending the further extension of those privileges-some of the members advocating full membership, whilst a few, although in favor of granting more privileges to the Ladies, were not prepared to go the whole length of full membership. This is a subject of great importance, and requires your most serious consideration, as I am of opinion the future success of our Order, at least in this jurisdiction, depends mainly on the course adopted by the National Division at its next Session in relation to this matter. If we are to expect greater success in our endeavours to extend our Order, we must give the Ladies a greater interest therein, for in all movements for the moral reformation of the human race, they can, and do work more effectively than the so called Lords of Creation. Let us then pass a strong resolution in favor of the extension of their privileges in the Order. Another matter was incidentally brought up at the meeting, but was not fully discussed, although several of the members expressed themselves favourably, that is, that the Constitution be so altered as to allow to youths under 18 years of age, the privilege of voting and holding subordinate offices. In the month of September last, accompanied by P. G. W. P. Rose, I visited several of the Divisions in the Eastern Townships. In the course of an eight days' tour we visited ten Divisions, and I am happy to say we found them all in a healthy and good working condition. The Divisions visited by us were the following: West Shefford, Shefford, Knowlton, North Missisquoi, Washingtonian, Cowansville, Farnham Centre, East Farnham, Adamsville and Granby.

I believe that such visits are conducive to the prosperity of the Divisions visited, and were they so carried out that every subordinate Division were periodically visited by one or more competent brethren, to instruct them in the working of the Order, tell them of what is doing elsewhere, and show them by their presence amongst them that in all their labors and efforts to ameliorate the condition of their fellows, they are sure to receive the support and sympathy of theirbrothers. Many Divisions in isolated situations have gone down in a great measure from the want of that sympathy and support which such visitations would afford. Let us then brothers take this matter into our most serious consideration and, if possible, devise means for the periodical visitation

I beg to submit a communication from the Grand Division of Canada West on the subject of the formation of a National Division for British North America on the same basis as that of Great Britian and Ireland.

The subject of Prohibition will also require your attention. It would be well if an united effort on the part of all the Temperance organizations could be devised and carried out, and I trust you will be enabled to do so.

From the Grand Scribe of Connecticut I have received a copy of By-laws and installation service for Lady visitors, and also an installation service for Ghaplain, adopted by that Grand Division, which I commend to your consideration.

The Committee on the Good and Welfare of the Order, to whom have been submitted the Reports of the G. W. P. and G. S. beg to Report :--

#### REPORT OF G.W.P.

In reference to the G. W. P's. report we heartily concur with the

sentiments expressed by him, that the civil war now raging in the neighbouring Republic, may soon cease, and peace again reign in the land. Adopted.

As to the subject of the meeting of the National Division for 1862 being held in Montreal in this Jurisdiction, as there is every probability of such being the case, we would recommend the appointment of a special Committee for the purpose of making arrangements for said meeting. Adopted, and Representatives Becket, H. Rose, Martin, and G. W. P. and G. S., were named a Committee of arrangements with power to add to their number.

With reference to the Circular of the M. W. P., we would recommend that our G. S. address a communication to him, expressive of the sympathy of this Grand Division for him, in the difficulties of his present position and for the calamity of civil war which has fallen upon the United States, producing among other great evils, a serious check to the progress and advancement of our Order. Adopted.

The necessity and propriety of using every exertions to secure a Prohibitory Liquor Law is regarded by your Committee, as a settled fact, and we would therefore urge that such must be the policy of the Grand Division. Adopted.

The recommendation of the G. W. P. in reference to petitioning the Legislature for a grant of money to build an Inebriate Asylum is, in the opinion of the Committee, premature and that it would be a useless appeal.

Moved in Amendment by P. G. W. P., G. M. Rose and seconded, that a Committee be appointed to draw up a Petition to Parliament asking for a grant of money to endow a reformatory for drunkards, and that the Committee have power to confer with the Committee appoint ed by the Grand Division of Canada West on the same subject.— Carried, and P. G. W. P., G. M. Rose, G. W. A. Russell and Representative Moore were named a Committee to carry out the resolution.

We concur with the sentiment expressed by the G. W. P. bearing upon the subject of the formation of a National Division for British North America, deeming it most advisable to defer the consideration of the matter at least till the present troubles in the Republic are settled. Adopted.

Your Committee deem the question of admitting Ladies into full membership one that requires deliberate consideration. That an extension of their privileges would add to their efficiency as co-labourers in the great work which we are prosecuting, is, we think, a fact which will not be disputed. At the same time we deem it due to the good of our Order, and also to the natural delicacy of the sex, to advise that some limitations be observed in regard to Ladies being made eligible for office.

In amendment it was moved by Representative Lay and seconded.

**Resolved**,—That this Grand Division request the National Division so to alter the Constitution of Subordinates as to allow Ladies the privilege of voting and holding office with the exception of that of W. **P.** Carried.

A great many matters are here alluded to which have been already referred to in the G. W. P.'s Report.

The thanks of the Grand Division are due to the P. G. W. P. H. Rose and Grand Scribe Hall for their trouble in visiting the Eastern Townships, as we think the visits of the Grand Division officers to Subordinate Divisions are very beneficial and productive of great good to our Order. Adopted.

We have examined the Bye-laws and Installation Service adopted by the Connecticut Grand Division for Lady visitors, and think they would be very well adapted for this jurisdiction and recommend them to the different Subordinate Divisions for adoption. Adopted, and the G. S. directed to get the same printed, and that one copy be sent to each Subordinate Division in the jurisdiction.

We would recommend that the National Division be urged to extend the privilege of voting and holding office. in Subordinate Divisions to youths between 15 and 18 years of age, with the exception of those of W. P., W. A., Chap. and Treasurer. Adopted.

In conclusion we rejoice in being able to congratulate the Grand Division on the general prosperity of our Order in Canada East. The influence we are exerting upon public sentiment is becoming every year more deeply marked. An appropriate odium, dark and deep is gradually settling down upon the infamous traffic in alcoholic drinks. In a few more years, no amount of wealth, nor conventional license, nor hypocrisy, will be sufficient to save the promoters of intemperance from the withering condemnation which sooner or later overtakes every great evil that afflicts humanity. Let us be faithful brothers—our "circle of honour" is a fortress of safety, and if true to our principles alcohol with its fell degradation, misery and bloodshed will be swept from the face of the earth.
