



REPORT

Of the Union Committees appointed respectively by the Wesleyan Methodist Conference, and the Methodist New Connexion Conference, of Canada; agreed to at the several meetings of said Committees, held in the Metropolitan Church, Toronto, on the 1st and 2nd day: of October, 1872; on the 30th and 31st days of January, 1873, and on the 9th and 10th days of April, 1873, concluding at 10 p.m., of the last named day.

PRELIMINARY AGREEMENTS.

1. This meeting deems a Union between the Wesleym Methodist Church in Union desine-Canada and the Methodist New Connexion Church, on such principles as may be mutually agreed upon, highly desirable.

2. A General Conference should be formed, to meet once in four years, having ferenet. power to make rules and regulations for the whole Church, subject to such restrictions as may be mutually agreed upon.

3. Lay representation should be included in the General Conference, in such form Lay Representation, as may be agreed upon.

4. The General Conference should be composed of ministers and laymen in equal Composition. numbers.

5. The General Conference only, should have power to make rules and regulations General Confor the entire Church, subject to such restrictions as may be hereafter defined and ers. accepted.

6. The Annual Conferences should be composed of ministers only, who have Annual Contravelled four years, and have been received into full connexion. They shall transact forences, all business appertaining to the Circuits, Stations or Missions within their respective bounds, and their decision shall be final on all questions of ministerial character.

7. One or more General Superintendents should be elected by the General Con-General Superference, to hold office for a term of years corresponding to the term of the said Conintendents. ference; such Superintendent or Superintendents to be set apart for the work hy such form of service as may be agreed upon, and to be amenable to the General Conference Amenable, &c. for all their official acts.

8. There should be District Meetings, and they should consist of all ministers and District meetpreachers on trial within the District, with an equal number of laymen, (to be appointings, eal as may be determined) surplaymen to have the right of taking part in all proceedings, except in the examination of ministerial character.

ACCEPTED DETAILS OF GOVERNMENT.

11. The United Methodist Conferences in British America, in the form of their General Cov-General Government, shall be composed of one General Conference, and sovers! An. Name of the Church.

12. The Name of the Church shall be called THE UNITED WESLEYAN METHODIST CHURCH OF CANADA. In case of a more general Organic Union of the Methodist Churches, it shall be called THE METHODIST CHURCH OF CANADA.

REFECTING THE GENERAL CONFERENCE.

Composition of the General Conference. 13. The General Conference shall be composed of one Minister and one Layman for every eight members of each Annual Conference. Provided nevertheless, that a fraction of three-fourths shall entitie a Conference to an additional representation. Provisos, Provided always that the President of each Conference shall be one of those so selected : and also provided always that the whole number of delogates elected shall not exceed two hundred and twenty.

Mode of elec-

14. The Ministerial numbers of the General Conference shall be elected by ballot.

15. The appointment of Laymen to the General Conference shall be made as follows :---

Laymon: how (1) The Laymon in each Annual District meeting next preceding the meeting of to be elected; and when, the General Conference shall elect from among the members of our Church within the bounds of the District, hpresentatives to the General Conference : the number so elected to be determined by the number of Church members in the District, as compared with the entire mon bership within the bounds of the Annual Conference : the whole number not to exceed the number of Ministers appointed by such Annual Conference.

Laymen : how to be elected. (2) The Lay members of the District Meeting making such appointments to the General Conference shall be elected by the Quarterly Official Meeting next preceding.

Duty of Score-taries.

16. The Secretary of each Annual Conference shall compute the number of Laymen to be appointed by each District in accordance with the principles laid down in section 15, and publish the mano in the minutes of the Annual Conference next preceding such District appointment. Each delegate must be not less than twenty-five years Qualification of Delegates. of age and must have been a member of the church continuously during the five years next preceding the time of his election.

Quorum.

17. A majority of those chosen to constitute the General Conference shall form a quorum for the transaction of business.

First meeting of General Conference, &c., &c. e

18. The first General Conference shall meet on the first Wednesday after the fifteenth day of September, in the year 1874, provided that the Conferences concerned shall have approved of the plan of Union ; and thenceforward, once in four years, on the first Wednesday after the fiftcenth day of September, in such place as may be decided by the General Conference.

24. The General Conference by a vote of two-thirds of its members, shall have Number and boundaries of power to increase or diminish the number, or alter the boundaries of the several An-Annual Connual Conferences.

25. The General Conference shall appoint a Special Committee, which shall deal Special Comwith questions of General Conference interests, in the interval between one General ^{mittee}. Conference and another.

26. Toward meeting the expenses of the First General Conference, a collection Expenses: how to be met. shall be made throughout our whole work, and the Annus' Conferences shall fix the time when such collection shall be made within their respective bounds.

RESPECTING GENERAL SUPERINTENPI'TS.

27. General Superintendents, one or more, shall be 'pointed who shall preside Duties of Genat the General Conference, travel through the entire connetion, preside at the Annual tendents. Conferences and their committees, and exercise a general 'upervision over the whole Geoerdinate work. If two or more General Superintendents be appointed, they shall have coordinate powers and jurisdiction, but the senior General Superintendent present shall open and organize each General Conference.

28. For the present, each General Superintendent shell reside within the bound- Residence. aries of the Conference electing him; but in the future, the General Conference shall designate the place of residence, having regard to the above mode of allocation.

29. After the first General Conference the election of the General Superintendents From whom to shall be made by the General Conference from those non nated by the Annual Conbe elected. Alternates. Forences. Provided always that the other nominees of the Annual Conferences shall be considered alternates, so that in case of the death or disability of one or more of the General Superintendents, the vacancy or vacancies thereby occasioned, shall be filled by such alternates in the order of their seniority.

30. The General Superintendents shall arrange among themselves the portion of Arrangement the work to be visited by each from time to time as converience or necessity may require.

31. The General Conference shall make an appropriation for salaries to each of Support of General Superintendents, which, together with traveling expenses, shall be pro-intendents. vided as the General Conference mey direct.

33. The General Superintendents with the advise and consent of the Presidents Duties in part. of the Annual Conferences, shall appoint the time for the meeting of the several Annual Conferences.

34. The General Superintendents shall have power to transfer from one Confer-Transfer of ence to another : Provided always that no Minister shall be so transfered, without his ^{Ministers.} consent and the consent of the Presidents of the Conferences to be affected by such change, as well as the Chairman of the District from which he is to be removed. Notice of all applications for transfer shall be given to the Chairman of the District, and the Presidents of the Conferences concerned, at least one month is fore the meeting of such Conference, and it Shall be the duty of the President of the Conference from which such transfer is to be made, to notify the General Superintendent of all such cases.

35. No Minister shall be transferred from one Conference to another against the

36. Each Minister transferred shall be subject to the action of the Stationing Committee of the Confernce to which he may be transferred.

AFEATING THE ANNUAL CONFERENCES.

37. The work in the Provinces of Ontario and Quebec shall be divided into three Three Conferences named. Annual Conferences, to be known as the Ontario, Huron, and St. Lawrence Conferrences.

How to be com-38. Each Annual Conference shall be composed of all Ministers received into full connexion and ordained, who are stationed and appointed by it.

President to be elected by ballot.

39. Each Annual Conference shall, on its assembling, elect by ballot without debate, a President, who in the absence of a General Superintendent, shall discharge all the duties of a President within the bounds of the Conference electing him.

- Secretary also. 40. Each Annual Conference immediately after the election of a President shall appoint a Secretary by billot without debate ; and shall also elect the Chairmen of Districts, according to the Discipline.
- To nominato General Super-intendents. 41. Each Annual Conference next preceding the meeting of the General Conference, shall nominate for General Superintendent a member of one of the Annual Conferences, and from amongst those so nominated, the General Conference shall elect one or more General Superintendents.

Provision in case of death, &c., &c. 42. In the event of the death, disability of, or occupation of the office of General Superintendent by a President of an Annual Conference, the ex-President shall immediately enter upon the duties of the Presidency and discharge them to the end of the year.

- Duties as to character. 43. Each Annual Conference shall examine the character and qualifications of all Ministers and Preachers on trial within its limits, and its decisions shall be final.
- Stations. 44. Each Annual Conference shall station all the Ministers and Preachers within its limits according to the rules of the Stationing Committee.
- Stationing Committee. 45. No change shall at present be made in the Constitution of the Stationing Committee, except that the lay members of the District Meeting shall also vote in the election of the Representatives.

President to be stationed. 40. Each President of an Annual Conference shall be stationed on a Circuit, and shall be ex-officio Chairman of the District in which he is stationed or through which he may travel. In the absence of a General Superintendent he shall fulfill all the duties of President within the bounds of the Conference by which he is appointed.

RESPICTING QUARTERLY OFFICIAL MEETINGS.

47. The Quarterly Official Meetings shall consist of, the Ministers and Preschers moetings; of whom to con-sist. on trial ; the Local Presiders, the Stewards of the Circuit, the Leaders of Classes, the Superintendents of Sablach Schools, being members of the Church ; one representative from each Board of Trustees, he being a member of the Church, and also of additional representatives who may be appointed by the Societies of the Circuit, the apportionment and scale to be fixed by the May Quarterly Meetings, which also shall specify the mode by which the voto shall be taken ; but such additional representatives shall not exceed the number of the Stewards on each Circuit.

Chairman.

48. The Chairman of the District, or in his absence, the Superintendent of the Circuit shall preside at the Quarterly Official Meetings.

49. The regular butiness of the Quarterly Official Meetings shall be ;

7. To examine the character of Exhorters, and annually, at the May Quarterly Exhorters. Meeting, to renew their licenses.

8. At any Quarterly Meeting, where there is no local Preachers' Meeting, to Specially, license Local Preachers in case of necessity.

RESPECTING LOCAL PREACHERS.

50. Where there are six Local Preachers on a Circuit of three years' continuous Number to standing, the Superintendent shall regularly meet the Local Preachers once a quarter. Ing. No person shall be put upon the plan as a Local Preacher, or be suff, red to preach among us as such, except on the nomination of the Superintendent, and with the approbation of the Local Preachers' Meeting, or the Quarterly Official Meeting of the Circuit, where a Local Preachers' meeting is not held.

51. The Superintendent at each regular Local Preachers' Meeting, or the Chair. Enquiry into man or Superintendent at the last Quarterly Official Meeting of the Circuit, shall inquire into the religious and moral character, doctrines, shility to preach, punctuality in attending appointments, of eac' Preacher by name.

52. The questions proposed in the examination of the characters of Local Preachers, Questions, shall be the same as those proposed in regard to Traveling Preachers.

53. All Local Preachers shall meet in class. No exception shall be made in re- To meet in spect to any who may have been Traveling Ministers or Preachers in former years.

54. No Local Preacher shall hold Love-feasts without the consent of the Super- Limitations. intendent, nor in any wise interfere with his business.

55. Whenever a Local Preacher or Exhorter removes how one Oirenis to another, Certificate of he shall obtain from the Superintendent of the Oirenit a certificate of his official standing in the Church at the time of his removal, without which he shall not be received as a Local Preacher or Exhorter in other places.

56. No Local Preacher coming to reside among us from another part of the world, From other although duly recommended, shall be allowed to preach or hold meetings in our they must do, Churches unless he become a member of the Church and submit to its Discipline.

57. No Minister or Preacher who has been suspended or expelled by the Con-Consent of ference, shall on any account be employed as a Local Preacher without the consent of the Conference.

Recorde.

58. The name of a y Local Preacher shall be recorded on the Journals of the Quarterly Official Moving of the Circuit in which he resides.

Located Preachers:

59. Preachers who have been formerly in connection with the Conference, but Preachers: multi respecting who have located, shall be subject to all the regulations affecting Local Preachers, and when charged with immerality shall be proceeded against as other Local Preachers. The Superintendent of the Circuit shall report the case to the District Meeting.

From other 60. Should any Local Freeener belonging to any other below the District or Super-Methodist application to be received into our Church, the Chairman of the District or Super-to be received, intendent of the Circuit, is concurrence with the Quarterly or Local Preachers' Meet-to be received. 60. Should any Local Preacher belonging to any other body of Methodists make ing of the Circuit on which such Local Preacher shall reside, is authorized to receive him, after having inquired into his qualifications and all the circumstances of his case.

RESPECTING CIRCUIT STEWARDS.

Qualifications.

61. Let them be men of solid piety, who both know and love the Methodist doctrine and discipline, and of good natural and acquired abilities to transact the temporal business.

Appointed ; how and when.

62. They shall be appointed by the vote of the November Quarterly Official Meeting, the Superintendent nominating.

63. It shall be the duty of Stewards to take an exact account of whatever has been collected for the support of Ministers and Preachers in the Circuit ; to make an accurate return of every expenditure of money, whother to the Minister, the Preacher, the sick, or the poor; to seek the needy and distressed, in order to relieve and comfort them ; to inform the Ministers or Preachers of any sick or disorderly persons ; to attend the Quarterly Meetings of their Circuits ; to give advice, if asked, in planning the Circuit ; to provide the elements for the Lord's Supper ; to write circular letters to the

Societies in the Circuit to be more liberal if need be ; to let them know, when occasion requires, the state of the temporal concerns at the last Quarterly Meeting ; to fill up the Circuit schedules correctly ; and to be subject to the President, the Chairman of their District, and the Ministers and Preachers of their Circuit.

Accountable.

64. The Stewards shall be accountable for the faithful performance of their duties to the Quarterly Officia! Meeting of the Circuit.

65. On each Circuit, there shall be not less than three, nor more than seven ; one Number. 65. On each Circuit, there shall be not less than three, nor more than seven ; one Nomination. Appointment. of whom shall be the Recording Steward, who shall be nominated by the Superintendent, and appointed by the meeting.

Provision in case of incapacase city.

66. When a Recording Steward of a Circuit becomes incapacitated for the duties of his office, the Superintendent of the Circuit shall have authority to appoint another of the Stewards to that office until the next Quarterly Meeting, when his place shall be supplied according to discipline.

RESPECTING SOCIETY MEETINGS.

Principal object.

67. Society Meetings shall be held in all our Circuits, wherever it is practicable, once a quarter, and the principal object of these meetings shall be the spiritual edification of the Church

RESPOTING FINANCIAL ECONOMY.

68. All the moneys nised for Missionary purposes in the several Conferences of the United Churches shall form one General Mission Fund. One Fund

Central Board. 69. There shall be a Central Missionary Board for the management of the Missionary Fund, which shall meet annually.

Composed, of 70. This Board shall be composed, for the present, of the General Superintend-whom, Lay-men, by whom ents; the President of each Annual Conference; one Minister annually elected from each Annual Conference ; the chief Officors of the Missionary Society, and an equal number of Laymen, of whom one shall be appointed by the second of each Annual Conference Missionary Committee, and the others by the sympet of the General Conference.

73. The General Conference shall appoint the Officers of the Missionary Society, Officers, who shall be ex-officio members of the Central Missionary Board.

75. There shall be within the bounds of each Annual Conference a Local Mission- Local Committee constituted as the General Conference may determine.

RESPECTING OTHER CONNEXIONAL FUNDS.

76. It is deemed desirable as soon as legal and other difficulties can be removed, Amalgamato amalgamato the different funds of the United Church and to place them under the management of a Centrel Board or Boards.

77. The Superannuated Preachers' Annuitant Society of the New Connexion Superannuated Annuit-Conference, and the Superannuated Ministers' Fund of the Wesleyan Conference be and Annuitamalgamated, and all claimants on the New Connexion Fund be placed on the same footing as Wesleyan Ministers, and receive from the Superannuation Fund of the United Church according to the scale laid down in the Constitution of the Superannuated Ministers' Fund of the Wesleyan Conference.

78. The Members of this Committee connected with the Wesleyan Methodist Recommendrtion respecting Church recommend to the Board of Management of their Superannuated Ministers' New Connex-Fund, to take into their most favorable consideration the cases of those Ministers of Ion Ministers. The New Connexion Church who are not members of their Annuitant Society, in order to constitute them claimants on the Superannuation Fund of the United Church.

79. Respecting the Missionary Fund, the Contingent Fund, the Church Relief Other Funds. Fund and the Children's Fund, the Committee is of opinion that no difficulty exists to prevent an immediate and perfect amalgamation of the same.

80. Whonever Connexional Funds are organized or amlgamated, their manage- Future manament shall be entrusted to a Board or Boards constituted by the General Conference gement. similarly to the Missionary Board

81. The publishing interests of the United Church shall be under the direction of Institutions. the General Conference.

82. The General Conference shall appoint the Editor or Editors and the Book Editors. Steward or Book Stewards.

83. The General Conference shall determine the number and character of our General Con-Educational Institutions, and shall prescribe the manner of ferming the Governing first preter Hoards of all Universities and Theological Schools. The General Conference shall also ence to prescribe a Conference of Study for all Candidates for the Ministry.

84. In the event Union between the Wesleyan Conference and the Methodist New Connexion Orierence in Canada, it is understood that the United Church shall constitute a distinct community, connected with the Wesleyan Methodist and Methodist New Connexion Churchés in England, only by fraternal ties; nevertheless this Joint Committee is constrained to express its deep and grateful sense of indebtedness to the Parent Boties in England for their liberal assistance and fraternal care, during the many years of our past history; and we devoutly pray that upon them, as upon ourselves, may rest continually the blessing of God, guiding us to such decisions and labors as may promote the evangelization of the world and extend the glory of the Redeemer's name.
