





AN ACT

TO INCORPORATE

THE EUROPEAN AND NORTH AMERICAN

RAILWAY COMPANY.

HEREAS it is contemplated, under concurrent Charters, Preamble, ' to construct a continuous Line of Railway from Bangor, h the State of Maine, through the Provinces of New Brunswick nd Nova Scotia, to Halifax, or some other Port on the Eastern Coast of Nova Scotia, under the name of "The European and North American Railway Company," thereby affording an uninerrupted route of land communication to all parts of North America, from some Atlantic Port in the most direct line of Emigration, Traffic, and Travel, between the Old and the New World: And whereas in furtherance of this great object, the Legislature of the State of Maine has passed an Act to authorize the construction of such Railway through their own territory, by Corporation under the aforesaid name: And whereas it is dvisable, for the more efficient and economical construction and working of the said Railway, that provision should be made in he concurrent Charters of the said Provinces and State, to enable be respective Corporations or Companies, by deed, contract or greement, if they deem it expedient, to establish a uniform stem of management and direction over the whole proposed ne: And whereas it is the duty of this Province to grant every cility and encouragement to such enterprising persons as may desirous and willing to make and maintain such a Railway roughout this Province, by granting to them an Act of Incorpration, with the privilege of establishing Branch Lines and seam Vessels in connexion with the said Railway, both on the Gulf of Saint Lawrence and the Bay of Fundy, as the Company ay deem desirable ;'

Millidge, President of the Bank of New Brunswick, Charles Brown, George Sutherland, John Wesley Weldon, Stephen Binney, Alexander Wright, and such other persons as shall from time to time become proprietors of the shares in the Company hereby established, their successors and assigns, shall be, and they are hereby declared, ordained and constituted to be a Corporation, Body Politic and Corporate, by the name of The European and North American Railway Company, and shall by that name have perpetual succession and a Common Seal; and shall and may by the same name sue and be sued, plead and be impleaded, answer and be answered unto, defend and be defended, in all Courts and places whatsoever, and shall also have power and authority to purchase, hold and enjoy lands, tenements and hereditaments, for them and their successors and assigns, for making the Railway, and for settlers on the line of the said Railway, and generally for the purposes of carrying the provisions of this Act into effect; and also that they the said Company shall from time to time, and at all times, have full power and authority to constitute, make, ordain and establish such bye laws, regulations and ordinances, as may be deemed necessary for the good rule and government of the said Company ; provided that such bye laws, regulations and ordinances, as may be deemed necessary, be not contradictory or repugnant to the laws of this Province; and provided also, that no bye laws, regulations and ordinances, made under and by virtue of the power and authority of this Act, shall be of any force or effect, until one calendar month after a true copy of such bye laws, regulations and ordinances, certified under the hand of the President of the said Company, shall have been laid

before the Lieutenant Governor or Administrator of the Government in this Province for the time being, for approval or disapproval, unless the Lieutenant Governor or Administrator of the Government shall before such period signify his approbation thereof.

II. And be it enacted, That the capital stock of the Company Capital to be hereby established shall be Fifteen hundred thousand pounds, the £1,500,000, divided whole to be paid in current money of this Province; the whole with power to amount of the said capital stock to be divided into sixty thousand increase. shares, of twenty five pounds each; and the said Corporation, if necessary, shall have power to extend the said capital stock to a sum or sums not exceeding Two millions of pounds of like current money, and shall have power to increase the number of shares accordingly; which original shares and increased stock shall be vested in the persons hereinbefore named, and such other persons as may take shares in the said Company, their successors or assigns; and upon taking such shares, they shall deposit in such Bank or Periods and Banks in the British North American Colonies, or elsewhere, as amounts of payments. the Directors of the said Company shall from time to time appoint for that purpose, the sum of five shillings per share current money aforesaid; and the remaining amount of such shares shall be called in as the work progresses, in such parts and amount per share as the Directors of the said Company may deem necessary; provided always, that two pounds ten shillings per share shall be the greatest amount per share of any one call which the said Directors may make on the shareholders, and two months at least shall be the interval between successive calls; and thirty days previous notice of payment being required for any one call, shall be given in the Royal Gazette at Fredericton, and one or more of the Newspapers published in the City of Saint John ; provided also, that the whole amount of such calls shall not exceed, in any one year, one third part of the amount subscribed; and on demand of the holder of any share, the Company shall cause a receipt or certificate of the proprietorship of such share to be delivered to such shareholder, and the same may be according to the form at the Schedule A to this Act annexed, or to the like effect, or in such other form as the said Company may by their bye laws prescribe ; and every of the said Shares to be shares shall be deemed personal estate, and transferable as such, personal estate. and shall not be deemed or taken to be of the nature of real property; and every such share shall entitle the holder thereof to a proportionate part of the profits and dividends of the said Company; provided also, that the money so to be raised as aforesaid, shall be laid out in the making, completing and maintaining the said Railway, and other the purposes therewith connected, mentioned in this Act, and in payment of the legal and other expenses incurred in and about the incorporating and establishing the said Company, and to no other use or purpose whatsoever.

Interest on moneys called in may be paid till the Railway be completed, subscribed, and the deposit of five shillings per share shall have been actually paid as aforesaid, and not before, it shall be lawful for the said Company, and they are hereby anthorized and empowered by themselves, their deputies, agents, officers, and workmen, t make, construct, and finally complete, alter, and keep in repair, Railway, with one or more sets of rails or tracks, with all suitable bridges, archways, turn-outs, culverts, drains, and all other necessar appendages, and to erect such wharves, moles, jetties, piers, docks harbours, landings, aboideaux, dikes, buildings, depots, and ware houses, either at the termini or on the line of the said Railway and to purchase and acquire such stationary or locomotive stear engines, and carriages, wagons, floats, and other machinery and contrivances, and real or personal property, as may be necessary for the making and maintaining the said Railway, and for the transport of passengers and merchandise thereon, and for othe purposes of this Act; and may hold and possess the land over which the said Railway is to pass, and such adjoining lands a may be required; which Railway is to run from some point of place from the Eastern Boundary of this Province, in the County of Westmorland, so as best to connect with a Railway to be constructed from the City of Halifax, or some other Port on the Eastern Coast of the Province of Nova Scotia, on the Atlantic Ocean, over the most practicable route through this Province o New Brunswick, so as best to connect with a Railway to be constructed from the City of Bangor, in the United States of America, to the eastern part of the State of Maine, under a Charter from the same State, with a like name as is used in this Act, as the Directors of this Company, in the exercise of their best judgment and discretion, shall judge most favourable and bes. calculated to promote the public convenience, and carry into effect the intentions and purposes of this Act; provided always, that a Map or Plan of the route determined upon shall be deposited in the Office of the Secretary of this Province.

IV. And be it enacted, That the said Company shall and may if they deem it expedient, make Branch Railways to every or any part of the Province, and manage such Branch Railways, and procure and own such steam boats or vessels as may be necessary to ply in connexion with the said Railway, in the waters of any part of the Gulf of Saint Lawrence, or in the Bay of Fundy, or in the waters contiguous to either of them; and for that purpose shall exercise and possess all the powers, privileges and authorities necessary for the management of the same, in as full and ample a manner as they are hereby authorized to do with respect to the said Railway.

And be it enacted, 'That it shall be lawful for the Director of the said Company, in their discretion, until the said Railway shall be completed and opened to the public, to pay interest at any rate not exceeding six pounds per centum per annum on all sums called up which the at such the purpose; proprietor respect o proprietor

And be it enacted, That the certificate of the proprietorship Evidence of proof any share in the said Company shall be admitted in all Courts perty in a share. as prima facie evidence of the title of any shareholder, his executors, administrators, successors or assigns, to the share therein specified ; nevertheless, the want of such certificate shall not prevent the holder of any share from disposing thereof.

VII. And be it enacted, That no shareholder shall be entitled No share to be to transfer any share, after any call shall have been made in transferred while respect thereof until he or she shall have paid all calls for the time in arrear. respect thereof, until he or she shall have paid all calls for the time being due on every share held by him or her.

VIII. And be it enacted, That the said Company shall not be Company not bound bound to see to the execution of any trust, whether express, implied to see to the execution of trust or constructive, to which any of the said shares may be subject; in respect of shares. and the receipt of the party in whose name any such share shall stand in the Books of the said Company, or if it stands in the name of more parties than one, the receipt of one of the parties named in the Register of Shareholders shall from time to time be a sufficient discharge to the said Company for any dividend or other sum of money payable in respect of such share, notwithstanding any trust to which such share may then be subject, and whether or not the said Company have had notice of such trusts, and the said Company shall not be bound to see to the application of the money paid upon such receipts.

IX. And be it enacted, That the several persons who have or Subscribers to the shall hereafter subscribe any money towards the said undertaking, Stock, and their representatives, or their legal representatives respectively, shall pay the sums to pay as appointed respectively so subscribed, or such portions thereof as shall from by the Directors. time to time be called for by the Directors of the said Company, at such times and places as shall be appointed by the said Directors ; and with respect to the provisions in this Act contained for enforcing the payment of the calls, the word "shareholder" shall extend to and include the personal representatives of such shareholder.

X. XI. And be it enacted, That if before or on the day appointed for payment any shareholder do not pay the amount of any call to which he is liable, then such shareholder shall be liable to pay interest for the same at the rate allowed by law, that is to say, six per centum per annum from the day appointed for the payment thereof to the time of the actual payment.

XII. And be it enacted, That it shall be lawful for the said Company, if they think fit, to receive from any of the shareholders willing to advance the same, all or any part of the moneys due upon their respective shares beyond the sums actually called for; and upon the principal moneys so paid in advance, or so much thereof as from time to time shall exceed the amount of the calls then made upon the shares, in respect of which such advance shall be made, the .Company.may pay.interest at such rate, not exceeding the legal rate of interest for the time being, as the shareholder paying such sum in advance and the said Company may agree upon.

XIII. And be it enacted, That if at the time appointed by the said Company, or the Directors thereof, for the payment of any call, any shareholder shall fail to pay the amount of such call, it shall be lawful for the said Company to sue such shareholder for the amount thereof in any Court of Law or Equity having competent jurisdiction, and to recover the same with lawful interest from the day on which such call was payable.

XIV. And be it enacted, That in any action or suit to be brought by the said Company against any shareholder to recover any money due upon any call, it shall not be necessary to set forth the special matter, but it shall be sufficient for said Company to declare that the defendant is the holder of one share or more in the said Company, stating the number of shares, and is indebted to the said Company in the sum of money to which the calls in arrear shall amount in respect of one call or more upon one share or more, stating the number and amount of each of such calls, whereby an action hath accrued to the said Company by virtue of this Act.

XV. And be it enacted, That on the trial or hearing of such action or suit it shall be sufficient to prove that the defendant at the time of making such call was the holder of one share or more in the said Company, and that such call was in fact made and such notice thereof given as is directed by this Act; and it shall not be necessary to prove the appointment of the Directors who made such call, or any other matter whatsoever; and thereupon the said Company shall be entitled to recover what shall be due upon such call, and interest thereon, unless it shall appear either that any such call exceeds the prescribed amount aforesaid, or that due notice of such call two succe XVI.

XVI. And be it enacted, That the production of the Register Register of of Shareholders shall be prima facie evidence of such defendant shareholders to be prima facie being a shareholder, and of the number and amount of his shares. evidence.

XVII. And be it enacted, That if any shareholder fail to pay Shares in arrear any call payable by him, together with the interest, if any, that may be declared forfeited. shall have accrued thereon, the Directors of the said Company, at any time after the expiration of two months from the day appointed for payment of such call, may declare the share in respect of which such call was payable, forfeited, and that whether the said Company have sued for the amount of such call or not.

XVIII. And be it enacted. That before declaring any shares Notice to be given forfeited, the Directors of said Company shall cause notice of such of intention to declare shares intention to be left or transmitted by Post to the usual or last place forfeited. of abode of the person appearing by the Register of Shareholders to be the proprietor of such share; and if the holder of any such share be beyond the limits of this Province, or if his usual or last place of abode be not known to the said Directors, by reason of its being imperfectly described in the Shareholders' Address Book, or otherwise; or if the interest in any share shall be known by the said Directors to have become transmitted otherwise than by transfer, and so the address of the parties to whom the said share or shares may for the time being belong shall not be known to the sail Directors, the said Directors shall give public notice of such intention in the Royal Gazette, at Fredericton, and also in one or mire of the Newspapers published in the City of Saint John, and the several notices aforesaid shall be given ninety days at least before the said Directors shall make such declaration of forfeiture.

XIX. And be it enacted, That the said declaration of forfeiture Forfeiture of shares shall not take effect so as to authorize the sale or other disposition a general meeting. of any share, until such declaration shall have been confirmed at the next general meeting of the said Company to be held after such notice of intention to make such declaration of forfeiture shall have been given; and it shall be lawful for the said Company to confirm such forfeiture at any such meeting, and by an order at such meeting, or any subsequent general meeting, to direct the share or shares so forfeited to be sold, or otherwise disposed of.

XX. And be it enacted, That after such confirmation as Forfeited shares aforesaid, it shall be lawful for the said Directors to sell the forfeited to be sold. share by Public Auction; and if there be more than one forfeited share, then either separately or together, as to them shall seem fit ; and any shareholder may purchase any forfeited share so sold as aforesaid.

XXI. And be it enacted, That an affidavit by some credible Evidence of person not interested in the matter, sworn before any Justice of purchased shares. the Peace, or before any Commissioner for taking affidavits in the Supreme Court, or other person qualified by law to take affidavits,

And be it enacted, That the joint stock or property Joint stock to be of the said Company shall alone be responsible for the debts and alone responsible engagements of the said Company ; and that no person or persons debts. who shall or may have dealings with the said Company shall under any pretence whatsoever have recourse against the separate property of any of the individual shareholders of the said Company, or against their person or persons, further than may be necessary for the faithful application of the funds of the said Company; provided also, that no shareholder of the said Company shall be liable for or charged with the payment of any debt or demand due from the said Company beyond the extent of his share in the capital of the said Company not then paid up.

LXIX. TO FACILITATE THE CONSTRUCTION OF

THE EUROPEAN AND NORTH AMERICAN RAILWAY.

Passed 28th March 1851.

B^E it enacted by the Lieutenant Governor, Legislative Council and Assembly and Assembly,-

1. When the Shareholders of the Enropean and North American When the share-Railway Company shall pay in to their Treasurer at least the sum holders pay to their Treasurer £10,000 sterling, and it shall be satisfactorily proved sterling, stock to a to the Lientenant Governor in Council that such sum has been like amount to be actually paid in, and is ready to be expended in the construction Province, and within this Province of the European and North American Railway, Debentures the Province Treasurer shall be authorized by the Lieutenant Company for the Governor in Council to subscribe on behalf of the Province for amount. shares in the said Company to the like amount, and in payment therefor to deliver to the said Company special certificates of debt, to be called Debentures, bearing interest at a rate not exceeding six per cent. per annum, the principal money redeemable in thirty years; and so from time to time when it shall be satisfactorily On further pay-proved to the Lieutenant Governor in Council that the sums there-tofore subscribed and paid in by the shareholders of the said Com-pany, and the proceeds of the Debentures previously delivered, to be taken. have been expended in the construction of the said Railway, and that a further sum of at least ten thousand pounds sterling has been actually paid in by the shareholders, and is ready to be expended in like manner, the Province Treasurer shall be again authorized to subscribe on behalf of the Province for shares in the said Company to an equal amount with the sum so paid in and ready to be expended, and also to pay in full for such shares by a further delivery of Debentures ; provided always, that the amount Limit. of shares in the said Company subscribed and paid for by the Province Treasurer in any one year shall not exceed one hundred thousand pounds sterling, and in the whole shall not exceed two hundred and fifty thousand pounds sterling.

The dividends arising from shares in the said Company held by the Provincial Treasurer, shall be applied towards the payment of interest on the said Debentures, and at the expiration of thirty years, when such Debentures become payable, the said shares, not before disposed of, shall be sold and disposed of, and the proceeds applied towards the payment of the same; and the faith and credit of this Province, and the ordinary Revenues thereof, and the amount or proceeds of any special impost which may hereafter be levied and collected for the purpose of paying off such Railway Debentures, and the interest thereon, shall be and are hereby declared pledged to any and every holder of the same for payment of interest as it becomes due, and for payment of the principal money at the expiration of the time limited for payment of the said Debentures, as they severally fall due; provided that there shall be no sale by the Province of any shares so held, below the par value, until after the expiration of ten years from the time of the first subscription for Stock by the Province Treasurer.
