No fault was found with the action of the Mayor and Controller Graham, who instructed the City Engineer to pay the extra sum to the contractor for the extra work done on the city work, in all probability, have had to pay. The report, however, recommended that the contractor who had taken advantage of the city should be given work in the future, and the clause, said that the men had worked on the job until it was nearly completed without making any complaint and when they demanded extra pay. They then asked for pay for drawing nine loads, when they only drew four.

Ald. Shaw thought the committee should endeavor to settle the claims of the property owners, who were kicked about by the extra \$32 involved.

The clause was referred back.

He said that the property owners are of the opinion that their money is being wasted. Over \$3000 was spent by the Council last year in catering to the masses and classes. He gave as an example the Opera House lane. The total cost of the work was \$90 and had been spent for inspectors' fees.

AGAINST DAY LABOR. "Day labor is not properly managed, and for that reason it must be stopped for a time," said Ald. Gowankow. At present it costs 60 or 70 per cent more than contract work, and the present system was a robbery of the people. There would be any amount of work done in the city if the confidence in the Works Committee and the administration of the City Hall.

Ald. Preston argued that if day labor was done away with it would leave the city at the mercy of contractors, who had already fleeced, robbed and defrauded the city for years. He said that the confidence in the works committee had been broken on other occasions.

"The revenue of every municipality in this province, being more or less dependent on excise duties from the City Council of Toronto believe that some amendments to the statute going away with these exemptions as a whole or in part should be secured; and in order to afford the different municipalities an opportunity of discussing the matter, by their representatives in council, and stating their positions in reference thereto, it has been deemed desirable that, afterwards, a convention be held in Toronto, say some time during the Industrial Exhibition, for the purpose, if possible, of then deciding a line of policy, and of bringing united action by the municipalities when the matter comes before the Legislature to be dealt with by it.

"With this end in view I have been directed to request you to bring the matter referred to at once before your council, and to respectfully say whether they will send a delegation to the convention referred to, or, say, two from each municipality, to meet at the holding of the Toronto Industrial Exhibition."

Yours of the 10th inst. has just been received. Overcharge on Richmond-street Pavement Discussed - Complaint of Property Owners - Arguments as to Day Labor Versus Contract Work - Batch of New Pavements - City Pays Excess of Estimated Cost - Communications and Delegation Around the City Hall.

The Board of Works spent most of its time yesterday afternoon discussing the report of Ald. Gowankow's "investigating committee."
