



MINUTES OF THE CONFERENCE

OF

New Brunswick and Prince Edward Island.

Held at St. Stephen, N. B., June 27th, 1883.

After the reading of the Scriptures by the Secretary, the 753rd hymn was sung, and the Revds. Frederick W. Smallwood and Dr. Pickard offered prayer.

Question VII.—Who have died since the last Conference ?**ANSWER.**

HEZEKIAH McKEOWN, who was born in Nictaux, Annapolis Co., Nova Scotia. He was converted during his residence as a student in the Wesleyan University, Middletown, Connecticut. In the year 1853 he was received as a probationer for our ministry, and in the year 1857 ordained. He was stationed on the Musquodoboit, Liverpool, Burton, St. Stephen, Carleton, (St. John), Avondale, Newport, St. Stephen (a second term), Woodstock, Fredericton, Chatham, Exmouth St. (St. John), and Sussex Circuits. He was seven times elected Chairman of his District. At the Annual Conference of New Brunswick and Prince Edward Island for 1879, he was elected its President. He was a delegate to the First General Conference of the Methodist Church of Canada, held in Toronto in 1874.

He was an effective pulpit and platform speaker. He did not so much aim to paint in words, whereby he might weave pictures of surpassing beauty, as he did to awaken men's consciences and to save souls. He loved the Sabbath School. He evinced a deep interest in the children of his congregations. He was eminently successful in directing those services, which we sometimes call "special services." His labours in the Church to promote revivals were abundant. In revival services he would bring out the whole strength of his vigorous and emotional manhood. On many of his circuits he was permitted to rejoice in seeing many souls gathered into the fellowship of the Church, as the fruit of his ministry. He was ardently attached to the Church in all its great essentials.

During the last year or two, it was manifest to those with whom he was most intimately associated that his health was becoming impaired. He was appointed to the Sussex Circuit at the Conference of 1882, and continued in the full and vigorous discharge of his pulpit and other duties, until, and including the Sabbath next preceding his death. On the night of his release from his earthly labors, he retired in, apparently, his usual health. A few hours later it was manifest to Mrs. McKeown that he was seriously ill. The family and physician were hastily summoned. The time for his departure had come. After having fallen into his first slumber of that night his consciousness

came not to him again. At 4 o'clock on the morning of Saturday the 14th of October, 1882, he exchanged the life of his earthly pilgrimage for the eternal life of the heavenly country in the 54th year of his age and the 30th year of his ministry.

The earnest attention of the members of our Church and of the Superintendents of Circuits is called to the following Rules of this Fund, viz. :

1. "Each circuit shall be considered as responsible for a yearly sum, equal at the least, on a general average of all the societies, included within that circuit, to ten cents per member; the number of the members to be taken in all cases as returned at the preceding Conference, and published in the Minutes.

2. "Every Minister shall, at the renewal of the Society Tickets during the August visitation, fully explain to the members the nature and reasonableness of the claims of this Fund upon the justice and liberality of our Church. He shall then enter in the Class Book the individual annual subscriptions, which are to be paid before the ensuing District Meeting.

3. "An annual public collection in Aid of this Fund shall be made in all churches and other preaching places in the month of December.

4. Application shall be made to our friends in each Circuit for Subscriptions and Donations in aid of this Fund."

5. It shall be the imperative duty of each Chairman of a District, to earnestly endeavor to secure the observance of the Rules of this Fund throughout his District, by calling especial attention to them at the September or Financial District Meeting; by particularly

enquiring at the regular District Meeting, whether proper attention has been paid on each Circuit to the interests of the Fund, especially in regard to the 5th and 6th Rules; and by reporting to the Conference if any preacher, superintendent or other, is unfaithful in this respect.

The particular attention of the Ministers and Preachers is called to the rule of Conference That the whole amount of the Annual Collection for this Fund be given, and not the average collection deducted for circuit purposes. And also their attention is called to the rule of the New Constitution, That all subscriptions and donations of Two Dollars and upwards on the circuits be published in the Minutes of the Conference.

XXIII.—What Miscellaneous Resolutions are adopted by the Conference ?

I. RESOLUTION RESPECTING NOMINATING COMMITTEE.

That, whereas, considerable time has been taken up at several Conferences in appointing the several Committees, and,

WHEREAS, it is desirable that a change should be made in the manner of appointment, therefore,

Resolved, That each Annual District Meeting be requested to elect one member of a Nominating Committee, and, that the Committee be instructed to prepare a list of Committees to be submitted to the Conference for its approval at its first session.

II. RESOLUTION RESPECTING THE DONOR OF DR. DUFF'S LIFE.

That the most cordial thanks of this Conference are due, and are hereby presented to the generous donor of the life of the late Rev. Dr. Duff, for the gift of this most inspiring biography of an eminent missionary to the members of this Conference.

III. RESOLUTION RESPECTING METHODIST UNION.

WHEREAS, it is generally conceded, that great advantages will result from an organic union of the Methodist bodies of this Dominion ; and,

WHEREAS, the General Conference of our Church did, at its session held in the city of Hamilton last September, appoint a Committee on Union, to meet a similar Committee appointed by each of the other Methodist bodies ; and

WHEREAS, the General Conference ordered that should the joint Committee agree upon a basis of union, the plan of union so agreed upon should be submitted to the Quarterly Boards for approval or otherwise, at the next February Quarterly Meetings, and, also, to the next ensuing annual Conferences ; and

WHEREAS, the said joint Committee did, after days of much thought and earnest prayer, with a remarkable approach to unanimity, agree upon a plan to serve as a basis of Union ; and

WHEREAS, the said plan has been accepted by a very large majority of the Quarterly Boards of our Church, and

WHEREAS, a Union upon said Basis will not involve the surrender of any one of the fundamental principles of the Methodist Church of Canada.

Therefore Resolved, That this Conference hereby declares in favor of the consummation of the proposed union on the aforesaid Basis at the earliest period, which may, by the Adjourned General Conference, be deemed expedient and found practicable.

IV. RESOLUTION RESPECTING RESTRICTIVE RULES.

WHEREAS, the omission of the Restrictive Rules forming a part of the Constitution of the Methodist Church of Canada from the Basis of Union, leads many of the members of the Conference to fear their omission from the Constitution of the proposed organic Union; and

WHEREAS, such omissions could not fail to have a most disturbing effect upon the entire Church,

Therefore Resolved, That this Conference most earnestly urges upon the General Conference the absolute necessity of their introduction into the constitution of the united Church.

V. RESOLUTION RESPECTING BOOK ROOM, &c.

That the Conference has listened with great pleasure and profit to the interesting, succinct, comprehensive and instructive statement of our esteemed Book Steward, the Rev. S. F. Huestis, and beg leave to assure him of our deepened sympathy, and more active co-operation with him in the arduous and far-reaching services, which he is rendering to our Church in these Maritime Provinces.

VII. RESOLUTION RESPECTING DISTRICT SCHOLARSHIPS.

In view of the strong inducements in the form of Bursaries and scholarships held out by various Colleges to influence the attendance of students, this Conference deems it very important in the interests of the Mount Allison College, that similar means of encouragement to students should be offered to young men in attendance and contemplating attendance at our College.

Therefore Resolved, That the Financial District Meetings be recommended to take into consideration the desirability of providing one or more Scholarships for each District, such scholarships to be made available for the ensuing year.

VIII. RESOLUTION RESPECTING REV. DR. RICE.

Resolved, That the members of this Conference have hailed with much delight the presence in their midst of the honored President of the General Conference of the Methodist Church of Canada, and, having listened with high satisfaction to his richly evangelical discourse from the pulpit of this Church on Sabbath last; and, also to his instructive and inspiring addresses in connection with the discussion on the publishing interests, educational work, and the centennial movement, reflecting upon them the wisdom derived from his wide observation and large experience, would hereby tender to that distinguished brother their warmest thanks for his valued services, and desire to assure him that they shall cherish for him the highest regard, and earnestly pray that he may be long spared, by the continued consecration of his eminent gifts, to promote the prosperity of the Methodist Church, which he has ever served so faithfully and loved so well.

Therefore Resolved, That this Conference hereby re-affirm its unswerving adherence to the rule of our Church touching the use of and traffic in spirituous liquors; and that we also express our sympathy with all earnest workers in the cause of Temperance, and entreat our members and adherents to co-operate with them in their efforts to save the tempted.

Therefore Resolved to use our influence to secure as soon as practicable the entire abolition of the soul-destroying business.

X. RESOLUTION RESPECTING MOUNT ALLISON PROFESSORS.

Resolved, That we have heard with pleasure from Dr. Inch, Rev. C. H. Paisley, A.M., and the Rev. Dr. Kennedy respecting our Educational work at Sackville, and we assure them of our continued confidence and appreciation of the importance to all the interests of our Church, of the great work in which they are engaged, and pledge ourselves to do all in our power to maintain the efficiency of these Institutions, especially by securing for them increased patronage from the families of our own people.

XI. REPORT OF CENTENNIAL FUND COMMITTEE.

1. That owing to the returns of the Districts being incomplete the Committee cannot report the amounts of Circuit subscriptions to the Fund.

2. The Committee unanimously recommend to the Conference that Bro. Currie be appointed to be their Agent in soliciting subscriptions to this Fund.

XII. RESOLUTION RESPECTING MOUNT ALLISON INSTITUTION.

1. That we have heard with much interest the statements concerning our Institutions at Sackville, of Dr. Inch, the Revs. C. H. Paisley, A.M., Dr. Kennedy and Dr. Rice.

2. That we assure those to whom is entrusted the management of our Educational Institutions, our appreciation of the great importance of their work, to all the interests of our Church, and of the ability and wisdom that have hitherto characterized their efforts.

3. That we regard ourselves committed to increased endeavour to maintain the efficiency of these Institutions by securing for them not only financial aid but especially the patronage of the families of our people.

4. That having appointed the Rev. D. D. Currie to visit our Circuits for the purpose of raising funds to complete the Black Memo-

rial Hall, we trust his appeals will meet with such a response as will justify the erection of a College building that will be not only a worthy monument of him whose honored name it bears, but will also greatly facilitate our Educational work.

Furthermore, it is required that the last-mentioned copies be handed in the forenoon of the day preceding that on which our first preparatory committee-meeting may be appointed to be held, that the Secretaries may prepare classified lists of all matters which are to come before the Conference, and thereby expedite business.

2. That as much trouble has been caused at different sessions of Conference in consequence of alterations made in the District Minutes, it is determined that when the Minutes of the several Districts shall have been signed by the Chairman and Secretaries, they shall not be altered, except by special permission of the Conference.

II.—PROVINCIAL WESLEYAN.

That in regard to subscriptions for the WESLEYAN, inquiry is to be instituted in the District Committees respectively, as to the fidelity of each brother responsible for the collection of such moneys—the accounts being previously sent to the Chairmen, and distributed at the Annual District Meetings.

III.—MISSIONARY LISTS.

Each Superintendent is requested to present, at the Annual District Meeting, prepared on foolscap paper, and made up in Canada currency, a perfect list of all Missionary moneys collected on his Circuit; and each Chairman is required to present such lists to the Missionary Secretary, in a state ready for publication, on the day previous to the meeting of the Missionary Committee.

The Financial Secretary is required to send to the Secretary of the Annual District Meeting, a list of the respective Districts, showing the current year's allowance is claimed for the birth of each of the

Resolved, That every Minister and Preacher is peremptorily required to settle his account with the Book Steward each year, at or before the meeting of Conference.

VII.—FINANCIAL ECONOMY.

The Conference recommends to the Quarterly Meetings of the several circuits, the following plan, by which it is hoped they may the more effectually raise the amount necessary to meet the allowances of the ministers and preachers, and which will make the collection of class and ticket money unnecessary.

1. Let the Quarterly Boards, at the beginning of each financial year, estimate the amount needed for the year.
2. Then ascertain from each member of the church, and, as far as practicable, from each member of the congregation, what each purposes to give as his or her weekly or monthly contribution.
3. Let these sums be entered by a steward appointed for this purpose in a book which he shall keep as Treasurer of the Quarterly Board.
4. If the total amount of these sums does not equal the needed amount, then let the stewards apportion the deficiency among such as are willing for Christ's sake to assume such deficiency, setting down to each person, with his or her consent, the additional amount which they think he or she ought weekly or monthly to pay.

5. Let the stewards then adopt and carry out a plan by which every one shall have the opportunity of regularly contributing each week or month, by envelope or otherwise, not grudgingly nor of necessity, the sum which has been pledged by him or her. Let these contributions be paid over regularly to the steward appointed to receive them, and be brought up by him to the Quarterly Meeting. The said steward shall keep an individual account of all the pledges and contributions, and shall pay over the same, under the direction of the Quarterly Meeting, to the preacher or preachers authorized to receive them.

6. That Quarterly Meetings adopting the envelope system be recommended not to include in their estimates the claims of Foreign and Home Mission, but to provide for those funds as in times past, by special collections and subscriptions.

7. That in the opinion of this Conference, the minimum salary of ministers should be \$750.

8. That in the opinion of this Conference, the minimum amount of young men's salaries should be \$400.

9. That in the opinion of this Conference, the salary of ordained, but unmarried, ministers should be \$520.

10. When a deficiency occurs upon a circuit having two preachers (a married and a single man), it shall be borne by each, according to a *pro rata* amount.

VIII. MINISTERS REMOVING.

In the case of ministers removing, they shall be held responsible for the supply of the pulpits on the circuits which they are leaving for two Sabbaths after the close of the Conference, and shall be required to provide for the pulpits of their new circuits on the third Sabbath after Conference.

APPENDIX II.

PASTORAL ADDRESS.

TO THE MEMBERS OF THE METHODIST CHURCH OF CANADA WITHIN THE
BOUNDS OF THE CONFERENCE OF NEW BRUNSWICK AND
PRINCE EDWARD ISLAND.

BELoved BRETHREN,—Assembled together in our Annual Conference, we gladly avail ourselves of the opportunity afforded us of addressing you, remembering the solemn obligation under which we are laid, to take heed unto ourselves and to all the flock over which the Holy Ghost hath made us overseers to feed the Church of God which He hath purchased with his own blood.

We “dwell together in unity.” The faith, hope and charity which shall abide in the Church throughout all ages, as the true principles of the Christian life are counted very precious by us, and we have no desire to “preach any other gospel than that, which we have preached unto you,” which “is the power of God unto salvation to every one that believeth.”

While we do not regard the success of the past by any means as commensurate with the agencies employed, much less equal to the gracious purpose of the Divine Master, “who will have all men to be saved and to come unto the knowledge of the truth,” yet we record with gratitude the tidings that many portions of the Conferential field have been visited with showers of blessing, enabling those who went forth weeping bearing precious seed to come again with rejoicing, bringing their sheaves with them.

We affectionately invite you to join with us in a renewed consecration of ourselves to God, under the deep and solemn conviction that upon the depth and consistency of our personal religion, will depend the continued and effectual blessing of God, and our influence for good in the world around us.

Let us always realize that nothing can be a substitute for the spirituality of the Church; neither a talented ministry, nor high morality, nor extensive beneficence, nor abounding wealth, nor multiplied and beautiful sanctuaries. The glory of the church is the presence of God in her midst; her beauty is the beauty of holiness, and then only will she be terrible to foes as an army with banners, when she is fair as the moon and clear as the sun. Her power to impress, to win and to save souls is from God, and we must seek our end by

pureness of knowledge, by long-suffering, by the Holy Ghost, by love unfeigned, by the word of truth, by the power of God, by the armour of righteousness on the right hand and on the left. Let us seek then for ourselves and for all our congregations the outpouring of the Spirit of Holiness.

We would particularly urge upon you to cultivate a living faith, realizing in your daily experience, the powers of the world to come, rendering influential on the heart and life, the word of God, his warnings and threatenings as well as his promises. So shall Divine truth penetrate the soul in all its affections and faculties, and give its own impress of holiness to thought and sentiment, to motive, feeling and judgment. So shall it mould and elevate and hallow act and habit and character. It shall elevate the morals of trade, and the tone of the domestic circle, no less than our personal enjoyment in spiritual religion.

In all the secular affairs of life we exhort you to have faith in God, as the God of Providence as well as grace. "For the eyes of the Lord run to and fro throughout the whole earth, to show himself strong in the behalf of them whose heart is perfect toward him. Never deviate from righteousness and truth in the transaction of business, under the delusive notion that thereby you will promote your worldly interests. The fear of the Lord is to hate evil. Let your religion be the religion of principle and not of circumstances. When tempted by the allurements of wealth or ambition or pleasure, to turn aside to crooked paths, let integrity and uprightness preserve you.

A living and fruitful faith will have, as one of its associate graces, the Spirit of love, without which whatever our gifts, our zeal, our faith, our self-denial, we are nothing. Maintain this divine love,—love that for Christ's sake shall seek the wandering souls of men, with daily prayer, with ceaseless personal efforts and willing sacrifices. He which converteth a sinner from the error of his way shall save a soul from death and shall hide a multitude of sins. This charity is the peculiar badge and characteristic of the disciples of Christ. By this shall all men know that ye are my disciples if ye have love one to another. This is the law of Christ's kingdom, the rule of his house and the bond of perfectness, girdling that seamless garment which covers and adorns the regenerate body of Christ's redeemed.

The spirit of devotion must be our constant aim. Let us associate with the spiritually-minded. Never trifle with conscience, to do so will prove a snare. No one can indulge in anything which his conscience tells him ought not to be done, but it will at length wear away his spirituality of mind. Brethren suffer the word of most earnest exhortation on this topic. Christianity in our land has exerted a vast and general influence on the public mind, has removed much darkness and error, has created a public sentiment and a public conscience, and brought the church and the world into much nearer relation. that should be forever separate? a danger lest by a gradual conformity to the world we come to disregard the solemn teachings of Christ and cease to condemn the world by righteousness; lest we forfeit our consistency and lose the power of rebuke, lest we grieve the Spirit of God and lose our christian manhood. Let us remember that there can be no fellowship between light and darkness, between him that believeth and an infidel, without a sinful weakness and a sinful conformity. To retain the adoption of sons and daughters of the Lord Almighty we must be separate and not touch the unclean thing. In the conflict of the church with error and sin, success depends mainly on the impression made by individual professors in their intercourse with others. It is not the public profession, but the private character that convinces, it is the good conversation that wins. Must we not admit the painful truth that the chief cause of scepticism, of distaste for the Gospel, is the practical infidelity of many who profess and call themselves christians. How great is this contradiction—to profess to be laying up treasures in heaven, and yet to devote every faculty of the mind and almost every moment of time to the acquisition of wealth—to be dead to the world and yet to vie with the most impetuous worldling in the whirl of business; with the most polished in the elegancies and style of life; with the most frivolous in amusement; with the most wealthy in lavish expenditure, and with the most penurious in exaction, oppression and inadequate remuneration. Most fatally will such a spirit re-act upon the Christian himself. Entering the soul it will eat out the very core of religion, leaving only the dead and shrivelled form of godliness. If ye then be risen with Christ, seek those things which are above, where Christ sitteth on the right hand of God. Set your affections on things above, not on things on the earth. We beseech you to ponder these matters prayerfully, to act out your solemn conviction of Christian duty, to cultivate an enlightened, fervent and devoted piety. So shall our God count you worthy of this calling and fulfil all the good pleasure of his goodness, and the work of faith with power.

Such holy consistency will make every man a preacher in his own house, an example there of all holiness patience and truth, a pattern of faith, purity and love. Let the impress of our renewed character fall first, and with gentle energy, upon our children and domestics. To them at least, let us be guides, in them at least, let us produce the deep conviction of the excellence of personal piety; and of the happiness of a sincere consecration to God. Let the sacrifice of praise and prayer ascend morning and evening to the God of the families of the whole earth, and never may our actions or words, our spirit or temper condemn our devotion or awaken perplexed thoughts in our children, or crush the unfolding of their piety, or discourage their earliest approach to the Saviour. Then shall the Lord create upon every dwelling place of Mount Zion, and upon her assemblies, a cloud and smoke by day, and the shining of a flaming fire by night.
