#### RULES OF ORDER.

RULE 1st .- At each Annual Meeting the letters from the churches shall be first handed in, trom which the Secretary shall immediately make out a list of Delegates.

RULE 2nd.—After religious worship the officers shall be chosen. The choice of the Moderator shall be made by ballot. No brother shall be chosen Moderator two years in succession.

RULE Srd.—The first letter read shall be from the Church with which the Association is assembled. | but to Hold

RULE 4th .- No subject shall be discussed without a motion first made and seconded, and no person shall speak on any subject more than twice unless by consent of the Association.

Rule 5th .- When any church is received, the Moderator shall give to one of its delegates the right hand of fellowship.

The evening was devoted to a Missionary meeting, which was opened by singing, and prayer by Rev. Dr. Cramp. The Report of the Committee on Missions was read and adopted. (Appendix A.) Bro. Selden then read a part of the Annual Report of the N. S. Baptist Home Missionary

The first Resolution was moved by Rev. D. W. C. Dimock, and seconded by Rev. G. F. Miles:

1. The instruction of our Lord was—"beginning at Jerusalem." We consequently regard Home Missions as demanding our first efforts. The experience of the past in our denomination teaches us that such labors are approved by our Lord and Master. We consequently hereby pledge ourselves to continue and increase our efforts to extend a knowledge of Christ in this land, and to pray for a blessing on the labors of those sent out in this work.

The resolution was also spoken to by Revds. J. Shaw, J. F. Kempton and W. McPhee. A verse having been sung, and a collection made for Home Missions, the resolution was adopted.

The second Resolution was moved by Rev. Dr. Cramp, and seconded by Rev. Geo. Armstrong, and adopted :

2 The Acadian French are our fellow-countrymen and have special claims on our christian sympathy and prayers. We therefore urge on the churches to give their practical approbation and liberal support to the French Missionary operations under the direction of the N. S. Western Baptist Association.

3. The carrying forth of the Gospel to the heathen world we esteem as a christian duty resting on all our churches and people. The employment of Native preachers in foreign countries, we, in common with all christian bodies, regard as the best means of reaching the people generally. Our being driven to this mode of employing foreign mission funds may be considered as special favor shewn to us, seeing that we are at present unable to find a minister suited to go from our midst. Whilst the fact that more than a dozen of these Burmans and Karens are supported by funds from these Provinces calls for gratitude to God, the existence of so much darkness in the world calls for continued effort and prayer that the Lord would send forth laborers into his harvest.

Pictou Mission.

Resolved, That Rev. D. W. C. Dimpck, and Bro. R. J. Griffiths be a Committee to purchase certain property in Picton, for the use of the Baptist Church there; and to invest the same in the best manner to ensure the purpose of such purchase, and to save the Denomination from loss—either by investing the same in the Missionary Board, or otherwise, as shall seem best advised—with power to sell the same if necessary, in case of debt accruing thereon. sary, in case of debt accruing thereon.

Resolved, That Rev. G. F. Miles, and Rev. T. A. Blackadar be a Committee for directing the Agency of the Picton Mission, and for securing a substitute, in case of the Agent's failure to fulfil his mission.

The Committee on Systematic Beneficence reported. Remarks were made by Revds. T. H. Porter, Jr., G. Armstrong, D. W. C. Dimock, M. P. Freeman, Dr. Cramp, and Bro. Lachlen McDonald. The Report was then adopted. (Appendix F.)

Resolved, That Brethren Porter, Boggs, and Creed be a Committee on Statistics; that blank forms be printed and sent to all the churches of this Association, previous to our next meeting; and that the expenses of printing and circulating said forms be paid out of the funds of the Association.

On motion, Bro Selden was appointed Auditor of the Account of the Infirm Ministers' Fund, and was requested to publish the same in the Minutes.

Resolved, That Revds. G. F. Miles, and J. E. Balcom, and Brethren B. Douglas, J. M. Layton, and A. S. Blenkhorn be the Board for the management of the Infirm Ministers' Fund.

Rev. H. Eagles was requested to investigate the circumstances of the Indian Harbor Church, and report at our next meeting.

Resolved, That the cordial thanks of this Association are hereby tendered to the members of the Baptist Church and congregation at North Sydney, and to other friends in the vicinity, for their kind hospitalities during the present session.

Resolved, That the thanks of this body be tendered to the other Denominations who have opened their meeting houses to us for preaching.

Resolved, That Revds. J. E. Balcom and D. W. C. Dimock, and Brethren S. Selden, and W. F. Cutten be a Committee to make arrangements for the conveyance of brethren to the Association next year.

The Treasurer's Report was then submitted.

On motion, The Treasurer was ordered to pay over the various sums to the respective Boards.

The Report was then adopted.

The Union Hymn having been sung, the Association adjourned to meet next year with the Upper Londonderry Church. Prayer by Rev. Geo. Richardson.

FROM THE EASTERN NOVA SCOTIA BAPTIST ASSOCIATION TO THE CHURCHES OF WHICH IT IS COMPOSED.

Dear Brethren,

The subject to which we invite attention in this our annual epistle, is that of The Jews. They claim our attention and regard as being a portion of the human race; and they claim peculiar regard, as being among the most interesting portions of that race. To them do we owe, instrumentally, all we enjoy in the present, and all we hope for in the future. From them sprung "the desire of all nations." "Out of Zion went forth the law and the word of the Lord from Jerusalem." This fact alone invests the Jew with an interest which nothing can enhance,

In treating this subject, we may advert to the present condition of the Jews; to the claims which they have on our christian sympathies; and then present some incentives suited to call into activity such sympathies. During the long lapse of eighteen centuries the Jew has stood forth conspicuous before the world, a monumental attestation of the truth of the divine word. The destruction of the city of their solemnities, and their dispersion over the earth, was a literal fulfilment of prophetic threatening, uttered long ages before, by the servants of God. "If ye will not for all this, hearken unto me, but walk contrary unto me, then I will walk contrary unto you also in fury, and I, even I will chastise you seven times for your sins; I will scatter you among the heathen and will draw out a sword after you, and your land shall be desolate and your cities waste." "And thou shalt become an astonishment, a proverb and a

Their case presents to our view with terrible conspicuousness the blinding process, the hardening power of unbelief, and its far reaching, fearful consequences. Scathed and blasted, we find this people dispersed among the nations and deprived of those privileges which are denied to no others. Like those great rivers which disembogue, and with distinct current, flow out far into the ocean, so do this people, though among, coalesced not with the nations of the earth. Wherever we travel we find the children of Abraham everywhere and always the same, groping in the darkness of a dispensation long since passed away. For until this day remaineth the same well untaken away." They have a zeal for God, but not according to knowledge. "Being ignorant of God's righteousness," of the divine and only way of justification, "and going about to establish their own righteousness, they have not submitted themselves to the righter ousness of God. Im Such is the condition of the Jew He is under disabilities from man, he is under the frown of Heaven, and in a condition the most wretched which falls to the lot of humanity, lest vine mystery, lest vinemual to tol od

Having adverted to their present condition, let us now with much brevity, glance at the second part of our subject, and notice the strong chims which they have on our christian sympathies. The sentiment of the great Apostle reverberates along the centuries and makes a responsive echo in every christian heart; 19 I am debtor both to the Greeks and to the Barbarians, both to the wise and to the unwise." "Go ye into all the world and preach the gospel to every creature," is the great command of him who "spake as never man spake you This excludes none, but embraces all the human race. And if there be a people, to whom beyond another, we owe a debt of gratitude yet unpaid, it

is that people, descended from faithful Abraham. As the depositaries of the glorious revelation of God to man, through them have come down to us the scriptures of eter-In these sacred oracles are contained those cheering and sublime teachings, those far-reaching, all-embracing prophecies which fill the entire field of vision to the close of time, and nerve the christian's heart for the great warfare of life.

That nothing may be wanting to incite to an energetic response to the claims which the condition of this people make upon us, we have presented before us the sure word of promise. "The children of Israel shall abide many days without a prince, without a king, without a sacrifice and without an image, without an ephod and without a teraphim. Afterward shall they return and seek the Lord their God and David their king." "And it shall come to pass that as I have watched over them to pluck them up, to break down and destroy and afflict, so will I watch over them to build and to plant, saith the Lord." And what is Ezekiel's vision of the reviving of the dry bones but an illustrious promise of a more glorious revival than has yet occurred, when that people shall turn to the Lord from whom they have revolted? Says the evangelical prophet: "It shall come to pass in that day that the great trumpet shall be blown, and they shall come who were ready to perish in the land of Assyria, and the outcasts in the land of Egypt, and shall worship the Lord in the holy mount of Jerusalem." Let us hear the decisive and final utterance of the great Apostle of the Gentiles: "I would not brethren, that ye should be ignorant of this mystery, lest ye should be wise in your own conceits, that blindness in part is happened unto Israel, until the fulness of the Centiles be come in, and so all Israel shall be saved." There shall be a general turning of Israel to the Lord their God." . sordiaquits nati

Again, have we not in the response of this people, to the claims of the Gospel in the earlier ages of Christianity, a bright promise of their glorious destiny? From the Acts of the Apostles we hear that many Jews early embraced the truth. By the preaching of Peter on the day of Pencost three thousand were converted; not long after, five thousand had embraced the truth as it is in Jesus; and to. the Church were daily added such as should be saved.

Along the subsequent centuries, we have from time to time cheering pledges that God has not forgotten to be gracious to his ancient people. In order to prove this we have but to refer to the Jews of the 5th Century, in the islands of Minorca, Cyprus, and Crete, when large numbers were brought to believe in the Lord Jesus Christ.

Through the dark, gloomy periods of the middle ages, the Lord ever had his witnesses among the descendants of the Father of the faithful.

We cannot here notice, except in the most cursory manner, the influence of the Reformation of the 16th Century, on the condition of the Jews. It may suffice to say, that the revival of literature, the study of the sacred languages, and of the Holy Scriptures, the study of oriental oustoms and manners, and that of the Hebrews in particular, led to a deeper interest in this people than had existed for long ages before. Then was awakened in the breasts of christians a very general sympathy in behalf of the ancient people of God. We learn that Luther, in his latter years, expressed the warm amonions of his heart towards them. And history informs us that Oliver Cromwell had thoughts and plans with reference to their re-establishment.

In the 17th Century a pious preacher of Strasburg named Schaddens, translated the four gospels and the Acts of the Apostles, into the Hebrew, and at his own expense published them, under the name of the Pentateuch of the New Testament Not long after this John Muller published a letter to the Jews, on the Salvation of Christ. cess of these two works was great, and many were brought

thereby to enjoy the blessings of salvation. In order further to encourage and incite us to the performance of duty, in this noble work, let us briefly notice the condition of this people during the past and present century, and the efforts which have been put forth for their conversion. We have thus far noticed only individual ef-But early in the 18th centary christian communities took the work in hand. The Meravian brethren were not backward in this noble cause. Zinzendorf had enlarged views of Israel's destiny, and ever treated the Jews with great consideration and affection.

The first society especially formed in their favor took place at Halle, in Germany, in 1728, under the name of

"the Jewish institute of Callemberg." In this institution we have a triumphant proof of the power of prayer. Said the pious and venerable Prelate, Hochestetter: "there are three things which in prayer, I have long asked of God. 1st. That he would be pleased to pour out an abundant effusion of his Spirit on christians in Germany; 2nd. That he would be pleased to send forth laborers into the vast field of Pagan lands; 3rd. That he would remember the vine of Israel and have mercy upon it." This last prayer was answered, and the noble institution above noticed, was established. Young Callemberg, the founder, continued for thirty-two years, to direct it. This establishment continued for sixty-four years, and sent forth Jewish missionaries through Europe, Asia, and Africa, who proclaimed salvation through the blood of the Lamb.

Whilst European christians have put forth such noble and successful efforts, christians in America have not forgotten their duty in this great work. In the cities of New York and Boston, central Jewish societies exist, with hundreds of branches throughout the Union. On the shores of the Hudson are lands, which christians of the United States have assigned to Jews who have fled from persecution in other countries. The Lord has largely blessed the efforts of American christians in this noble cause.

Permit us now, before concluding, to present some of the many motives which urge us to labor and pray for Israel's conversion to doubtedue

1st. Sympathy for the suffering calls for our prayers and our efforts. Has ever a people endured such numerous and long continued wrongs, as have the Jews. Theirs have been the rigors of an Egyptian cudarance, for age on age. Their unceasing cry has been, when the morning came, would God it were evening, and at evening, would God it were morning," because of the terror which has seized upon them. Nor let any in reply to this, say "such was the prediction of the prophet, and such the purpose of heaven. Divine purpose and human duty, so far from running always in parallel lines, are not unfrequently seem opposed, the one to the other. By the determinate counsel and foreknowledge of Godd was our Lord's betrayal; yet was it by "wicked hands that he was crucified and slain." 1. Among these signs is the marked change which is taking place in the civil condition of the Jews. We find alike in England and France, in Germany, Holland and Russia, yea, everywhere, that the civil disabilities under which they so long labored are fast being removed.

2. There is at this time, a disposition on the part of the Jew to listen to the christian such as has never before ex-

isted since the time of the Apostles. 70 701 /1(1) 24711 3. The general expectation of this people is another eheering sign. At the advent of the blessed Jesus, there was a general expectation of some near, unknown, but great event; and such is now the state of expectancy on the part

of the peeled and scathed sons of Abraham.

4. Lastly, the numerous conversions which have taken place among them, within the past few years, is one of the extraordinary and encouraging signs of these times. In Beflin, where there are not 7,000 Jews, no less than 1,000 have professed faith in Jesus Christ. We are told that in Hungary and Gallicia, the field seems white, ready to the

harvest. In Russia, within the last 15 years, about 2,000 have embraced the truth. Some cases of thrilling interest have lately occurred in America, of the conversion of Jews, the recital of which, did space permit, would cause our hearts to leap for joy. And let us recur to the generally well known fact, that more Jews have been converted within the last quarter of a century, than during the previous

period of seventeen hundred years.

Is there nothing, Dear Brethren, in these, and in such facts as these, to awaken our highest expectations and our fullest activities with reference to Israel's destiny? Are we desirous of blessings richer far than all the abundance of corn or wine? Behold the sure high-way to such blessings : "I will bless him that blesseth thee, and curse him that curseth thee." Castigations the most rigorous have ever fallen upon Israel's persecutors, while those which have shown them favor, have shared in the richest benedictions. This is a fact which deserves to be deeply pondered. Are these rich promises for those who propagate the gespel? Are there in store for them rich blessings of heavenly favor? Does their peace flow as a river, their righteousness as the waves of the sea. But if there be blessings richer and fuller for the diffusion of heavenly truth among one people more than another, it is for those who say anto Israel, "Arise, shine, for thy light is come, and the glory of the Lord is risen upon thee?"

Though the time has not yet come, it may be drawing near, when it will be our privilege and duty, as a body of christians, to establish a Jewish Mission. May we unite with our praises for blessings enjoyed, our activities and prayers, for their largest diffusion, and be in readiness, at

the divine call, for every good word and work.

# REPORT OF THE COMMITTEE ON MISSIONS.

Every one who has partaken of the riches of grace and mercy purchased by Christ's life, death and resurrection, will, by personal effort, and by combining with his brethren, endeavour to communicate to the perishing a knowledge of the way of life.

The institutions for appropriating the benevolence of the Baptist churches in this land—the Nova Scotia Baptist Hom. Missionary Society embracing our missions in the English and Gaelic languages; the French Mission that to the Acadians; and our Foreign Mission that to the millions of British Burmah, present to us opportunities of carrying out our Master's direction to the fullest extent.

The Home Missionary Society claims our first consideration. Your Committee regret to learn that, in consequence of the smallness of the amounts contributed in some fields visited by the missionaries, there have been demands made on the Board which have involved them in liabilities amounting to about \$900, and that it will therefore be necessary to use greater caution in making appointments during the current year.

Your Committee deeply regret that this should be the case when such urgent calls are made from many places, and such a wide door is opened for preaching the truth as

it is in Jesus. Under these circumstances we would urge more attention to systematic efforts, by weekly, monthly, or quarterly contributions in behalf of this benevolent object.

The growing character of the population in many parts of the Central and Eastern Associations, especially in the mining districts, renders it exceedingly important that mis-

sions be sustained in their midst.

Your Committee regard the operations of the Missionary Board as affording much ground for encouragement. The fact that 19 men have been employed during the year, making on the whole 306 weeks or 5½ years of labor expended, at a cost of 10 or 1200 dollars, shews that these combined efforts are an economical appropriation of mission funds. The fact that 69 persons have been baptized on a profession of faith in Christ is another reason for devout gratitude to the Divine Spirit, and indicates that his blessing rests on our labors.

The recommendation to the churches to release their Pastors for missionary visits your Committee deem very important. An agreement between neighboring pastors to hold missionary meetings in their churches would, we think, have a very salutary influence in keeping awake missionary

interest and zeal amongst the brethren.

Our Foreign Missionary operations by means of Native preachers we regard as a wise arrangement; but we think it also highly important that the Board should, as early as possible, secure a man from this country, to go out, having the sympathy of the churches, and being sustained by them, who shall be prepared to take direction of the labors so efficiently performed for several years by our respected and beloved brother, Rev. A. R. R. Crawley. Our warmest thanks are due and are hereby tendered to our brother for these labors of love, which at present none could so well or effectually perform.

The French Mission we regard as a highly important part of the operations for the evangelization of this land, and would recommend a careful perusal of the Report of the French Missionary Board, given with our last year's Minutes, and more liberal donations and subscriptions towards sustaining the mission to the Acadian French.

#### REPORT ON EDUCATION.

Your Committee has much pleasure in reporting that—
The work of educating the youth of our Province is being promoted with increasing efficiency. Under the operation of enlightened legislation, the common-school system has been greatly improved, and the advantages of general instruction are now being enjoyed by a larger number of individuals than ever before in Nova Scotia. In view of the bearing of intelligence and mental culture upon the moral and religious condition of the people, we regard this as subject of congratulation for our Association as a body of Christians.

Concerning our own institutions at Wolfville we have to report that, while much has yet to be done to make them in all respects what the Denomination would have them,—yet they continue to hold a high and rising position among the educational institutions of the country. It is gratifying to know that measures have been taken to remedy past defects, and to render the appliances of education there existing more perfect and satisfactory than ever before. We believe that, under judicious management, our seminaries will afford facilities for the intellectual culture of our young men and women second to none in the Province.

Acadia College has been signally owned and blessed of God as an instrument of good. Not only have many there received a sound mental training, but have been educated in the principles of pure Christianity, and become the followers of Christ. The past history of our Institutions shows clearly that God has set his seal of approbation upon them. This stimulates their friends to patient, persevering efforts to sustain them and render them more efficient.

During the past year 36 students have received instruction at the College, and about 80 in the Academies. Six young men, having passed through the Collegiate course, graduated on the 5th of June last. Year after year, those who have completed the course prescribed go forth to enter upon honorable pursuits in life, benefitting their fellow-men and promoting the cause of truth and religion. Some of them are now in our midst, whose efficiency in the discharge

of their duties testifies to the advantage of a sound Chris-

tian education.

There is cause for rejoicing in the fact that Dr. Cramp has consented to continue in the Presidential Chair another year, and that Dr. Crawley is again employed at the scene

of his former labours.

Your Committee feel assured that, when the Baptists of these Provinces take into consideration the benefits which have resulted to our Denomination from our Institutions of learning,—when they look upon those in their midst preaching faithfully and successfully the gospel which they love,—who have there been trained for their work,—their attachment will be strengthened and their liberality increased.

#### REPORT ON SYSTEMATIC BENEFICENCE.

The Committee on Systematic Beneficence would report their gratification at the action of the last Association in recommending the adoption by our Churches of the system of benevelence urged by the Apostle in 1 Cor. xvi. 2. Admitting the necessity of raising money for benevolent purposes, and of system in order to do it well, and remembering that our object should at the same time be to train the donors in the right discharge of a difficult duty and the proper exercise of a rich grace, they cordially commend this plan as the most Scriptural, and in all respects the best ever devised for accomplishing this twofold purpose. And it is their belief that a departure from it and the substitution of human methods have largely operated to render the sentiment expressed at the public Anniversary of the Missionary Union so sadly truthful—"To move Christians to give as the Lord has prospered them—alas that it should be said—is one of the most difficult problems of the day."

In carrying out this plan most effectively two things are essential;—first, its unanimous and hearty adoption by churches, and second, its equally cordial adoption by individuals. If there is a failure in either of these, there must be a corresponding failure in the working of the system. It will therefore be evident that only faithful and persevering effort on the part of those interested; can bring about the desired result.

Your Committee regret that so few of our churches have reported the adoption of the plan, but believe that this has been in no small measure the result, in some cases of a wait of understanding of its working, and in others of there being already in operation a system deemed equally good. They would unanimously express the hope that this matter will be more seriously considered; and our returns next year shew more favorable results.

And for the more mature consideration of the subject they would invite attention to a communication in the C. M. of June 6th, headed "The letters to the Eastern Baptist Association;" to a tract by Rev. Parsons Cooke, entitled "Religion and Beneficence;" a pamphlet published by the

Your Board beg leave to submit their ninth Annual Report.

While we have to acknowledge with reference to the results of the last year's efforts, that they by no means come up to our desires, yet we have great cause for grattude and thanksgiving to God, that more work has been done than on any previous year. This year we have had the services of 19 missionaries, last year 16. The number of weeks services last year were 238, this year 306. sermons are reported this year, against 530 last year. Last year 139 Prayer and Conference meeetings were held, this year 330. 2079 family visits were made this year, against 978 last year. The baptisms last year were 29, this year 69 willing converts have put on Christ in baptism. Last year 4488 miles were travelled by your miscionaries, this year 6036.

From the appeals for additional pecuniary aid made to you in the Messenger by your Board, and from the Circulars sent to the Churches, you will be prepared to hear that the Society is greatly embarrassed by debt, contracted during the past year, so that not only are we now unable to employ missionaries, but our liabilities to those already employed are about 900 dollars. This deficit has arisen from the very small collections made by some of our missionaries, and that, too, in places where the largest amounts have been expended, as well as from the amount of labour performed in excess of that of previous years. While some of our missions have been nearly self-supporting; others. as for instance the Pictou mission,—has cost the Society the sum of \$353.25, while the collections made there during the year for the Society have been but \$62,75

Now it is very sad for us to be compelled to say, that while the fields for occupation were never more inviting, are white unto the harvest, and while at almost ever monthly meeting of the Board, urgent entreaties are made

to us, to send missionaries to those pining for the bread of life, yet we are compelled to leave the ripened harvest unreaped, and to refuse the earnest requests of our beloved friends, because our charches fail to send the needful pecuniary supplies. Unless immediate material support for carrying on the operations of our Society be sent us, we have to submit to the consideration of their successors, that no missionaries be hereafter at pointed, unless they engage to make their mission nearly or quite self-supporting.

And inasmich as your Board are best acquainted with the destitute fields and the requisite demands on the funds, they beg leave also to submit that all appointments for the year be left to their judgment and discretion. One great reason of our present embarrassment being the appointments made by the Board at the Eastern Association at its

last session.

And now, dear friends and Brethren of our Churches, will you not help, even though in order to do it, you may have to make some sacrifices. Many of our Churches in the Province are emphatically the results of missionary zeal and labour, surely the debt of gratitude you owe to God for giving you the blessing of the living ministry and stated preaching of his word, call upon you to contribute liberally and cheerfully of your means to the sacred cause of our domestic missions. A year or two ago we had to beg for laborers for the work, now we have willing laborers, but are destitute of funds to send them out. We earnestly entreat you to wipe off from our churches this reproach: and this year place your Board so largely in funds, that not only shall they be enabled to satisfy the demands made upon them, but largely to increase the sphere of their labors.

Our period of active exertion will soon be over; in the grave, whither we are hastening, there will be no opportunity for doing good. Whatsoever our hand, therefore, findeth to do, let us do it with our might. If we do not intend that our final reckoning shall be that of a niggardly and slothful servant, let us break from the shackles of a covetous heart, and of spiritual indelence, and up and work for our God, and contribute generously to his cause. Who would care to hoard up riches for himself, and family, if he must die under the cutting reflection that he had been an

My mission was pleasing to myself and I hope not altogether upprofitable to such as I had the privilege of laboring among. The reception met with, the kindness shewn, and the liberality manifested, on the part of the people, proved that your missionaries are welcomed to the Isle of minerals.

After the lapse of ten years Lhad the pleasure of meeting with the fruits of former labours, scattered over the Island from the Strait of Canso to Mira Bay; but some have fallen asleep. Brethren, send to Cape Breton. "The field is white already to the harvest." Upper Baddeck, Big Glen, St. Ann's, and Boulardrie Island are large missionary fields, chiefly settled by Gælic people; they need one to labour among them capable of preaching in Gælic and English. Could you not send them one?

Rev. J. F. Kempton has been in the service of the Board at Mira Bay and vicinity 39 weeks and 3 days during the present year. Preached 108 sermons, attended 123 prayer and conference meetings, made 457 family visits, Laptized 14, distributed 1898 pages of tracts, collected \$123.02. 150 copies of religious papers circulated monthly.

The following extracts are from a letter received and

published in the Messenger on th 10th Jany., 1866:

My heart has been cheered of late by seeing the work of the Lord prosper. It is really blessed after having labored almost constantly for three years past, and seeing scarcely any fruit gathered for Christ, to witness the manifestations of the Spiric's power and love, in the restoration of the wandering child of God, and in the conviction and conversion of souls to Christ. I can safely say this I have witnessed of late.

This thought has given me much comfort and encouragement for a year past,—that some of God's children were crying to him day and night for the bestowal of his Holy Spirit. I felt that these supplications must prevail, and they did prevail. Odd heard them, and he is now verifying his promise to them. To his name be everlasting praise. Let what he has done encourage both us and others who may read these lines to "wait upon God," feeling sure that he will cause them to triumph in the end.

My heart felt almost in an agony of anxiety sometimes that God would be with us at our Quarterly Ministerial Conference to be held in Nov. last, and that he would bless the exercises to our good and that of the people. prospect seemed so dark that I confess my faith almost failed me. But a goodly number of the Church met on Saturday in Conference and God was present.

It was very evident that a work of grace had commenced. I was not surprised, therefore, the next morning after our brethren left to learn that one soul had been set at liberty from the shackles of sin, and made to rejoice in the par-

Since then the work goes on. We hold no extra meetings. But every few days we are called on to rejoice with the Angel of God over the repenting and the forgiving sinner. Thirteen have been led to tell of hope in God, ten of whom have been buried with Christ in baptism. Others are evidently under deep conviction of sin.

I have been particularly pleased with the appearance of There is nothing that looks like undue excitement. We desire to give all praise to God for what has been done, and pray that the glorious work may continue.

On the 24th Jan. Bro. K. writes to the Board as follows: I am glad to state the work of grace still continues. Our meetings have, however, been greatly thinned, on account of the measles appearing among the people. Almost every family for many miles around us have been or are now attacked by this malignant disease. Many, very many, especially among the children, have died. Several deaths have occurred among those of more advanced years. One mother of a large family, a member of our Mira Church, died of this disease a few days ago. But we desire to bless God for the precious testimony she left behind of the value of the religion of Jesus. Although she had only few hours warning that her departure was near, she was fully prepared to go; and joyfully bade all her dear ones adjeut and in heavenly raptures went forth at midnight to meet the Bridegroom. My soul felt comforted and strengthened as I stood by her bedside and saw her "lean her head on Jesus breast and breathe her life out sweetly there." How different was a scene I witnessed only the day before in almost the next house! A brother and sister lay in the next room, a few feet from each other, -- both struggling at the same time with the "King of Terrors." brother was 20 years of age, and the sister 22. One week before they were both stout, healthy, and to all appearance very far from the door of death, -now they were both in the last stages of inflammation of the lungs, the result of cold after measles. They were both unconverted. very soul felt anguish as I looked upon them and tried to point them to the Lamb of God. The poor young man was too far gone to be made keenly sensible of his real condition. The disease seemed to affect his head and blunt his faculties, so that it was with great exertion we could get his attention fixed on the concerns of the soul. Notwithstanding this, I tried to direct him to Christ on the cross. But all I fear in vain. Seeing his state I turned to the dying sister who lay panting for breath, and gazing with the utmost anxiety upon her poor brother, and greedily devouring every word that fell from my lips. I repeated John iii. 14-18, to her, and tried to picture the love of God manifested in the death of Christ on the cross. She seemed to grasp the glorious plan of salvation. She said she thought she could trust Christ. She continued sinking for a few hours after, but her faculties were not in the least impaired. Her brother breathed out his last, and death drew on apace to bear her soul away. But she turned her attention to Christ crucified a she called on him for mercy; and a few hours before she died light burst upon her agenised soul, and she rejoiced in a newly-found Saviour. Her soul mounted high on the wings of faith, and triumphed over death, but triumphed in Jesus' name. She told her parents and all who came to see her what a deliverance Christ had given her. Those who witnessed it told me it was perfectly amazing to hear her language. Her voice continued strong to the very last. She expired nine hours after her brother; but left strong reason to hope that she went to dwell with Christ.

go forward. Though we cannot tell of many conversions to God, yet I think we may safely speak of four or five who have since my last report given expression to comfortable hopes in Christ. Four have been baptized, making in all 14 since the work commenced. Several others now waiting for baptism are detained by illness. A great deal of sickness, and many deaths have taken place among us of late. In several of those who died we have the strongest reasons for believing them to be "sleeping in Him."

One of these, a little boy of 93 years, died in ecstasies of He had been sick about a fortnight, but not supposed to be dangerously ill, till a few hours before his death, when the diphtheria set in and terminated his earthly career. He appeared greatly distressed about his state before God, for several days before his death, and frequently requested prayer to be made to God on his behalf. On Saturday morning, the day he died, he requested his parents to send for Mrs. K. and myself to come and visit him. On arriving we found him evidently very anxious about his soul. read and commented upon Isaiah lv. 1-7, and then tried to implore the Divine favour in his behalf; an hour or two more passed which were indeed hours of distressing anxiety to some of us. We saw that he was rapidly sinking and had no reason to hope that his sins were forgiven. Yet nothing was said to lead him to think he was near his end or to excite his natural feelings in any way. At length, when alone with him, I said, "Tommy, we are exceedingly anxious about your soul; we don't know, but fear that you may not get well." He replied quickly, "If I do not I believe that Jesus will pardon all my sins." Shortly after, he called his mother to his side, and said, " Oh, the Sunday School, the Sunday School!" (He had been several years a member of the S. S.) A few moments after this he called his elder brother to him, and rising upon his knees in bed, and fixing his eyes upon his brother's face, with a look which I think I can never forget, said, "Charley, good byed I'm going to heaven. Will you seek Jesus, and meet me in heaven? (etc., etc. He then talked) most delightfully of his happiness in Christ, declaring that the blood of Christ had washed all his sins away. After this he called his parents, brothers, sisters, his grandpa, uncless aunts, hired man and maiden, and all of his playmates who

were there, and embraced them one by one. imploring them to seek Jesus and meet him in heaven. Once as I leant over his bed to enquire if he desired anything, he threw his little arm most affectionately around my neck exclaimed, "Oh I'm so happy, as happy as you would be if you were going almost." After this he suffered much for a few moments, and then rising upon bis hands and knees and looking upward repeated distinctly, till the lips moved without sound, "Joy, joy, joy." Then laying his head upon his pillow, he gasped a few times for breath and

It was the most delightful death scene I ever witnessed or read of. Let no one doubt if children of nine years of age, can understand the nature of sin, repent and be converted and rejoice in the assurance of pardon and salvation.

#### **Cumberland County**

Rev. S. Thompson is labouring with the churches at Westchester Mountain, Glenville, Wentworth, and New

Annan, and has received from the Board \$40.

The report received by the Board states that Brother Thompson usually preaches twice on the Sabbath, and once or twice during each week, and attends three conference meetings monthly. He has baptized 8 persons during the year.

#### Halifax County.

Rev. Obed Parker has spent 6 weeks in Dartmouth and vicinity. Preached 27 sermons, attended 11 conference and prayer meetings, made 57 family visits. Collected \$17.

Expenses \$11.

Bro Parker reports as follows;—In closing my last six weeks' mission ending July 20, 1865, I see much to encourage and cheer, although I have felt much discouraged and depressed here at times. Our Sabbath morning service at Dartmouth, on the 16th July, was the most interesting since my arrival in this place. At the Eastern Passage where we have held service in the afternoon, there is a prospect of a rising interest. I have visited Lawrence, town, where the word of the Lord was listened to with interest; have also visited Waverly and held three meetings, one in the Baptist Meeting-house, the others in the Hall situated in the village, which was filled to overflowing.

At the Eisner neighborhood the Baptist cause is increasing, and a Sabbath School has been commenced. I have visited Tufts' Cove several times, and a Sabbath School has been organized there under the Superintendance of Bro. Rhuland, of the Granville Street Church, Halifax.

Rev. A. F. Porter has been labouring in Dartmouth since July 1, 1865, having been 52 weeks in the service of the Board, for which he receives at the rate of \$100 per anuum. Service to be held every Sabbath morning.

Bro Porter reports as follows—I have been able to preach once every Lord's day, and occasionally twice during the year. The congregations have generally been small,

but very attentive. Sometimes I have been a little encouraged to hope that the cause would again revive here;

at other times the prospect looked dark.

This is a hard field. The Baptists are very much scattered, so that it is impossible to get much of a congregation in Durtmouth. I have no doubt, however, that if there was a stated Missionary on the ground who could go among the people and visit all the sections of the church, including Waverly, in the course of time a considerable

It is sad to see this important field neglected for want of I have often heard the Macedonian cry from Waverly, but have not been able to visit them. Quite large congregations can be had at Cole Harbour Road and at Tutts' Cove. I should like to visit these places. brethren and friends in Dartmouth have made an effort to liquidate a debt on their Meeting-house, but have not been able to raise more than half the amount; for this reason their returns in aid of the mission are small. Preached 55 sermons, visited 50 families, attended 45 prayer and conference meetings. Collected \$18.07. Administered the Lord's Supper 9 times. Received into the church one who had been previously baptized, but had been for several years a member of the Wesleyan body. He is a worthy young man, and bids fair to be useful. I cannot report any conversions. 3 persons seem to be under deep concern of mind; I hope they will soon be on the Lord's side.

### Hants County.

Rev. Geo. Wethers has performed 12 weeks Missionary labour during the year in the above county, visiting statedly the following places: Maitland, Rockville, Dimock Settle-ment and Upper Kennetcook. Preached 42 sermons, Preached 42 sermons, attended 3 conference and prayer meetings, visited 44 families, many of them monthly; travelled 760 miles.—Collected for the Society \$77.58, twenty dollars of which was due on the preceding years' mission.

MAITLAND .... Bro. Wethers writes encouragingly of this field of labour, although there have been no additions to the church by baptism. He says; I think your care for the

little band of disciples in that region has not been without some good results. Several with whom I have conversed seem much impressed with the value of religion, and concerned about their soul. appeared in the Messenger:

Walton is a small but thriving village, depending chiefly upon ship building and plaister quarries; the other resources such as the manganese mines, fisheries, and cultivation of the soil are not, as yet receiving much attention. There are but few Baptists in Walton. They have, however, a very good meeting house, and when there is preaching there is a good congregation. I had the pleasure of baptizing one person, an aged widow.

Kempt Shore.—The Rev. B. Vaughan, the Pastor of the Kempt Baptist Church, has for the past few months been unable, by reason of ill health, to attend to his pastoral duties. I received a cordial welcome from both pastor and people, and supplied, during my short stay, the various preaching stations within the bounds of the church. The congregations were not large, owing to the musually wet seas n. My appointments, however, were all kept, and frequently the attendance much better than I expected. They are a united church, but they lamented their spiritual lethargy and weakness. Amidst the smouldering embers I found many sparks of living fire.

Bro. Jas. F. Morton, Lizentiate, laboured 10 wee's in the following places, under the direction of Rev. W. E. Hall: Northfield, Kitty Settlement, New Cornwall and the Branch Preached 20 sermons, attended 10 conference and prayer meetings, visited 61 families, travelled 412 miles, distributed 330 pages of religious tracts. Collected \$2.73\frac{1}{2}; travelling expenses, 90\frac{1}{2}.

Bro. Morton writes as follows, on the 1st Sept., 1865:—
There are small Baptist Churches at New Cornwall and the Branch, but my time has been chiefly spent in Northfield and the Kitty Settlement. The large majority of the people in Northfield are Lutheran, the rest are mostly Episcopalian; in the Kitty Settlement the greater proportion are Presbyterian. The prospect at first was indeed discouraging, there being but two or three Baptists surrounded by a prayerless people who are looking to the Church rather than Christ for their salvation. The congregations, however, have been very attentive, regular, and on the increase, and some are manifesting quite an interest.

This is undoubtedly an encouraging field for further labour, and I feel assured that the efforts of a faithful Missionary would be crowned with abundant success.

Rev. Augustus Shields has laboured 12 weeks in the service of the Board in the above county.

On the 6th Jany. Bro Shields writes as follows:—When I entered this field, the prospect was indeed discouraging. Sin and alienation scattered the little flock, very small before. Few manifested any interest in the cause of our blessed Lord. "Zion's ways mourned and few came to her solemn meetings." But this state of things has in a measure passed away, and a brighter day is evidently about to dawn on the heritage of the Lord. Multitudes are now constantly crowding to our services, and a degree of attention and respect shewn to our meetings and sentiments never evinced before, especially at Mahone Bay. Here I haptized for three Sabbaths in succession. The influences exerted by this significant and Heaven-ordained and approved rite, were evidently salutary on the minds of persons heretofore opposed.

This is a vast field for Missionary labour. I extended my labours to North West, Heckman's Island, Peninsula, New Cornwall and Mahone Bay. My success was not as great as I desired, but thanks be to God for the few tokens of his approval bestowed. We are looking for a season of refreshing. This is just our want, and that of all our churches, and the want of the world.

elling expenses \$3.50.

Rev. W. E. Hall has performed a mission of 10 days at

New Ross

The following report was sent in the 21st May. As we have so much destitution of Baptist preaching in those parts, our church concluded that what it does for Home Missions this year it will do in the county. So they passed a vote at our last business meeting to send me on a mission to New Ross for ten days, and that a report of the work should be made to the Board. I visited 17 families, preached 10 sermons, attended 1 conference meeting, and administered the Lord's Supper to the church the first time they have had it in about four years. Collected for the society \$3.58½. Beside the above I attended one business meeting of the Church and Society, at which steps were taken to finish their meeting-house this season. I found the little church in a very dark state. If the Board can send them help in the Autumn after their House is done, I believe it will be for good. Do remember them.

Rev. D. G. Shaw spent 6 weeks in the service of the Board at Tancook Island. Preached 10 sermons, attended 11 conference and prayer meetings, made 67 family visits, baptized 1, travelled 140 miles. Collected \$25, travelling

expenses \$6.70.

Bro. Shaw reports as fellows: I arrived in Lunenburg on Saturday, 15th July, meeting here with several friends of former acquaintance who were very anxious that I should stay a few days with them, I tarried one week, preaching and visiting from house to house, it was a refreshing senson to God's people and I trust not unprofitable to others.

I arrived in Tancook on the 22nd July, and found the

friends had been expecting me for some weeks. The church here has had to contend with many things quite adverse to their prosperity. Having no "Shepherd to seek after the flock and to feed it with the sincere milk of the word," and owing to its isolated position almost entirely excluded from the privileges of attending elsewhere to those means of grace so necessary to the growth and prosperity of a church, as may naturally be expected, a spiritual declension is almost invariably the result. Through the praiseworthy efforts of a few individuals the prayer-meeting has been continued every Sabbath, and I found during my stay among them, that by the strong desires and earnest petitions of several of the members that they were determined by divine grace to persevere in the way of the Many were the expressions of gratitude to the Board for their remembrance of them.

## Pictou County.

Rev. Alfred Chipman remained 6 weeks in Pictou County during the present year, from 1st June to 15th July. Collected for the Society \$37.20; travelling expenses, including the previous 10 months. \$20.

On the 27th September Brother Chipman writes as follows:—About the middle of June I commenced a regular Sabbath evening service in Pictou Town, and continued it about one month, or until my place was supplied by Bro. Laugridge. At first our Hall was nearly filled, subsequently the attendance fell off much, probably owing to the recommencement of preaching in the Morrisonian chapel. That much of my labour in that Town, as elsewhere, was sadly inperfect, no man is more conscious than myself. The fruit of such labour or of that which may have been better put forth, will also probably remain a longer or shorter time invisible.

I spent about two weeks more in the County; had some precious visits; enjoyed a Sabbath in Merrigomish; left that place with much reluctance, and there still comes from the hearts of our brethren and sisters there the yearning entreaty to our Board,—send us further aid.

Rev. R. J. Langridge having received an appointment

of 12 months to Pictou, at a meeting of the Board held during the Eastern Association of last year, has been since that time labouring in Pictou Town.

On the 5th June Bro. Langridge forwarded a report, from which the following extracts have been taken:

Since my arrival in this place, I have attempted, in my feeble way to advance the cause of the Redeemer who has done so much for me. With the exception of about 3 weeks, (during which I was very ill,) I have preached, lectured, visited, &c., endeavouring to make use of every means to benefit my fellow-men. Experimental religion has been my chief topic, in the pulpit, and in the house. The life-giving power, flowing from a hearty belief of the truth as it is in Jesus. I have been encouraged, by the attendance and attention of the people, and I trust some impressions have been made that will never be erased,though as yet none have come forward to join our ranks, and increase the number of our struggling little band. When I first entered upon my labours here, my congregations were very small, amounting to about 20 persons in the morning and about 40 in the evening.

After about two months in the small Hall, Bro. Griffith rented the Assembly Hall, a much larger building, and easier of access. I published a list of subjects, and our congregations greatly increased, numbering about 35 in the morning and from 400 to 500 on Sabbath evenings. Our Tuesday evening meetings, I trust, have proved profitable to those who have attended, often 20 to 25 present; but the great drawback is the want of a building of our own. I have received great kindness since my sojourn here, especially during my affliction, by persons of different denominations. I have been treated with Christian

courtesy by ministers of the town.

I regret we have done so little towards increasing the mission funds, but you must remember that the rent of the Hall is very high, and takes all the collections, yea, Bro. Griffith has had to pay no small sum to make up the deficiency. Collected in the Hall, for the rent, Fourteen pounds and some odd shillings. The members of our church are poor and therefore unable to do much.

In the former part of my time, I visited River John, but found the distance of 20 miles too long to drive to be

in Pictou on Sabbath evenings. The friends there have, held in consequence of bad roads, neglected to assemble thembeen selves together for prayer. They have a frame building, but not yet finished, owing to the want of co-operation on port, the part of the friends. I can't say much about Merrigomish, as I have not visited the place lately. the prejudices of many in this part have been removed. The following is a summary of my labours: Sermons preached, 134; Prayer and Conference meetings attended, 17; visits made, 269; miles travelled, 319; administered the Lord's Supper 8 times. Collected for the Society,

My prayer is that my successor may be made more useful in this vineyard, where souls are neglecting the great salvation, notwithstanding all the efforts put forth by the respective ministers of the town.

## Prince Edward Island.

Rev. Ben. Scott labovred 13 weeks on the above Island. Preached 38 sermons, attended 3 conferences, besides prayer and other religious meetings, visited 204 families, trayelled 500 miles, dispensed the Lord's Supper twice, ordained 1 deacon, and addressed Temperance meetings. Collected for the Society \$100; travelling expenses, \$10.

On the 4th Oct. Bro. Scott writes as follows :-

Lot 49.—The small Baptist Church is still endeavouring to pursue its course in view of the time when it shall be favoured with more pastoral labour. The congregations were large and very attentive to the word preached as well on week evenings as on the Lord's day. We held a Conference meeting, dispensed the Lord's Supper and ordained one deacon. I spent four weeks here preaching and "going from house to house."

Grand River.—This is a new but large and growing The protestant part of the community is composed of Presbyterians, Baptists, Bible Christians and Wesleyans. There is a Sabbath School in connection with the Baptist Church at Annandale; much good has resulted from it. The Church and their friends purpose erecting forthwith a Baptist Meeting house at Dundas,

which is becoming the centre and rallying point of this field of labour. I laboured seven weeks at this place, fully believing it was not in vain in the Lord. This field is "white to the harvest" and affords much encouragent.

St. Peter's,—This is an old and extensive settlement. The Protestants are mostly Presbyterians. They opened their new meeting-house for our preaching. The Baptists are few in number, and have no place of public worship. I laboured here a fortnight, sewing the seed of the kingdom, with much hope that the harvest will be gathered in due season.

Uigg.—Preached one Sabbath here in exchange with Elder Samuel McLeod, for the benefit of the Gælic people at Grand River.

The Island is a most interesting field for missionary labour, and should the plan of operation be well formed, generally speaking, the expenses of the mission will be realized from the people.

Bro. John McDonald laboured 10 weeks in the service of the Board on the above Island. Preached 38 sermons, attended 12 conference and prayer meetings, visited 80 families, travelled 700 miles; travelling expenses, \$18.50.

Collected for the Society, \$41.09.

Bro. McDonald writes on the 6th Sept., 1865:—During the mission assigned me, I laboured at Cavendish, Bedeque, Clyde River, North River, Tryon, Long Creek, East Point, Three Rivers, and Uigg. It is not for me to say what amount of good has been done. Serious attention to the means of grace was almost everywhere apparent.

Having finished my mission to Tancook, I returned, by way of St. Margaret's Bay, to Hammond's Plains, to set in order, if possible, our new chapel for the approaching vearly meeting. We succeeded, and held therein a series of deeply interesting meetings. As is usual on those occasions there was a very large gathering together both of white and colored friends, who manifested much joy on I think you will say, Brethren, we have done well towards our meeting-house. The outside is finished, the floor laid, seats and pulpit erected, and the walls ceiled up to the window, and all paid for; it now remains to lath and plaster, finish the gallery, and paint when it will be completed. But where are the means to come from? Many thanks to the friends who have helped us, and many prayers that the Lord will stir up the hearts of others to offer willingly to the house of the Lord.

From here 1 returned home, tarried one week and preached one Sabbath at Windsor Plains. I then left for Preston. On Sabbath, Oct. 1st, preached and baptized 12 adults in the beautiful lake near the Nelson meeting-

house,—the fruits of seed sown last fall.

I desire to "praise God for his goodness and for his wonderfaul works to the children of men." I visited Lake Thomas, near Waverly, preached one Sabbath, and administered the Lord's Supper. Returning to Halifax, I took passage on poard the packet, Capt. Hadley, for Guysborough, where I arrived on the 23rd Oct. Capt. H. would take no pay for my passage, and both himself and wife, who was on board, manifested much interest in our efforts to improve the moral and spiritual condition of the colored people. 25th I went to Crow Harbour, preached there twice, and as often at Half Island Cove; returned to Guysberough en the 30th, left for Tracadie in company with Bro. Kennedy, and on Wednesday reached my much desired field of labour, in behalf of which so much was said at the Association in Canard.

One very serious difficulty was felt during my labour with this people,—the want of a meeting-house. A frame, boarded in and roof shingled, and nearly without floor or vindows, and remaining thus for the last four or five years,

tells a true but sad tale of the lamentable state of the As was the temporal, so I found the church in Tracadie. spiritual building, rent with dissensions, and scattered by reason of sin, the meetings given up, except in shadow, till this "Zion had become a wilderness," through the prodigal conduct of a large number of its members. am happy to say I found a few who were willing to come up to "the help of the Lord." We continued our meetings nearly every day; they became more and more interesting; those from afar came until, by force of numbers, smoke and cold, we were driven from the miserable hovel, bearing the name of a school-house, to seek an asylum in the more commodious apartments of the neighbouring dwelling houses. At length the darkness gave way to the light of the gospel, as it shined unto them. Backsliders began to come home, wicked men and women believed, repented, and were baptized, confessing their sins and their love to Jesus. Among the Roman community there was no small stir: numbers of them attended our baptisms and some our meetings. One of them, a married woman, after enduring a great conflict within and sore trials without, was brought, through grace, to taste the joys of pardoned sin, and, gladly following her Saviour's example, was baptized.

I remained in this field between three and four months,—much longer than I had at first anticipated, but the circumstances of the case forbid my leaving sooner.

Dear Brethren, it requires but a short experience to see that Tracadie, including Manchester and Guysborough, furnishes a very extensive field for missionary effort. The fields are white and ready to the harvest,—where are the labourers? A missionary should be stationed constantly in this single field, which can be enlarged to almost any extent, by including various contiguous white settlements, the coloured population alone amounting to between 800 and 1000 souls. I baptized at Tracadie 28, restored to church fellowship 25 excluded members, some of them of long standing.
