The G. W.P. read his report as follows:

To the Grand Division of Nova Scotia.

OFFICERS AND BRETHREN,-

Another roll of the wheels of time has been made, and we have been permitted by a kind Providence to come hither to discharge the highly important duties incumbent upon us, in virtue of the confidence reposed in us by the noble band of fellow-workers who have chosen us their representatives in Grand Division. Another eventful year in the progress of "the cause of all mankind" has terminated, and the period has arrived for holding this, the twenty-first annual session of this Branch of our noble and much loved fraternity. Brought together once more to take sweet counsel with each other, may we be enabled to look up to, and confidingly rely upon the all-wise God to grant us the necessary wisdom and direction to devise the best means for the accomplishment of the glorious object we have in view.

Although unable to announce an increased accession to our numbers in this jurisdiction during the past year, yet from other points of view it may safely be concluded that the Temperance cause has not only held its ground, but has made favorable advances to a considerable and appreciable extent.

The organization of a Provincial Temperance Alliance, and branch Alliances in several of the counties of the Province, having as their principal aim, the formation of a Political Prohibition party, the action of the Legislature, b which a law was enacted, which approaches, not only in spirit but in letter, very nearly to a total Prohibition of the retail traffic in intoxicating drinks in this Province, and the discussions which took place, and the resolutions passed by several of the religious denominations in their Synodical or Conventional capacity, all strongly indicate that the monster evil which we aim to eradicate, is attracting greater attention, and consequently is becoming more universally viewed and seen in its true enormity and real heniousness of character.

The following extract from the last report of the M. W. P., may in a great

measure be applied to Nova Scotia.

"The startling array of facts and figures which the manufacture and use of alcoholic beverages are daily and hourly bringing to light, presents an argument so undeniably and overwhelmingly true, that conviction from its own weight is fast forcing the conclusion, that reform in the habits, customs, and laws of the land in regard to the liquor traffic, is an absolute essential to the peace and safety of society. Indeed the drinking customs of the day have become a matter of the greatest importance, and demand the consideration of every citizen who loves his country and his kind. The inquiry, "Is the toleration of an evil such as the liquor traffic, consistent with morality or the christian religion?" begins to be heard. The question "Is its persistent defiance of law, and its demoralizing effects upon society conformable to patriotism or philanthropy?" is heard from lips unused to such utterances."

I regret to have to reiterate the complaint many of my predecessors in reference to the want of such information as should be furnished from the county D. G. W. P.s, which prevents me from giving that information to you in reference to the state of the Order in this jurisdiction as is desirable. I can only avail myself of the scanty material I have at hand, and refer you to the report of the

Grand Scribe for statistical and other valuable information.

ANNAPOLIS COUNTY.

No reports from this county except from our tried and worthy brother Ricketson, who says, "our Division (Olive Branch) is holding on its way; we anticipate a great struggle at our approaching sessions. The rum interest will do its best to get licenses for another year. I hope they will not succeed."

ANTIGONISH.

P. G. W. P. King writes, "I beg to say that the order is holding its own in this County. There is not so much interest manifested as in years gone by, but the principles of Temperance have become deeply rooted in the hearts of many who were either careless or opposed to us."

CAPE RRETON.

County Deputy Johnston says, "I am sorry to report that Cape Breton Division seems to be losing ground. The members, with some few exceptions, appear to have lost all interest in the cause. Archangel Division, I am glad to say, is doing well; although suffering at present from the removal of some of her best members from the Province. North Sydney Division is working well, with a very good attendance of members. W. W. Bown reports that Morien and Homeville are doing well; although not so large in members as formerly, their influence in the community is greater than at any former period. II. A. Taylor is still living, and will likely take a fresh start when times get better. Brother Charles Bown reports Beacon Division doing well; they have one rumseller in the locality whom they hope soon to be clear of, as he is now in jail to stand his trial for stabbing one of his customers. Outside of our Order I have nothing to report; runselling still abounds, and the majority of the people still look on with indifference. I am sorry to say there is still a number of the clergymen in this county who appear to take no interest in the temperance cause." G. C. Clement II. Harrington writes "I am happy to report that 'Star in the East" is still helding on its way, and doing what it can to enlighten our little community as to their true interests. We are not so strong in numbers, and perhaps not so abundant in labour as at some former periods of our history, but we have hardly as yet recovered from the effects of the fire in 1867. We have among us a few tried friends of the cause, who will never suffer the colors to be struck, and now we are looking forward with glowing expectations of a visit from the Grand Division in July next, believing that not only would such a visit cause increased prosperity in our Division, but that it would give a new impetus to the cause of temperance throughout the whole region."

COLCHESTER.

Divisions in general not losing ground. Truro bidding fair to become useful again, is about to celebrate her 21st anniversary. Pleasant Valley not increasing in numbers, but there appears to be a *spirit* prevailing among the Brothers that says "we will uphold the Division through the most adverse circumstances." In the late political contest in this county, intemperance did not prevail to anything like the extent as on former similar occasions.

CUMBERLAND.

Brother Dep. M. B. Huestis, of Wallace, writes, "I am happy to be able to report some progress in temperance effort with satisfactory results during the past quarter.

The License law has been enforced by our Clerk of License; fines levied and collected at Wallace, Pugwash, and at the Intercolonial Railway works, Folly Lake. Our Division is of late steadily gaining ground "by the right." People are awake to the necessity there is for determined effort in arresting our greatest evil."

Co. Deputy Black writes, "In waiting for Div. Deputies-to forward their reports, I fear my report will be too late for Grand Division.

"Brother Blenkhorn, of Rescue Division, reports temperance prospects encouraging in Advocate Harbour, 6 members having been initiated during the quarter. We have very good attendance, and meetings regular. He is the only Div. Deputy who has reported.

"Amherst Division still holds its ground with unwavering steadfastness, notwithstanding the attractions of new Orders—rival to it, if not hostile.

"The meeting of the Grand Division in Amberst was of great benefit to our Pivision. The able and whole-souled temperance men who came from a distance to gather in quarterly session, evidenced to thepeople that there was reality, vigour, and life in the Grand Division, and Amberst Division received an impetus, and the cause made a great advance in the minds of the lukewarm Temperance people."

HANTS.

The amendment in the License Law has had the desired effect in the western division of this County. Brother McLearn writes: "While we have to mourn the departure of some from our ranks we are gratified to know that the Temperance principle is gaining and taking deep hold on the minds of some. At West Hants, where licenses for the sale of intoxicating liquors have been granted heretofore, the Justices in Session have refused to continue that practice. Yes, we have a few warm-hearted, philanthropic Justices in West Hants. The publicans at Windsor, some six or eight, have used every influence, and even closed their houses from the public, but so far our cause has not been discouraged. At East Hants, the people are generally against the granting of licenses. The Bench of Justices is also quite unanimous in refusing; consequently there is little trouble.

Rechab Division, located at South Rawdon, is still holding out with increased members, nine having been initiated during the past quarter. Through the exertions of Bro. Creed, and a few others, the Order is being well sustained here. Full weekly meetings, with a spirit of energy. "Miners' Own," at the Gold Diggings, is not working; but there is a fair prospect of a revival. "Still-in-time." although located in a thinly populated place, still bears its title, and is doing an excellent work, notwithstanding many obstacles.

OF HALIFAX,

The stronghold of intemperance in the Province, and the bulwark of hope for the country, Bro. Charles Robson writes:

Halifax, October 25, 1869.

WORTHY BROTHER,-

Having received but few reports from the various Divisions of the County of Halifax during the past year, I regret that I am unable to furnish you with much information as to their present position and prospects.

Ingraham Division, Margaret's Bay, is doing better than for some time

pas

Marathon Division, Indian Harbor; Granite Division, Sambro; and Lake

Echo and Crystal Rock Divisions, at Lawrencetown, are doing well.

Orior Division, Oldham, is in a prosperous state. The Rising Sun Division, Musquodoboit, is not very prosperous; but the brothers of that Division are determined to hold on; and the same may be said of Waverley Division, the condition of which is much affected by the decline of the mining business. Gibraltar Division is not doing so well as it might. Champion Division is

improving, and is said .. be one of the best Divisions in the County.

So far as numbers are concerned, the Divisions in the city are nearly holding their own. Some of them, indeed, have lost considerably, but others have gained. The members of Chebucto, Mayflower, and Richmond Divisions have diminished by 82; but the Micmac, Howard, and Athenæum Divisions have increased by 79. The additions, however, have been made chiefly from among the men of the 78th Regt., while the losses have occurred principally from among our own citizens. It is to be regretted, therefore, that, as regards its influence on our own population, our Order appears to be losing ground; and it is remarkable that the habitual frequenters of our Division Room are, to a great extent, young men, and, comparatively new members; many of the old members having ceased to attend. These two startling facts seem to indicate some imperfection in our system of working, and a consequent failure to accomplish the objects for which the Order was designed. Large numbers of our members are lost to the Order because they are either unable or unwilling to pay the arrears of dues, which accumulate in consequence of their losing interest in the divisional meetings, and attending only at long intervals. For this state of things there is no remedy, but the creation of an intense and general interest in the great subject of Temperance Reform; and how this may be effected is a question which demands our most serious consideration.

The City Divisions are working smoothly and harmoniously, but it is to be regretted that the Chebucto and Richmond Divisions alone are able to meet

their expenditure out of their annual income.

The Day-Spring Division, in Dartmouth, still perseveres in holding up the banner of Total Abstinence amidst great discouragements. It contains a number of young brothers who deserve very great praise for the energy and perseverance with which they have labored to make the meetings attractive to their fellow members. The number of regular attendants is small, but they are determined to persist; and we may well hope that their efforts will yet be rewarded with success.

KINGS.

G.W.A. Bill writes: "I regret that I have nothing very flattering to communicate with reference to the state of our beloved Order in Kings County.

Some of the Divisions are in a very feeble statesome respects during the last few months, and a new quickening impulse is everywhere needed. With unflinching perseverance nothing can hinder our onward march, and this should now be the order of the day.

Lake Division is pursuing a useful course, not only by gaining accessions to

its ranks, but also in the influence it is exerting in the community.

Pereaux Division continues to increase slowly but surely; the meetings have been conducted very harmoniously; and the brothers and sisters are now exerting themselves in preparing to build a Temperance Hall.

Rockport Division is doing a good work. A prosperous winter campaign is anticipated. The rum power has received a decided check through the energetic demonstrations of this Division.

A County Temperance Alliance has been formed, and the platform of the Nova Scotia Alliance adopted. Representatives from the different Temperance organizations were present, and exhibited great interest in the subject of Prohibition and in the objects contemplated by the Alliance."

INVENBURG.

County Deputy P.G.W.P. Skinner, writes: I can only report in reference to three Divisions, viz., Chester. Phænix, and Noble. These are doing as well as usual; struggling as best they can to beat back the foe intemperance and to wave the flag of total abstinence over the land. The other seven have not been heard from. Doubtless, however, you have received returns from most or all of them, from which you can judge somewhat correctly as to their standing.

I am sorry to say that I shall not be able attend the Annual Session in your good city to-morrow. I had fully intended to lothere, but a combination of circumstances have rendered it quite inconvenient. I can say, however, that my interest in the good cause of Temperance has not in the least abated. Next to the cause of religion, I believe it to be the noblest work that can engage the attention and employ the energies of the Christian and philanthropist. May Heaven smile on the deliberation of your Session.

I was going to give you my opinion in reference to some of the grave questions to be brought before the Grand Division, but I forbear. I trust that God, who hears the cry of the suffering—whose hand is evidently in the Temperance movement—and who, I believe, has called into this noble work many of the most pious and devoted of his servants, will be with them, to guide them to right conclusions and happy issues.

PICTOU.

P. G. W. P. Marshall writes, "The Divisions in the county may be considered as healthy; there is not that active vigorous effort we were wont to see, still we may judge that Divisions only share in the general lull, and will bestir themselves as occasion demands. I think our county has made rapid strides in the temperance journey last year. The religious temperance movement has been most active on the one hand, and the loyal element on the other; both, I conceive are necessary, have done much, and will yet accomplish wonders, and the sister organization has done much in the sparsely settled localities. But keep up the Divisions. Wellington's Guards were not more necessary at Waterloo, than the Sons with their drill, discipline, and prowess are to the great moral contest now going on.

SHELBURNE.

Brother Locke, of Locke's Island, writes: "Our Division is in a very prosperous state, attendance good, and exerting a powerful influence over the drinking habits of the people. We have succeeded in driving all the "Grog" out of the community."

Brother Crowell, of Barrington, reports "Concord Division just at present is low, few members at home, but in two or three months we shall be reinforced when we shall resume more active work. Granite is in good order, well attended by its members, and rather an increase of interest. Montrose not been working most of summer, but now has began work again. I think McMurray has been working quite regular, have not heard from the other Divisions.

YARMOUTH.

P.G.W.F. Christic writes: "I regret to say that having been so long from home, it will not be possible for me to attend the meeting of the Grand Division to be held next week in Halifax. I would gladly attend, but my duties in other ways make it impossible. I trust, however, that you will have such a large attendance that my absence will not be felt.

"There is just as much need as ever to labour in the good cause. I assure you I am not idle, though I regret to say that the cause does not seem to prosper. Two or three months ago I preached a sermon, which roused our community pretty effectually. Since that there has been a most determined war with the liquor sellers. They feel it, and in their fury they have been trying to take vengeance on the Clerk of License, and the community have been taking means to protect and support him. I think I can venture to promise that we will ere long have good tidings to report, though I assure you the few who remain firm have up-hill work. Hoping that love and harmony may prevail in your approaching session, and that wisdom from above may guide all your deliberations."

AGENCY.

You will be informed by the report of the Agency Committee, that for the want of funds a travelling Agent and Lecturer has been employed only during six months of the past year. This is much to be regretted, and until this branch of our operations can be placed upon an efficient footing, we cannot hope for progress or prosperity in our cause as in times past, and I carnestly hope that some means may be devised, by this Grand Division, by which an able and efficient missionary may again be employed in advocating the principles of our noble brotherhood. Whether the distribution of temperance tracts and books might not in some manner be connected with the labors of a Lecturer, thus combining the work of imparting information by the written and oral word through the agency of the same missionary, is a question which I submit for your consideration. Written works on Temperance have now assumed an important position in the literature of the day, and it becomes us to consider how far it may be available in promoting the principles of Temperance in our own Province.

ABSTAINER.

Every argument, entreaty and expostulation in reference to the absolute necessity of sustaining this indispensable and truly valuable periodical, have been so often arged upon this Grand Division, that allusion to it may be considered a mere repetition of what has been formerly advanced on the subject. Be this as it may, the question as to the efficient support of the Abstainer is one which cannot be lightly passed over. Without the aid received from its able advocacy of our principles heretofore, Nova Scotia could never have attained to the position which she now occupies in the National Division of the Sons of Temperance of North America. When the Abstainer came out in its enlarged form, at the commencement of this year, we all hailed it with joyful pride, and admired the noble courage of its energetic and talented editor and proprietor, but what shall we now say, or rather do, upon being told that owing to want of support, and consequent loss to the publisher, it must be discontinued? I submit this question to you my brethren, as one second in importance to none which will occupy your attention at this session.

N. D. FOR B. N. A.

The propriety of establishing a National Division for the British North American Provinces will be submitted to you during this session, which will require your most careful consideration.

INEBRIATE ASYLUM.

The necessity and value of such an institution cannot be doubted, and its importance in connection with the Temperance Reformation cannot be over-estimated, nor should it be overlooked. I would recommend that all the influence which this Grand Division can bring to bear upon the Government and Legislature, be employed to obtain such aid from the public revenue as will secure the establishment of such an asylum as will afford a safe harbor to the wrecked and cast away unfortunate victims of strong drink.

AMENDMENT OF BYE-LAWS.

According to notice given at the last quarterly meeting of this G. D. a resolution will be moved to amend the bye-laws, which will impose a tax of ten cents on Subordinate Divisions for every new member initiated, for the purpose of meeting a similar tax imposed upon the Grand Division by the National Division.

And now, my brethren, my term of office draws to a close. The past year is gone, and has flown, like all years, too swiftly for the work we should have done. I have much to thank you for, not only for the high honor conferred upon me in electing me to this office, but also for the kindness and love bestowed upon me during my occupancy of it. I have had much pleasure in witnessing the progress of our Cause, and aiding, according to my ability, in the advancement of it. I will ever remember, with high satisfaction, that my official intercourse with you has been of so harmonious and so brotherly a character.

I hope still to labor in our glorious Cause unto life's end, and to die an honorable and consistent Son of Temperance.

To our Grand Scribe I tender my heartfelt thanks for his ready aid, his pru-

dent management, and his untiring zeal in the good work.

May the Father of Lights, from whom every good and perfect gift doth come, grant unto us wisdom, prudence, and love, while we deliberate, consult, and decide upon the questions which affect the interest and perpetuity of the Order.

[Note.—Some Reports from Deputies came in after reading of above report, and substance of them added, with consent of G. D. A report from the County Deputy for Annapolis, in which he hoped for the opening of two new Divisions, was received a few days after the segsion closed.]

Referred to Committee on State of the Order.

Representative O. J. Spencer of No. 246 being announced in waiting, he was obligated in the ante room by the P. G. W. P., and admitted to a seat as a member.

The Grand Scribe presented the following Report which was referred to Committee on State of the Order:

In assembling in twenty-first Annual Session of Grand Division, the Grand Scribe offers his congratulations to the Representatives from the various parts of the jurisdiction on the good achieved through the instrumentality of our organization since the first annual meeting of this body, and prays that a merciful Providence will vouchsafe as successful a career for the Order of the Sons of Temperance in this Province in the future as in the past.

As respects the

STATE OF THE ORDER

in the jurisdiction at the present time, a definite conclusion cannot be arrived at, owing to the non-receipt of many Returns from Subordinate Divisions, and absence of Reports from a number of Deputies. From Returns and Reports to hand, however, sufficient information has been gathered to indicate that our Order is not quite as active now as it was twelve months since. This state of inaction may be attributed to several causes, the principal being the want of an active, energetic Agent in the field. Want of funds has prevented the employment of a Lecturer; hence the absence of vitality in many of our Subordinates. Decrease in the circulation of The Abstainer is another cause, as many brethren are not now as well informed on the doings and progress of the Cause as previously, or as they should be. Another great cause, no doubt, is the prevalence, for many months past, of hard times, and in consequence of which many members, in not a few districts, find it difficult to keep their accounts square on the books of the Financial Scribes.

Notwithstanding the drawbacks mentioned, which render it difficult for a number of Divisions to maintain their ground, it is pleasing to know that many of them are progressing and prospering, and doing good service for the cause. One fact is worthy of note respecting these prosperous Divisions—their members are generally the most liberal in contributing to the Agency Fund, and the most generous in the support they have given to *The Abstainer* as the Organ of the Order.

NEW DIVISIONS.

No new Divisions have been organized during the quarter.

The proposed Division at Annapolis, for which a charter was granted previous to last meeting of this body, has not yet been organized.

Since last annual meeting eight new Divisions have been organized, viz.: two in Lunenburg County, and one each in the Counties of Halifax, Hants, Cape Breton, Shelburne, Colchester, and Richmond.

DIVISION RESUSCITATED.

Tusket Division, No. 229, located at Tusket, Yarmouth County, which had been inactive for several quarters, resumed operations about the first of the present term, and is likely to prosper.

NATIONAL DIVISION FOR RANGA.

The subject of a National Division for the British North American Provinces will be submitted for your consideration. A communication in reference to the matter, from the G. D. of Quebec will be laid before you.

ASYLUM FOR INEBRIATES.

I would respectfully recommend the Grand Division to again petition the Local Legislature in favor of the establishment of a Provincial Asylum for Inebriates. I would also renew the proposition made in my last Report, presented at the July Session. viz.: that the G. D. make an appropriation of at least \$100 in aid of the establishment of such an institution, provided preparations for the same are commenced within a certain given time.

AGENCY.

It is of the utmost necessity that our Agency work be resumed at the earliest possible moment. Funds, however, are required; and unless the Divisions, with a few honorable exceptions, be more liberal in their contributions to the fund, their wishes in reference to visits from an Agent and Lecturer cannot be complied with. This question requires serious consideration, and something practical should be done with the view of keeping alive the interest in this department of our work.

THE ABSTAINER.

While regretting the necessity for so doing, I am compelled to announce to you that at the end of the current year, 1869, The Abstainer shall have to be discontinued. For a few years past, it has been published at a loss. With a view of meeting the wishes of many Temperance men, as well as to create a greater interest in Temperance literature, I was induced to issue the paper in its present enlarged form at the beginning of this year. Although many desired a larger paper, and promised support thereto, it has been published at a loss. Promises respecting it have not been fulfilled, and my expectations have not been realized. Several causes may be assigned, only one of which I may allude to here. Little or no effort has been made by professed friends to extend its circulation through the Province. Justice to the Printer, as well as to myself, compels me to decide upon discontinuing it on the 31st December next.

Should the Order still decide to have an Organ, and a fair guarantee be given as to circulation, I would feel disposed to issue a monthly periodical, in Magazine form, at the rate of fifty cents per annum; or a semi-monthly at one dollar a year. It is for the Representatives assembled to decide whether they will be prepared to give a guarantee for a circulation of a certain number of copies. The responsibility cannot be assumed without a fair guarantee as to its support in the shape of subscriptions, &c.

NATIONAL DIVISION JOURNALS.

Since the July meeting, I received the quota of copies of Journal of Proceedings of the National Division at its last Session, to which this body was entitled, and mailed one copy to each Subordinate Division.

OTHER MATTERS.

Among other subjects that will engage your attention will be the advisability of admitting females to full membership in the jurisdiction; the propriety of giving certain Divisions the power of granting the privilege of voting to members between the ages of 14 and 18 years, and how to meet the requirement of the National Division of the tax of ten cents on new members admitted during the year.

In reference to the last named matter, it would be well that instructions be given the Grand Officers as to making any remittance to the National Division, at end of the year, for the Propagation Fund.

We fully endorse the sentiments respecting the necessity of a general, or Provincial, Asylum for Inebriates, and will cheerfully co-operate in all suitable efforts for the speedy establishment of such an institution or institutions.

P. M. W. A. Cramp presented the following report from Committee on State of the Order, which was discussed by clauses, and adopted:

The state of the Order was so fully considered in the Report presented by the committee appointed at the last Quarterly Session, that scarcely any additional observations are required; no change of importance having occurred since that Session.

The committee would have rejoiced if the Report of the Grand Officers had been of a more cheering character. They do not, it is true, tell of calamities and defeats; but they suggest the existence of a condition of affairs which cannot but be centemplated with deep anxiety. The wheels of our enterprise seem to be somewhat clogged, and the strength of the labourers in a measure decay-The Order may be said to be at a stand-still, if indeed, it be possible to stand still, such a supposed state of things almost always implying a backward movement.

It is distressing to hear, from Session to Session, of the imperfect discharge of duty by officers in various parts of the Province, who have been placed in situations of honour and responsibility-of withdrawals or expulsions occasioned solely by neglect to meet the moderate expenses necessary to the successful working of the Order-of the failure of the Agency branch of our efforts-and of the difficulty of sustaining the Organ of the Grand Division, a difficulty

which now threatens to issue in a disastrous change.

On the other hand, however, it is to be borne in mind that the Order of the So s of Temperance has been largely blessed. To their zealous endeavours the Province is indebted for the extensive diffusion of information on the subject of alcoholic liquors, their pernicious character, and their destructive influence;—to their active interference very many persons owe their rescue from the degradation of drunkenness, and have been restored to their friends and to society; -by their persevering labours, public opinion has been so moulded that Temperance Institutions are looked upon as public benefits; and Temperance advocates are listened to with respectful attention; -- and last, but not least, men of all parties and persuasions, religious and political, have united in this benevolent crusade; content to sink their differences, while with combined energy and compassion they have sought to raise the fallen, reclaim the wandering, and improve the tone of social morality. These are interesting and glorious results. The members of the Order may congratulate each other on the successes which have been achieved, and be encouraged by the review to encounter with unfaltering determination, the obstacles and opposition which are yet

Adverting more particularly to some of the points which have been alluded to, the committee beg to call the special attention of the Grand Division to the Agency Department. A judicious and effective Agency is essential, in their opinion, to the progress of the Order, nor ought its maintenance to be difficult. There are members of the Divisions who are able to contribute liberally to the object, and whose benevolence should not need to be stimulated and urged. The members and lady visitors of the Grand Division number together 14,435, according to the last report presented to the National Division:—now, it may be presumed, that 435 members (the fractional number) might be found, whose donations of one dollar each might be secured—amounting to 435 dollars: a contribution of five cents each from 14000 members would realize 700 dollars more, making in the whole 1135 dollars,-a sum amply sufficient to support an Agent during an entire year's labour, and defray all incidental expenses connected with his mission. Why should not this amount be raised? How is it that the friends of temperance often seem reluctant to part with ther money, even for the promotion of the object to which they have pledged themselves?

The case of the Abstainer excites painful emotions. Brother Monaghan announces that in consequence of the losses that have been incurred, the publication of that useful paper will cease at the end of the year. This is a sad announcement. The fall of the Abstainer will be a heavy blow to our cause. The committee trust that an earnest effort will be set on foot during the present Session, whereby the Grand Division may still enjoy the advantages derivable from the use of the Press.

A suggestion offered by the Grand Worthy Patriarch deserves serious consideration. It relates to the circulation of books and tracts by the Agents employed by the Grand Division. Probably much good may be effected in this manner. The books might be sold, and the profits derived from the sale might

be expended in the purchase of tracts for distribution.

On the subject brought before the Grand Division by the Grand Division of Quebec, viz., the formation of a National Division for British North America, your Committee are not prepared to recommend any action. However desirable it may be to form such a National Division, it does not appear that the time is yet come. Union is necessary for the accomplishment of the object, and the committee observe that the Grand Division of New Brunswick has already decided in the negative. The committee consider that it is our duty to remain for the present as we are, and to continue to enjoy the pleasures of union with our brethren in the neighboring Republic.

The imposition of the payment of ten cents for every member admitted to the Subordinate Divisions, in order to the establishment of a Propagation Fund, strikes your committee as objectionable in this respect, that the funds raised by this means are not likely to be available for propagation within this jurisdiction, but will probably continue to be expended in the States of the Union. Our brethren in the United States do not require the aid of our benevolence. It will be expedient, in the judgment of your committee, to memorialize the National Division for the repeal of the impost, or the exemption of the Grand Divisions of Bri-

tish North America from its operation.

With regard to the County Deputies, some of whom are referred to by the Grand Worthy Patriarch in his Report, as negligent in transmitting to him the necessary information respecting their districts, the Committee suggest that it may be proper to revise the lists of those officers, and to retain such only as have been veryed to be diligent and faithful

have been proved to be diligent and faithful.

Inebriate Asylums have been tried and found eminently serviceable, as places of refuge and discipline for the victims of intemperance. The Committee recommend that this Grand Division renew its petition for the establishment of

such an Institution in this Province.

In conclusion, the Committee beg to record their firm conviction that nothing short of absolute Prohibition ought to be finally accepted by the Grand Division. We may avail ourselves of amended license laws, as far as their enactments are wise and salutary, and we must undoubtedly continue to employ to the utmost of our power, moral suasion and argument; but if we would save the population from the destructive effects of intemperance, we must agitate for the legal prohibition of the manufacture and sale of intoxicating liquors, for beverage purposes. The rumshop is a nuisance; benevolence, justice and religion demands its suppression.

The amended licence law passed in the last session of the Provincial Legislature, contains many excellent enactments which ought to be sternly and impartially enforced. Should any attempt be made for the repeal of that law, or for any material modification of its provisions, the Temperance organizations will

unite, it is to be hoped, in resisting such movement.

The Committee refer with satisfaction to the proceedings of the Provincial Temperance Alliance held in this city in March last, at which a new organization—the Provincial Temperance Alliance—was established, the grand platform

of which is Prohibition. The successful operation of that Alliance is "devoutly to be wished."

P. G. W. P. Longley presented the following Report, which was considered by clauses, and adopted:

The committee appointed to report upon the best means to be adopted for the prosecution of the Agency, regret that they have only been able to give to the subject a somewhat hasty consideration. They can therefore offer nothing

better than the following:

1. That each Divisional Deputy be communicated with, and requested to prepare a subscription list, with a view of collecting not less than \$4.00 from the members of his Division and the friends of Temperance within the limits of his section or the circle of his influence.—The sum thus raised reaching, we hope, an amount not less than \$400.00. Where annual contributions are already made by a Division, any further contributions will of course be voluntary.

2. They recommend that the sum which may be raised in the way above indicated be supplemented, if necessary, to the extent of \$100.00, either by a direct appropriation from the funds of the Grand Division, or by a subscription to be opened before the adjournment of the present session, and completed as speedily as possible, and in the event of the better suggestion being acted upon that the means required for raising the sum last named, be devised before we senarate.

3. The committee assume that the services of an efficient lecturer may be secured for the sum of \$600.00, not at any-rate exceeding \$700.00; this would leave only \$200.00 to be raised by collections, to be taken by the agent, which

may be considered a moderate estimate.

4. In regard to the support of the Abstainer the committee feel that the paper must not be allowed to go down, and suggest, should the foregoing recommendation regarding the prosecution of the "Agency" be acted upon, that the deputies, while employed in filling up their subscription lists for the agency, also act as agents for the Abstainer, and earnestly seek both to increase the list of subscribers for the paper and collect arrears due for the same.

5. Failing these means to sustain the paper, the committee recommend that the sum of \$100.00 be voted from the funds of the Grand Division towards that purpose, provided that even in this way the paper can be sustained, otherwise

not to be thus appropriated.

6. Regarding the distribution of temperance literature, referred to in the G. W. P.'s report, and also noticed in the report of the Committee upon the state of the Order, the Committee have no suggestions to offer.

On motion of P. G. W. P., Longley, seconded by P. G. W. P., McRobert, the Grand Scribe's salary for ensuing year was fixed at \$300.

On motion of P. G. W. P., Longley, seconded by P. G. W. P., King, the subject of continuing *The Abstainer* was referred to a committee consisting of P. G. W. P. Taylor, P. G. W. P. Brown, J. Grierson, P. G. W. A. Murray, Wm. Wilson.

P. G. W. A. Murray moved, seconded by P. G. W. P. Longley, That \$100 be appropriated towards payment of expenses of Representatives who may attend Annual Meeting of National Division, to be held in Newark, N. J., in June next.
