




## CONSTITUTION AND RULES

---

### NAME

1. The name of the Club shall be "THE VANCOUVER CRICKET CLUB."

### LAWS OF PLAY

2. The Laws of the Marylebone Cricket Club shall govern all questions of play.

### OFFICERS

3. There shall annually be elected a President, Vice President, Secretary, Treasurer, and five Committee-men, or in the event of the offices of Secretary and Treasurer being held by one man, six Committee men shall be elected.

### EXECUTIVE

4. The affairs of the Club shall, from each annual general meeting to the next, be under the control of an Executive Committee composed of the Secretary, the Treasurer and five or six other members as specified in Clause "3"

**GENERAL MEETING**

5. The annual general meeting, for election of officers and general business, shall be held during the month of March at such time and place as the Committee shall direct.

**NOTICE**

The Secretary shall give to every member, seven days notice in writing of any general meeting, and his declaration that such notice has been mailed to a member's usual address shall be taken as proof that such notice has been duly given.

**SPECIAL GENERAL MEETINGS**

6. A special general meeting may be called by the Committee at any time by giving due notice as above directed, and it shall be the duty of the Committee to call such a meeting upon the written request of any five members as soon as possible after the receipt of such request by the Secretary.

The notice of a special general meeting shall specify the business for which such meeting is called, and none other shall be transacted at such meeting.

**BUSINESS OF COMMITTEE**

7. The Committee shall as soon as possible after their election, fix the time and place

of their regular meetings, and define the conditions under which special committee meetings may be held.

#### NEGLIGENT COMMITTEE-MEN

If a member absent himself without reasonable excuse, from three successive regular meetings of the Committee, his seat shall be forfeited.

Vacancies in the Committee which may from time to time occur shall be filled by the remaining members of the same, at a regular meeting.

#### SUBSCRIPTION

8. The annual subscription of each member shall be £5, payable to the Treasurer on or before the first day of April in each year.

#### LIST OF MEMBERS IN STANDING

The Secretary shall keep posted in a conspicuous place on the ground used by the club, a list of the members showing what members have paid their subscriptions, and only those having paid their subscriptions shall enjoy the privileges of the club.

#### VISITORS

The Committee may regulate the terms upon which visitors may be temporarily admitted to play in practice or local matches.

**QUORUM**

9. At any general meeting thirteen members, and of any Committee meeting three members, shall form a Quorum for the transaction of business.

**MAJORITYES**

The vote of a majority of the members present at a meeting shall decide any question excepting as provided in clause "II."

**CHAIRMAN'S VOTE**

The Chairman of any meeting shall have a casting vote only.

**NEW MEMBERS**

10. New Members may be elected by the Committee or at the annual general meeting.

Such election shall be by ballot, two black balls to exclude in committee and one in five in general meetings. A candidate must be proposed and seconded by members in writing.

The subscription of a new member elected by the committee after April 1st. must be paid to complete his election.

**TWO-THIRDS VOTES**

11. Any change in the constitution of the club; or the expulsion of a member,

may be effected only by a vote of two-thirds of the members present at a special general meeting.

12. Every member of the club, and new member on his election shall receive a copy of these rules, and shall be bound by their provisions.

13. The club colors shall be Red and Black caps and sash.
