

According to news received by the Em press of China the four thousand jinricksha coolies of Yokohama and Kanagawa are wildly exercised over the now building electric tramways. At first the owners of the man power vehicles held quietly conducted meetings to oppose the tramway movement. The storm of excitement grew though, and an open air meeting was held at Zerkangama, a mile or so outside Yokohama. At this meeting the rickshaw men became so in censed at the tramway people that they marched into the city and assembled in front of the city hall, where the tramway question was under discussion, and when the members of the assembly came them, in some instances committing serious assaults on the unfortunate representatives. There is something peculiar about the way in which Egyptian mummies are prepared, and to an expert the marks of peculiarity are always noticeable. Anyone who has studied the matter will tell you that decomposition has taken place under the skin and the cuticle itself will remain intact for countless ages. The conditions of its being kept are few in number; the air must be perfectly dry, with the presence of a lime formation to keep it absolutely in perfect shape. That was what we found here. It only required a slight lifting of the wrappers to cause an emanation of the strangely faint, yet decidedly penetrating, odor that is noticed with all Egyptian mummies when the first wrappings are first disturbed. This is due to the preservation spices in which the body




