The "Amy B." The wood-boat Amy B., Capt. C. C. McLean, owned by the New Brunswick Trading Company, and bound for Pictou, recently laden with coal for the Point Escomias and Point Misou Bay alum stations, was in Miramichi Bay on Saturday night and Sunday last, anchored for shelter from the prevailing westerly storm in the outer channel below Fox Island, nearly off the Preston Lights. The wind having shifted from S. E. to N. W. on Monday morning, and then to W. S. W. with increased to a heavy gale, which was thickened. The vessel was got under way about one o'clock, p. m. on Monday and ran in the direction of Point Escomias. Capt. McLean's intention being to seek shelter under the land there. When off the Point, under double reefed fore-sail and main-sail the schooner's foremast snapped off where the jaws of the gaff of the double reefed foremast struck against it, and in its descent struck a hole in the deck forward on the port side, the sea, meantime, breaking over the deck, and rendering great watchfulness on the part of the crew necessary to prevent the vessel being washed overboard. After this mishap the main-sail alone was used but its strain parted the rigging at the mast-head and the main-mast broke off about four feet above the deck. The vessel had meantime run into a comparatively sheltered position within three-quarters of a mile of the shore to the eastward of the Pictou wharf, where two anchors were cast. The bottom being composed of led rock here the largest anchor, in catching hold, was broken with the great strain, and the Captain, seeing that the vessel was drifting toward the shore, was visited by thieves, who stole two hats containing 72 lbs. butter and a ham. The same, or another party stole quite a large quantity of fine fish from another craft in port while another other craft were raised more or less.
