An Act to amend the Act to establish a Registry office
in each Electoral County in Lower Canada.

WHEREAS it is expedient to amend the Act passed in the session held in the eighteenth year of Her Majesty's Reign, intituled: "An Act to establish a Registry Office in and for each Electoral County in Lower Canada," by providing a more equitable mode of raising and providing funds for paying the expense of procuring from any Registrar, in whose office there shall be registered any deed, instrument or document affecting real property in any Electoral County which shall have become a Registration County under the said Act, copies of, or any entries relative to such deed, instrument, or document for the purposes of the Registry Office established in such electoral County, Therefore Her Majesty, &c., enacts as follows:

Preamble.
18 Vict., c. 99.

I. The funds which may be required to pay any Registrar in whose office there shall be registered any Deed, Instrument, or document affecting any real property in any Electoral County in which a Registry office for such County shall have been established, for copies of the said Deeds, instruments and documents, and of all entries relative thereto, and for paying all expenses attending the same, shall be raised by a special tax, to be levied upon all the land owners in the former Registration County or Counties of which the Electoral County in which such new Registry office shall have been established as aforesaid, previously formed part.

By whom the cost of deeds, &c., obtained from other Registrar for the Registry office in an Electoral County.

II. So much of the eighth section and of any other part of the above cited Act as may be inconsistent with this Act, shall be, and the same is hereby repealed.

Part of sec. 8 of the said Act repealed.

III. This Act shall be deemed to be a public Act.
