An Act to extend the time for completing the Louth Harbour.

WHEREAS, in and by an Act of the Parliament of Upper Canada, Preamble.
passed in the third year of the Reign of His late Majesty, King
William the Fourth, and intituled, *An Act to incorporate a Joint Stock* Act of U. C.
Company, for the construction of a Harbour at the mouth of the Twelve 3 Will. 4. c.
5 Mile Creek, on Lake Ontario, under the name and style of "The President 23.
and Directors of the Louth Harbour Company," certain persons therein
named, with others who became Stockholders in the said work, im-
mediately after the passing of the Act, proceeded to expend a large sum of
money in the erection of Piers at the mouth of the said Creek, sufficient
10 to secure the reception and shelter of such craft as then commonly na-
vigated the Lake, but did not use the power and authority given them to
demand and receive tolls, from which doubts may have arisen as to
whether that Statute still continues in force: And whereas it is expedi-
15 ent that all such doubts should be removed, as it would be manifestly
unjust that the Company should be deprived of the benefit of their work
in the construction of the said Harbour: Be it therefore enacted, &c.,
as follows:—

That the said Statute of the late Province of Upper Canada, passed in
20 the third year of the Reign of King William the Fourth, chaptered twenty-
three, and every thing therein contained reserving the rights, privileges
and immunities of the said Louth Harbour Company, shall be deemed
to have been, and is hereby declared to be continued in force, any
doubts that may have arisen to the contrary in any wise not withstand-
ing.

25 II. This Act shall be a Public Act.
