burning structure, and just as the latter was exhausted a powerful stream was put on from the steam fire engine, and the danger was over.

The building in which the fire originated was precisely destroyed, and a small barn connected with it was left in the same condition. The water was so abundant that which were in good order, together with a large quantity of bottles, some household effects and other personal property stored in the place were totally destroyed, so that the loss to Mrs. Trow was considerable. It is thought the fire was incendiary origin, caused by some of the criminal idlers who loaf around the streets by day and commit some depredations upon decent citizens' premises nearly every night.

There was \$2000 insurance on the building and \$500 on the machinery, etc. destroyed. The fire commissioners and firemen deserve much credit for the prompt action which they met this emergency and the performance of the engine in sending so strong a stream so far and all the way up hill was very favorably commented on.
