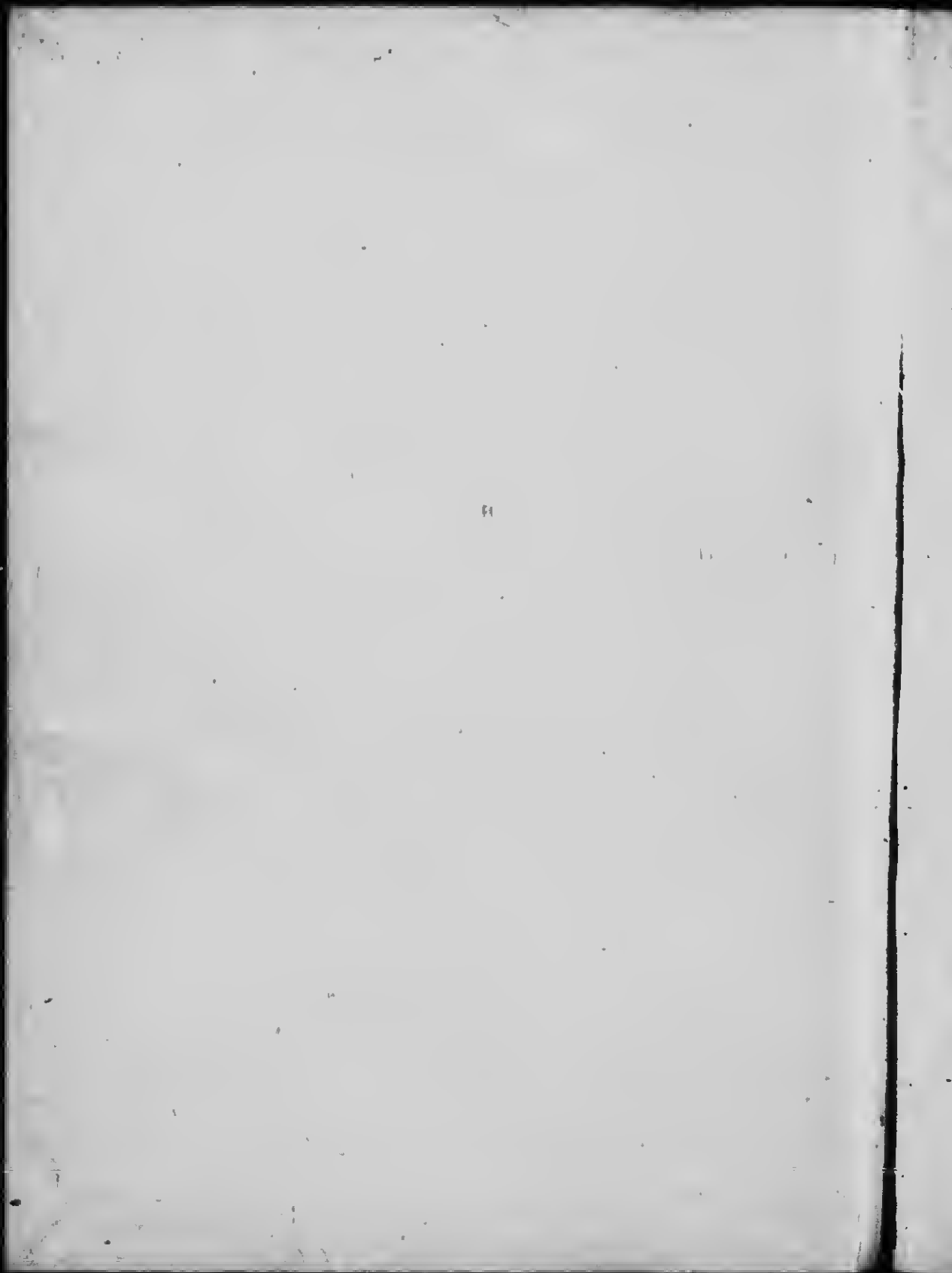
MICROCOPY RESOLUTION TEST CHART
