





REPRESENTATION TO THE

PUBLICK,

Of AFFAIRS between GILBERT BARKLY of Philadelphia, and JOHN HAY of Quebec.

In June or July 1762, Mr. Hay, at the particular Defire of Gilbert Barkly, brought with him to Pbiladelpbia, to be laid before him, a State of their Affairs in Canada, after Perulal of which, a Settlement of Accompts was made, and figned by both Parties, and a mutual Obligation executed before Witneffes paffed between them, wherein Gilbert Barkly referves the Revital of their Affairs in Canada to himfef, as the immediate Settlement was only from a floor Abftraft brought by Mr. Hay from the Books, and not faitsfactory to the faid Gilbert Barkly. Mr. Hay by this Writing was impowered to difpole of the Goods on Hand in Canada, at publick Vendue, in the Space of fix Months after the Date of the Obligation, if not fold before at private Sale, in Order to enable him to remit Gilbert Barkly a certain Sum of Money, and in End, Gilbert Barkly obliges himfelf to pay the faid John Hay Two Hundred and Forty. Pounds Quebee Currency, for his Share of Profits gained at Louifburg, which Mr. Hay agreed fhould be in full of all Demands, and that the fame fhould be deducted out of a larger Sum due to Gilbert Barkly by the faid John Hay, " in Confideration whereof Mr. Hay refigns, in Favour of the faid Gilbert at "Louifburg."

AFTER which Mr. Hay proceeds to Quebec, and when the Six Months he was limitted to in the aforefaid Obligation was expired, he went from Quebec to Montreal, fells off at Vendue all the Stock of Goods belonging to the Company on Hand at that Place, the principal Part of which bought by his own Agents for his private Accompt, and no Intelligence thereof given by him to Gilbert Barkly: In the fame Manner the Brew-houle, Diftillery, and Stock of Goods on Hand at Quebec, were fold off, with the utmoft Diligence, at Vendue, and the principal Articles bought by his own Agents for his private Accompt, and in whole Poffeffion to this Day the Diftillery and Brew-houles at Quebec and Monireal continue, out of which Subjects a very inconfiderable Sum was remitted Gilbert Barkly, though many Letters were fent, and James Skinner (my own Clerk) fent as an Express to acquaint Mr. Hay of my being in the greateft Need and Want of Money.

IN ORober 1763, the Vendue Accompts were remitted by him to Gilbert Barkly, and with them a flated Accompt Current, dated the Twenty-fixth of the fame Month, figned by Mr. Hay, and in which Accompt one Article at Gilbert Barkly's Debit flands as follows, viz. "To John " Hay's Share of Profits gained at Loui/Jourg, as agreed, to be paid him per a mutual Obligation, " figned at Philadelphia the 25th of Ollober, 1762, Two Hundred and Forty Pounds."

THE impartial World is defired to judge, after perufing this Narrative, and what has been done in Confequence of this Writing paffed between them at *Pbiladelpbia*, what Right Mr. Hay has for defiring it fhould be cancelled, or from what Motive his Counfel advifes him to demand it.

In Confequence of the juft Right Gilbert Barkly had of perufing the Books kept at this Place in Name of Barkly & Hay, he arrived at Quebec the 2xd Lay of June laft, and a few Days thereafter demanded the Books: Mr. Hay delivered him a Set of Books keeped by him/Elf, which he called his principal Books, a Set of Books keeped at the Brew-houfe in Quebec, and others keeped at a Store in the Lower-Town by George Towng, he alfo delivered Books keep'd at the Tbree-Rivers, by Brown and Sanguinet, and a Set after they left that Place keep'd by George Ricban, as alfo Books keep'd at the Brewhoufe in Montreal, and a Set keep'd by George Towng, the Gibert Barkly, with all the Attention he was Mafter of, continued to revie what was called the principal Books, and found by many concurring Circumftances that they were Books made out on Purpoie to annufe and defraud him of his real Intereft and Property: He went to Mr. Hay and told him he muft not dare to put upon him in that Manner, and demanded the real Books, which with forme Hefitation Mr. Hay delivered to him.

AFTER

AFTER which Gilbert Barkly compared the Sales of Goods in the real Wafterbooks, with those In the Walte-book given him at his Arrival, and was altonither tai walte-pook, with thore in the Walte-book given him at his Arrival, and was altonithed to find wide Strides taken to defraud him; he told Mr. Hay of this, and defired he should compare the Books with him, which was done for two Days, and fuch glaring Attempts found out, that it was reckoned ne-ceffary to poly up regular Books from the real Walte-books, and defired Mr. Hay to exert him-felf in procuring an able Books keeper for that Purpole, which he promifed to do j feverals were fpoke to, but (for what Reafon I know note some could be found to take the Tafk in Hand, at last I found one, and began the arduous Tafk. George Richan took one Year's Books in Hand, James Skinner (my own Clerk) took another Year's, and myfelf took a third. Mr. Hay was rold thet this was an 4 for of Conference to him as well as me and reputfield for him to rise his James ownner (my own Clerk) took another years, and myleit took a third. Mit. Hay was told that this was an Afair of Confequence to him as well as me, and requefted of him to give his Attention thereto; he pretended Bulinels, and modeftly proposed to me to reture to Pbiladelphia, and come back in the Winter, when he would be at Leifure to give his Attention: This modeft Requeft was not juitable to my Inclination, and as he found binnelf a Man of fuch Confequence; I defired that his Clerk, James Jodd, fhould attend, which was on Actousty granted, and has been prefer the most confiderable Part of the Time we continued at Work, which was between Six and Swam Week. Six and Seven Weeks

On Sunday Night, the Second Inftant, I paffed the Evening at the Houfe of Mr. John Ord. Merchant of this City, the Keys of my Room in which the Books and Papers lay, which was my Bed-room, in my Servant's Pocket; I came Home and went to Bed, the next Morning George Richan and James Skinner came into my Room in Order to go to Work, when they altonished me by telling me all the Books and Papers, put into our Hands by Mr. Hay, were conveyed away, as also a Set posted up by myself, and a Set posted up by George Richan out of George Name's Books Young's Books.

I BEING then in Bed, got up and dreffed myfelf, went to Mr. Hay's Room, alked him, "What could induce him to commit fuch an unprecedented Action, and requested him not to expose himself, but return the Books:" He told me, "he was not in a Condition to be spoke. with, and refused to grant my Request."

I THEREAFTER applied to John Morifon, Efq, my Counfellor, and told him the Particulars of what happened, and requested of him to apply to Mr. Hay, and tell him I was ready to refer the Affair to Six or Seven honeft Men, his own Fellow-Citizens: This was agreed to by both Parties, the Gentlemen's Names mentioned, and the Bonds of Arbitration wrote, agreeable in all Refpects to Mr. Hay's own Defire: We met at his Houfe in Order to have them ligned, and when it came to the Push he absolutely refused to comply.

Be it remembered, That on the Eighteenth Day of September, in the Fourth Year of the Reign of our Sovereign Lord King GEORGE the Third, Annoq; Domini, One Thouland Soven Hundred and Sixty-four, Beföre Me, WILLIAM GREGORY, Efquire, Chief-Justice of the Province of QUEBEC, perfonally came and appeared Gilbert Barkly of Philadelphia, Merchant, now in Quebec, and made Oath on the Holp, Evangelifit, That all and every Part, of what is com-tained in the foregoing Writing, institled. "A Representation to the Publick, of Affairs between "Gilbert Barkly of Philadelphia, and John Hay of Quebec," is just and true. And further this Department (aith mat. Deponent faith not.

Sworn before Me,

WILLIAM GREGORY, Ch: Juf:

THIS Day perfonally appeared before Me, WILLIAM GREGORY, Efquire, Chief-Juftice of the Province of Quebec, the following Perfons, George Richau and James Skinner, who folemnly, fincerely and truly declare, That there was in the Bed-room of Gilbert Barkly, Merchant of Philadelphia, who lodged in the Houfe of John Hay, Merchant in this City, the following Books, viz. A Wafte-book, Journal and Ledger, carried on in the Name of Barkly & Hay, called by John Hay his principal Books, and a Set keep?d at the Brew-houfe of this Place, a Set keep'd at a Store in the Lower-Town by George Towng, a Set keep'd at Three Rivers by Brown and Sanguinet, and after their Departure from faid Place, a Set keep'd by George Richan, as likewife a Set keep'd at the Brew-houfe in Montreal, a. Set keep'd by George Towng while he managed Bufinefs there, as alfo Accompts of Sales rendered by Francis Kaipe and George Towng, together with an Invoice-book of Importation and Exportation, keep'd by John Hay, in the Name of Barkly and Hay.

WE also had in our Poffeffion, in faid Bed-100m of Gilbert Barkly, three Walte-books and two. Ledgers, which last mentioned Set of Books we discovered, by many convincing Circumstances, to be the original Books keep'd in the Name of Barkly & Hay by the faid Jobn Hay.

Wz the faid Deponents do hereby further declare, That each of us took one of the real Waftebooks in Order to form a juft Set of Books therefrom, and *Gilbert Barkly* took the other Waftebook for the fame Purpole; and by comparing the Wafte-books first given in to *Gilbert Barkly* with the real Wafte-books, we found them dilfer in Articles and Prices: The Wafte-books of the Sets called the principal Books, being confiderably in the Sales of Goods lower than the Prices the fame Goods fold by the Wafte-books and real Tranfactions, which the Books themfelves will teffify, and which to us feemed a defigned Fraud, fong Bills of Exchange bought by *Jobn Hay* at a lower Exchange than what they were charged *Gifter Barkly* when remitted to him, which appears by the first Books delivered him, which he calls his principal Books, and many convincing Proofs of Fraud which at that Time appeared clear to us, and which we now cannot recolect.

DURING the Courfe of our pofting from the faid Wafte-books, fome Entrys appeared dark to us; Gilbert Barkly, in Order to clear up the fame, earneftly requested of John Hay (in our Prefence) that he the faid John Hay would give his Attendance to the posting of the Books, as it was a Matter of Confequence to both, which John Hay declined by pretending Businefs.

Soon after, James Todd (Clerk to the faid John Hay) came to affift us, and continued the moft confiderable Part of the Time we were at Work, which was between Six and Seven Weeks; but your Deponents finding that they had no occafion for the faid James Todd's Affiftance, acquainted Gilbert Barkly thereof, which was anfwered by him, "That it was not for his Affiftance that he " requefted his Prefence with us, but only that he might be a Witnefs of the Juftice done to the " faid John Hay in pofting up the faid Books."

ON Sunday Evening, being the 2d Inftant, we locked the Room, leaving all the Books and Papers there, James Skinner, one of your Deponents, delivered the Key thereof to John Rofs, Servant to the faid Gilbert Barkly, and next Morning, being the 3d Inftant, we went to faid Room in Order to go to Work, and not finding the Books and Papers in the Place where we left them, we afked the faid Gilbert Barkly if he knew where they were, to which he replied, " are they " not there?" We anfwered him, " they are not," upon which he immediately got out of Bed, and faid, " this is what I fulfpected," and after dreffing himfelf went out of the Room. Upon a further Search, we likewife found that a Set of Books polted by Gilbert Barkly, as alfo a Set polted by George Richan out of George Young's Books, were alfo miffing. GEOROF RICHAN.

PERSONALLY appeared before Me, WILLIAM GREGORY, Elquire, Chief-Juftice of the Province of Quebec, John Rofs, who folemnly, fincerely and truly declares, That he received the Key of Gilbert Barkly's Bed-room (in which he faw many Books and Papers lying) from James Skinner, on Sunday Evening the 2d Inftant, and that no Perion demanded the Key of him, nor had any Accels by his Permifilion till Gilbert Barkly came Home in Order to go to Bed, which was about Ten or Eleven o'Clock at Night.
