The University Club of Toronto Historical Sketch.

At a meeting of the Toronto Branch of the University of Toronto Alumni Association held on the 1st of May, 1905, a committee was appointed "to take steps toward the establishment of a club for University graduates". This committee, while unsuccessful in actually establishing a club, secured a great deal of information and did much preliminary work, which subsequently resulted in the formation of the present club.

In September, 1906, the committee above mentioned, having achieved no tangible result, a luncheon club was formed as a modest beginning from which it was hoped that a more permanent organization would finally grow. The originators of this luncheon club were:

The club met every Friday for luncheon in an upper room over what was then Phil Davey's Hotel at the south-west corner of King and Bay streets, the first luncheon being held on 12th October, 1906. Mr. S. C. Snively, Toronto, 1905, was soon after admitted to membership. On the 4th of January, 1907, Messrs. L. M. Rathbun, Toronto, 1905, and F. H. Lytle, Royal Military College, 1904, were admitted to membership, the method of election being that of the six names proposed each member was allowed to vote for two nominees, the two securing the greatest number of votes being declared elected.

On the 1st of March, 1907, the meeting place was changed to a more convenient private room at the St. Charles Restaurant, corner of

Yonge and Colborne streets, and the following new members were admitted:—

The method of election in this instance was to admit such of the twenty nominees as secured ten out of the fourteen available votes. This brought the total membership of the club to twenty-three.

On the 26th of January, 1909, at a special meeting of the members, it was decided to take a lease for one year of two rooms at 36½ King street east, arrangements having been made with the Brown Betty Tea Room, which occupied the premises above the club quarters, to serve luncheon in the club rooms.

On the 10th of February, 1909, steps were taken for the permanent organization of the club, and the

various committees necessary were appointed.

On this date there were admitted to membership by open vote:—

who had been working independently upon lines similar to those adopted by the founders of the club. Messrs. G. R. Geary and C. A. Moss were also added to the club membership by open vote.

On the 23rd of April, 1909, the club was incorporated under the Ontario Companies' Act, without share capital, the original incorporators being,

On the 27th of September, 1909, the club premises proving inadequate, a lease was taken for three years from

1st November, 1909, of the top floor of the old Canadian General Electric Building, known as Nos. 14 and 16 King street, east, Toronto, a kitchen and dining room being added to the club's equipment.

On the 29th of December, 1911, the club again moved to new premises at 82 King street, west, which were purchased. These premises allowed the equipment and operation of a club in all its branches.

The next step forward was taken in October of last year when the construction of two Squash Racquets Courts was begun, which are now in use and constitute one of the most popular departments of the club. The membership is now,

Constitution

of

The University Club of Toronto

ARTICLE I.

Name.

The name of the Club shall be
"The University Club of Toronto."

ARTICLE II.

Object.

The object of the Club shall be
the promotion of social intercourse
between the members thereof.

ARTICLE III.

Members.

(1) No one shall be eligible for
election to membership in the Club
who is not of the full age of twenty-
one years and who is not a graduate
or the holder of an honorary degree
of a University or College recognized
as being of sufficient standing by the
Committee of this Club.

(2) There shall be three classes
of members: (a) Resident; (b) Non-
resident; (c) Honorary. The number
of members of each class shall be in
the discretion of the Committee.

(3) No person shall be eligible for non-resident membership whose usual place of residence or business is in Toronto, or within twenty miles thereof, or who in the opinion of the Committee is not a non-resident of Toronto. Any non-resident member ceasing to be eligible as aforesaid, shall forthwith resign such membership, and default shall be deemed a wilful infringement of the Rules of the Club. Non-resident members shall not be entitled to vote on ballots for membership and shall not be entitled to a vote at meetings of the Club nor to notice of such meetings, but save as aforesaid shall be entitled to all the rights and privileges of members.

(4) The Committee may by the unanimous vote of those present at a special meeting called for the purpose, admit any person qualified for membership as above provided, to honorary membership in the Club for life, or for a limited period. James Brock O'Brian of the City of Toronto, one of His Majesty's Counsel shall be an Honorary Member of the Club for life.

ARTICLE IV. Visitors.

(1) Subject to the regulations prescribed from time to time by the

Committee, any member may introduce non-residents of the City of Toronto to the privileges of the Club as Visitors for two weeks, not necessarily consecutive, by entering their names in the Visitor's Book, but the same person shall not be so introduced for more than two weeks within six months. Persons introduced under this rule may not introduce or entertain any persons who are not members of the Club.

(2) Any member may introduce as a visitor a person not a member of the Club, for any meal, provided that no such person being a resident of Toronto shall be so introduced more than six times within the year.

(3) The member introducing a visitor to the privileges of the Club shall be answerable for any debt he may incur to the Club, and for any damage done by him to the Club property.

ARTICLE V.

Election of Members.

(1) The nomination of every candidate for admission to membership shall be submitted in writing to the Committee, signed by two members as proposer and seconder,

neither of whom shall be a member of the Committee and shall state the Candidate's University or College, his year of graduation and degree, his residence and his profession or occupation, and unless approved by two-thirds of the members of the Committee present at a regular or special meeting, such nomination shall be rejected.

(2) On the nomination of a candidate being approved by the Committee, the Secretary shall forthwith post such nomination on the notice board, and after the expiration of two weeks, such candidate may be voted upon by members entitled to vote. Voting shall be by ballot and the poll shall be held open at the Club House for ten consecutive days, or in the discretion of the Committee, for a longer period. No member shall cast more than one vote. In order to constitute a valid ballot at least fifty members must have voted in favour of the candidate, and one unfavourable ballot to every twenty favourable ballots shall prevent the election of the candidate. No person who has been so rejected shall be again eligible for nomination within twelve months, provided, however, that this shall not apply to any candidate who has been rejected only be-

cause less than fifty members have voted in respect of his nomination.

ARTICLE VI.

Change of Residence, Etc.

(1) Any resident member shall be entitled, if eligible, to be admitted without ballot as a non-resident member upon application; and any non-resident member, shall be entitled to be admitted without ballot as a resident member upon application and upon complying with the provisions in respect of an entrance fee required from resident members at the date of his application and upon payment of an annual fee computed as provided by section 2 hereof.

(2) If a member changes from resident to non-resident membership or vice versa during the currency of a year, his annual fee for such year shall be computed as follows:—\$3.00 per month for every month or fraction of a month of such year during which he is a resident member, plus the sum of \$10.00; provided, however that the total fee for such year shall not exceed the sum of \$30.00 if the member is a shareholder in Graduates Limited, or the sum of \$35.00 if he is not a shareholder.

ARTICLE VII.

Resignation of Membership.

(1) Resignation of membership shall be by notification in writing addressed to the Secretary, by whom it shall be submitted to the Committee at their next meeting. No resignation shall be considered until all moneys owing to the Club have been paid by the member tendering such resignation, and if the resignation is not received before the 1st of February, the annual fee for the then current year must be paid. Any member whose resignation is accepted shall cease to be a member of the Club, and shall forfeit all right or claim to its property or funds.

ARTICLE VIII.

Conduct of Members.

Any member who wilfully infringes the Rules of the Club or who is guilty of conduct in or out of the Club, which, in the opinion of the Committee is detrimental to the character or interests of the Club, or is unbecoming a gentleman, shall be liable to suspension for such period and on such terms as the Committee may think fit, or to expulsion from all the privileges of the Club; the Committee may take cognizance of

the matter of their own motion, and shall take cognizance of the same at the written request of any five members. Such suspension or expulsion shall be imposed by resolution of two-thirds of the Committee present at a meeting, the notice calling which shall have stated that the question of the Member's conduct is to be investigated. Notice of such suspension or expulsion shall at once be given by the Secretary by registered letter mailed to such Member's last known address. Such member shall have the right to appeal from such suspension or expulsion by delivering to the Secretary notice in writing of such appeal within two weeks after the mailing of such notice, and such appeal shall be to a Special General Meeting of the Club, to be called by the Committee and to be held within three weeks after the delivery of such notice of appeal; of which meeting at least seven days' notice must be given on the notice board, and also by mail to the suspended or expelled member at his last known address. If the suspension is sustained by vote of a majority of the members of the Club present at the Special General Meeting so called, or if the member suspended fails to appeal as aforesaid he shall be debarred from en-

joying the privileges of the Club during the term of such suspension. If the expulsion be sustained by vote of a majority of the members of the Club present at the Special General Meeting so called, or if the member expelled fails to appeal as aforesaid, he shall thereupon cease to be a member and shall forfeit his entrance fee.

ARTICLE IX.

Dues.

(1) Every resident member of the Club whose application for resident membership was received after the 1st of January, 1912, shall be required to purchase from the Club one share (par value \$100) of stock of Graduates Limited, such subscription to be in lieu of an entrance fee.

(2) There shall be payable to the Club by every Resident Member who is a shareholder in "Graduates Limited", an annual fee of \$35.00 in half-yearly instalments of \$17.50 each in advance; the said sum of \$35.00 to be subject to a reduction of \$5.00 if the sum of \$15.00 be paid on or before the first day of February in each year and a further sum of \$15.00 on or before the first day of August. Every Resident Member who is not a shareholder in "Graduates Limited"

shall pay an annual fee of \$40.00 in half yearly instalments of \$20.00 each in advance; the said sum of \$40.00 to be subject to a reduction of \$5.00 if the sum of \$17.50 be paid on or before the first day of February in each year, and the further sum of \$17.50 on or before the first day of August. There shall be payable to the Club by every Non-Resident Member a fee of \$15.00 payable in advance subject to a reduction of \$5.00 if the sum be paid on or before the first day of February in each year, PROVIDED, that, in the case of any person admitted to Resident Membership after the first of May, his annual fee shall be computed at the rate of \$3.00 per month for any portion of a month and remaining months of that year.

(3) It shall be the duty of the Treasurer to notify any member whose debts or obligations to the Club have remained unpaid for one month, and no such member shall be allowed to exercise any of the privileges of membership until such debts or obligations have been paid. The Committee shall adopt such rules and regulations as they may deem advisable from time to time for the payment by members of debts or obligations owing to the Club, and the

name of any member failing to pay any such debts or obligations within one month after the same are due, shall be posted in the Club. All credit shall be stopped to any member while posted. In the event of such debts or obligations remaining unpaid for three months, the Committee may by a vote of not less than two-thirds of the members present at any regular or special meeting, declare that the member so in default has forfeited his membership, and he shall thereupon cease to be a member and his name shall be struck off the list of members, provided, however, that no such declaration shall be made unless and until one month's notice of the member's default and his liability to be struck off the membership list shall have been given such member by registered letter mailed to his last known address and by posting a notice to that effect upon the Club notice board; on the name of such member being struck off the list of members as aforesaid, he shall forfeit his entrance fee and all right or claim to the property or funds of the Club, but his annual fee for the current year, if paid, shall be returned to him pro tanto and he shall be in-

eligible thereafter for membership or to be introduced as a visitor.

ARTICLE X.

Officers.

(1) The officers of the Club shall be an Hon.-President, two Hon. Vice-Presidents and a President, two Vice-Presidents, an Honorary Secretary and an Honorary Treasurer, who shall be elected by the Committee at its first meeting held after the annual general meeting. They shall hold office for one year, or until their successors are elected. All of the said officers except the Honorary President and Honorary Vice-Presidents shall be elected from the members of the Committee.

(2) The President, or in his absence, one of the Vice-Presidents, shall preside at the meetings of the Club and of the Committee. The President, or, in case he is absent or for any reason unable to act, a Vice-President, or such person as the Committee may appoint for that purpose, shall with the Honorary Secretary or the Honorary Treasurer, sign all written contracts and obligations of the Club.

(3) The Honorary Treasurer shall collect all moneys payable to the Club and keep the accounts of the Club, and report thereon whenever requested by the Committee. His accounts shall be audited annually by such person as the Committee may appoint. He shall pay all bills when authorized by the Committee. At the end of each year the Treasurer shall prepare his annual statement and submit it to the Committee for adoption. A copy thereof shall be sent one week before the Annual Meeting to each member of the Club.

(4) The Honorary Secretary shall give notice of all meetings of the Club and of the Committee and shall keep minutes of the same and a record of the names and addresses of the members. He shall conduct the correspondence and keep the records and seal of the Club. He shall notify persons elected to membership of their election and shall furnish to the Treasurer the names of all such persons.

ARTICLE XI.

Committee.

(1) The Committee shall consist of thirteen members elected at the annual general meeting or at a

special general meeting called for that purpose, and shall hold office for one year or until their successors are elected.

(2) The Committee may meet at any time without notice, if all the members be present, or if those absent signify their consent to such meeting. Special meetings may be held upon the call of the President, or of any two members of the Committee, and notice thereof shall be sufficient, if delivered or mailed by the Secretary to each member thereof at least one day before the meeting is to take place. Regular meetings of the Committee shall be held weekly on such days and upon such notice as the Committee may from time to time appoint. Five members of the Committee shall form a quorum.

(3) The Committee may fill any vacancies in the Committee that may occur during the year.

(4) The Committee shall have general charge of the affairs of the Club; and they shall report to the members at the Annual General Meeting as to the matters within their charge, and in particular as to the finances of the Club. They shall have power to appoint sub-committees and to depute to them such

powers and duties as to the Committee may seem advisable.

(5) The House Committee and all other sub-committees shall in all respects be subject to and report to the Committee who shall decide all questions as to their duties, powers and jurisdiction, and who may at any time control their action. Subject, however, to this, their decisions shall be binding upon the members of the Club. Vacancies arising in any sub-committee shall be filled by the Committee forthwith.

(6) The House Committee shall consist of three members to be elected by the Committee. The House Committee shall have charge of the management of the Club House and of the enforcement to their rules and regulations relating thereto, and shall have power to make rules relating thereto.

(7) The Committee may appoint a Secretary at such remuneration and on such terms as the Committee may deem advisable and may delegate to such person such powers as the Committee may deem advisable.

(8) The Committee may from time to time make rules and regulations in respect of the management of the

Club premises and the privileges to be enjoyed by members, and more particularly (but not restricting the generality of the powers hereby conferred) in respect of the following:—

- (a) The admission of visitors.
- (b) Hours during which the Club shall be open, and during which meals and liquors shall be served.
- (c) Cards and billiards, including use of card and billiard rooms.
- (d) Use of private dining rooms.

The Committee may vary or repeal such rules and regulations from time to time, and all such rules and regulations while in force shall be posted in the Club and shall be binding upon all members of the Club.

ARTICLE XII.

Meetings of Members.

(1) The Annual General Meeting of the members shall be held as the Committee may appoint, on the Second Monday in February in each year, or on such other day in the months of February, March or April as the Committee may appoint.

(2) Special general meetings of the members, may be called at any time by the Committee; and the Committee shall, on the written re-

quisition of twenty-five members, stating the object of the proposed meeting, call a special general meeting.

(3) Notice of the time and place of holding the annual or any special general meeting shall be given at least ten days previously thereto by posting a notice in the Club House and by mailing a copy of such notice to each member at his last known post office address.

(4) Twenty members shall constitute a quorum at an annual or special general meeting.

ARTICLE XIII.

Changes in Constitution.

(1) The Committee may by a vote of two-thirds of the members present at a regular or special meeting repeal, vary or rescind any article or section of the Constitution of the Club or enact new articles or sections, but any such change, unless in the meantime confirmed by a two-third vote of the members present at a special general meeting, shall have force only until the next annual general meeting, and if not then confirmed by a vote of two-thirds of the members present shall from that time cease to be in force.

(2) Notice in writing of any change in the constitution of the Club to be proposed at the annual or any special meeting must be left with the Secretary at least five days, and must be posted in the Club House at least three days before such meeting.

(3) No change shall be made in the constitution of the Club, other than as provided for by Section 1 hereof except by a vote of two-thirds of the members present at an annual or special general meeting.

HOUSE RULES
of the
UNIVERSITY CLUB OF TORONTO.

1. Hours of Opening and Closing.

The Club House shall be open for the reception of members on weekdays from 7.30 o'clock a.m. until midnight, and on Sundays from 8.30 o'clock a.m. until midnight.

2. Dining Room.

Meals will be served at the following hours:—

Breakfast	7.30 a.m. to 9.30 a.m.
Luncheon	12.30 p.m. to 2.00 p.m.
Afternoon Tea,	4.30 p.m. to 6.00 p.m.
Dinner	6.30 p.m. to 8.00 p.m.
Supper	8.00 p.m. to 12.00 p.m.

Meals may be arranged for at other hours on giving one half hours' notice to the Steward.

No meals except afternoon tea shall be served in any part of the Club House except the dining-room, or a bed-room in case of illness.

Members are requested not to smoke in the dining-room between the hours of 12.30 and 2.00 p.m., and 6.30 and 7.30 p.m.

Members must write out and sign their own orders for meals and on

no account employ a waiter to do so.

The exclusive use of a private dining-room or of the main dining-room may be secured by arrangement with the House Committee. The member making such arrangement shall be personally liable for all debts incurred on the occasion for which the room has been engaged.

3. Bar.

No member shall purchase liquor for any other member except in the dining-room at meals.

On any day, or during any hour, when by the Liquor License Act in force in Ontario, the sale of liquor is prohibited in the City of Toronto, no member shall purchase any spirituous liquor for a visitor except at meals.

No member shall at any time purchase spirituous liquor for a guest under the age of twenty-one years.

4. Reading Room.

No periodicals shall be removed from the reading room except after 6.00 o'clock p.m.

Silence is requested in the reading room.

5. Guests.

A guest book shall be kept in which shall be recorded the name and ad-

dress of each guest introduced, the name of the member introducing him, the date of the introduction, and the extent of the privileges accorded him.

No guest shall be present at any business meeting of the Club.

The privileges extended to any guest may be withdrawn at any time at the discretion of the Committee.

No guest shall be introduced who is under the age of sixteen years.

The attention of the members is directed to Article 4 of the Constitution respecting the introduction of visitors.

6. Servants.

The giving of fees or gratuities to any servant by any member or guest is absolutely prohibited, and subjects the servant accepting the same to instant dismissal.

No servant shall be sent out of the Club House by any member or guest on any errand. Messengers will be obtained on application to the steward.

7. Games.

Regulations for the use of the billiard-room, card-room, squash rac-

quets courts, and swimming-pool, shall be made by the Amusement Committee.

No card or billiard playing shall be allowed in the Club House on Sunday.

8. Bed Rooms.

The bed-rooms of the Club are intended for the use of members, and are not supposed to be occupied by the same person for more than a limited period. The regulation of this department of the Club is entirely under the control of the House Committee who may at any time ask a member to vacate his room. The charge for rooms may be regulated by the House Committee from time to time.

9. Advertisements.

No advertisement, notice or pamphlet shall be displayed in the Club House except by permission of the House Committee.

10. Dogs.

No dogs shall be permitted in the Club House.

11. Complaints.

Servants must not be reprimanded by a member. In the event of any fault being found in any department, a complaint should be made in writing to the House Committee.

12. Injury to Club Property.

Property of the Club injured or destroyed must be paid for by the member responsible, and the amount to be paid will be determined by the House Committee.



RULES GOVERNING THE USE OF THE SQUASH RACQUETS COURTS.

1. Playing Periods.

On Saturdays and Holidays engagements of courts are limited to half an hour.

On other days engagements are limited to half an hour during the following periods: 12 noon to 2 p.m. and 4 to 7 p.m.

Provided that in the event of a Court not being previously engaged for any half hour, the players using the Court for the previous half hour may, before entering the Court, extend their engagement to one hour.

2. Engagement of Courts.

The Courts may not be engaged earlier than the day preceding the day of play, but for strictly Tournament games, advance engagements may be made to any reasonable extent.

The names of both players must be entered on engagement sheet before commencing play.

Engagements may be made by telephone at the risk of the player.

3. Punctuality.

A Court not occupied within ten minutes of commencement of period for which engaged may be used by other players, in which case the use of Court will be charged proportionately. If not used by other players those engaging Court will be charged for full period.

Players must stop punctually at the expiration of period for which Court was engaged. Notification will be given by bell when period has expired.

4. Charges.

The charge for the use of Courts including showers and plunge, is 25c. for each player for each period of half an hour.

5. Lessons.

The Professional is not permitted to give lessons between the hours of 12.30 and 2 p.m. nor between 5 and 7 p.m.

The charge for lessons is 50c. per half hour. This includes the Court fee.

6. Playing.

The Professional is not permitted to play with members between the

hours of 12.30 and 1.30 p.m., nor between 5.30 and 6.30 p.m.

The charge for playing the Professional is 75c. per half hour. This includes Court fee.

7. Racquets and Balls.

may be obtained from the Professional.

8. All Charges.

for supplies, lessons, and playing are payable to the Club. The Professional is paid extra for each lesson and each "playing" period, and members are requested to refrain from giving fees or gratuities of any kind direct to him.

9. Rubber Soled Shoes.

Only persons wearing rubber-soled shoes may enter the Courts.

10. Special Meals.

Players are requested to order luncheon or dinner before entering the Courts if desired outside the following hours: Between 12.30 and 2.30 and between 6.30 and 8.00.

PLAYING RULES.

1. All matches shall be the best three out of five games.

2. The game shall be "fifteen up"; the first server to be decided by the spin of the racquet.

3. If the server loses a point he shall also lose the hand. Every point won by either player shall add one ace to his score.

4. At "thirteen all" the outplayer may set to three or five, and at "fourteen all" to three.

5. The ball shall be served alternately right and left, beginning on whichever side the server elects.

6. The server must stand with at least a part of one foot in the "service box" and serve the ball over, but not touching the line on the front wall and returning within the lines of the proper service court, i.e., the court opposite the server, otherwise it is a fault.

Serving a double fault, missing the ball, striking the telltale or any other part of the court before reaching the front wall, or hitting the back wall on the volley in or above the netting is a hand out.

The outplayer may not play the first fault of a double fault.

7. A ball, to be fair, must be struck before or on the first bound and be

returned to the front wall on the volley above the telltale, and must not touch the ceiling, the gallery, or any wood, iron or netting not a part of the court itself, before or after reaching the front wall.

8. Until a ball has been touched or has touched the floor twice, it may be struck at any number of times.

9. Only a player to whom a ball is served may return it.

10. A ball touching either player before the second bound loses an ace for the player touched.

11. If a ball, after being struck and before touching the front wall, hit the striker's or adversary's racquet, or any part of his body above or on the knee, it is a let, and shall be played over, if below the knee it counts against the striker.

12. Every player must keep out of his adversary's way. If, in the opinion of the referee, the striker is interfered with in any way by his opponent, in striking the ball, he must call the point a let and not wait for an appeal.

When a "hinder" appears to the referee to be deliberate or intentional, the player making the "hinder" shall

lose one ace from his score and also the hand if he is to be the server.

13. If a ball hit in or above the netting on the back wall on the volley it counts against the striker, if it hit in or above the netting after touching the floor it counts a let.

14. If the ball breaks during a play the point shall count as a let and be played over.

15. At any time when not in actual play a new ball may be substituted by mutual consent of contestants or by appeal to referee.

16. The referee's decision on all questions referred to him shall be final. No appeal can be made on the service.



BILLIARD RULES AND REGULATIONS.

The charges for the use of billiard tables shall be as follows:—

For ordinary billiards at the rate of 40 cents per hour, with a minimum charge of 20 cents.

For Life, Pyramid, Pin or Snooker Pool, 5 cents per player per game.

From 12.30 to 2.30 p.m. members may play only one half hour, and at other times only one hour if other members are waiting to use the table.

Tables may be reserved in advance for Tournament games only.

The attention of members is called to the Rule in all games of Billiards or Pool requiring a player to have one foot on the floor when playing. Shots made otherwise are foul and are absolutely prohibited.

Injury to Billiard Tables, Furnishings, Balls or Cues will be charged to any member causing same.

CARD RULES and REGULATIONS.

The charge for cards except for Bridge shall be forty cents per pack for new cards and twenty cents per pack for seconds.

The charge for cards for Bridge shall be ten cents for each player per sitting for new cards and five cents for each player per sitting for seconds.

The cards shall remain the property of the Club, except when sold as second-hand cards to members, to be taken out of the Club House.

Members must sign for cards on receipt of same.

The stakes must not in any case exceed:—

Bridge, including Auction Bridge, 1/2 cent points.

Draw Poker, 25 cent limit.

Stud Poker, Loo, and other round games of any kind for stakes are strictly prohibited.
