

An Act to separate the front of the Township of Escott from the front of the Township of Yonge for Municipal and other purposes.

Received and read, first time, Tuesday, 8th March, 1859.

TORONTO:

An Act to separate the front of the Township of Escott from the front of the Township of Yonge in the United Counties of Leeds and Grenville, for Municipal and other purposes.

WHEREAS certain of the inhabitants of the Front of the Township Preamble. of Escott have represented by their Petition that their union with the Front of the Township of Yonge greatly retards the improvement, interest, and prosperity of Escott, and have prayed for an Act to dis-5 unite and separate the Front of the Township of Escott from the Front of the Township of Yonge, and to erect the same into a separate Municicipality; And whereas it is desirable to grant the prayer of such Petition; Therefore Her Majesty, &c., enacts as follows:

I. Upon, from and after the first day of January next after the passing After 1st Jan. 10 of this Act, the Front of the Township of Escott shall be disunited and the front of separated from the Front of the Township of Yonge; and the broken separated from front and first, second, third, fourth, fifth and sixth concessions of the the front of said Township of Escott, together with the Islands in the River St. Law- Yonge, and to rence in front thereof, shall for all municipal and election purposes, form Municipality. 15 and become a separate and independent Township and Municipality, to be called "The Township of the Front of Escott," and shall be such separate Municipality for all municipal, school, judicial and other purposes whatsoever, in the same manner to all intents and purposes as though the said Front of the Township of Escott.had never formed part 20 of the "Front of Yonge and Escott," and shall enjoy and exercise all the rights, powers, and privileges conferred by any Acts or Laws whatsoever upon Township Municipalities in Upper Canada.

II. The front of the Township of Yonge, as heretofore constituted as The front of part of the Municipality of the "Front of Yonge and Escott," shall, on Yonge to be 25 and after the said day, constitute a separate Township Municipality, by the name of the "Township of the Front of Yonge," and shall enjoy and exercise all the rights and privileges conferred upon Township Municipalities by the Acts and laws in force in Upper Canada.

III. The fifty-ninth, sixtieth, sixty-first, sixty-second, sixty-third, and Provisions of 30 sixty-fourth sections of the Act respecting the Municipal Institutions Municipal Act to apply as of Upper Canada shall apply to the dissolution of the union between to present the said Front of Yonge and the said Front of Escott, the Front of debts and Escott being reckoned the Junior Township, and the Front of Yonge obligations. the Senior.

IV. For the purposes of the first Municipal Elections after the passing Who shall be of this Act, the Town Clerk for the Front of Yonge and Escott shall returning officers in first act as Returning Officer for the Front of Yonge, and the Reeve of the Municipal

Elections in the new Townships. They shall of Collector's Rolls.

Front of Yonge and Escott shall act as Returning Officer for the Front of Escott; and the said Town Clerk and Reeve respectively, shall procure, for the purpose of such election, the necessary copies of so much procure copies of the Collector's roll of the Front of Yonge and Escott as relates to the inhabitants of the said new Townships respectively, as constituted by this Act; and the first Municipal Election for the Front of Yonge shall be held at such place in that Township as the Returning Officer therefor shall appoint, by public notice, posted up at not less than four public places in the Township, at least ten days before the election; and the first Municipal Election for the Front of Escott shall be held at such 10 place as the Returning Officer therefor shall appoint in the manner aforesaid.
