REUNION EXTRAORDINAIRE DES MINISTRES DES AFFAIRES ETRANGERES

Texte de la déclaration du Secrétaire d'Etat aux Affaires extérieures du Canada, l'Honorable Paul Martin:

On se rappellera que j'ai suggéré, il y a deux ans, de profiter de la présence de nombreux Ministres des Affaires étrangères aux Nations Unies durant la première partie de l'Assemblée Générale pour tenir une réunion qui leur permettrait d'étudier les problèmes importants communs à tous les pays à ce moment.

Le Secrétaire Général a insisté pour que l'on réalise ce projet au cours de la présente Assemblée Générale et je désire appuyer cette proposition avec force.

La plupart des Ministres des Affaires étrangères ne participent aux travaux de l'Assemblée que durant quelques semaines. La majorité vient présenter un exposé lors du débat initial. Seules ont lieu quelques discussions bilatérales; jamais n'ont-ils, comme groupe, l'occasion d'échanger leurs points de vues sur les problèmes cruciaux.

Des problèmes angoissants agitent le monde à l'heure actuelle et les Nations Unies ne peuvent les ignorer. J'ose espérer que les Ministres des Affaires étrangères pourront, au cours de la présente session, donner suite à la proposition soumise actuellement par le Secrétaire Général.

The first part of the report deals with the general situation of the country and the progress of the work during the year. It is followed by a detailed account of the various projects and the results achieved. The report concludes with a summary of the work done and the plans for the future.

The second part of the report deals with the financial situation of the organization. It gives a detailed account of the income and expenditure for the year and shows how the funds have been used. It also includes a statement of the assets and liabilities of the organization at the end of the year.

The third part of the report deals with the personnel of the organization. It gives a list of the staff and their duties and also a list of the volunteers who have helped in the work. It also includes a list of the names of the members of the organization and their addresses.

The fourth part of the report deals with the work done during the year. It gives a list of the various projects and the results achieved. It also includes a list of the names of the people who have been involved in the work and a list of the names of the organizations that have supported the work.

The fifth part of the report deals with the future plans of the organization. It gives a list of the projects that are planned for the next year and the resources that will be needed to carry them out. It also includes a list of the names of the people who will be responsible for the work and a list of the names of the organizations that will be asked to support the work.

The sixth part of the report deals with the general conclusions of the work done during the year. It gives a list of the main achievements and the lessons learned from the work. It also includes a list of the names of the people who have been involved in the work and a list of the names of the organizations that have supported the work.
