BILL.

An Act to amend the Act incorporating the Peel General Manufacturing Company.

WHEREAS the "Peel General Manufacturing Company" have, by Preamble.
5 their petition, represented, that to carry out the objects of their
incorporation an amendment of their Act of Incorporation is required,
so as to enable any person or body corporate, owning lands in the
Township of Toronto, in the County of Peel, to sell, dispose of and
convey such lands as may be required by the Company for its use and
10 occupation, and to take stock in the said Company in payment in full
or in part for the land so required, sold and conveyed to the Company,
and have prayed that such amendment should be made, and it is expedient
to grant the Prayer of the Petitioners: Therefore, Her Majesty,
by and with the advice and consent of the Legislative Council and Assembly
of Canada, enacts as follows:

15 1. Any person or body corporate owning real estate or other property
in the Township of Toronto, in the County of Peel, the possession of
which would be desirable for the Company for its use and occupation,
may sell or dispose of the same to the Company, and may take paid up
20 stock for the same of the Company in payment therefor, or as may be
agreed upon, any thing in any Act of Incorporation to the contrary
notwithstanding.

Company may pay for real estate, &c., with paid up stock.
