## Allied Government Will Make Declaration.

### British and French Have Reached Agreement--May Day Almost Quiet in Paris--Reds Demonstrate in Toronto the Loyal.

#### AN AGREEMENT REACHED.

LONDON, May 1.—The British and French Governments have reached an agreement on how to deal with Germany to compel payment of reparations and exact immediate guarantees. In broad outline it is agreed that the Allies will make a declaration to-morrow, but not to Germany. They will announce that the Reparations Commission will notify Germany as to the amount she is required to pay and how it is to be paid, together with the proposed financial controls. The Allies will then announce that within ten days, this period being subject to possible modification by the Supreme Council to-morrow, they will proceed to carry out the penalties if the terms are not accepted. The plan provides for a competitive scheme of supervision and control of Germany's sources of revenue. It is not yet completed, but while the experts are still working on it, France will proceed with all her military preparations for the occupation of the Ruhr Basin. The French Government will, to-morrow, order the mobilization of one additional class. This is the general result of an agitated day of conversations and conferences that seemed likely to end in sharp disagreement among the Allies. The agreement was brought about by the intervention of the Belgian Foreign Minister, M. Jaspar, at the meeting of the Supreme Council this afternoon. The whole subject will come up for discussion again at another meeting of the Council to-morrow morning. Both sides feel that they measurably succeeded in having their policies accepted. The French Parliament is not in session, as M. Briand was able to accept a short time extension without having to explain to the Chamber forthwith, while Lloyd George has satisfied to the same degree, opposing liberal opinion. The French Premier asked the British naval co-operation, suggesting the blockade of Hamburg. The British Prime Minister replied that public opinion in the United States would not approve of such course, and he could not agree to a blockade which would bring the Allies into controversy with the United States. M. Briand agreed to this point of view. He added that the course of the United States had been absolutely correct. Unanimous still exists among French delegates over the possibility that Washington may endeavor to mediate, they declare this is not their desire, but some of the delegates have made it understood that it does not originate with French Ambassador M. Jusserand.

#### FRANCE IS WORKING.

PARIS, May 1.—The first of May with its traditional revolutionary demonstrations, passed to-day with probably less excitement than an ordinary Sunday. There were fewer than the usual number of arrests for minor infringements of the law in the city and not a single case of disorder was reported throughout any other portion of France. In Paris Labor Headquarters closed shop at noon, when it was found that few workers were coming there to have their cards punched, in proof of the fact that they were not working to-day. Generally the only idlers were those persons in trades that never carry on work on Sundays. There were Red flag parades in a number of cities, but these had few spectators. Most of the populace throughout the country enjoyed to-day in picnicking.

#### MAY DAY IN BRUSSELS.

BRUSSELS, May 1.—May Day demonstrations throughout Belgium were carried out without any disorders.

#### KNOX PEACE RESOLUTION.

WASHINGTON, May 1.—The first step of the Harding Administration toward placing the United States on a technical legal basis of peace was taken last night by the Senate in adopting the Knox Peace resolution. The resolution now goes to the House with prospects of prompt action there. It would repeal war resolutions affecting Germany and Austro-Hungary, release enemy property, reserve to United States all rights and privileges under the Treaty of Versailles, and other peace treaties.

#### NO NEW DEMAND.

WASHINGTON, May 1.—Denial was made at the State Department yesterday that any new demand had been sent to Russian Soviet authorities re prisoners in Soviet Russia. The Department has insisted, however, the release of prisoners, but it has refused to deal directly with the Soviet authorities. A despatch from Riga on Saturday said United States Government had demanded the release of U. S. Citizens held prisoners in Soviet Russia.

#### LOCKED OUT WORKERS.

CHICAGO, May 1.—The lock out, declared by employing associations in the building trade, summarily stopped work on approximately thirty-five million dollars worth of construction work yesterday. More than ten thousand workers were affected.

#### REDS IN TORONTO.

TORONTO, May 1.—Two hundred men gathered in Queen's Park Saturday afternoon at a "Red" meeting which was orderly, but strongly critical of the local authorities for having used police to scatter a crowd of local unemployed from in front of the City Hall, one day last week. Followers were present in large numbers at the Queen's Park meeting. Mrs. Joseph Knight, one of the local leaders of the "Reds," offered for sale some book, including, "Lenine, his life and works," "Left wing of Communism," by Lenine, and "Red Menace" by Isaac Macbride.

## Running a Railway.

Editor Evening Telegram.  
Dear Sir.—In my last letter I said that the importation of engines and cars was unnecessary, and in this letter I will try to show why I said it. If the owners of your paper should find that their press is not looking after all the business offerings, they, like good business men, will first ascertain whether the press is being worked to its full capacity. If not, they will see that it is made to do so, and if they find after speeding up the press, that it can handle all the business offerings there will be no need of buying a new one. The foregoing illustrates in a crude way that which the Government should have done before spending such a huge sum on the purchase of new equipment for which there is no necessity. The trouble with the railroad is not lack of engines and cars, but lack of management. Let me give a sample of it. When an order is given to start a train, the first thing you have to do is to shift about 30 cars a half dozen times in order to get the cars that you are going to take with you. This uses up 4 or 5 hours. Now having got the train made up, you back or pull up to the station for your running orders, but instead of getting your running orders, you are told to put the train in the siding, because a work train had been dispatched with orders giving it the right of track over a stretch of road that you required to pass over. You are now forced to wait another 3 or 4 hours until the work train gets in. When it arrives you will get your running orders, and perhaps a crossing order, which will in all probability delay you another two or three hours on a crossing point, so that from the time you were first called to take out the train until you arrive at your destination, 30 or 35 hours might have elapsed. Now, had both trains been managed in the proper way, the engine that required, say, 30 hours to make the run, could, under proper management, have traversed this section of the road 3 times, which would mean the same thing as if you had three times the number of engines, or in other words, one engine would do as much work as three engines. As I have already said, it is not lack of engines that is the trouble, but the improper way in which engines are handled. We have more engines for the traffic handled than any other railroad in the world, but the reason we do not do as good as other roads is because those roads keep their engines rolling while we keep ours waiting. What has been said about engines applies also to cars, for it is clear that if the capacity of our engines is reduced by two-thirds, the usefulness of the cars is reduced in like ratio, as we cannot run with our cars unless we have the engines to pull them. The foregoing is about the usual course of events on the railroad. Of course, it is not always work trains that cause the delay, sometimes the delay is due to crossing two 10-car trains on a siding that can only hold one car and engine, etc.

#### STAMBEES FREED.

BLOCK ISLAND, R.I., May 1.—The Portuguese steamer Mormugud started for New London late to-day under her own power, after having been floated by tugs from the West side of Block Island, where she grounded in heavy fog on Friday last. She was accompanied by several tugs. Her forehold was flooded from a hole torn in her side when she struck rocks, but it was thought she would have no difficulty in reaching New London.

#### TWELVE MILLIONS NOW DUE.

PARIS, May 1.—The Reparations Commission to-day made public its note to the German War Burden Commission on reparations. The communication, which is dated May 1, informs the German Commission of the intention of the Reparations Commission to establish within the shortest time possible, the amount of damages for which Germany owes reparations under the Treaty of Versailles. Meanwhile without prejudice to the foregoing accounting, the Reparations Commission notifies the War Burden Commission that twelve million marks in gold are due to-day. The note is signed by Louis Dubois, President of the Reparations Commission, and M. De Lacroix, former Premier of Belgium.

#### WITHDRAWN FROM PERSIA.

RIGA, May 1.—A wireless message from Moscow announces the withdrawal of the British from Persia. A Russian diplomatic mission has arrived in Teheran, the Persian capital, the message adds.

#### IMPEDENCE ADDED TO INJURY.

BERLIN, May 1.—The German Government does not propose to get into touch with the London Conference while awaiting President Harding's answer to the German proposal. This declaration was made today by a member of the Government, who in discussing the rumor that a suggestion was coming from the Entente that Germany present fresh counter proposals direct to the Supreme Council at London, said, "So long as the door to Washington is open to us we do not propose to knock at our doors."

#### BELGIUM'S REPARATIONS PLANS.

LONDON, May 1.—A plan for the reconciliation of British and French views with regard to steps to be taken to enforce payment of reparations by Germany, was submitted by M. Jaspar, Belgian Foreign Minister, at a meeting of the Supreme Council this afternoon. This plan now is under consideration by the British Cabinet. British experts and other delegations, and will be further discussed at 11 o'clock on Monday morning. The plan would allow France to continue her preparations for penalties to be applied in view of the failure of Germany to comply with the terms of treaty with respect to reparations and war criminals, and at same time would meet the British view that Germany should be given a short extension of time to meet the Allied terms and give guarantees.

#### Lake Wonderful.

Lake Eyre is one of the wonders of the Australian continent, according to a Sydney paper. The district is actually below the level of the sea, yet in the near neighborhood of the lake are some fine springs of water that may be considered fresh in that cattle will drink from them. So, too, can drovers, though the water has a medicinal effect which prejudices them in their appraisal of its value.

In the centre of the lake is an island of rare beauty. A legend is that, many years ago, perhaps when the first droving party (Dr. Black's) took cattle through to his northern territory one of the more daring of the party of white men, unheeding the warning of the blacks that an old man debilitated lived in the lake, and fed on men who ventured into the water, undertook to get to the island.

He started away on horseback, but did not return. The blacks, who had mysterious means of communication, gave it out that his horse had made the island, where the animal was seen by some of them long after the cattle party had gone. That proved the legend as far as they were concerned.

One of the peculiarities of the water of the lake is that it will preserve anything thrown into it. It is exceedingly buoyant. Stones thrown into it do not sink.

It may be as stated that some of the stones—the kind that does not sink—would probably float in any kind of water, being pumice of the lightest variety, almost sponge in texture.

right to cry halt. There are other ways to make a showing—and it would show up on the credit side of the balance sheet, too,—than painting gilt letters across the tenders. Such a showing as this will never increase the tractive power of the engine or reduce the coal bill by one cent. It is no profit to a railroad to see an engine going along all "dolled up" with paint and gilt, if that engine is burning 1 to two tons of coal more than it should burn. What we need is the greatest tonnage hauled at the least expense, and we will never get this while attention is given to such things as gilt and paint. We would ask the Government to look into matters, but to do so is the same as asking the officials of the road to do so. The Government is powerless to do anything. It is bound hand and foot by the new deal. Not only this, but there is a rolling hitch around the necks of some of the Government officials, and they must move in what ever direction the string is pulled. In view of this is it any wonder we are paying for railroad material which we do not need?

## Haunted Royalties.

Uttering the words "Venit, iudicet vivos et mortuos," (Judgment, I come, judge the quick and the dead; I come for judgment), is glided away from them, disappearing quite inexplicably in one of the ancient archways.

On another occasion, far more recently, it revealed itself to one of the princesses of the late Royal House during her sojourn in the Castle of Neuhans, Bohemia. She was standing before her mirror one evening, trying on a new robe, when, wanting something, she called to her attendant.

In response there was a shuffling movement in the rear of the room, and, turning round to ascertain the cause of it, the princess perceived the figure in the white, with the face of someone long dead.

descending the staircase of his headquarters one morning, he met a figure slowly ascending with its head very much bowed.

On approaching the Tsar, the figure suddenly looked up, and Nicholas then perceived, to his consternation, the exact counterpart of himself, but with this difference—the countenance revealed to him was that of the dead and not of the living.

Italy's Waving Flame.  
The Royal Family of Italy are reported to possess several ghosts, one of which takes the form of a man's head, which is seen looking through a doorway whenever the death of a prince or princess is going to occur.

Another of the ghosts is the shadow of a gigantic plume that is seen waving to and fro on the wall or floor prior to a Royal death, or some very grave catastrophe.

It was alleged to have appeared during a banquet at which the late king, Victor Emmanuel, was present, and to have been seen by everyone there, saving the monarch himself, who died within a week of the event.

Denmark has a very unpleasant royal ghost, that of a prince who murdered his brother in circumstances of almost unparalleled savagery even in those times. For that and other offences he was buried in unconsecrated ground near the Wood of Poole, which his spirit even now haunts in a guise so terrible that those who see it sometimes go mad with terror.

It was reported to have appeared to a number of soldiers prior to the Schleswig-Holstein War of 1866, and again to servants of the Royal Family before the death of the late king.

Another Danish Royal phantom is that of Valdemar IV, that haunts the Forest of Gurro, near Helsingfors. This ghost is alleged not to have any particular significance, excepting if it shows itself to anyone connected with the Royal Household, when its appearance must be taken as a portent of ill to the nation, and to the Royal Family in particular.



**"Salting" the Country.**

Early in the present session of the House of Assembly it developed in reply to a question put by the Leader of the Opposition, that a cargo of salt on Government account had been imported in a foreign steamship, and paid for out of the Public Treasury, being subsequently delivered or transferred to a business concern for either consignment or storage. It further developed, according to the Report of the Auditor-General that the value of the greater portion of this salt had not been paid for by the concern which took it over, the indebtedness to the Surplus Trust Fund being in the vicinity of Sixty-one Thousand Dollars. The discussion following upon this little bit of scandal is too fresh in the public mind to need repetition or comment, but the point to be observed is that there is an outstanding sum due the Government on account of this salt of Sixty-one Thousand Dollars, and so far as official information given in the House goes, there has been no payment made to date. It was had enough to purchase this cargo of salt out of public moneys without authority, but it is infinitely worse to have it become a charge on the public accounts, with the possibility of a dead loss having to be written off. There is no precedent for any transaction of this nature. Never before was it heard of, and the men who are responsible should be driven from public life and politically pilloried for all time.

The half million dollars taken from the public funds to purchase fish last fall, this salt business, appears to have been wholly to serve the interests of the North. The South and West did not participate in any of the benefits to Northern fishermen, accruing from the purchase of fish and salt with Government capital. On the contrary these sections were penalized in every possible way, their trade held up and ultimately strangled, commercial prospects ruined and the business fabric, erected after a struggle of years, entirely destroyed, and Western representatives stood by and saw this being accomplished without a murmur of protest. Neither did they raise their voices loud enough to be heard in condemnation of the salt deal, which appears now to have entered upon an entirely new phase. It is claimed that the salt cargo of s.s. Tuckahoe has not been sold outright. Only a portion of it, payment for which was made some considerable time after the transaction had been made the subject of a question in Parliament. The payment to the shippers of this salt—German it is alleged, as the salt came from Hamburg—is the Treasury was entirely irregular and illegal, and was evidently made on the instructions of some Minister of the Crown only, instructions that were most reprehensible and mis-

chievous, opening as they did avenues for further improper expenditure. The balance of the salt—unsold, obviously, as it is not paid for—is at Port Union, and the deeper the probe is put into this matter, the more involved it seems to become. The Prime Minister owes a duty to the country at large in this connection, and if he be sincere, should have a Select Committee of the Whole House appointed to thoroughly investigate this transaction and make a report thereon. "Salting" the country is a dangerous practice.

**Returned After Winter Work.**

**DID WELL IN LUMBER WOODS.**  
By the Kyle on Thursday last some 90 or 100 men who were employed in the lumber camps at Cedar Bay on the north side of the St. Lawrence River returned to Port aux Basques on the way to their homes in different parts of the country. The men had been at work all winter being engaged last fall by an agent of the Franklin Pulpwood and Lumber Co. at \$30.00 a month, but with overtime the average wage was about \$180.00. On Saturday the following men arrived here by express:—H. Cunningham, T. Thomas, A. Keon, T. Collins, W. Murray, J. Butler of St. John's and M. Mosey, M. Kinsella, E. Caswell, T. Goss of Torbay. The men speak highly of the treatment accorded them by the Franklin Co. and intend going with them again next season.

**At George St. Church.**

Two laymen engaged the attention of the congregation at George Street Church last evening. The subject was "Christian Missions." Mr. H. N. Burr, as Chairman, dealt with the past, present and future of the subject, considering the debt of the past, the opportunity of the present and the promise and hope of the future. His treatment of the subject was dignified and forceful and in his office of Chairman he gave a fine setting to an interesting and profitable service.  
The Speaker of the evening was Mr. Watson, of the Grenfell Association. He is a College man with a Y.M.C.A. training. A man of good physique and pleasant manner, he has a fine capacity to enforce and inspire. It is from his class that the best leaders of thought and action are secured in Canadian and American life. Our own hope of the future must depend largely on the development of such a type among our young men. This is the first time Mr. Watson has met a large public audience in this country and he will be welcome again. His treatment of his subject showed a wide range of knowledge of people and their habits, especially of those far removed from us and of the effect wrought upon them by the introduction of the Christian religion. He had the different types of people about whom he spoke illustrated by the appearance in native garb of representatives of the various people of foreign lands.  
The Missionary Anniversary was thus fittingly and effectively recognized by this church. The thought of the day was introduced and impressed in a very able sermon in the morning by Rev. D. B. Hammon, B.A., whose discourse included a recognition of the world-wide questions involved by present-day conditions of the nations. In both these addresses the outlook and the whole consideration was greatly enhanced and clarified by the broad and inclusive display of thought that was brought to bear upon the subject.

**Motor Car Stolen.**

Last night a motor car owned by Sir Michael Cashin, was stolen from the yard of the R. C. Cathedral and up to press hour has not been recovered. Sir Michael left it outside the Cathedral when he went to Vespers last night, and did not remove the switch-key, so that it was an easy matter for anyone who understood how to drive a car to take it away. The number of the car, which is a six cylinder, seven passenger Paige and cost \$4900.00, is 1244. It has probably been left by the thief or thieves on some country road and will be found during the day, as it is impossible to take a car any distance from town owing to the impassable condition of the roads.

**Brought to Book.**

As a result of police investigations larcenies at Woody Island, F.B., a man named Parly is now on remand at Placentia awaiting trial. Some time ago, the store of a Maroonite named Kelly, was entered and a quantity of goods stolen. The matter was at once placed in the hands of the police and their investigations resulted in the arrest mentioned above.

**SCOTCH CONCERT.**—The St. Andrew's Society intend holding a Scotch Concert in the Methodist College Hall on May 18th. Everything possible is being done to make their fair a most successful one.

**The Printers' Strike.**

**ADVOCATE PRESENTS ITS POSITION.**  
The Telegram finds that the position taken by the Advocate is similar to that taken by the Daily News. The Advocate informs us that in that office the wages paid to operators averages about two dollars more than the Union scale, which is \$22.00 per week of 48 hours, and the demand of the Union for a 44 hour week is impossible under present circumstances.  
The Advocate points out that the demand is conceded by the Local Typographical Union to be unreasonable under our local conditions, the position thus narrowing itself down to the point where newspapers here find themselves at the mercy of a foreign organization, which is a peculiar situation, to say the least. The Advocate has done all in its power to meet reasonable demands of the Typographical Union, but finds itself unable to comply with this latest demand, which comes at a time when every industry in existence finds itself compelled to curtail expenditures. The Pressmen this morning went out on strike for a 44-hour week. These men were receiving \$25, \$28 and \$33 per week.  
The Advocate will not be published to-day, but will appear as usual in a few days.

**Invaded Municipal Office**

What looked like a small riot took place at the City Hall this morning, when a number of men seeking employment, crowded past the door-keeper and went to the top flat of the building, where the Deputy Mayor and Messrs. Ryan and Bennett were in consultation. The crowd, which numbered about 150, demanded that they be put to work. Deputy Mayor Mulrady asked the men to be patient and by Wednesday morning he would be able to work for them. On Tuesday night the first gang of about 200 will have completed a week's work when they will be paid off and replaced. It is said that the men at work refuse to quit until the money held by the Council is expended.

**The Strike Situation.**

**ALL PREMISES DESERTED.**  
None of the L.S.P.F. men turned up to their work on any of the mercantile premises to-day, and even the constable hands such as checkers, etc. left their employment. There is very little freight at present to be moved and all the employers say that what is to be done can easily be handled. At Job's premises there is a schooner, "the Spencer Lake, loading bulk fish" for market, and her cargo is completed to all but 400 qts. This, the owners say, will be put on board the first fine day. The S.S. Fortia is at Boyving Bros. premises and is ready to take freight. The Minister of Shipping under whose department the ship is run said he expected to get the steamer loaded and away by Wednesday next. Asked what his position regarding the strike was, he replied, "I know nothing about it, the Union did not notify this department that they intended to strike." At Crobble's premises freight is being received for s.s. Susu and she will be loaded by the permanent employees of the premises, so that it is expected that her sailing will not be delayed. This is the first general strike of the Longshoremen for some time and the attitude of both employers and the workmen seems firm. Many of the family men who have been at work for a number of years with the one employer feel the hardship of having to leave the positions which they had held so long.

Mr. Allan immediately seized the young thief and had him taken to the police station. Mr. Allan thinks this boy was stealing for other and bigger boys, who incited him to go in and commit these depredations.

**Negotiating for Gravel Pit.**

Negotiations are under way for the purchase of a gravel pit at Bennett's Dam, and this morning the Deputy Mayor interviewed the owner of the property with a view to its purchase. The gravel will be used for general street repairs and if the terms which will be submitted to the Council this evening are satisfactory, it is thought that there will be work for some 80 men at the site.

**Personal.**

Head Constable O'Neil, who was on duty along the railway line in connection with his department, returned to town recently.

**PUBLIC HEALTH REPORT.**—Two cases of smallpox were recently reported in the city. As there is, at present, no smallpox hospital, the sufferers are being attended at home, strict watch being kept on the affected houses. Two cases of diphtheria were reported in the city yesterday.

**Police Court.**

**Like Old Times.**—The Police Court was filled to capacity this morning by people eager to hear the proceedings, and the main entrance was simply blocked. The docket was reminiscent of the Monday morning's previous to prohibition, for it was filled with drunk cases.  
**Broke Pane of Glass.**—A man was charged with being drunk and disorderly and breaking a pane of glass in the shop of Jas. O'Neil. From the evidence of the constable who arrested the accused it appears that the latter fell through the window whilst in a scuffle with a friend. He was fined \$5 or 10 days.  
**Trjed to Enter Shop.**—A man was charged with being drunk and trying to force an entrance to the shop of Mr. Mesley on Hayward Avenue. When approached by a police sergeant, accused said he was breaking in to see if Mr. Mesley were there. This was at midnight Saturday. He was discharged.  
**Break up Furniture.**—Still another drunk appeared before the Magistrate. The accused in this case was further charged with assaulting his wife. She said, in evidence, that he came home at 1.30 a.m. Sunday and "broke up everything in the house." The defendant said he was not in the habit of doing things of this sort. His Honour said the accused was the only sufferer as he had smashed up his own furniture and gave him a chance to better himself.  
**Drunks Fined.**—Three drunks were fined \$1 each.  
**Disorderly Conduct.**—A youth was charged with disorderly conduct on the public streets. A constable stated the prisoner was wrestling with another lad on the sidewalk and was an obstruction to the public. He refused to give his first name and when taken to the Police Station, he struggled so much that he had to be handcuffed. Superintendent Grimes informed His Honour that there were many complaints of hooliganism from New Gower Street. The prisoner was fined \$5 or 10 days.

**Taken to Asylum.**

Passengers by the express which arrived here Saturday morning state that the young man Martin who attempted suicide with a razor at Port aux Basques a fortnight ago, came to Waterford Bridge on that train and from there was removed to the Insane Asylum. The unfortunate man is horribly disfigured as he eluded himself indiscriminately.

**Before the Days of Paper.**

Papyrus is what the Egyptians wrote on over four thousand years ago, and our word paper is derived from it.  
Bladders of sheep were used by the Arabs when paper was unknown, and many famous sayings have been found on these remarkable "paper substitutes."  
"Album" used by the Romans, was a preparation of white chalk, with which they covered the wood upon which they wrote. It is from this chalk, viz. white "album" that the modern word album is taken. The Romans carried tablets of wood or metal and a little bit of pointed iron to write with. The iron point was called a "stylus"—which suggests the present-day "stylus." Two of the tablets (sometimes covered with wax, sometimes with album) were often joined together by wire hinges, and the backs ornamented with ivory, gold, or precious stones. An expensive substitute for a double sheet of writing-paper!  
Leather was used by the Jews for writing purposes, and they were renowned for their skill in this respect. Linnen and silk took the place of paper as "writing materials" in many countries.  
Thin plates of gold were used in Java in the production of a book before paper was made. It was written on both sides of these gold plates, and great writers, especially Euclid, traced their designs with a stick on a tablet covered with common dust.

### Veteran Dies at Sanatorium.

Yet another of our Veterans answered the final bugle call, in the person of ex-Serjt. Uriah Bursay, who passed away at the Sanatorium on Saturday afternoon. It can certainly be said of him that he died in the same spirit as many more of his comrades who laid down their lives in France and elsewhere. He went Overseas with the First Battalion and served continuously until he was severely wounded in October, 1914. His injuries, which were caused by a bullet wound in the head, caused him much suffering, eventually undermined his constitution and he developed tuberculosis from which he succumbed. On his return home he was employed at the Pay and Record Office where his genial and estimable qualities found him a place of high regard amongst his fellow employees and returned men. Later he accepted a position in the office of Baine Johnston & Co., where he worked assiduously until March last year when he was forced to relinquish his appointment and take treatment. His body was forwarded to his home town, Caplin Cove, Bay de Verde, by this morning's train where interment will take place. The sympathy of all returned comrades and the general public will go out to his aged father, Mr. George Bursay. The close association existing between all Comrades of the Great War created bonds of friendship which will never be wiped out by the passing of our friends. They shall always be remembered.—Com.

The Begum (Princess) of Bhopal, India, who bought 4,000 silver watches to take back to her people in the central Indian State when she visited Switzerland in 1911, has just sent for another lot of 3,500 timepieces. The Begum, or Mohabbe median Princess of Bhopal, probably is the only female ruler of a State in India, and is also called Sultan. The throne of Bhopal has descended in a female line for more than seventy years, and many of the Begums have displayed modern tendencies in looking after the welfare of their subjects, who number 665,000. The Sultan Jahan Begum succeeded to the throne in 1901. Bhopal is the principal province of central India, and its capital, the City of Bhopal, has about 76,000 population.



### Bible in a Nutshell.

A man in Philadelphia has carved a spider on one side of a mustard seed and an elephant on the other, and claims the champion of the world for minute inscriptions.

If the records of the past are any guide it is not unlikely in this age of powerful lenses, and fine tools that the record might be beaten. Long ago a man achieved fame by writing a verse of Homer on a grain of millet; another wrote a verse in letters of gold and enclosed it in the rind of a grain of corn.

But that is only the work of a short time thrown off in a fit of enthusiasm for the tiny. What of the man who does this thing with the foolish and of incurable devotion? Peter Dale, a scholar of Queen Elizabeth's time, lives in the Harleian Manuscripts at Oxford for having written the Bible in so small a hand that it was enclosed in a walnut. "The nut holdeth the book; there are as many leaves in this little book as in the great Bible, and he hath written as much on one of his little leaves as on a great leaf of the Bible."

The British Museum possesses a portrait of Queen Anne not much above the size of a hand, on which appear what seem to be a number of scratches. The scratches when magnified prove to be the entire contents of a book carried in the Queen's hand. One of the legends of antiquity credits a man known to Cicero with having put the Iliad of Homer into a nutshell. When the legend was 1,700 years old Huet, the great French

scholar, tested it to amuse his pupil, the French heir.

He took a piece of film but plant paper, ten inches long and eight inches wide. By writing tiny characters with a fine pen he found that he could get thirty verses of the Iliad into a line and 250 lines to the page, 75,000 verses in all. Thus, by using both sides of the paper, he could write 150,000 verses on it, the number contained in the Iliad. The paper when folded up fitted into a walnut shell, and so the possibility of the feat of Cicero's friend was proved.

### French Duke Must Pay German Company

Before the war the Duc de Vicence d'Espauilles bought a house in the Avenue de Wagram in Paris, on which a Berlin insurance company held a mortgage for 500,000 francs. Since then the interest has not been paid, and the Berlin company has been seeking payment through the French courts. The Duke's defense was that during the war his estate at Caulain Court, near St. Quentin, worth 3,000,000 francs, was destroyed by the Germans, and that if he owed anything on account of the mortgage it was owed

under the treaty to the French Government, which in turn owed him 3,000,000 francs on reparations account. The court, however, held that the Duke must pay his debts pending the time of full settlement with Germany. So the Duke to whom Germany owes 3,000,000 francs, has to pay to the German company the accumulated interest on the mortgage since 1914.

### Important Decision.

MIAMI, Fla., April 23.—A sheriff has no right to go aboard a foreign vessel and search for liquor under the Prohibition Law, and the liquor seized in such a manner cannot be admitted in evidence, according to a court decision rendered here this week.

The judge disclosed charges of violation of the Prohibition Law against two members of a British schooner, arrested after the sheriff had found ten quarts of rum aboard, according to his testimony at the preliminary hearing.

### 'Spurs Win English Cup.

Tottenham Hotspurs defeated Wolverhampton Wanderers in the final for the English Cup at Stamford Bridge on April 24th. Stamford scored for the 'Spurs eight minutes before the second half had been started. This is the first time the 'Spurs have won the Cup in 20 years. Aston Villa won from Huddersfield in 1920, but neither of these teams were anywhere near the top this year. The football season in England has now come to an end and cricket is already in full swing again. The M.C.C. will be twenty on the look out for additions to the English team as the Australians, under Armstrong's leader-

ship, are going over to beat them on their home ground. It will be remembered that the English team lost all five of the Test Matches played in Australia recently.

Previous to this the ground had  
been prepared by solving the needs

Edward Morris. The Morris poli-  
of building branch railways and  
the Newfoundland Regiment  
take part in the great war were  
heavily assailed by President Coak-  
and his followers in the Legisla-  
The Reid M.B. Coakland's  
capitalistic corporations were  
described as combative and destitute  
of high ability and of good in-  
terests in so far as the interests of  
the fishermen and the country in  
general were concerned.

It has only to recall the party  
spirit which characterized the  
general election to be convinced  
that the seed sown and nurtured in

phrases as "the graters must go," and "sink  
Coaker with Coaker," illustrate the  
determination of the organization  
to see their trust in the President  
as at its height. To show the finan-  
cial plight of the fishermen was  
so deplorable as an outsider  
might imagine from the utterances of  
President Coaker as published in his  
paper—the Advocate—money poured  
into the fishermen's pockets, like  
water whenever the call for help  
came forth. First we see them con-  
tributing their hard-earned money to  
the President for expenses in  
the trial of Sir Edward Morris and  
members of his Cabinet. Then we  
see them contributing large sums to  
enable the President with a luxu-  
rious motor car and the celebrated  
yacht that ticked out the warning,  
"Morris must go for Coaker says  
so."

In 1912 finding himself unable to  
control the policies of  
the fish exporters of Water  
the President conceived the  
of moving the headquarters of  
the Union from St. John's  
to an important settlement  
located on the northern  
shore of the Bay. The plan as  
outlined by Coaker was submit-  
ted to the General Council and as  
a result of the deliberations of the  
delegates a resolution was passed  
to the effect that the largest and  
most profitable business premises in  
St. John's were erected in North  
Arm and named Port Union.  
The premises in connection with  
the Port Union were floated and the fish-  
ermen contributed liberally towards  
their capital thus proving that their  
financial standing in the country was  
anything but that of "underdogs."

PEOPLE WHO WARN YOU NOT TO BELIEVE THEM.

You cannot im-  
agine anyone go-  
ing around say-

false." can you?

**In Defence of Sir John Crosbie.**

Dear Sir.—Please allow me space in your esteemed and widely read paper to condemn the abusive attacks in the Daily Star on Sir J. C. Crosbie, whose popularity in this district cannot be lessened by anything that the Star or Advocate can say. Sir John is so solidly entrenched in the fishermen's estimation that all the abuse of Government scribblers will never do him any harm. Last fall in our darkest hour he came to the assistance of our fishermen, helped them out financially and gave them provisions to tide them over the winter.

The iniquitous Fish Regulations ruined business men and fishermen here, and if it had not been for Sir J. C. Crosbie there would have been starvation in certain places in this district. Cave and LeGrow refused to help out their constituents, but allowed them to be ruined and their season's earnings sacrificed, but the noble hearted Crosbie, who is vilified by the Daily Star, came to their help and sympathized with them in their troubles and proved himself a benefactor. If Sir J. C. Crosbie ever contests this district, he will be elected by the largest majority ever polled here.

"Lives of great men all remind us. We can make our lives sublime; And departing leave behind us Foot-prints on the sands of time."

The promise of the repeal of the Fish Regulations is a relief to us, but, unfortunately, it comes too late. W. F. Coaker now sees his mistake in promulgating regulations which ruined our staple industry and crushed middlemen and fishermen down in the dust. Sir John Crosbie struck the right note when he said in the House a few days ago "poor old Bay de Verde," once she was independent, but where is she now?"

Yes, Sir John, the people of Bay de Verde appreciate your efforts in their behalf. No supplies and scores of cod-traps ashore this season. Picture this and then you will understand how we are situated. Our representatives, Cave and LeGrow, should resign at once. They allowed fishermen in their district to be ruined. Why were men like P. J. Shea prevented from buying fish at \$10.00 per quintal for the American market last fall and this fish had subsequently to be stored by Sir J. C. Crosbie? Shame on you Cave and LeGrow. You are not fit to tie Sir John Crosbie's shoes.

Go ahead Sir John. Bay de Verde is solidly behind you and Sir M. P. Cashin, and are looking to you to save ruin and insolvency. Cashin is the fishermen's friend. The son of a fisherman, he understands their troubles and misfortunes. The people are behind them and are proud to have men like Cashin and Crosbie in the people's house to save us from thralldom and slavery. Senseless abuse will not injure Sir John Crosbie, and indignation is expressed here against those who would defame a man who is a credit to his native land and a man whose name will be eternally enshrined in the hearts of his countrymen.

**Bradbury vs. Caul.**

Editor Evening Telegram.

Dear Sir.—Kindly permit me sufficient space in your esteemed journal to insert a brief reply to the letter which under the caption, "Defends Union," appeared in Saturday's issue of the News over the signature of Jas. Caul. Mr. Caul in his opening remarks proposes to reply to my letter, which was published in the Telegram on Friday, but whether he intended writing that reply and conveniently forgot it, or whether his memory failed him, I cannot say, but the fact remains that his reply has yet to be written.

Mr. Caul endeavors to repudiate my argument by purloining certain parts of its contents and winds up by questioning my sincerity and loyalty as a member of that Union, but his meagre attempt has only served to disclose his inaptitude without resorting to the decayed formula of plagiarism. He would like to know what I meant by saying that the Union is a sane and intelligent body. Surely Mr. Caul is aware of the fact that for the past twelve months the chief industry of this country has been practically at a standstill, and during these months of industrial depression importations have been coming in in enormous quantities, while our export commodities were lying dormant. The result was a gradual draining of the country's finances with a consequent decline in labor; hence my contention that the time is inopportune to adopt such drastic measures as those advocated by Mr. Caul. As regards the other question of Mr. Caul, I would advise him if he wishes to find the solution to re-read the paragraph in which the sentence occurs where unless he is the superficial reader that I think he is, he will perceive after a careful perusal, that the paragraph in question is based on the contention that if the employers intended reducing the wages, they should offer to the Union a sufficient justification for doing so, and if from their claims the members considered they were justified they would take them into consideration and govern themselves accordingly. The paragraph in question reads as follows:—"In the first place we know that as a result of the experiments of the present Administration and the deplorable condition of the markets consequent upon their blundering, the business men of this country have suffered severe financial reverses. This is an important fact which I think the Secretary of the Employers' Association unfortunately omitted in his communication, merely stating that the figures in his possession warranted the reduction and intimating that in order to restore business to a proper basis it was necessary that something along these lines be done, but no reference whatever was made to the adverse financial circumstances of the various concerns which he represented. The Longshoremen's Protective Union is composed of a sane and intelligent body of men, and had the Secretary done so I have no doubt that it would have received their earnest consideration and the decision arrived at would have been different from that which now threatens to deliver a severe blow at the already tottering commercial structure of this country."

It is difficult to conceive how after carefully perusing the above Mr. Caul could have selected those words as a point of dispute and he has evidently misconstrued the whole sentiment, for he says, "I also would be pleased if he would tell what the Union has to do with today's present conditions." Mr. Caul, of course, is the victim of his own idiosyncrasies, and as such must place upon everything, interpretations peculiar to his fancy. He has obviously evinced from my letter an impression entirely contrary to that which it intended to convey. I did not mean, as Mr. Caul insinuates, to be understood as stating that the Union had anything to do with the bringing about of present-day conditions, but I contend that the Union as a commercial power in the community can do a great deal to remedy these conditions. May I ask Mr. Caul his reason for quoting so profusely from my letter. Was it because of his limited vocabulary and inadequate power of expression, or that he lacked the courage of his convictions? In either case he should have called upon his legal adviser, whom he is so fond of visiting when such occasions arise. It is a consolation to me to know that Mr. Caul himself is immune from criticism by the members of that body, which is no doubt wholly justified, seeing that his interpretative faculty which should be exercised in their interest, is so totally lacking comprehensiveness. May I suggest to him that before he attempts another exhibition of this kind to first consult his brothers in the Executive before stigmatizing them by his blundering.

Yesterday afternoon Mount Caschel Building Committee met in the new building at Mount Caschel, when reports of the work accomplished during last year were submitted. Mr. W. J. Higgins, K.C., presided, with Mr. J. C. Pippy as Secretary. Previous to the meeting an inspection of the new building was made by the Committee who were well pleased with what they saw. Mr. Higgins in opening the meeting congratulated Rev. Superior Conway and Brother Ennis and staff on the work done and explained that through the efforts of Brother Ennis the new building, which under contract would cost \$50,000, had been completed for \$30,000. Unfortunately a debt of \$12,000 had been brought about and it was to the Committee to see that it be paid off as quickly as possible. A scheme whereby the money would be subscribed was outlined and approved by the Committee who will begin work forthwith and continue it until the debt is paid off. Rev. Brother Conway in thanking the Committee for its valuable assistance and co-operation in the past felt that in their new undertaking they would not fail even though conditions were not as had existed during the last few years. He was followed by Rev. Brother Ennis who briefly told the story of how the new building had been erected so cheaply. A great deal of free labor had been furnished and valued help had been given by Messrs. Murphy, Coady and Pigeon while the work was in progress. He also gave a recital of the work at Mount Caschel since its establishment in 1897, when some 20 or 30 boys were taken in charge, while to-day about 160 were looked after. He paid a splendid tribute to Rev. Brother Brennan who has been connected with the institution for over 20 years, and also the other Brothers of the community who have labored so well in the interest of the boys. Rev. Brother Ryan, of Mount St. Francis also spoke and referred to the splendid work of Brother Ennis who had erected a lasting monument to himself in brick and mortar in the new building. He also congratulated the Committee and the people of St. John's for the great assistance given the Brothers at all times and said that in no part of the world where the Brothers gave instruction were they held in better esteem than in Newfoundland. Speeches were also made by Dr. V. F. Burke, C. Hutton and J. P. Crotty, the meeting closing at 6 o'clock with a firm resolution that the \$12,000 debt would be lifted in a very short time.

**Brought Insane Patient.**

Sergeant J. Fitzgerald arrived by express on Saturday from Rose Blanche having in charge a young man of the place who had recently attempted suicide. Sergeant Fitzgerald had to bring his charge via Fort aux Basques, and during the journey he experienced a trying time, the unfortunate young man being at times very violent. On arrival of the express he was conveyed to the Lunatic Asylum.

Amazing Medicines.

"Will you please give mother a nut to put a spider in?" was the queer request of a Tiverton child to a tradesman.

"What do you want it for?" asked the astonished man.

"Please, sir, baby's got whooping-cough!"

In the West Country this is still believed to be a charm, or cure, for whooping-cough. You get a live spider and a nut. Into the nutshell you place the spider, tie the charm round the nut's neck, and when the spider dies the cough goes.

Gilpates are said to swear by roast dormouse as a cure for whooping-cough, and in Lancashire it used to be considered that no child could contract this disease who had ridden upon a bear. In Cornwall, a sick child is sure to be cured if passed three times under a hawk's tail. In Sussex, the cure for whooping-cough is to fly three field-sparrows, draw them, roast one, and let the afflicted child eat it! That ought to cure anything.

Worse Than the Disease. A European resident in Bangkok who fell ill of a fever, had this prescription given to him by a native doctor. "Two small pieces of elephant's tusk and rhinoceros horn, the tooth of a tiger, a crocodile, and a bear, powdered bones of vulture, geese, and ravens, a fragment of a stag, a bison's horn, and a minute piece of sandalwood." The patient thought the cure worse than the disease, and, rather than take it, promptly got well.

Some of the ancient remedies would be hard to come at in these days. "A halter wherewith anyone has been hanged, if tied about the head, will cure headache. Moss growing upon a human skull, if dried and powdered and taken as snuff, is no less efficacious." And the chips of a willow, tied on a string and worn round the neck, it appears, are a certain cure for ague. In these days such a cure would result in an attack of the cold shivers! Tuberculosis is still rampant among us. Probably this is because the proper remedy has not been used. Here it is. A peck of snails and a quart of green

earth-worms, the former washed in beer, and the latter salted. To this mass should be added angelico, agrimony, bear's feet, barbery wormwood, saffron, rue-tumeric, and milk. Two spoonfuls at a time is the dose. If the other things are hard to get, try milk!

Botted Insects. An English nobleman taken ill in Paris at the end of the sixteenth century, applied to the French court physician, and that worthy gave him, as a compound of musk, amber, gold, pearl, and unicorn's horn, though where he procured the last is not stated. This was for internal use. Externally, plasters were applied to the patient's site. It is not stated whether they were good or alive! Anyway, the nobleman promptly expired.

Here are a few Chinese cure-alls. The blood-vessels of the ear are good for "moonstruck" cases, while bottled crickets are very efficacious as blood-purifiers. Snake's skin, dragon's skin—first catch your dragon—with the inside membrane of a well-seasoned and ancient egg are cures for jaundice. Whilst all skin diseases yield to a decoction of spiders and green snakes.

Pliny's cure for a cold in the head was three kisses on the mouth of a mule. If the mule should happen to give a kick for a kiss, the cure would probably be permanent! Here is another ancient cure, but this time a donkey is required. "If a person bitten of a scorpion sits upon an ass with his face towards the tail, the ass will endure the pain and not he." And the same authority gives this as a cure for the morning after the night before's feelings. "One's eyes given in wine for three days to drunkards will make them loathe it." This seems probable!

Two and Two. In ordinary sailing-vessels, where no passengers are carried, the captain acts as ship's doctor. As a rule, a medicine-chest is carried, with tweezers as to how and when to use the various drugs. For instance, for dyspepsia, a dose of No. 7; for sprain, No. 2; for rheumatism, No. 5; etc. And there is an old story of how a skipper, when one of his crew complained of a pain in the region of his waistcoat, being out of No. 7, prescribed a mixture of No. 5 and No. 2, on the principle that five and two make seven!

TO-DAY'S MESSAGES.

ALL QUIET IN U. S. WASHINGTON, May 1. Reports to the Department of Justice, to-night, said that May Day had passed quietly in the country on the whole. A few Radical meetings were reported, but they were said to be nothing out of the ordinary. Department agents, however, will maintain vigilance to-morrow, because the day will be observed then more conspicuously, since to-day was Sunday.

THE NAVY READY. LONDON, May 1. "We understand," says the London Times, "that in the event of Allied action in Ruhr, British naval co-operation against Germany is probable."

REJECTED WAGE CUT. NEW YORK, May 1. Although Union leaders declared to-night that a strike had not been called, Marine Workers Union's meetings here to-day voted to reject the fifteen per cent wage cut proposed by United States Shipping Board, until proposed working conditions are modified.

BOMB EXPLOSION. JOHNSTON, Penn., May 1. An eighteen-year-old girl was killed, and five other persons were injured last night, at South Fork, near here, when a bomb cast through the mails exploded in a store owned by Tony Haneri. Anno Taneri was killed and three of his sisters, a brother and an unidentified person were injured.

A LITTLE FLARE-UP. BUENOS AIRES, May 1. May Day was marked by the throwing of two bombs, an attempt to blow up a railway bridge, and a parade by Socialists and workers, who carried Red flags. Nobody was injured by the explosion and little material damage was done by them.

NO DISORDERS IN ROME. ROME, May 1. May Day, coming a fortnight before the general election, acquires greater importance than in past years. Both Fascist, or Extreme Nationalist, and Socialist appeared determined not to provoke disorders. This gave rise to a hope that the day would pass without serious trouble.

A BAD BREAK. LONDON, May 2. Elaborate arrangements, which were being worked out between England and Australia, for regulation of sales of the latter country's enormous stocks of wool, have broken down, and the position is causing anxiety here, and still more in Australia.

MINERS BECOMING AGGRESSIVE. LONDON, May 2. The Miners' delegates who attended the London conference, have been busy during the week-end explaining Government's offers in various districts. Reports to hand give little hope of any movement towards a settlement, and there appears to be no wavering on the part of the men. At a mass meeting of 12,000 miners at Merthyr, yesterday, it was decided to make an attempt to-day to withdraw all safety men working in the Rhondda District. Mass picketing is to be commenced with the object of preventing volunteers going down in the pits.

PAPER WORKERS WALK OUT. BOSTON, Mass., May 2. About eighteen hundred paper workers in New England were idle to-day, as a result of their refusal to accept wage reductions, ranging from 20 to 30 per cent.

THEY LIMIT NARROWING DOWN. LONDON, May 2. The declaration of the Allied stand on the reparations question, in which Germany will be given a brief interval to comply with the Allies' demands, was drawn up at a conference, this forenoon, by the Foreign Ministers of Great Britain, France, Italy and Belgium, and submitted to the Supreme Council of the Allies, when it met at 12.30. The document will take its final form in the Supreme Council. The Council adjourned after an hour's consideration, until 6 p.m.

Mayflower Performance Pleases Experts.

Mr. George S. Hudson, of the Boston Herald staff, who attended the race here last autumn and who is recognized as a yachting expert, in reviewing the trial trip of the Mayflower in Boston this week, gives some interesting points that characterize the new craft.

When the cup contender was doing her prettiest in a northerly breeze at the entrance to Broad Sound outward bound, she logged better than 10 nautical miles being on a close reach under four lowers and the mainmast stayed still, fluttoped but no sail heaved. The water was smooth and the breeze steady. This speed was developed with at least a foot of freeboard and the vessel being stiff and delicately balanced.

Leaves Little Wake. In absence of a displacement wave was observed, the only disturbance being the frictional wave that can be reduced at least ten per cent by smoothing the under body in anticipation of the international race. A glance over the Mayflower's bow revealed a remarkable clean entrance. The wake attenuated out a few feet from the water and disappeared a vessel's length later. In contrast to the Esperanto carried broken water a considerable distance while the Belgawana, her competitor piled haycocks of foam against her counter, when reaching in strong breeze. Judging from yesterday's trial the Mayflower is going to do her best in smooth water and strong breeze when booms are eased a bit.

Yet, of course, there is difference in opinion, and with the vessel in best trim she also may prove a wonder on a wind and running. "One can't describe the Mayflower as a diddler, but the fact remains the old lay her 14 knots, says a reporter back of a sea in several occasions she shipped seas over the bow, a fact all sailing craft possess, some to a greater degree than others."

It is understood that Captain Reynolds, once skipper of the Esperanto who was on the Mayflower on her trial trip, regards the latter craft as much faster than the Gloucester boat. Moreover, that she should prove an excellent fisherman.

Fast Tacking. The writer says that the schooner's boom projects only a few feet over the hull, a feature much admired by fishermen. Mr. Hudson also states that they tackled the Mayflower in 10 seconds from head-on to tacking away to the other hither and this performance, under the circumstances, would indicate the new vessel to be wonderfully spry in stays. "Presently," says Mr. Hudson, "she'll go about in 40 seconds and the standard boat must be a veritable snapper if she can hitch in less than that."

The Mystery Crates of Arizona.

The so-called "crater" of Canyon Diablo in Arizona is still as much a mystery as ever was. The supposition is that it was formed by the impact of a giant meteor. The crater is circular, three-quarters of a mile in diameter, and 200 feet deep. But if it were made by a meteor the latter was presumably a good bit smaller. Strong support for the meteoric theory is given by the finding of thousands of fragments of meteoric iron, some of them weighing many pounds, in the immediate vicinity of the hole.

Repeated attempts have been made to dig for the meteor. It should be a mass of metal (chiefly iron, presumably) big enough to be worth getting hold of—though, of course, its chief value would be as a curiosity of interest to science. One company organized for the purpose started to excavate at the crater's bottom, but its operations were brought to a pause by quicksand, which the machinery could not handle.

Now another concern, calling itself the Crater Mining Co., is drilling with two powerful rigs on the inner edge of the hole. It is thought that the huge projectile from the sky may have struck at an angle to the vertical, and that consequently the mass may lie not directly below the crater's centre, but off at one side. In some of the scattered meteoric fragments above mentioned were found tiny diamonds, which lend additional interest to the problem.

Canada's Giant Parks.

The Canadian Government has taken time by the forelock, and reserved for all time for the public enjoyment four national parks, which dwarf any other parks in the whole world. They are in the Rocky Mountains, and were all visited by the Prince of Wales during his recent tour of the Dominion. In fact, one of his official "stunts" was the opening of the latest addition, Revelstoke Park, which overlooks the vast valley of the Columbia River.

Each of these parks is as big as a good-sized country, with mighty pine-forests, waterfalls so high that they lose themselves in spray, and lakes of a hue which even Switzerland cannot match. The Government is building splendid roads of access, so that even the




