



ODD FELLOWS HALL, VICTORIA, B. C., 13th June, 1900.

GRAND MASTER'S REPORT.

NEW WESTMINSTER, B. C., June 13th, 1900.

To the Officers and Members of the Grand Lodge of British Columbia, I. O. O. F.:

BRETHREN:—We are again assembled together as Brother Odd Fellows. For twenty-six (26) years we have met in succession, and to-day we meet on the ground sacred to the formation of the first Lodge in this vast Province of ours, the home of Odd Fellowship in British Columbia. What thronging memories must be recalled to the members here present, more especially the older brethren, as they take a retrospective view over the years to the time the first lodge, old "Victoria," No. 1 was instituted; after which followed "Columbia" No. 2. and so on, along the line to the instituting of "Enterprise" No. 43 at which I had the honor of officiating in September last.

In looking over the list of Brothers who have preceeded me in the Executive Chair, 1 find there are eighteen (18) still living, a remarkable record for twenty-six (26) years, and I am led to believe that all are still good Odd Fellows and in touch with the order. A majority of them I have met and enjoyed their fellowship and the association with these Brethren will be one of my most lasting memories.

And now let us come to our own personal affairs:-Our laws require that the Executive Officers shall make a report of the business transacted by them in their official capacity; and custom has provided that they should submit such recommendations as might be suggested by experience in executing the laws, contact with the brothers, and the opinions and ideas resulting therefrom which might prove beneficial as well as interesting to the body which has honored them by the exalted position of trust and responsibility.

The following report of my actions, as Executive Officer of this Grand Lodge is therefore submitted for your consideration with the earnest hope that its contents may meet with your approval, and that what has been done during the last year may redound to the advancement of our beloved order,

Perhaps no one, unless he has occupied a like responsible position, can realize the amount of work and the anxiety which a Grand Master is called upon to undergo: as well as the caution, prudence and discretion he must exercise in discharging his obligations; while I have endeavored to perform my duty and do justice to the position

as far as my ability and qualifications would allow, no one realizes more than I that I have come very far short of perfection and I have many times felt that I had not fulfilled the expectations of the Brothers who elected me to this honorable office. yet I have striven at all times to do what I believed to be right, and permit me to say that if at all times I have not done so it has not been through neglect on my part. I did not expect when elected to this important position to sit idly down and be content with the honor of the office-I was aware that the duties entailed a considerable amount of work, and my expectations have been more than realized. It seems to me there has been more than the usual amount of work for the Grand Master this year, as the increasing number of Lodges and Membership increases the work and responsibility of the Executive Officer. But whoever assumes this important position must expect at times to sacrifice personal comfort and to some extent, at least neglect personal affairs-still in this connection I have no regrets but the wish that I could have done more for the advancement of our beloved Order, and such of my time as I could spare I have freely given to the cause, and where and how my time has been spent the following will show:

STATE OF THE ORDER.

During my visitation over the whole of the jurisdiction I had ample means to observe the condition of the Order and I find every Lodge has prospered as well as could be expected considering their locality and surrounding circumstances. A good many of the lodges own their own halls, furniture, etc. Five (5) fine new halls have been built and dedicated during the year and (2) new Lodges instituted and in the interior several of the new towns are looking forward to the formation of Lodges and I anticipate that before the next meeting of our Grand Lodge several new Lodges will be added to our number. The financial standing as far as I was able to ascertain is very good, many even of the smaller Lodges having a good surplus on hand, but you will receive a statement of this and also the membership through the Grand Secretary in his report. I instituted a new Lodge at Trail on the 19th of September with a membership of thirty-six (36) and have since learned that their membership is now more than double that number. A new Lodge has also been instituted at Moyie but cannot at this time give the date in connection with it. A Lodge has been talked of at Fernie for some time and I have no doubt but one will be instituted there in the near future. Grand Forks is another point at which a Lodge of our Order will soon be located. I have been in communication with several brothers for some time in regard to this and have no doubt the brothers' wishes will soon be realized.

Other new towns are springing up throughout the whole of the Interior of our Province which will no doubt be asking for charters for Lodges and it is only a matter of time when the representatives from the Interior will be a strong factor in our annual deliberations.

THE REBEKAH BRANCH.

QUESTIONS AND DECISIONS.

1. A Brother was in arrears up to the 19th of August, 1890—on the 13th he paid to the Secretary an amount sufficient to place him in standing which was entered on the books on the date it was paid —on the 19th the Secretary was not present and no keys to the desk consequently the payment was not reported to the Lodge until the next meeting on the 26th. In the meantime the brother met with an accident on the 24th. Ques.—Is the brother entitled to benefits?

Ans.—Yes, if duly entered on the books though not reported on the 19th.

2. Ques.—Can our Lodge legally vote \$10.00 to a Women's Hospital for the purpose of purchasing an operating table?

Ans.—Yes, if you have a contingent fund on which to draw.

3. Ques.—A suspended member of our Lodge has died, can we attend the funeral as a Lodge and perform the usual ceremony.

Ans.—You can attend the funeral simply as Odd Fellows but are not liable for any funeral benefits or funeral expenses and would not advise the performance of the ceremony.

4. Ques.—Is it necessary to have our By-Laws registered?

Ans.—Yes, if you are incorporated under the Benevolent Societies Act, also all future amendments.

5. *Ques.*—Is it necessary for a P. G. to belong to an encampment and a Rebekah Lodge in order to be a representative to our Grand Lodge?

Ans.—No, that law only refers to representatives to the Sovereign Grand Lodge.

6. A Brother was taken very sick and required a nurse. The friends of the brother hired a nurse without reporting the matter to the Lodge. The Brother at the time owed nine (9) months dues—he claims the Lodge should pay the nurse bill. *Ques.*—Can the Lodge pay for nursing a brother who is in arrears and not entitled to benefits?

Ans.—No, the Lodge should have been notified and the nurse hired by the Lodge or the friends instructed by the Lodge to procure one.

7. *Ques.*—A Brother having an official receipt paid to date is it necessary for him to have in addition to this an order for the pass word in order to visit another Lodge?

COMPLAINTS.

I received several complaints from brothers who appealed to me against the actions of their Lodges, most of which I consider it unnecessary to enlarge upon in this report as they were all I think satisfactorily settled but all correspondence in connection with them are on file and can be seen it required.

APPEALS.

I received an appeal from Bro, John Flett of Western Star Lodge, No. 10, against the action of his Lodge in refusing certain benefits and after getting all the information possible in connection with the case I decided that the Lodge was liable and think the decision was satisfactory to both parties as I have heard of no app all from my decision. The papers in connection with this case are also on file.

I also received an appeal through a Solicitor acting on behalf of the friends of a Bro, Johnston deceased, against the action of Vernon Valley Lodge, No. 18, in refusing to pay certain benefits claimed. After getting all the facts possible in connection with the case 1 deeided the Lodge was liable. From this decision the Lodge has appealed and the matter will come before you for consideration through the Committee on Appeals

I received a request from Bro. J. B. King, Grand Secretary of the Grand Lodge of Ontario for permission to appeal to this jurisdiction on behalf of the Brothers who suffered in the Ottawa-Hull fire which request 1 did not think it expedient to grant for reasons set forth on page No. 46 of No. 2 letter book.

I wish to record a very pleasing visit, which, though not official, was fraternal and international. By invitation of Blaine Lodge, No. 80, Wash, and Bro, G. Elsperman, Grand Warden of the Grand Lodge of Washington, I, in company with flfty (50) of the New Westminster brothers paid a fraternal visit to the above named Lodge in February last where we were right royally entertained by the Blaine brothers. After the conferring of the initiatory degree by a team of New Westminster brothers a st enjoyable time was had in the Banquet Room, in the exchange of international courtesies, the rendering of patriotic songs and speeches. It again becomes my duty and high privilege to submit a report of the transactions of this office and of the work of the Order in this Jurisdiction for the past year, which affords grounds for satisfaction and encouragement.

During the year Two new Subordinate Lodges have been instituted, "Enterprise," Lodge, No. 43, at Trail on the 19th September last, and "Wildey" Lodge at Moyie on 18th May, 1900, the latter lodge asks that No. 13 which is vacant, be assigned to it, and this request is submitted for your consideration. Both these Lodges give promise of success which I trust will be fully realized. "Enterprise" Lodge reported 64 members on 31st December last and will be represented ut this meeting. Enquiries have been received on the subject of instituting Lodges at Fernie, Grand Forks, Armstrong and Barkerville and I have no doubt but that Lodges will be organized at these places in the near future. The necessity of a careful survey of all the conditions so as to secure permanency is invariably impressed on the applicants in replying to their enquiries.

The membership of the Subordinate Lodges on 31st December last was 3060 an increase of 215 for the year.

In compliance with a Resolution of last Session the question of the legality of permitting New Westminster Lodge, No. 3, to change its name to Royal City Lodge, No. 3, was submitted to the Grand Sire and as Bro. Pinkerton decided that it was within the powers of this Grand Lodge to permit this change, a Charter with the altered name was issued accordingly.

Legal opinion was also obtained as per instructions of last Session as to the necessity of the registration of amendments to the By-Laws of Lodges whose By-Laws are registered under the Provincial Statute. The opinion received was in the affirmative and it was communicated to all the Lodges.

A very regrettable incident occurred immediately after the adjournment of our last Session. The "Province" newspaper of Vancouver published an item containing untruthful statements connecting our representatives with a disreputable street fight in that city. The matter was promptly and energetically taken up by our Vancouver brethren but as a correction which they secured in the same paper was not considered satisfactory it was deemed advisable, in justice to the representatives attending the last Session, to lay a true statement of the facts of the case before the membership of this Jurisdiction, which was done in a circular letter addressed to all the Lodges.

The Sovereign Grand Lodge at its last Session decided to provide a Jewel for D. D. G. Ms. to be worn by them whilst holding that office in order to designate their rank. The price of this Jewel has been fixed at \$1.50 each, a copy of the Circular issued by the Grand Secretary, with a photograph of the Jewel, is attached for your directions.

A communication from the Grand Encampment of Wisconsin is submitted herewith asking our co-operation in their endeavor to secure Bi-Annual Sessions of the Sovereign Grand Lodge and likewise a reduction of the number of representatives to that Grand Body.

N while \$149.2 longin receiv \$20.25 Fund, leaflet written by him entitled "Odd Fellowship, What Is It?" Bro. Harwell states that the free distribution of this leaflet has materially assisted in increasing the membership in that Jurisdiction, 1251 in the year 1899 and 1334 in the year 1898. This leaflet is copyrighted, but the brother generously gives us permission to print and use it, with any alterations we may deem proper, providing it is distributed gratuitnously. If the circulation of this leaflet produced such good results in Tennessee it is worth considering whether it would be equally effective in British Columbia.

It is with great regret that I have to report the death of Bro. John Weiler, P. G. M., which occurred in this city on 6th September, 1899. Bro. Weiler was the second Grand Master of this Grand Lodge Illing the chair in 1875, and was also a Charter member of Victoria Lodge, No. 1. From close personal intimacy with him for many y ars I can bear testimony to his inflexible integrity, his genial and generous disposition and his stundy, stirling character. He was a honest man, an exemplary and highly respected citizen and a true Odd Fellow. I recommend that a Memorial Page be inserted in the printed proceeding of this Session to his memory.

FINANCIAL.

It is gratifying to be able to announce that the Estimates of Revenue for Per Capita Tax has been exceeded by \$112.25 and that this has been supplemented by Charter Fees, \$60 and Interest on deposit of moneys in the Grand Treasurer's hands in Bank of British Columbia, \$11.73. Through the business forethought of Bro, Stark a special arrangement was made for this money to be deposited in the Savings Bank Branch of the Bank so as to carry interest and to be withdrawn by Cheque. The balance in the hands of the Grand Treasurer is \$200.38 more than was anticipated.

ODD FELLOWS HOME FUND.

This fund is slowly accumulating, the grant of 10 cents per member realized \$298.55, Bank Interest \$9.98 and a contribution of \$1.85 was received from the Vancouver Lodges, making the total income \$310.38 and the present balance to the credit of this fund \$800.80.

AGED ODD FELLOWS FUND.

No claimant has yet been registered on this fund, it has meanwhile been steadily increasing, the receipts for the year include \$149.27, being 5 cents per capita. Sale of old Regalia formerly belonging to Mission City Lodge to Enterprise Lodge, No. 43, \$35.00, received from members of defunct Lodges for Grand Lodge Cards \$20.25 and Interest 64c. Total \$205.16 making the total value of this Fund, \$339.04.

The salient points on which we may congratulate ourselves in reviewing these figures are the increase in membership, 215; the decrease in the number of members suspended for non-payment of Dues, 41; the reduction in the number of brothers who have been in receipt of Sick Benefits 9, and in the amount which has been paid under this head, \$188.75 notwithstanding the increase in membership; the substantial increase in the total Assets \$11,730.52 and diminution in the cost per member for working expenses and for all Lodge expenditures aggregating \$1.11 per member, all these items are important factors of success in institutions such as ours.

On behalf of the Odd Fellows of this city I welcome you in assembling here to-day in the birth place of Odd Fellowship in this Province, here the first Lodge was instituted on the 10th March, 1864 and it was here that this Grand Lodge was instituted, with only five Lodges, on 25 April, 1874. At that time the majority of the Lodges and members were in this city, but what a change has come over the scene, to-day we have representatives here from almost every section of the Province. Now the vast areas of the province are being populated, its immense resources are being developed, towns are springing up in all directions and it would be strange indeed if Odd Fellowship with all its beneficient advantages and its social and fraternal attractions should not participate in the general prosperity and keep pace with the remarkable progress which we have witnessed on every hand.

The pioneers of Odd Fellowship in this Jurisdiction, many of whom I am pleased to say we have with us to-day, must rejoice at the success which has attended their efforts in planting the seed of our order here, they greet you to-day and wish you God Speed in your mission of fraternity and love. They built better than they knew, they laid the foundations of the structure deep and broad, and it remains for us to add to the permanency of the edifice by wise and useful legislation, by earnest and indefatigable work, repairing and replacing any defective points that may be apparent and vigorously striving to extend its borders.

Our annual gatherings I am convinced are productive of much good, and are looked forward to with expectant pleasure, they enlarge our views and revive our enthusiasm. I trust the present meeting will prove both pleasant and profitable and that our deliberations may tend to the upbuilding and strengthening of the Order in this highly favored Province.

The Grand Master appointed the following to form the Committee on Distribution:—Rep. T. A. Muir, No. 3, T. F. Neelands, No. 8, J. Crossan, P. G. M., No. 5.

J. E. Phillips, P. G. M., No. 3, read the report of the Grand Representative which was ordered to be received and printed with the proceedings of this Session.

To the Grand Lodge of British Columbia, I. O. O. F.

DEAR SIRS AND BROTHERS:—In compliance with the requirements of our office your representatives attended the 75th annual session of the Sovereign Grand Lodge, or the Diamond Jubilee of Odd Fellowship, which convened at Detroit, Michigan, on the 18th of September last, the usual Saturday excursion and Divine Services on Sunday were highly appreciated by many members of the Sovereign Grand Lodge.

The first formal and public reception was held on Monday the 18th of September at 10 a.m. in the Detroit Opera House.

Col. O. A. Janes, Chairman of the General Local Committee, delivered the address of welcome in behalf of the Odd Fellows of Detroit.

The Mayor of Detroit, Bro. W. C. Maybury, was there to tell how good an Odd Fellow he was, in intent at least, and to give a welcome both for the State and City. His Worship was loud in the praise of the good work being accomplished by the Order, and made special and kindly reference to our motto, "Friendship, Love and Truth".

G. M. Col. E. H. Sellers spoke on behalf of the Grand Lødge of Michigan, Bro. Robt. Donovan for the Grand Encampment, Brigadier-General C. S. Martin for the Patriarch Militant, and Sister E. Haskins, President of the Rebekah State Assembly, on behalf of the ladies of the Order. Between each of the addresses the orchestra discoursed sweet and appropriate music. Among other tunes noticed was our National Anthem, God Save the Queen.

Then came the response of Grand Sire A. S. Pinkerton, which was a master-piece of oratory,

The Public exercises being concluded the Officers and members of the Sovereign Grand Lodge repaired to Harmony Hall, where the 75th session was promptly called to order, and after the usual opening ceremonies the body settled down to business.

Your representatives were appointed on the following committees—Dempster, Committee on Correspondence; Dailey, Committee of International Relations; Phillips, Committee on Unfinished Business.

The following are a few brief extracts from the Grand Sire's Report:

Eighty years ago American Oddfellowship was born. Seventyfive years since the Sovereign Grand Lodge came into existence. Wonderful has been the development of this fraternity. In 1819 one

MEMBERSHIP.

On December 31st last our Subordinate Lodge membership was 830,961 and the number of Sisters enrolled in Rebekah Lodges 190,007. These figures in combination exhibit a total of 1,020,008 and enable us for the first time to honestly claim fraternal affiliation with over a million persons.

The above figures show an increase of 18,041 in subordinate lodge members and of 12,184 in female membership of Rebekah Lodges. A total net gain during the last calendar year of 30,225.

The number of subordinate lodges has increased by 190 making 11,419 now in existence, while the 5,053 Rebekah Lodges indicate an increase of 257. During the past year 65,588 persons have been initiated in the former class and 51,671 in the latter.

The total revenue during 1898 was \$8,766,393.56. The total expenditure was \$7,582,712.96. Suplus of Revenue over expenditure, \$1,183,680.60.

87,613 brothers and 5,707 widowed families shared in the \$3,422,-986.50 distributed in relief.

The total invested funds of the Order amount to \$27,185.241.46 a gain of \$796,545.72, surely a profitable showing especially in view of the fact that during the same time our expenses increased by \$194,572.76 and the amount paid for relief by \$58,357.09, while the total revenue decreased \$79,866.34. The number of weeks sickness for which benefits were paid was 34,316 less than in the preceding year and while the above financial exhibit is highly gratifying in many ways, especially in the large increase of invested funds and in its demonstration of the Order's care of and generosity towards its nuembers it is to be hoped that in your several jurisdictions you will seek to impress upon the members the necessity of measuring the expenses by income.

The substantial increase in the subordinate membership as compared with an average net gain of 8,399 during the past four years and of 6,989 during the past two years illustrates the latent energy of our Order and argues well for what is to come. As long as Oddfellowship is maintained in its purity, subordinate lodges will continue to be strong. It is not to be anticipated that the rapid growth of the Rebekah Lodges largely due to legislation that admitted a

class of women once excluded, would continue, but the increase of 14,648 indicates the prosperity of a degree that has rapidly grown in favour. The legislation of the last few years has greatly enlarged the powers and increased the burdens of these lodges. In many places these powers have not been understood nor have the members entirely adapted themselves to the new conditions. Conservatism and a study of present surroundings should in my opinion, dictate the policy to be pursued in the immediate future relative to this growing and attractive branch of our fraternity.

With a view to economy only two copies of the Journal will in future be furnished to each Grand Representative and the mailing list will be dispensed with.

All amendments to the constitution were defeated.

All Jurisdictions were represented.

LEGISLATION ADOPTED.

The law giving authority to a Noble Grand or Chief Patriarch to communicate the pass word upon an official certificate was amended by the following:

Resolved, That the possession of a visiting card the date of which extends to a date later than when the same is presented or an official Certificate for dues paid to a date later than that when the same, is presented properly signed and sealed be, and the same is hereby declared sufficient proper and legal authority for any Noble Grand, Chief Patriarch or Noble Grand of a Rebekah Lodge, upon proper identification, to communicate to the holder thereof the annual travelling pass-word, or the annual pass-word of the Rebekah degree (as the case may be) and if the holder of a visiting card or official certificate as above mentioned is a member of a Lodge, Encampment or Rebekah Lodge in same jurisdiction as the Lodge, Encampment or Rebekah Lodge to which the said visiting card or official certificate is presented, then in that event the Noble Grand, Chief Patriarch or Noble Grand of a Rebekah Lodge is authorized to communicate to the holder of said visiting card or official certificate, the semiannual pass-word or check word (as the case may be).

Resolved, That all laws in conflict herewith be and the same are hereby repealed.

Resolved, That the committee on printing supplies be and are hereby authorized to have made an appropriate jewel for District Deputy Grand Masters the same to be sold at a remunerative price. We recommend the adoption of the resolution with the provision and understanding that, that but one shall be made until a photograph of the same with a circular of explanation has been sent to the various jurisdictions and further that these jewels shall only be made upon order for same to the Grand Secretary.

The language of the visiting card was amended as follows:

Resolved, That the Committee on Printing supplies be requested in future editions of the visiting card to print after the word "Oddfellows," in the 15th line below the head line, the word "until" in lieu of the words "for the space of" as at present used, the said word "until," when the card is filled for use, to be followed with the definite date to which the card is issued.

The law governing the duty of Brothersaway from their respective lodges was amended by the adoption of the following:

Resolved, That the law found on page 10,900 of the Journal of this Grand Lodge for 1887, and the digest in section 112, of White's new Digest 1895, be and is hereby amended to read as follows, to wit; "Resolved, (1st) That it is the duty of every Oddfellow when he is away from home and out of the jurisdiction of his Lodge, to give attention and care to his Brethern in distress, and watch with the sick when necessary, as well as when he is in his own jurisdiction; and further, "Resolved, (2nd) That it is and shall be the duty of every member of the Order upon taking up his residence away from vicinity of his own Lodge to report himself to the Lodge near residence, or when it is equally near to two or more Lodges, to one thereof, within 30 days after taking up such residence, and in making such report he shall give the name and number and location of his Lodge, and when requested by the Lodge to which he has reported, shall watch the sick who are under the care of said Lodge, both members and visitors; and any such member failing so to report or watch shall not be entitled to attention from any Lodge, and this legislation shall not be construed to hinder or prevent any Lodge or member from furnishing watchers or giving attention to any sick or needy brother."

The law with reference to members of defunct subordinate lodges and encampments was amended as follows:

Resolved, That Grand Lodges and Grand Encampments through their proper officers shall be permitted to issue to members of defunct lodges or encampments withdrawal cards or dismissal certificates, according to the standing of the brother when the lodge or encampment surrendered its charter, and members holding such cards or certificates shall have the same privilege and are to be recognized by every subordinate lodge or encampment to which they may be presented, whether in or out of the jurisdiction issuing them, as having the same force and effect of a withdrawal card or dismissal certificate that has been issued by an existing subordinate in good standing, and will enable the holder to join another subordinate lodge or encampment.

Resolved. That all laws in conflict with the above resolution be and the same are hereby repealed.

That the following be added to the telegraph code: Benefit— What sick and funeral benefits do you pay? Widow—Wife or child of a deceased member of your lodge is in our city asking assistance. Shall we draw on you to the extent of \$----?

That the dollar mark be added before the blank at the end of sentence following key words "fund" and "regalia" now in use.

That such property as comes from defunct Lodges as are directly subordinate to the Sovereign Grand Lodge be at the discretionary disposal of the Grand Sire and Grand Secretary. Likewise that such property coming from defunet Lodges to a Provincial Grand Lodge be at the disposal of the Grand Master and Grand Secretary of such Provincial Jurisdiction.

s, por d e s al That each subordinate encampment is hereby allowed to procure not exceeding six rituals and each subordinate lodge not to exceed four rituals for the use of said subordinate bodies.

That the law passed at the last Session' prohibiting the use of the name of the Order by insurance societies was repealed as to the Oddfellows' Relief Association of Canada.

Resolved, That subdivision 6 of the Code for the Government of Rebekah Lodges be amended by adding thereto the following; "Their daughters, their sisters and their mothers and the daughters, sisters and mothers of deceased Oddfellows" and when so amended the same shall read as follows: "Section 6, subdivision 2: All Oddfellows in good standing and their wives, their daughters, their sisters and their mothers and the daughters and sisters and mothers of deceased Oddfellows."

Section 26 of the Code for the Government of Rebekah Lodges is hereby amended to read as follows: Section 26:—Visiting and withdrawal cards and dismissal certificates and certificates for former members of defunct Rebekah Lodges shall be provided by the Grand Secretary of this Grand Lodge for the Rebekah Lodges and their members and the same shall be furnished to State, Territorial or Provincial jurisdictions at the same price as those for subordinate lodges and their members, and all law and decisions of this Grand Lodge relating to application and fees for and to issuance, use, force and effect of similiar cards and certificates, in and by Grand and subordinate lodges and their members shall apply and extend to said cards and Certificates. A committee was appointed to present at the next session a sister's word of distress to be used by sisters in the work when in need of assistance; also "Assembly Honors" to be used in Rebekah Lodges on official visitations.

The next session of the Sovereign Grand Lodge will be held at the City of Richmond, Virginia.

DECISIONS.

One hundred and sixty-four decisions were made by the Grand-Sire, all were approved—a record imprecedented in the history of Oddfellowship. Some four of five were slightly modified. All 'hat are of any probable interest to our jurisdiction, in our opinion are produced herewith.

2. Ques. On Page 226, Journal of the Sovereign Grand Lodge, 1898, it is provided that a properly signed and sealed certificate, under proper indentification, shall be authority to any Noble Grand to communicate the "current travelling pass-word of the Order." What is meant by "current travelling pass-word" in this resolution?

Ans.—The annual travelling pass-word.

3. *Quis.*—Does this resolution authorize the communication of the term pass-word of a jurisdiction upon the presentation of said Certificate to the Noble Grand of a lodge other than that to which the holder of the Certificate belongs?

Ans. If does not.

4. *Ques.*—Is a brother who receives an official receipt for his dues entitled to receive the annual travelling pass-word in connection therewith?

Ans. – Only such brothers as pay their dues in advance are entitled to receive the annual travelling pass-word at the time they pay their dues and receive an official certificate therefor.

5. Ques. Does the adoption of resolution No. 200, Page 226, Daily Journal of the Sovereign Grand Lodge, authorize the Noble Grand or Chief Patriarch to communicate the term, or semi-annual, pass-word in addition to the travelling pass-word, when official certificate is presented by members of their own jurisdiction?

Ans.—The resolution authorizes the communication of the travelling pass-word only. The law relating to the communication of the term pass-word is not changed by this resolution.

6. *Ques.*—Under the same resolution would the Noble Grand or Chief Patriarch be authorized to communicate the travelling password to a brother in possession of a visiting card, and not having an order or an official certificate? Aus. - A Noble Grand or Chief Patriarch can communicate the travelling pass-word only to such holders of a visiting card (unless a member of his own lodge or encampment) as have in addition thereto an order for such pass-word, or an official certificate certified as in resolution.

7. The holder of a visiting card desiring to procure the annual travelling pass-word from the Noble Grand of a Lodge, other than bis own must also present a properly executed order for such password.

8. The resolution adopted by the Sovereign Grand Lodge (Page 16,136 of Journal, 1898, Report 199) did not anthorize a Noble Grand to give the annual travelling pass-word to the holder of a visiting card, such holder not presenting an official certificate such as is named in said resolution, unless with said card was also presented a properly executed order for such pass-word.

9. Ques.—Under the recent law of the Sovereign Grand Lodge (Page 16,136 of S. G. L. Journal, 1808) a Noble Grand can legally communicate the annual travelling pass-word to a brother presenting an official certificate, executed in the manner described in said resolution, without a written order for the pass-word.

10. Ques. There is nothing in the general laws of the Order which deprives a Past Grand, who is more than thirteen weeks in arrears for dues, of the privilege of voting for Grand officers.

14. Ques. — A subordinate lodge may provide in its by-laws that, "any brother of this Lodge, taken sick, shall not be entitled to benefits for more than four weeks anterior to the time of reporting such sickness to his lodge" provided, there is no law of the Grand Lodge of the jurisdiction to the contrary.

15. Ques. – An official certificate can be used in lieu of a visiting card as a basis for application for membership in another lodge than that to which the member belonged when the certificate or card was issued, the applicant retaining his membership in the first named lodge pending the result of his application to the second. Such official certificate takes the place of the visiting card required by law as set forth in section 668 of White's Digest, 1805.

17. Ques.—A member in good standing of a subordinate lodge can resign membership therein at any time before charges have been preferred against him.

18. Ques.—Attentive benefits do not depend upon a member's good standing in his subordinate lodge. A brother, though in arrears for dues and thus not entitled to pecuniary benefits, is entitled to attentive benefits, including watchers, when needed, so long as he

remains a member of his subordinate lodge, and is not dropped or suspended therefrom.

19. Ques.—A provision for night watchers is a form of attentive benefit and a mode of care distinctly different from payment of sick benefits and the one is not dependent upon the other.

20. Statement.—A brother in open lodge moves that a donation be made from the lodge funds to be placed to the credit of a member, sufficient to place the member liable to suspension in good standing. Motion carried.

Ques.—Is this legal.

Ans.—It is not. A lodge has no right to remit dues, nor can it draw money from its treasury to pay dues for any class of members. The use of lodge funds, in the manner indicated in the statement, while called a donation is simply the transfer of funds to the brother's credit for the purpose of paying his dues, and is therefore an illegal use of lodge funds, under the general laws of the Order.

21. The disabilities of an ancient Oddfellow are removed when he is readmitted to membership in a lodge, and he is then entitled to all the privileges and benefits that such membership confers.

22. Members can retire from the lodge room when the lodge is closed in one degree, and before it is opened in another.

23. If at the time set for the installation of Officers the Noble Grand elect is unable to be present by reason of illness, and for such reason is excused by the lodge, the Vice Grand then installed should thereafter occupy the Noble Grand's position until the installation of the Noble Grand elect.

24. In a subordinate lodge a third degree member is eligible to appointment as right supporter of a Noble Grand.

25. Ques.—Is not an official certificate for dues paid in advance, signed by the Noble Grand and attested by the secretary of the lodge with the seal of the lodge thereon, per se an order for the annual travelling pass-word in the hands of the holder thereof in other jurisdictions than his own?

Ans.—It is, upon proper identification, such an order for the annual travelling pass-word on the continent of North America.

23. Where the constitution of a Grand Lodge requires the secretary of a subordinate "To notify the Grand Secretary of rejection of candidates and expulsion of members" it is the duty of the Secretary of such subordinate lodge to notify the Grand Secretary when an applicant for membership by card, either withdrawal or visiting is rejected. 29. The official certificate properly executed is itself an order for the annual travelling pass-word. No other order for the pass-word is necessary.

30. A member can not vote or take part in the business of the lodge unless clothed in the appropriate regalia.

31. The rejection of an application for membership based upon the deposit of a visiting card, subjects such applicant to the provisions of law that forbids applicants rejected to apply to any lodge for admission within six months after such rejection.

33. The charter of a subordinate lodge cannot be surrendered by a vote of the members present at a regular meeting of the lodge, should five members wish to retain and work under it, even though those five members were not present at the meeting when it was voted to surrender the charter.

35. A subordinate lodge has no right to issue to a brother in return for the payment of his dues an order for a receipt, or a paper to be exchanged for a receipt when the brother shall so desire. The issuance of such a paper is a palpable evasion of the law requiring the use of the official certificate. It is in effect a receipt, although not so termed.

36. When a Grand Officer is visiting officially a subordinate lodge he should be introduced after he has addressed the chairs and should then be received with the honors of the Order.

37. Ques.—(a) Can the Noble Grand of a Lodge legally authorize a member of his own lodge other them a Vice Grand or a Past Grand (whom he knows to be legally in possession of the annual travelling pass-word) to communicate the annual travelling pass-word to a visitor bolding an order for the same?

(b) Does the law of the Order regarding the admission of visitors permit the Noble Grand to appoint a scarlet degree member, not the Vice Grand, who may be in possession of the annual travelling password to communicate the annual travelling pass-word to a visitor holding an order for the same?

(c) In the absence of the Noble Grand and the Vice Grand, a Past Grand being in the chair, is it permissible to appoint a visiting brother, who is the Noble Grand of another lodge, to serve apon the committee of examination, for the purpose of communicating the annual travelling pass-word to a brother holding an order for the same?

Ans.—The answer to each of these questions must be No. The By-Laws and general legislation of the Sovereign Grand Lodge clearly contemplate that the Noble Grand a presiding officer of a lodge

(other than the R. S. or N. G. temporarily occupying the chair) should communicate the annual travelling pass-word to visitors, and 1 am not aware of any law that authorizes him to delegate that privilege.

38. A subordinate Lodge can not examine a visitor in the Grand Lodge degrees,

39. It is mandatory upon a subordinate lodge issuing a visiting or withdrawal card, to insert therein the highest rank which the brother, to whom the card is issued has attained in the Order, and this whether such rank has been attained in the subordinate, or Grand Lodge, or in the Sovereign Grand Lodge.

40. Ques. Referring to the laws digested in Sees, 700, 701 and 703. White's new Digest of 1895, and particularly to the words "he having been first notified of the action that would be taken" in the third resolution on page 7505 of the Journal of 1877. Must this notice of contemplated suspension be given after the full years dues have accured, or may such notice that suspension will follow if dues for one year are permitted to accure, be given before the end of the year?

Ans.—Such notice must be given after the full year's dues have accrued.

4). Past official rank can only be obtained by service. It can not be conferred by a resolution of a lodge as a mark of esteem for a brother who has not actually rendered the required service,

42. A Grand Warden, being an elective offleer of the Grand Lodge, takes vank and precedence user a instrict Deputy Grand Master.

43. The Vice Grand, while occupying the chair of the Noble Grand, should wear the regalia of the Noble Grand.

44. A minor daughter of a brother, and a member of his family, is not entitled to be paid by a lodge for mursing her father during his illness.

45. A newly instituted subordinate lodge must be opened by the Grand Master or instituting officer in the third degree.

46. The snicide of a brother is no bar, under the general laws of the Order to the payment of funeral benefits by his lodge.

47. The travelling pass-word as well as all the pass-words of various degrees of the Order, are to be spoken as written and prononmeed in English and are not to be translated into any other language. 48. When the Vice Grand of a Subordinate Lodge is given suthority to appoint his own supporters, the Noble Grand can not prevent their installation upon the claim that the appointces are not acceptable to him.

19. An instanc brother incapable of performing an intelligent act cannot be expelled from membership because of infraction of the rules of the Order.

50. Under no circumstances can a member who has not received the third degree be elected Vice Grand of a lodge.

51. A Junior Past Grand is not an officer of a subordinate lodge sud is not subject to a fine imposed by the lodge upon "absent officers."

52. The possession of an official certilicate or a receipt for dues does not of itself permit visitation. It is the duty of a lodge to which such certificate is presented to cause the brother's identity to be proven by an examination, or otherwise, and no brother refusing to submit to such examination can insist upon his admission to the lodge.

54. It is obligatory upon a lodge granting a withdrawal card to state therein the highest rank that a brother has attained in his lodge.

55. The petition of a subordinate lodge must be signed by at least five members in the third degree, in good standing, including brothers holding unexpired withdrawal cards; brothers holding dismissal certificates or withdrawal cards out of date, may join in the petition, but such petition must also be signed by at least five third degree members in good standing.

59. Statement -On the 14th of April 1860, Royal City Lodge No. 13, of New Westminster, B.C., merged with New Westminster Lodge No. 3, of the same place under the provisions of the By-Laws of the Grand Lodge. It appears that at the time the financial position of the Royal City Lodge was superior to that of New Westminster Lodge and that some of its members objected to its mergement if its identity would be entirely destroyed by the transaction. In order to meet this objection and accomplish the object sought, it was unitually agreed that the consolidated lodge should be called Royal City Lodge, No. 3, thus taking the name of one and the number of the other Lodge. Prior to this amalgamation the charters of both lodges were destroyed by fire. A petition was presented to the last session of the Grand Lodge on behalf of the united lodge asking that a charter be issued it under the proposed name.

Qaes.—Under this statement of facts can such a new charter with the new name and number be issued?

.tns.—It can. The power to authorize the consolidation of subordinate lodges and to arrange the terms and conditions of such consolidation, is vested in subordinate Grand Lodges, and such Grand Lodges possess the power to issue, under the circumstances named, a new charter to the consolidated lodge, bearing such name and number as the Grand Lodge shall determine.

REBEKALI DECISIONS.

60. An official certificate is a sufficient guarantee of good standing in a lodge to accompany a petition for membership in a Rebekah Lodge in another jurisdiction.

61. In absence of any local law to the contrary, a Past Grand of a subordinate lodge, who is a member in good standing of a Rebekah Lodge, can be appointed and commissioned by a Grand Master as a special deputy over a Rebekah lodge.

62. The legislation of 1893 providing for Rebekah installation floor work has never been repealed.

63. Ques. - A sister of a Rebekah lodge has served a majority of meeting nights as Noble Grand of her lodge, when, because of a failure of a quorum of its members, the lodge finally became defunct before the expiration of the regular term. Is the said Noble Grand entitled to a Past Noble Grand's certificate?

Ans.—She is not.

64. *Ques.*—What standing does a brother have in his Rebekah lodge, who stands suspended for non-payment of dues, in his subor-indate lodge?

Ans.—Membership in a Rebekah lodge is dependent upon continuous good standing in a subordinate lodge, and a brother suspended for non-payment of dues in his subordinate lodge is, by reason thereof, suspended from membership in the Rebekah lodge to which he belongs.

65. *Ques.*—Does his membership in his Rebekah lodge cease immediately upon his suspension by his subordinate lodge, or does such suspension in the Rebekah lodge date from the time the official notice from the subordinate lodge is received by his Rebekah lodge?

Ans.—He is suspended from Rebekah lodge from the date of his suspension in the subordinate lodge.

66. *Ques.*—If the brother stands suspended in his Rebekah lodge by reason of his suspension in his subordinate lodge (even though he may have paid his dues for one year in advance in his Rebekah lodge) how does he become reinstated in his Rebekah lodge after being reinstated in his subordinate lodge. Aus.—When the brother's disabilities are removed in the subordinate lodge, and he is restored to good standing therein, he becomes *ipso tacto* reinstated in his Rebekah lodge, provided, he is not in arrears for dues in such Rebekah lodge.

68. *Ques.*—Is a Rebekah lodge an auxiliary to, or has it any connection whatever with, the subordinate lodge?

Ans.—A Rebekah lodge is an entirely independent organization from that of the subordinate lodge. It is auxiliary to the subordinate lodge only by reason of being engaged in kindred work, and being a division of the same order of Oddfellows, beyin its government and chartered existence it is independent of, \exists not auxiliary to, the subordinate lodge.

72. Ques.—Can the wife of an Oddfellow be admitted to membership in a Rebekah lodge, she being at the time of her application thereto under the age of 18 years,

Ans.—Yes, if a white woman. The qualification for membership in such case is based upon the marital relation and not upon age.

73. A divorced woman is an unmarried woman and as such is eligible to membership in a Rebekah lodge.

74. Ques.—Can the Noble Grand before assuming the chair and before clothing herself in the regalia fill vacant chairs and direct that the officers repair to the preparation room, there to clothe themselves in the regalia and return to the lodge room, the object being to introduce a little floor work at the entrance of the officers in a body to assume their chairs, prior to the Noble Grand calling the lodge to order for the opening ceremony.

Ans.—There is no objection to the Noble Grand requesting members present to take the place of absent officers for the above named purpose, but should the actual officer arrive, before the entrance of such procession, such officer cannot be excluded from her proper place therein, and when the procession reaches the chairs, an officer who may not have been present when the procession entered, but who is then present cannot be displaced in her proper chair by the substitute invited by the Noble Grand to act in the procession.

75. *Ques.*—May the Warden be assisted by the Conductor in taking up the pass-word prior to opening a lodge?

Ans.-Yes, by direction of the Noble Grand.

79. An instituting officer of a Rebekah lodge, at the time of institution and in absence of qualified representatives of the jurisdiction in which the lodge is instituted, can invite a Past Grand Master of a neighboring jurisdiction, who happens to be present, to exemplify the secret work of the degrees for the benefit and instruction of the members present,

80. A lady is not rendered ineligible to membership in a Rebekahlodge by the mere fact of being the daughter of a saloon keeper.

81. A Rebekah Assembly can neither anthorize, or permit any additions to, or subtractions from the vitual of the Rebekah degree.

82. No portion of the encampment ritual can be used in a Rebekah lodge whether in connection with the Rebekah ritual or otherwise.

83. A Rebekah Assembly cannot admit representatives to seats therein who do not possess the qualifications designated for membership therein by the charter of the Assembly and the laws of the Sovereign Grand Lodge.

85. An Oddfellow who has only received the initiatory degree is entitled to membership in a Rebekah lodge. All provisions to the contrary were repealed by the enactment of the "Laws for the Government of Rebekah lodges" now in force.

MISCELLANFORS DECISIONS.

132. Q_{acs} . All insurance legislation having been repealed, will it be against the law of Odd Fellowship to use the name or emblems of the order in carrying on such busines.

 t_{ns} . It is against the general laws of the Order for any insurance company, or association, to use the name or emblems of the Order in carrying on such business.

B33 = Ques. Will it be against the law for them to advertise to insure Odd Fellows only?

.tas. An insurance company or association is not violating the laws of the Order by simply advertising that it conducts its business with Odd Fellows only.

138. An amendment to the constitution of a State Grand Lodge is inoperative until approved by the Sovereign Grand Lodge, or the Grand Sire in recess.

 $142 = \Lambda$ Grand Lodge cannot by unanimous consent, suspend the operation of either its constitution or its By-Laws. Such laws are in full torce until repealed or amended, in prescribed legal manner.

101. In all ledge processions whether Grand or subordinate the pest of honour is in the rear, and upon the occasion of a visit of the Grand Officers of a jurisdiction to a subordinate lodge, when such officers enter in procession, the Grand Officer or Ranking Grand Officer should be in the rear.

10. The manager of a wholesale liquor establishment is not in eligible to membership in the Order by reason of the provision of Section 5, Article 16, of the constitution of the Sovereign Grand-Ledge.

117. The contingent fund authorized by the Sovereign Grand-Ledge, and referred to in Section 378 of White's Digest of 1895, can not be used for pleasure excursions, or the mere gratilication of individual members of the Order, but may be appropriated for the purpose of buying flowers, or music, at the funerals of deceased members, the payment of necessary railway or carriage expenses of bearers, or of members, attending such funeral, and for such purpose as tend to present the Order to the public in its true light, such as the procurement of speakers to instruct in the tenets of the Order, and in such kindred ways as will awaken general interest in the Order and its work.

151. Statement A sister is put on trial on certain charges herhusband appears for her, he walks out of the committee room during the trial, in indignation, and leaves her without representation; she is not present. The trial committee found her guilty of contempt and her lodge sustained the fluding; she took an appeal to the Grand Lodge and reversed the decision of the Lodge. What is the defendant's status? Is she liable to trial on the charges?

Ans. The proceedings for contempt are entirely collateral to the main issue. The conviction for contempt being reversed, the defendant can now be fried on the original charges. (See appeal, Morning Star Lodge, S.G.L., 1874, Page 6,283; Appeal of O'Hara, S.G.L., 1883, Page 9,288.)

153. Where the constitution governing subordinate lodges provides, in describing the treasurer's duties, "That the treasurer shall pay all warrants drawn at a regular meeting" and "That a lodge may at any time call a special meeting but cannot transact any business at such special meeting except that named in the call without the consent of two-thirds of those present,"no warrant for payment of money can be ordered at such special meeting unless the question of issuing said warrant is named in the call, or its issuance is the necessary, or natural, consequence of the business the meeting is called to consider.

154. The Sovereign Grand Lodge having designated the second Tuesday in June as Memorial Day, and required the Grand Sire to issue his proclamation requesting all subordinate lodges to properly observe such day, it is not within the power of a state Grand Lodge to flx by legislation the 30th day of May, or any other date, as Odd Fellows Memorial Day. The evident intent of the Sovereign Grand legislation was to flx a day which should be observed generally. throughout all jurisdictions, and the date so fixed by it is binding and operative, throughout all subordinate Grand jurisdictions, to the extent that such subordinate jurisdictions cannot designate another day for such services.

155. A Noble Grand, who is not also a Past Grand, cannot be elected representative to a Grand Lodge.

156. The Grand Sire has no power to permit a Grand Lodge to meet at any other time or place, than is designated in the constitution of such Grand Lodge.

157. The Sovereign Grand Lodge has not fixed a minimum fee to be charged by a state Grand Lodge for a Charter, issued by it, to a sub: dinate lodge. The power to fix such fee rests in the Grand Lodge of the jurisdiction.

164. Statement—A member is in good standing and entitled to sick benefits; he is injured to such an extent that he is unable to perform any work, but during the time he is disabled his salary as clerk continues.

Ques.—Is he entitled to sick benefits? The Lodge constitution is, "Every member qualified, as required by the By-Laws shall, in case of being disabled by sickness, bodily accident or mental infirmity from following his usual occupation or otherwise earning a livelihood, be entitled to and receive weekly benefits."

Ans.—Under the above circumstances, the salary of the brother continuing, and his earning capacity not being affected by his injuries, he would not be entitled to benefits. (Appeal East Tennessee Lodge, 13428.)

CONCLUSION.

We have attempted to give you a brief account of the most important acts of the last session of the Sovereign Grand Lodge that are of interest in our estimation, to this Grand Body.

We sincerely hope that our efforts in this direction may prove of benefit to the Order in this jurisdiction.

We feel deeply grateful to the Grand Lodge of British Columbia for the distinguished honour conferred upon us by our election to the exalted position of Grand Representatives.

A communication was read from Columbia Lodge, No. 2, asking permission to exhibit the work of the Third Degree by a team of that Lodge at such time as the Grand Lodge might decide on. It was moved, seconded and carried: That the request be granted for to-morrow at 8:30 p.m.

The Committee on Appeals submitted the following Report which was adopted.

VANCOUVER, B. C., June 11th, 1900.

To the Grand Lodge of British Columbia, I. O. O. F., Victoria, B. C.

DEAR SIRS AND BROTHERS.—The Committee on Appeals to whom was referred the appeal of Vernon Valley Lodge, No. 18, from the decision of the Grand Master, re the claim of the relatives of Wm. Johnston, a deceased member of the said Lodge, beg to report that we find the grounds of appeal to be as follows:

1st: The relatives are asking for what the brother never claimed while he was living.

2nd: The relatives are claiming benefits for a period, during which time we have a letter stating that the brother had had better health than at any time since leaving Vernon.

3rd: Providing that he had intended to ask for benefits, he was not entitled to \$10.00 per week, as he had drawn the full limit according to the By-Laws, when paid his last benefits, viz: \$240.

4th: The Lodge offered to pay benefits for his last sickness, or the sickness that carried him off, providing the relatives would state the period, but claim was made for \$10.00 per week, from the date of his recovery from the previous sickness.

The Committee have gone very carefully, and thoroughly, into this matter, realizing the importance of rendering a decision that will insure to the relatives of deceased brothers, all that they are entitled to, and at the same time, not impose on the living, a tax to meet a claim which can be questioned in any way.

Taking the fourth clause of the grounds for appeal, we find, that the lodge was willing to pay benefits for the last sickness, or that which carried him off, providing the relatives would state the period. According to the lodge By-laws, "A member not disqualified to re-"ceive benefits, who by sickness or accident, may be rendered incap"able of following his usual occupation, or otherwise earning a live "lihood, shall receive from the funds of his lodge the following "benefits."

No evidence or proof of any kind has been submitted, that at any time from September 20th, 1898 to January 13th, 1899, the deceased brother was capable of earning a livelihood, but we have the doctor's certificate which gives absolute proof (proof that would be accepted in any law court) that the deceased was unable to work during the period for which benefits are claimed.

In regard to clause 3, it can readily be understood that persons not members of the Order would make the mistake that benefits were to continue at \$10,00 per week, as that amount had been paid.

In sustaining the decision of the Grand Master we might add, that from all the evidence before us, we find that the relatives of the deceased brother Wm. Johnston are entitled to benefits as follows: 2 weeks at \$10,00 per week. September 29th to October 13th, 1898, making 26 weeks or six months in all at \$10,00; and 13 weeks from October 14, 1898 to January 13, 1899, at \$7.50 per week, making the total amount due \$117.50.

The Committee on Statistics re Dues and Benefits presented the following Report which was adopted.

To the Grand Lodge of British Columbia, I. O. O. F.

Your Special Committee on Statistics redDues and Benefits, beg to present herewith in tabulated form, an Abstract of the Reports of the Subordinate Lodges of this Jurisdiction, of their Receipts and Payments, for the past ten years, with the averages shewn in each case.

We beg to congratulate you on the fact that the number of members on 31st December last is the largest ever reported in this Jurisdiction, but it is also noted that the number of weeks for which sick benefits were paid, the gross amount paid for sick benefits, and the average duration of sickness per member, are the highest shown for the past ten years. We are pleased to observe on the other hand that the aggregate prid for working expenses is less than last year, and that the average cost per member for relief was 67 cents less, the average cost per member for working expenses 11 cents less, and the average cost per member for all lodge expenditures \$1,11 less than in the preceding year.

It is also gratifying to point out the steady reduction in the average cost for all lodge expenditures amounting to \$1.97 permember, which has occurred in the past lifteen years, as shewn in the appended abstract.

It would appear from the reports that there was a net profit on the working of the Lodges last year of \$11,919,78 or \$1.88 per member.

The sum shown as disbursed for current expenses, represents an average of \$1,97 per member and although this is 11 cents less blan last year, we incline to the belief that it is still in excess of what it should be, as it is 27 per cent of the gross receipts, and 15 per cent of the total received for members dues; it thus makes, in our opinion too serions an inroad in the funds that should be set aside to meet future demands, which will inevitably arise, for sick benefits as our membership grows older, to be regarded with indifference.






