IN CHANCERY.


BETWEEN AQUILA B. MITCHELL, - - - - - PLAINTIFF,
AND
JOHN D. NOBLE and others, - - - - - DEFENDANTS.

Whereas a suit has been instituted by the above named plaintiff for the sale of certain lands, being in the Township of Enniskillen, in the County of Lanark, containing by admeasurement forty-nine acres, more or less, being composed of the North half of the East half of Lot Number Eleven in the Twelfth Concession of the said Township of Enniskillen, excepting thereout one acre at the South-West corner of the said North half, sold and conveyed by the plaintiff to John G. Bolt and Octavius Prince; and I have been directed by the decree made in this cause, and dated the Twenty-sixth day of May, A.D. 1875, to enquire whether any person other than the plaintiff has any charge, lien or encumbrance upon the said estate. **And whereas** it has been made to appear before me that you have each some lien, charge or encumbrance upon the said estate, and I have therefore caused you each to be made a party to this suit, and appointed Wednesday, the Twenty-third day of June, A.D. 1875, at three o'clock in the afternoon, for you to appear before me at my Chambers at the City of London, either in person or by your Solicitor to prove your claims.

Now you are hereby required to take notice: 1st—That if you wish to apply to discharge my order making you a party, or to add to, vary or set aside the decree, you must do so within fourteen days from the service hereof, and if you fail to do so you will be bound by the decree and the further proceedings in this cause as if you were originally made a party to the suit.

2nd—That if you fail to attend at the time and place appointed you will be treated as disclaiming all interest in the land in question, and it will be dealt with as if you had no claim thereon, and your claim will be in fact foreclosed.
